The 2024 Annual Business meeting of the Virginia Mosquito Control Association was held at the Virginia Beach Hilton Oceanfront on February 22, 2024.

President Elect (Acting President) Karen Akaratovic called the meeting to order at 11:02 am.

Motion was made by Lauren Lochstampfor, seconded by Eli Hosen, to accept the meeting minutes from the February 16, 2023 annual business meeting as it was submitted on the VMCA 2024 Annual Conference webpage. No discussion, all in favor, none opposed, motion carried.

Student Competition: Chair Jay Kiser, thank you to my committee, student poster submitters, judges of the posters, and everyone that participated and donated to our fundraising events over the past conference and year. This was a successful meeting. We had a total of 4 great poster submissions from 4 different states, including DC. New Business:

Election Results- Committee chair Carla Caulkins, announced the results for the 2024 elections.
