We are seeing history in the making! The US Department of Health and Human Services, the US Department of Treasury, and the US Department of Labor, released a report titled "Reforming America's Healthcare System Through Choice and Competition". This 119-page report is directed at both the medical and dental fields.

Dental therapy and dental hygienists are mentioned a few times, most notably, under scope of practice section. Below are important excerpts from this report. These can be beneficial when discussing the dental therapy bill, SB541, with your legislators. The backing of the federal government to encourage states to adopt the dental therapy model into practice, is another tool we can use in our reasoning when discussing SB541 with them.

"Extremely rigid collaborative practice agreements and other burdensome forms of physician and dentist supervision are generally not justified by legitimate health and safety concerns. Thus, many states have granted full practice authority to APRNs, but there is significant room for improvement in other states and for other professions. 111 Emerging healthcare occupations, such as dental therapy, can increase access and drive down costs for consumers, while still ensuring safe care. States should be particularly wary of undue statutory and regulatory impediments to the development of such new occupations."

Recommendations: Broaden Scope of Practice

- States should consider changes to their scope-of-practice statutes to allow all healthcare providers to practice to the top of their license, utilizing their full skill set.
- The federal government and states should consider accompanying legislative and administrative proposals to allow non-physician and non-dentist providers to be paid directly for their services where evidence supports that the provider can safely and effectively provide that care.
- States should consider eliminating requirements for rigid collaborative practice and supervision agreements between physicians and dentists and their care extenders (e.g., physician assistants, hygienists) that are not justified by legitimate health and safety concerns.
- States should evaluate emerging healthcare occupations, such as dental therapy, and consider ways in which their licensure and scope of practice can increase access and drive down consumer costs while still ensuring safe, effective care.
- "...For example, advanced practice registered nurses (APRNs),96 physician assistants (PAs), 97pharmacists, 98 optometrists, 99 and other highly trained professionals can safely and effectively provide some of the same healthcare services as physicians, in addition to providing complementary services. Similarly, dental therapists and dental hygienists can safely and effectively provide some services offered by dentists, as well as complementary services.

LATEST NEWS House Passes SB 541!

Elected delegates from local components in Michigan united to set policy and direction for the profession.

The exciting weekend of Friday October 5th, kicked off with a continuing education class presented by Dr. Sanjay Chand, M.D. "Infection Control Guiding for the Dental Patient and Pain Management in the Dental Patient." Dr. Chand brought a medical perspective to the practice of dentistry by linking oral manifestations to systemic disease. The Standing Rules, Agenda, and the 2017 amended minutes were adopted and the Annual Reports were accepted. Saturday evening concluded with the Motown themed Detroit Diva President's Dinner, honoring our very own GDDHA member Janet Miller. House personnel came dressed to impress to this networking opportunity, enjoying dinner, drinks, a DJ, and lots of dancing.

The Second Session commenced on Sunday, October 7th. Voting took place for the proposed resolutions and new officers were elected. Inducted as our new 2019 MDHA President is Becky Domagalski. Some of our very own GDDHA members voted in at the state level include Danielle Rouch as President Elect, Sandy Sutton as GDDHA Trustee and Michelle Spencer as MDHA Treasurer. Congratulations to our amazing members and all they do for our profession!

Delegates and student delegates gave written and verbal testimony on the House floor. This experience ignited the student's passion for involvement and interest regarding transitioning into becoming professional members. 
