## "OPERATION OMEGA" YIELDS MORE ARRESTS

PUTNAM COUNTY, TN — On the evening of November 28, 2023, Putnam County Sheriff's Office Drug Unit, assisted by Patrol, Warrants Division, and Jackson County Sheriff's Office has located and arrested the following individuals. These arrests are followed by yesterday's "Operation Omega".

**Rebecca Leann Bohannon** is currently being held at Jackson County Jail on other charges. Upon release from Jackson County, **Bohannon** will be transported to Putnam County Jail for her outstanding warrants. **Bohannon** will be charged with 4 counts of Manufacture, Sell, Delivery, and Possession of Schedule III Drugs. **Bohannon** will have a bond of \$50,000.

**Eric Brandon Hix** is currently being held at Jackson County Jail on other charges. Upon release from Jackson County, **Hix** will be transported to Putnam County Jail for his outstanding warrants. **Hix** will be charged with 2 counts of Manufacture, Sell, Delivery, and Possession with Intent of Methamphetamine. **Hix** will have a bond of \$75,000.

**Rebecca Suzanne Kinney** was arrested and charged with 4 counts of Manufacture, Sell, Delivery, and Possession of Methamphetamine. **Kinney** has a bond of \$65,000 and a court date of 1/24/2024.

**Natosha Marie Stafford** was arrested and charged with 2 counts of Manufacture, Sell, Delivery, and Possession of Schedule IV Drugs. **Stafford** has a bond of \$50,000 and a court date of 1/22/2024.

**Samantha Hope Quillen** was arrested and charged with 2 counts of Manufacture, Sell, Delivery, and Possession with Intent. **Quillen** has a bond of \$125,000 and a court date of 1/22/2024.

Sheriff Farris would once again like to thank the Tennessee Bureau of Investigations, Tennessee Highway Patrol, Cookeville Police Department, Jackson County Sheriff's Office, Department of Safety and Homeland Security, and the U.S. Marshals Service for their partnership and help with not only "Operation Omega" but the day to day as well.


