Veterinarian Program Rules:

- Only Veterinarians in good standing with Boehringer Ingelheim, with established Veterinary Client Patient Relationship and purchasing Qualifying Products for patients under their care, and who are not enrolled in special Boehringer Ingelheim pricing programs, are eligible for this program (“Eligible Customer”).
- The following Boehringer Ingelheim products are eligible for a program rebate (collectively, “Qualifying Products” and individually, a “Qualifying Product”): ALPHA™ vaccines, BIO-MYCIN® (oxytetracycline injection), BOVIKALC® Calcium Supplement, BOVIKALC® DRY Calcium Supplement, CYSTORELIN® (gonadorelin), DIAQUE® Nutritional Supplement, ENTERVENE®-D vaccine, EPRINEX® (eprinomectin), EXPRESS® vaccines, EXPRESS® FP vaccines, IVOMECS® PLUS INJECTABLE (ivermectin and clorsulon), IVOMECS® 1% Injection (ivermectin), IVOMECS® POUR-ON (ivermectin topical solution), LOCKOUT® Teat Sealant, LONGRANGE® (eprinomectin), PRESPONSE® SQ vaccines, PYRAMID® vaccines, PYRAMID® + PRESPONSE® SQ vaccines, SYNANTHIC® (oxfendazole oral suspension), SYNCHSURE® (cloprostenol injection), ToDAY® (cephapirin sodium intramammary infusion), ToMORROW® (cephapirin benzathine intramammary infusion) and ZACTRAN® (gamithromycin).
- Eligible Customers earn the greater of (“Base Rebate”):
 - A 3% rebate on purchases when they reach \$15,000.
 - A 6% rebate on purchases when they reach \$75,000.
- Only orders of Qualifying Products placed by Eligible Customers between February 1, 2026, and March 31, 2026 (“Program Term”), that meet the following criteria will qualify for this Program (“Qualifying Purchase(s)”):
 - Orders for Qualifying Products must be submitted to Boehringer Ingelheim directly or through one of its authorized sales agents.
- Rebates on Qualifying Products that are on back order and ship during the Program Term will be awarded when the back order is shipped and invoiced. Qualifying Products that are on back order and do not ship during the Program Term will not qualify for any rebate in this program.
- Program rebates are in addition to other Boehringer Ingelheim programs for Eligible Customers.
- Eligible Customers who purchase a minimum of \$5,000 from each of the following brand groupings during the Program Term will earn an additional **3%** rebate on their cumulative purchases totaling **\$15,000** OR **6%** on their cumulative purchases totaling over **\$75,000**:
 - GROUP A : LONGRANGE® (Rx) (eprinomectin), IVOMECS® PLUS INJECTABLE (ivermectin and clorsulon), BOVIKALC® Calcium Supplement and BOVIKALC® DRY Calcium Supplement
 - GROUP B : EPRINEX® (eprinomectin), IVOMECS® POUR-ON (ivermectin topical solution), ToDAY® (cephapirin sodium intramammary infusion) (Rx), and LOCKOUT® Teat Sealant
 - GROUP C : SYNANTHIC® (oxfendazole oral suspension), ToMORROW® (cephapirin benzathine intramammary infusion) (Rx), and IVOMECS® 1% INJECTION (ivermectin)
- Rebate checks will be paid at the end of the Program Term. Allow six to eight weeks for processing.
- This promotional-incentive rebate is offered for sales in support of the Boehringer Ingelheim independently driven business plan.
- Rebate requests may require resale information to verify rebate eligibility.
- Sales to other channel resellers disqualify a veterinarian's eligibility for all rebates.
- Boehringer Ingelheim reserves the right to end or modify the program, in whole or in part (including the removal or addition of products or product lines), at any time without notice.
- Void where prohibited by law or regulations. All federal, state and local laws and regulations apply.
- All sales must be INVOICED in the program period in order to be eligible for a rebate and are while supplies last.
- If an Eligible Customer returns any Qualifying Product purchased during the Program Term that impacts the minimum purchase amount, Boehringer Ingelheim may (in its sole discretion) deduct the difference from any other rebates earned during the Program Term. Returns of Qualifying Products purchased during the Program Term may be credited at 85% of the original purchase price.
- Rebate checks will only be issued for amounts over \$50.
