Action Steps and Talking Points:

- 1. Local Action = National Impact
 - Why does local involvement matter more than ever?
 - Reflect on General Flynn's quote and how it applies to your role in your county.
- 2. Grassroots Groups Build Friendships—and Power
 - What groups are active in your area?
 - How can collaboration increase your effectiveness?
- 3. Share Media Contacts
 - What local radio shows, podcasts, or journalists can help amplify your message?
 - Start building a list to share with aligned groups.
- 4. Create and Share Voter Guides
 - Do you know at least one candidate or elected official?
 - Work with other groups to compile names and build joint voter guides.

- 5. Compare Political Contacts
 - List your known local leaders: Mayor, Sheriff, School Board, City Council, etc.
 - Combine contacts across groups to apply collective pressure.
- 6. Endorse America First Candidates
 - Who meets your group's criteria?
 - How will you support their campaign—fundraising, events, digital support?
- 7. The One Hour a Month Rule
 - Can you give one hour per month to make a difference?
 - Brainstorm one small action to take this week.

4. Understanding the Hidden Power Structure


- In most states, including Florida, two of the most powerful figures in the legislature are the Speaker of the House and the Senate President.
- These positions are often influenced or controlled by special interest groups and large donors—many of whom are not elected and have no accountability to the public.
- The Speaker and Senate President typically determine who is appointed to chair legislative committees.
- Committee Chairs hold immense gatekeeping power—they decide whether a bill is even allowed to be heard by the committee.
- This top-down structure means that even well-meaning legislators are often powerless to advance bills if they go against the interests of these entrenched powers.
- The will of the people in a local district may be ignored if the legislator is beholden to the leadership or party establishment for future support, money, or advancement.
- Real reform starts by understanding this dynamic—and working locally to elect principled leaders who resist these pressures.

5. The Grassroots Path to Reclaiming Legislative Power

- To disrupt the current top-down control, grassroots citizens must strategically elect multiple competent, valuesaligned leaders across districts.
- One legislator alone has limited power—but when several principled officials are elected at the same time, they form a voting bloc that can influence leadership decisions.
- Over time, this group can grow strong enough to challenge and eventually win key leadership positions, such as Speaker of the House or Senate President.
- Once in those roles, they gain control over committee appointments and legislative agendas—ensuring that bills with broad public support are actually heard.
- This is how we turn grassroots energy into structural influence: by building power collectively, planning long-term, and supporting candidates who don't sell out to the establishment.

Campaign Finance Reform

Speaker: Bob White – Republican Liberty Caucus of Florida (https://rlcfl.org)

Campaign Finance Reform is one of the most misunderstood and misused levers of power in Florida politics. Bob White, Chairman of the Republican Liberty Caucus of Florida, will break down how PACs and legislative leadership control the political system—and how grassroots citizens can fight back.

Discussion Points:

- What is a Political Action Committee (PAC)? How are PACs used to consolidate political power?
- Can grassroots groups form and use PACs? Why should they, and how can they compete effectively?
- How do legislative leaders control which bills succeed or fail? Understand the influence of the Speaker, Senate President, and committee chairs.
- What can you do to change who represents you in Tallahassee? Practical steps for reshaping your local delegation
- Can we adopt a long-term strategy like the establishment has? Sketch out a multi-year plan to elect liberty-minded candidates and shift the balance of power including those who occupy the speaker and senate president positions as well as committee chairs.

Micro Fundraising and Community Engagement for Group Growth

Speaker: David Kalin – CEO, Kalin Enterprises

Dr. Kalin shares how to build grassroots strength by organizing low-cost, high-impact fundraisers that not only bring in revenue, but grow membership, strengthen goodwill, and position your group to take over hostile or inactive local organizations.

1. Why Micro Fundraisers Work

- Easy for members to organize—no need for top leadership to run each event.
- Require minimal financial investment or resources.
- Attract new members through community engagement and fun activities.
- Build local goodwill that strengthens your group's influence and reputation.
- Can disarm and outgrow hostile or establishment-controlled groups by making your group more relevant and attractive.

2. Examples of Micro Fundraisers

- Charge local businesses a small monthly sponsorship to display their logo on your meeting screen, newsletters, handouts, or website.
- Host wine glass painting or similar creative social classes that appeal to a broad audience.
- Organize themed dinner events with live music or dancing—fun, social, and community-centered.
- Run raffles, silent auctions, or prize-based contests at events that cost little but generate enthusiasm.
- Encourage members to host small home gatherings with food and short presentations about your mission.

3. Strategic Use of Fundraisers to Take Over Hostile Groups

- Outgrow their relevance: build a larger, more active membership than the hostile group.
- Build your reputation with fun, positive, visible activities that draw public support.
- Use consistent fundraising success to show capacity and leadership strength.
- When their leadership falters or vacancies arise, your group becomes the natural successor.

4. Connecting the Dots: From Micro Fundraisers to Political Power

- Every successful micro fundraiser draws new people in—and that's the beginning of group growth.
- A growing group means more volunteers: fresh energy, new skills, and greater bandwidth for action.
- With more active members, your group can support strong candidates by raising money, hosting house parties, knocking on doors, making calls, and sending texts.
- When your group becomes a hub of organized, reliable support, it becomes essential to both current elected officials and rising candidates.
- Instead of begging for influence, you become the influencer—offering manpower and resources that candidates need to win.
- Establishment figures lose ground when you can supply the next wave of qualified, values-based candidates—and the grassroots army to back them up.
