We accept responsibility for communicating all applicable property rules, restrictions and safety requirements to our guests and vendors before their arrival.

ASSUMPTION OF RESPONSIBILITY

As the couple/hosts, we voluntarily accept responsibility for ourselves and for the conduct of all guests, family members, invitees and vendors whom we invite or authorize to enter the property in connection with our elopement.

We understand that use of a private residential garden property may involve ordinary risks associated with outdoor spaces, including but not limited to uneven ground, gravel, landscaping, steps, patios, furniture, weather conditions, insects, plants, lighting, parking areas and other natural or man-made conditions.

We agree to exercise reasonable care while on the property and to instruct our guests and vendors to do the same.

RELEASE, HOLD HARMLESS & INDEMNIFICATION

To the fullest extent permitted by Arizona law, we, the undersigned couple/hosts, voluntarily agree to release, defend, indemnify and hold harmless The Pavilion on San Tan Blvd, LLC, and its owners, Brenda Miller and Kevin Miller, from claims, demands, damages, liabilities, losses, costs or expenses arising from or related to our presence or activities on the property; the actions or conduct of our guests, invitees or vendors; property damage caused by us or individuals attending at our invitation; injury, loss or damage resulting from ordinary risks associated with the elopement; violations of property rules; or claims arising from the negligent or wrongful acts of the couple/hosts, their guests, invitees or vendors.

Nothing in this agreement is intended to release any person or entity from liability that cannot legally be released or waived under applicable Arizona law.
