PROCES VERBAL OF THE CANVASS OF THE DECEMBER 10, 2022 ELECTION FOR THE OLD JEFFERSON CRIME PREVENTION AND IMPROVEMENT DISTRICT:

BE IT KNOWN that on Tuesday, January 10, 2023, at 7:00 P.M., the Board of Commissioners of the Old Jefferson Crime Prevention and Improvement District (“Board”) met at Jones Creek Library, 6222 Jones Creek Rd., Baton Rouge, LA 70817.

The Board examined and canvassed the returns of the December 10, 2022 election in accordance with La. R.S. 18:1292. The certified election returns for the following proposition are as follows:

OLD JEFFERSON CRIME PREVENTION AND IMPROVEMENT DISTRICT

Shall the Old Jefferson Crime Prevention and Improvement District (“District”), be authorized to levy and collect an annual parcel fee on each improved and unimproved parcel located within the District for a period of 10 years, beginning in 2023 and ending in 2032, with an initial fee of \$100 per parcel and shall the District be authorized to increase the parcel fee one time each subsequent calendar year by an amount not to exceed 5% of the amount of the fee imposed the previous calendar year provided the fee shall not exceed \$150 and the parcel fee for owners of lots granted the Louisiana Special Assessment Level pursuant to Article VI, Section 18(G)(1) of the Constitution of Louisiana shall be 50% of the parcel fee levied and collected on other lots, with the proceeds of the parcel fee to be used to aid in crime prevention, to enhance security, to provide for an increase in security patrols and to provide for the overall betterment of the District and for the purposes provided by Act 106 (2022) (the estimated amount reasonably expected to be collected from the initial levy is \$79,750.00)?
