Guidelines for Genetic Counselors to Claim CEU Credits

The National Society of Genetic Counselors (NSGC) has authorized The George Washington University to offer up to 3.258 CEUs or 32.58 Category 1 contact hours for the activity The 17th Philadelphia Prenatal Conference. The American Board of Genetic Counseling (ABGC) will accept CEUs earned at this program for the purposes of genetic counselor recertification.

Instructions to Claim NSGC CEU Credits

Step1: Participate in all the genetic sessions you intend to claim CEUs for.

Note: If you are attending the **Live Conference in person**, you must **check in and check out each day** to receive proper contact hour credit.

Step2: Complete the Required NSGC Evaluations and Quizzes

-- Live Conference attendees:

Complete the NSGC CEU Evaluations for the sessions you attended.

-- Enduring Conference attendees:

Complete **both the NSGC CEU Evaluations and the CEU Quizzes** for the sessions you watched.

Note: In order to receive the proper CEU credits, you **must complete the session courses before** you can access the <u>NSGC CEU Evaluation</u> (and the <u>NSGC CEU Quiz</u> if applicable).

Step3: Submit the 2025 NSGC CEU Report Request Form.

You can also scan the QR code to submit this form.



Note: Include your **NSGC Member Number** (or another relevant membership number).

⚠ Only submit the form once, after completing all required items.

Step4: CEU Certificate Delivery

Once your submission is reviewed:

- CEUs will be reported to NSGC.
- Certificates will be available for download at https://www.nsgc.org/

Frequently Asked Questions (FAQs)

I am a genetic counselor but not an NSGC member. Can I still earn CEUs?

Yes. You do not need to be an NSGC member to obtain CEUs accredited by the NSGC.

Can I attend non-NSGC accredited sessions offered by the conference?

Yes. However, only NSGC-accredited sessions will provide CEUs for genetic counselors.

What is the difference between the Live Conference and the Enduring Conference?

Can I attend both live and enduring sessions to maximize my CEUs?

Yes. Your CEU record will reflect participation in both the live and enduring components.

Do I need to record or list which sessions I attended?

No. Attendance is automatically tracked by our platform or by check-in/check-out onsite.

What qualifies as a "completed" session?

A session is considered completed if you view at least 90% of its total duration.

Can I earn CEUs for sessions that were free?

No. CEUs are not granted for sessions with free registration unless the registration fee is paid.
