The 2023 Election Will Be for All 5 Director Positions!

For the May 11, 2023, PMA Board Meeting, there should be an agenda item for the Board to issue a "Call for Candidates" for the 2023 Election.

Because the 2022 Election did not occur, and because the Bylaws specify that the Director terms are limited to 2 years, the 2023 Election will be for all 5 Director positions. (The PMA has had only 2 Directors since January 2021.)

Please consider volunteering to serve as a Director!

The PMA Board's "Revised Proposed Enforcement Fines and Policies" are Still Unreasonable!

On April 13, 2023, the PMA Board issued a "Revised Draft Enforcement and Fine Penalties and Procedures." The current PMA fine amounts, from the "2023 PMA Policies" are: "not less than \$10.00 nor more than \$50.00 per occurrence or continuation of violations." However, the proposed new fine amounts range from \$100.00 to \$4,000 "per occurrence" and go up to \$1,500 for "continuing violations." Please note that the proposed fine increases came from only 2 Directors - because we only have 2!

Before the Saturday, May 13th deadline to submit comments, please send and email to Property Manager Brenda Dougan at bdougan@stewardprop.com to state that 1) The Board's proposed fines are unreasonable and 2) Only a full Board of 5 Directors should make these types of decisions for the 342 sets of Members.
