

Golden Oaks Village Annual Report

Although the year 2020 will forever be remembered as the COVID-19 pandemic "Lock Down" year, the community did not experience attrition in our resident population that was above our normal rate. Some of our employees tested positive and were isolated; however, none of them suffered any serious reaction to the virus. Golden Oaks followed the CDC and Health Department guidelines and participated in the "lock down" for the required timeframes. Everyone learned a great deal about becoming creative with communication and providing as much support to our residents as possible during this trying time. The staff are

sharply aware of the heightened need for aggressive infection control measures along with all the health screenings, tests, and vaccine opportunities that have become part of our new normal. All in all, we have much to bless the Lord for!

This year also marked the significant change from a for-profit entity to a 501c3 not-for-profit organization. This new change in organization is going to allow us to participate in fundraising, give us access to grants, and allow for more favorable financing for future projects. Additionally, Baptist Village Communities, a long-established organization who successfully operates multiple communities throughout Oklahoma, has been engaged to serve as operational consultants. They helped with the transition to not for profit status, and they continue to provide operational support to the management team.

This long pause that was caused by the pandemic has also provided the time to reflect on our very bright future and all that we hope to accomplish over the next several years. I joined this team in June of 2021 to serve as the permanent Executive Director, with the very task of leading the organization to achieve those planned-for accomplishments. Golden Oaks Village Opens Renovates the Fitness and Wellness Center

The community made the decision to renovate the fitness center that would be open to residents to provide our seniors a place to work-out independently. This strategy has not only increased the number of current residents who work-out consistently. The aquatic center was open to the outside community for group workouts – it was also a way to get to know potential future residents. We had one community aquatic member move to GOV.

Golden Oaks creates new partnership with a Rehabilitative Therapy Team

Coinciding with the new Patient Driven Payment Model (PDPM) for patients receiving skilled nursing care, Golden Oaks created a new partnership with Reliant rehabilitative therapy team to manage the provision of physical, occupational, and speech therapies.



Health Services News

In accordance with the CMS requirements for all facilities that offer long term care and participate in Medicare and Medicaid programs, our facility has a dedicated Infection Control Preventionist on staff who has been trained and certified in Infection Control and Epidemiology. The goal is to protect our residents and have fewer people returning to the hospital.



Tomorrow's Leaders Internship Program

Opportunities are available to young people who are interested in careers within the senior living industry. Our program helps develop the next generation with hands on experience and is beneficial to both residents and interns. We recently announced that five interns graduated from the program earning their Certified Nursing Assistant Certifications. There are currently eight students in the program.



Resident Financial Assistance Fund

Qualified residents in our community, who have outlived their resources through no fault of their own, received assistance through the Resident Financial Assistance Fund. Through the compassion of this program and the generous support of donated resources, residents were able to stay in their long time homes through financial difficulties.

Making an Impact through Community Partnerships

During the COVID-19 pandemic Golden Oaks Village (GOV) received more than 750 hand crafted masks to deliver to employees and to distribute to seniors living independently outside our community.

Residents and employees provided more than 30 boxes of Christmas gifts to overseas children through Samaritan's Purse.

Groups of GOV residents and staff participated in multiple walks/runs to raise awareness and funds for issues affecting our community to include: Arthritis, Alzheimer's, Fallen Heroes, and OKC Memorial Marathons.

Temporary Compassionate Housing was provided to families displaced by inclement weather or natural disasters.

Employee Appreciation Fund provided financial benefits to staff.

Community Partnerships cont.

The Compassionate Quilter Group provides quilts for all GOV veterans, Gold Star families for Memorial Day and for honored veterans at the Legacy Award Ceremony on Veterans Day. More than 40 quilts were distributed.

For recognition on their partnership with the veteran community, GOV received a donation of a visitation pod used as a safe and secure visitation center for residents in all certified health services.

The Needlecrafters Group provided caps and matching blankets for stillborn baby's reunion with parents. They also provide caps and prayer shawls for cancer and hospice patients.

GOV uses surplus furniture assets to provide assistance to needy families.

GOV professionals provided assistance to ten (10) veterans needing Aid and Attendance benefits to offset certified health services.

Both organizations have a rich Christian heritage and combined desire to serve aging adults and look forward to serving together.

Financial and Operational Performance

Despite the unprecedented challenges of the COVID-19 pandemic, our strong operating and financial performance has kept the organization on solid ground and assured the long-term viability of our mission. This past year we have continue to focus on executing the right strategies and action plans to assure Golden Oaks remains well positioned to serve current and future residents through programs, services, and amenities that promote joy, peace of mind and a life of continued purpose. Contributing to our solid financial standing is our high levels of occupancy, with 78% of our units occupied, sold, or committed companywide.





Physical Improvements Continue

Furthering the Leadership Team's commitment to the highest-quality resident experience possible, the past year brought continued improvements to the physical structure of Golden Oaks. Renovation work was completed on several vacant Independent Living homes. Our Plant Operations Team organized a series of projects designed to increase the reliability of our HVAC system and improve our ability to respond to issues. They continue to make improvements to reduce overall maintenance and utility costs, improve our relationships with consultants and vendors, and prepare our campus for growth.
