



Consignment Agreement

*Agreement made between _____ ("Consignor") and The Pink Highland (The Pink Highland Consignment & Boutique, LLC) at the address of 26353 WI-27 Suite F, Holcombe, WI 54745

*Consignor appoints The Pink Highland to act as Consignor's agent for the sale of the items identified on a specified list of inventories on the Consignor's portal account. Additional inventory may be incorporated into the contract at any time.

*Items are only accepted in new, excellent and like new conditions. All items must be gently worn to like-new condition. Any clothing with odors, stains, tears, fading, broken zippers, missing or broken buttons will not be accepted. The Consignor represents and warrants that he/she is the sole owner of the item(s) on consignment. Items sent which are not accepted by The Pink Highland, must be taken by the consignor the same day, no exceptions. If the Consignor does not pick these items up, items will be donated or discarded. Pick up and mail in consignors will not have items returned, these items will be donated or discarded.

*Consignment period is **90 calendars days** from the day the items go on the sales floor.

The Pink Highland has the sole discretion in determining the pricing of all items. The pricing determined by The Pink Highland will be a function of market value, condition and appearance with the intention to sell the item with the highest potential profit. The Pink Highland reserves the right to re-price items at any time.

***Forty percent (40%) of the selling price will be paid to Consignor when Consignor's item(s) sells.**

*You have three options for payouts. (select one)

____ 1. **In-Store Credit:** Roll your payouts into in-store credit to use any time. When an item sells, your in-store credit balance will be updated within 1 business day of your item selling.

____ 2. **Venmo, PayPal or CashApp:** payments are sent once your balance reaches \$20 or more. (2% fee applied for electronic payouts). Any balance under \$20 will remain as in-store credit until your balance reaches \$20.

____ 3. **Check:** Payments are made once a month for sales made the prior month and are mailed via United States Postal Service. \$20 minimum balance for a check. Any balance under \$20 will remain as in-store credit until your balance reaches \$20.

All sales, pay outs and inventory can be tracked via the Consignor portal.

*The Pink Highland is not responsible for any loss or damage to items. Including, but not limited to damage caused by theft, fire, flood, or any type of stains/tears, loss and any other damages or losses without exclusion.
