Response to motion to leave

So even though Gilbert wanted to only discuss defense, I asked Gilbert if he could ask the mom something when he cross examined her. This was the first question of many more that need to be asked if everyone is going to take it to this level. Gilbert said no with a tone that showed slight disgust and agitation and told me i was thinking of weird things and to stay on task.

This was after Gilbert expressed how he was trying to help me by asking me if i thought subpoenaing the school would do good for me. Something he already asked me that i responded to through text. I felt insulted and argued how it was a legitimate question that could clear up everything real quick. My tone was assertive but i didn't say anything disrespectful to Perez, who claimed i was being disrespectful. We ended the conversation by agreeing to meet the next day at 1230. Right as i submitted a complaint to the FCLU and the NYS commission of judicial conduct, Gilbert called me back and said he scheduled a digital hearing for the next day where he was going to drop from the case.

I anticipate KDV showing her disappointment in me again as she paints a narrative that i am to blame, and I'm sure I'll be seen as the one who is delaying the trial, Again.

When I asked Perez to do something that could actually help me win this case, Perez drops out and is doing what everyone does, blame me.. Proof. Again. That discrimination and unfair right to trial is happening. Proof. Again. That the court is trying to control and manipulate everything. Unless the court has a plan to stop interfering with the Dad's, the Mom's and the child's lives, there is no excuse for any of this and it needs to be shut down immediately. The corruption needs to go immediately.

It's funny how people blame me for bribing, yet the truth is, I have been holding on to evidence, in hopes that the court will do the right thing. Holding it because I don't want to hurt my son"s mom.

All I've seen so far is manipulative tactics that are far to familiar. Eerily similar to what the mom has done. Now I'm really wondering if my sons mother is the one to blame or is it her lawyer? If a parents lawyer is responsible for coaching deceptive behavior that are actually attempts to divide a parent and child by manipulating things to make it look like the other parent is brainwashing and Alienating, does that lawyer belong anywhere near a family court? How can a court claim to want whats best for the child while they allow a parent and a lawyer to do things like this? This family court is garbage and they are literally ruining children's lives.

Maybe it's not the small hearted boy Jeff. Maybe it's someone else with deeper roots in the system. You see, the further we go the more I see, and the more likely this is going to get way bigger than anyone wants. But it just keeps going. And if it is, everyone is still responsible for what they've done.

What I asked of Gilbert was one of many things that needs to be asked at trial. And if my lawyer refuses to represent me, I will report it. Because there is nothing wrong with what I suggested and it was nothing unethical like Jeffrey Gerace using a photo album to get me arrested, from an order of protection that should be used against the mom and whoever told her to file it, because it shows what the court has done to my sons mother and

how everything I've said in my petition is real and why my son and I need to get away. For me, so far I've received a lawyer who didn't respond to me, then I pay a law firm that gets taken off of the case while I lose \$2500. Then I get a lawyer who doesn't want to ask questions that are very relevant, and that would end this harassment and brutal attempt of parental alienation once and for all. Everyone knows whats going on but they all want to teach me a lesson. Teaching me a lesson is obviously far more important than the well being of the child, but these people don't care if it's obvious, Because they can just tell me I can't speak and tell everyone that I'm crazy.

This court case has been a circus and a complete joke. It's obvious no one cares about the child here but me. Everything you all have suggested, claimed and enforced hasn't helped the child or Ashley or me one bit.

I feel like i asked a place to help my family , that is responsible for destroying it and the further we go , the worse it gets.

I'm starting to feel like my sons mother is a small portion of the reason for many things that happened. Could the family court be responsible for child abuse? Maybe the family court is being pressured by someone else? Maybe that's why Lorna lied, why my business has been sabotaged, why secret orders were placed, why I was told not to speak as the false narrative driven OOP was enhanced, and why Jeff stooped so low.

I've been blamed for coercion, but it looks like my son's mom is being coerced by others.

I've been blamed for parental alienation, yet all I see is people going out of there way to divide my son and I.

I've been blamed for brainwashing, but I only tell my son the truth and I'm seeing a lot of lies and manipulation from the people who make decisions for children and families.

This is considered parental alienation. Each person who assisted a false narrative, created obstruction to having a peaceful life with my son, and each person who has done something unethical in relation to this case, is guilty of parental alienation.

The Mom made the wrong choice by lying and manipulating to get help from scum bags and criminals. The court made the wrong choice by allowing her to manipulate them. Meanwhile you all watch my son and I go through unbelievable times while my heart is completely ravaged on a daily basis. that I would do something that could possibly put me in jail will be fought until the death of me. There is no way the family court could possibly allow a parent time with a child that the child doesn't want to be with (for great reasons), while also forcing the child around a man that has disrespected the child and the other parent in such ways. There is no way a court can allow split custody to a parent who is directly related to a business sabotage so bad that their child lost his home. Now that's on record. That should be more than enough.
