

2020 Monona County Fair

Dear Monona County Fair Participant,

Plans are now being made to assign all inside booths and outside areas for the 2020 Monona County Fair to be held; **Tuesday, July 14th thru Sunday, July 19th.**

Enclosed is the reservation form that needs to be filled out to indicate your plans as a participant for the 2020 fair. **Please return this form by June 1st to guarantee your spot.**

If possible, **we request all exhibitors set up their displays on Tuesday, July 14th, or on Wednesday, July 15th between the hours of 9 A.M. to 5 P.M.**

- All exhibit buildings will be opened at 10 a.m. and locked at 8:00 p.m. Thursday-Saturday and from Noon until 6:00 p.m. on Sunday. **All booths need to be staffed during these hours.**
- Booths may be dismantled after 6:00 p.m. on Sunday or Monday morning between 9:00 a.m. and Noon.
- A contracted commercial exhibitor cannot sub-lease exhibit space to another party.
- Vehicles may enter the area to load/unload goods or exhibits only. During the Fair, vehicles are allowed in this area from 7:00 a.m. to 9:00 a.m. unless expressed permission is received from the Fair Office.
- All exhibitors are to shut off all electrical items they might have in their booth when the booth is not occupied, and when the building is closed to the public. This means fans, special lighting and other enhancements.

The Monona County Fair Association will not be held liable or responsible for missing items or merchandise. The office will be open by 8:00 a.m. each day if you have questions or concerns during the fair.
