

Eaton Canyon Board of Directors Meeting  
Minutes March 19th, 2026

**Call to Order:** The meeting was called to order at 5:55 PM

**Board Members Attending:** Joan Huthmacher, Guy Labbe, Chris Murphy, Ruby Alvarez, Richard Briggs, Jason Clark, Scott Wright and John Gilmour. Excused: Chris Cimino.

**Election of Secretary:** Motion was made and seconded to elect Dale Pelch as Secretary and approved without objection

**President – General Update:**

- Discussions with Aaron Hennessy, new CoCourse representative have been encouraging with new general manager to be more focused on Eaton Canyon Golf Course and participate in Board meetings.
- New mechanic was able to get additional carts repaired and available for 3/14 Tournament. Discussion of challenges with new carts (County requires 4 year leases; battery warranty is only 3 years).
- Discussion of possible shotgun start for April Tourney – Course typically only approves one shotgun start per year – generally for December Tourney.

**Approval of Minutes from the previous meeting:** The minutes were approved without objection.

**First Order of Business:**

- The 2026 Calendar - still trying to finalize an away tournament for September. Ideally would have 2 away tournaments. Challenge – courses contacted charge premium on green fees. Exploring Lakewood and Mountain Meadows – County courses not able to charge extra credit for tournament rounds
- Possible special event for May explored – cross country format, alternate shot and "Happy Gilmore" theme discussed.
