Tour-Type Modifieds must follow either 2020 SMRS, Whelen Tour, ROC or Valenti Modified Racing Series Rules

Rules may not be combined between series. Must claim Series at registration **with the following exceptions:**

- A. Any Safe modified race car with a wheelbase between 104 inches-110 inches
- B. Maximum tread width 84 inches measure wheel bead to wheel bead.
- C. Rear ends must be locked. Non quick-change rear ends allowed. Tri-y headers allowed
- D. All carbs must pass all go/no go gauges. No modifications except removal of choke tower. All 390 CFM carbs must meet NASCAR Guidelines. All carb boosters must be secure by no less than 0.025 inches steel wire.
- E. Spoiler: Max blade height 8 inches, Max width 48 inches. Must be clear polycarbonate. Max height of 44 inches from the ground to top of spoiler with driver in car.
- F. Weight rule: 6.80 LBS per cubic inch. Plus 175 LBS with a minimum weight of 2600 LBS, 56% max left side weight with driver. Exception: NASCAR spec motor must weigh minimum of 2645 LBS, 56% max left side weight and must meet all NASCAR spec motor requirements per NASCAR rule book.
- G. Any Steel ported cylinder head may run a maximum 650 CFM carburetor.
- H. Any Steel non-ported steel cylinder head may run a maximum of 750 CFM carburetor.
- I. Aluminum 23-degree head engines, maximum 390 CFM carburetor, allowed to run open boosters.

Tire Rule: HOOSIER Tire Compound M20 Left / M30 Right. Tires will be available at the track.

- Four tires may be changed during the race. (Max of 8 race tires) No tire softener allowed. No Emergency tires allowed.
- Racing Fuel will be available at the track. Sunoco 110 or 112 (All teams must purchase a minimum of 20 gallons)
- Mandatory drivers meeting, time to be announced each day. All cars must have an AMB Transponder for scoring to be allowed on track including practice. Any car without a transponder will be black flagged immediately. Rental \$25
