






Tribal Quality Cont.

 - Control Plan includes all characteristics and the control method along with a sample size to measure
- First articles completed before machine is approved to run
- In Process Inspections are completed hourly
- Final Inspections are done on each machine daily
- Advanced quality equipment to increase speed and accuracy of critical quality checks
