1. CALL TO ORDER: The meeting was called to order at 5:31 p.m.

2. ROLL CALL:

Present: Directors Babich, Caldwell, Young, and Chair Pearcey.

Absent: Director Mason excused.

3. **PUBLIC COMMENT:** None currently.

4. CONSENT CALENDAR:

Director Babich made a motion to approve the consent calendar. Director Caldwell seconded the motion.

5. REVIEW/POSSIBLE REVISION AND APPROVAL OF THE MINUTES FROM THE SEPTEMBER 24, 2024, MEETING.

Director Young made a motion to approve the September minutes as written. Director Caldwell seconded the motion.

Motion passed 4 - 0.

6. **COMMUNICATIONS:**

a. Open Door: Hilda Contreras informed the District that they have four new

providers and in January 2025 will have 1 new virtual doctor. Today was also the first day using the new mobile medical van.

7. COMMITTEE REPORTS:

A. **BUDGET/FINANCE COMMITTEE**: (Directors Young and Caldwell)

1. For review/Possible discussion on the updated 2024 – 2025 Budget.

Director Babich made a motion to approve the updated budget. Director Caldwell seconded the motion. Motion passed 4-0.

2. Review and approval of invoice DNHCD 0924 from Del Norte Senior Center for the September 2024 Senior Nutrition Program of \$31,000.

Special Counsel Henion to submit a new contract requesting better itemizing on the invoice as one of the items requested by the Board.

Chair Pearcey made a motion to approve the invoice for \$31,000 to the Senior Nutrition Program to be paid once there is a signed agreement in place. Director Babich seconded the motion.

Motion Passed 4-0.

B. COMMUNITY OUTREACH COMMITTEE: (Chair Pearcey & Director Babich)

1. Discussion/Possible approval of adding SingleCare resource guide to the Website. (Chair Pearcey).

More research is needed at this time, possibly add to November Meeting.

C. HEALTHCARE EXPANSION:

- 1. Community Food Council: (Directors Caldwell and Babich)
 - a. Update from Andrea Lanctot on the CFC and strategic planning.

Andrea Lanctot: We have received our 501 C3 status. We are now a full independent non-profit. We have a full board of directors and bank account. The Family Resource Center of the Redwoods is starting to transfer some funds starting on November 1st, 2024, with the remaining funds hopefully by January 1st, 2024. We are going to sign our final separation MOU next month. We have hired a bookkeeper and are setting up bookkeeping, payroll, insurance and working with a financial consultant to do some financial projections. We did write a 10 year strategic plan that I will leave with you. We are working with True North that is

helping with concept plans for the food hub building. We are working on permits, and we are working on applying for four different grants to fund this project.

Chair Pearcey appointed Directors Babich and Young to a subcommittee to meet with the Community Food Council regarding the Food Hub Center.

2. Recruitment and Retention: (Director Caldwell)

Director Caldwell spoke with local physician regarding the District's possible help with recruitment for his practice. He seemed interested and was going to check into some things.

D. HEALTH PROMOTION:

1. Swimming Programs: (Director Young)

Update by Eric Wier: The pool with be closing for an overhaul. It will be closed in December, January and February. We have been approached by South Coast Community Aquatics; they would like to keep their pool open during the months that we are closed. So it would be a partnership where they are taking on the utility fees to keep it heated to 84 degrees. We would provide pool staff. This will cost an estimated 32,000 more and the city council did support it. We do intend on having our swimming lessons In January and February. For the seniors that want to do it they would have the option for them to get their passes and go to Brookings.

a. Discussion/Possible approval of funding of swim passes for disabled persons.

Board to get information from the pool staff regarding programs that exists and what might be needed. Agendize for November.

2. Non-emergency Transport: (Director Young)

Transports are being made to Medford. Numbers are low and we are thinking about doing more promotion. There was some discussion regarding local transportation.

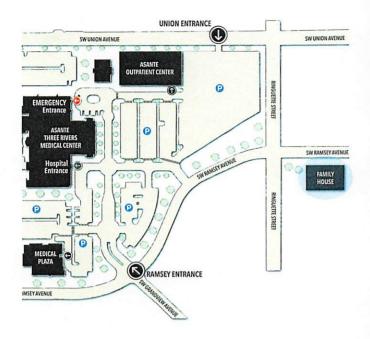

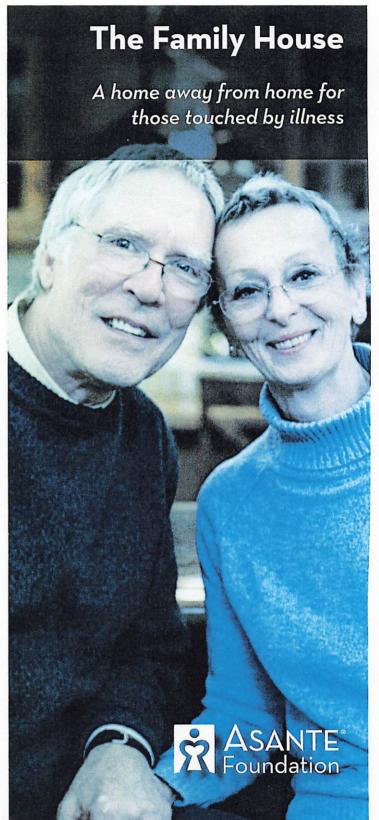

The Family House is located within close proximity to Asante Three Rivers Medical Center. The 7,400-square-foot facility provides a framework for mutual support while affording the privacy guests require. This philosophy is reflected in the design of The Family House.

Seven separate guest rooms with private baths are available to accommodate up to 25 people. Guests can prepare their own meals in the common kitchen and eat together in the dining room. A fully equipped laundry room, free parking, television, DVD player, free WiFi and children's playroom are some of the amenities available so that guests feel at home. No pets allowed. In addition there are five RV spaces located next to The Family House.

Reserving a room

The Family House provides lodging and support for out-of-town patients who need a caring, comfortable, affordable and safe place for themselves or their families while they receive treatment at Asante Three Rivers Medical Center. The Family House does not offer medical services.

To inquire about a room at The Family House, please call **(541) 507-3000**. Rooms are provided based on the greatest critical need. You may call ahead to be put on the waiting list. The maximum length of stay is 12 consecutive days.

Dear Del Norte Health District Board,

The Del Norte and Tribal Lands Community Food Council (DNATL CFC) is seeking funding and commitment from the Del Norte Healthcare District to construct a 15,000-square-foot DNATL Resiliency Center and Food Hub. This facility will serve as a regional food hub, providing essential infrastructure for the sourcing, storage, and distribution of fresh, local, and healthy food to institutions and markets. It will also serve as a community hub of activity with commercial kitchen space for food entrepreneurs, a teaching kitchen for training, a community meeting space, a corner market, a tool lending library, offices, and indoor/outdoor farmers market and event space. By design, it will serve as a critical resource during disasters, ensuring access to food when supply chains are disrupted.

As part of a Northern California food hub network, the facility will contain cold storage, dry storage, wash and pack, loading dock, processing, and distribution infrastructure for the region, enabling local institutional and customer purchasing of local food from an online food hub platform. A retail market will accept EBT, WIC, and prescription food benefits while showcasing local products, providing local producers and entrepreneurs with additional revenue streams. Additionally, the facility will feature a commercial kitchen to incubate small food businesses, enabling local entrepreneurs to create and market value-added products. The kitchen will also provide career technical education training for the community members in food preparation and preservation. An indoor farmers market will offer year-round access to fresh produce, and event space will support community gatherings and educational workshops. A tool lending library will provide kitchen, garden, and farm tools for cultivation, preparation, and preservation of local food to community members and producers.

We have been working with the DNHCD for two years to plan and implement a Resiliency Center and Food Hub. We are currently working with an architect to develop conceptual design plans and are working on several grant proposals to secure funding for the construction of the building. In order for us to apply for funding and start the process of Del Norte County Use permit application, we are requesting from the DNHCD a letter confirming their commitment to the following:

- Allowing the DNATL CFC to utilize the land north of the Open Door Clinic for the construction of a food hub.
- Allowing DNATL CFC to apply for a Del Norte County Use permit for the construction of the food hub
- Commitment of up to 2 million dollars that could cover pre-planning soft costs, site work, utility connection, and construction of the outer shell of the building.

Our partnership and collaboration with the Del Norte Healthcare District is essential to our success. We are dedicated to increasing access to nutritious, culturally relevant food for our region. We request your support to make the Food Hub a reality, enabling us to tackle the pressing issues of food insecurity and food production that our community faces.

Bus Corral: The fencing is going up and a security camera has been installed.

Garden fencing is almost completed. I believe just the gates are left to do.

On Tuesday 11/5/24 it was discovered that the fence on the north east side had been cut open in two places. I sent the board pictures on that day. I spoke with The Local Mow Man, and they are going to repair them. I also spoke with them about the fence repair on the far north side of the field and they are going to get us a quote to repair and reinforce that location in the fence.

Just so you're aware I am receiving bills regarding the elevator that I am paying (Phone line & maintenance contract etc.) until the issue is resolved. I am waiting for the letter from Special Counsel to send to DHHS regarding the issue. We also have an order prohibiting use from the DIR due to invalid permit and we can not get a permit until it is repaired.

Just a reminder that the Oath of Office will be on December 6th, 2024. This is a Friday. We need to schedule a time for this. This is for Directors Caldwell, Babich and Pearcey.

I still have a couple of directors that may still need to complete their ethics. If you have done so, please let me know. If not, please complete them.

We have received the updated agreement from Special Counsel regarding the Senior Center Nutrition Program. It is being signed today (11/21/24) and check issued for September invoice.
