Getting Relief From Unexpectedly High Medical Bills

Unexpectedly high medical bills occur daily in the United States, but there are ways to get relief. According to the Consumer Financial Protection Bureau, one in five Americans is affected by outstanding medical debt, which costs \$88 billion.

In a 2022 study, the bureau found that roughly 20% of U.S. households report having medical debt, with collections appearing on 43 million credit reports. As of the second quarter of 2021, 58% of all bills in collections on credit records were medical bills.

Medical debt affects households unevenly, too, according to the agency. Past-due bills are more prevalent among Black and Hispanic people than white and Asian people, and medical debt is more common in the Southern U.S., in part because states in that region did not expand Medicaid coverage.

While fighting high medical bills can be time-consuming and frustrating, advocates stress that patients should not be intimidated by the system. If you have received a surprise medical bill, here is what you should know:

When Tessa, 33, received a medical bill for over \$1,000 after an emergency hospital visit for a viral infection, she could have the whole amount covered by the hospital after appealing to their financial assistance policy.

"At first, I thought it was just a cold, but it turned out to be something I needed specific medication for," said Tessa, who asked to be identified only by her first name due to privacy concerns. "It was awful by the time I went to the ER."

Thanks to a viral video, Tessa had heard about the patient advocacy organization Dollar For, and she filled out the nonprofit's online form after receiving her surprise bill. The organization contacted the hospital, which was based in central Florida. Eventually, the hospital contacted Tessa directly to let her know she did, in fact, qualify for financial assistance. Even though she had already paid some of the costs with a credit card, Dollar For could get those payments refunded.

Laws governing charity care require nonprofit hospitals to lower or write off individual bills depending on household income. To determine if you qualify, you can simply Google the hospital along with the phrase "charity care" or "financial assistance policy." Dollar For also provides a simplified online tool for patients to see if they qualify.

"Federal law requires hospitals to have these programs to keep their tax-exempt status," said Jared Walker, CEO of Dollar For. "If you're within their income range, they will write off, waive, forgive, or reduce your bills."

He said that even if you have already been paying off medical debt, the hospital will be required to refund the payments you have made.

"It was my first time going through something like that," Tessa said. "I tried to be an informed consumer and ask questions about the costs when I was in the hospital, but obviously, it's hard when you're sick in the emergency room."

While protections against surprise bills have long existed for those with Medicare, Medicaid, and Tricare, laws are now also in place for those with private or marketplace insurance.

The federal No Surprises Act covers people with insurance through their employers, the marketplace, or individual plans. It says that insurance companies must reasonably cover any out-of-network services related to emergency and some non-emergency medical care. That means that if you are being charged more than you are used to or expect when you receive in-network services, that bill may be illegal.

To challenge any bill covered under this law, you can use the free help desk and the Centers for Medicare and Medicaid Services hotline. Many states also have free consumer assistance programs to help with disputes and insurance questions. You can always contact the medical billing department of any hospital in writing to say that you believe a bill violates the No Surprises Act and ask the hospital to deal directly with your insurance company.

"The complexity of the system itself is as big a problem as affordability," said Kaye Pastaina, who heads research on patient protections for KFF, a nonprofit health policy organization. "Much of it is from the fragmented system and complex rules, but also lack of awareness about existing protections that are a part of federal law that might help."

Even if you do not qualify for charity care or you are not sure the No Surprises Act covers your bills, you may be able to reduce the charges.

Medical billing is notoriously byzantine and rife with errors. Anytime you receive a bill, ask the hospital or healthcare provider for an itemized bill that includes the billing codes of all the care you received. The Health Insurance Portability and Accountability Act (HIPAA) mandates that providers share this information.

Next, check whether the billing codes are accurate. Again, simply Googling the codes with the phrase "medical billing code" can help. If something is off, contesting your bill with your medical provider or physician's office can yield changes.

Another approach is comparing the bill with insurance companies' estimates of fair charges for services. If the price you were charged is more than average, you can have your

costs lowered. You could even take the provider to small claims court over the discrepancy (or let them know you have a case).

Finally, compare your insurance company's "explanation of benefits" to the bill. This explanation of costs covered and not covered must match the hospital's bill. If they do not, you have another reason not to pay and to ask the provider to work with your insurance company first.

Despite the hassle, these steps can save you considerable sums of money. Even after taking these steps, you can always appeal health claims with your insurance company if you think there is any reason the bills should be covered entirely or more than the company initially decided. You can also contact your state insurance commissioner for support. "What we've seen in our research and the data is that those folks who appeal — and there are few who appeal — but for those who appeal, there's a high level of overturning," Pastaina said.

Community Assistance Grants

DNUSD proposal for Healthcare District support of the Harvest of the Month program for all K-8 schools

- a.1. Any amount is appreciated to support Harvest of the Month for all K-8 students in Del Norte Unified School District. The approximate cost of this program is \$2,000 per month for 10 months, totally \$20,000.
- 2. The funds will be used to provide Harvest of the Month fruits or veggies to every student in our K-8 schools once a month. The fruit or veggie will be something in season and locally grown as much as is feasible.
- 3. We provide educational material to teachers with the Harvest of the Month. Our goal, which I believe supports the Healthcare District mission is to encourage students to try things they may never have tried and to understand the importance of a balanced diet which includes fresh fruit and vegetables.
- 4. Nutrition services can, if the Healthcare District would like, send invoices monthly showing the purchase of the fruit or veggie for that month as well as what we are using as the educational item for that month.



Dear Healthcare District Board Members,

On behalf of the Del Norte Senior Center (DNSC), I am writing to request funding assistance to support DNSC's long-standing senior nutrition program. With the end of pandemic-related supplemental funding, and the unavailability of the Community Development Block Grant program, DNSC is facing a projected deficit of \$250,000 for fiscal year 2024-25. We are requesting your support to close that gap.

DNSC is a 501(c)(3) private non-profit corporation founded in 1976. DNSC receives a significant portion of its overall funding from federal contracts and grants which require DNSC to participate in annual Single Audits and multiple outside agency reviews of its accounting practices and program outcome documentation. It has the capacity to responsibly manage and report the results of funding provided by the Healthcare District.

The DNSC Senior Nutrition Program serves individuals aged 60 and over with one nutritionally balanced meal per weekday. In cases of extreme need, additional meals are provided for weekends and holidays. Meals are served on-site for group dining and delivered to those who qualify as homebound and unable to prepare their own meals.

Support for the Senior Nutrition Program is completely aligned with the mission of the Del Norte Healthcare District to support the health and wellbeing of our community. Multiple studies, including those conducted by Meals on Wheels America, the National Institutes of Medicine and the American Association of Retired Persons, have highlighted the critical problem of food insecurity and malnutrition among seniors. These same studies have demonstrated the significant health benefits of providing nutrition support to seniors. Documented outcomes of

senior nutrition programs such as ours include reduced health care costs, reduced out-of-home care placements, increased food security, improved diet quality, reduced falls, increased home safety and reduced social isolation and loneliness. Home delivery programs in particular provide our most vulnerable seniors with a critical daily check-in that can identify life-threatening issues early.

Core funding for the senior nutrition program comes from federal Older Americans Act Title III and Nutrition Services Incentive Program. The funding comes through the California Department of Aging and the Area 1 Agency on Aging. Title III and NSIP funding has never supported more than half of the program costs. The program has always needed supplemental funding to operate.

Between 2020 and 2023, COVID supplemental funding supported both normal funding needs and the increased need brought on by the pandemic. These supplemental funds have run out, but we have not seen the need decrease.

Traditionally, DNSC has been included in the County's Community Development Block Grant applications. The last application was awarded in 2022 for the 2021 application year. These funds were fully expended in January 2024. Because of decisions made by the state agency that controls the funding, Del Norte County has not been able to reapply since 2021. The 2024 funding application process has so far been delayed. Based on past experience, even if we are awarded funding, it will not be available until FY 2025-26.

The need for the senior nutrition program has dramatically increased in the last six years. In 2018-19, the program served 781 individuals with 42,503 meals. In 2023-24, the program served 873 individuals with 67,706 meals. Del Norte has an aging population, and we do not see the need for these critical services decreasing over time.

In that same time, costs for food, fuel, packaging and staffing have skyrocketed. The California minimum wage has increased from \$11 an hour in January 2018 to \$16 an hour in 2024. We have had to increase our minimum to \$20 an hour to compete with the new minimum wage for fast food service workers. Increases in the minimum wage impact all staff costs since additional compensation is needed for positions of increased responsibility.

The average price per gallon for gas increased from \$3.15 in January 2018 to \$4.77 as of June 2024. These increased fuel prices impact us in two ways. Most directly,

the cost of running our three delivery trucks has increased. In addition, increased fuel costs are passed on to us by our food and supply delivery vendors. Costs have increased the most over the last two years as inflation has impacted everything.

The tables included with this letter show the increases in service needs and costs since 2018-19. While we are taking steps to reduce costs for fiscal year 2024-25, cost reductions alone will not close the funding gap without resulting in catastrophic reductions in services. We would have to end at least two of our three delivery routes currently serving Smith River and parts of the north side of town, cutting services to hundreds of seniors we currently serve.

The immediate help of the Healthcare District is critical to addressing the senior nutrition program's current \$250,000 deficit through the 2024-2025 fiscal year. It is also our hope that we can build an ongoing partnership to help stabilize the funding for this essential service in the coming years.
