

APPOINTMENT PREPARATIONS

The Redemption Appointment Suggestions for Zim Holders doing the RSS program.

Statement: The Redemption Appointment will be conducted by an Agent from the Alliance. The Alliance has engaged the services of the Angelic Realm to conduct the Appointment. You will be assigned a personal counselor from the Angelic Realms to assist in your Humanitarian activities.

The Appointment Process

The Appointment Process is easy but needs prior preparations to be successful. It behooves each Zim Holder to quit listening to the disinformation and prepare for the appointment with a very positive thought process. The most important bit of knowledge is that the **Alliance is backing us, 100%**. We are the ones they are depending on to do the heavy lifting of mankind out of poverty and back into financial freedom, worldwide. We take over when the Alliance has **cleared the battlefield and eliminated the bad characters.**

They can not do the Humanitarian work themselves because we are the ones who have been chosen to receive the money and get the job done. We are the ones the Alliance has been praying for to put on our full Humanitarian Amor and join in

the process. The Alliance would never short us on the funds needed to do our work. It is our turn.

The appointment itself will be conducted by an Alliance Agent from the Angelic Realms whose job it is to get this new Gold-Backed money into YOUR hands; the hands of Zim Holders who are considered Sovereign Humanitarians by the Alliance. The amount of funds available is staggering, it is beyond our imagination so we just say it has a lot of zeroes and just leave it at that. The interviewers have no limitations as to how much money they can give you. It all depends on the rate you ask for, if you are a Humanitarian, and the humanitarian projects you have planned to do. If you have read the Love Won Society program documents, you can see that we will require huge sums of money to get our job done. If you don't see this yet then re-read the documents again as if you are the only one in charge of implementing the programs worldwide. That can be overwhelming.

So, let's be sure we are prepared for our redemption appointment which is the starting gate to the whole adventure. All our preparations point to that moment in time. Put on your Sovereign Humanitarian outfit and play the part until the part becomes you. Cancel the guru culture that destroys humanitarian dreams and leave it on the side of the road behind you.

Love Won Society Documentation.

We have been assured that those Zim Holders who intend to participate in the Love Won Society programs will not have to explain the whole program. The Alliance Angels conducting the redemption appointment will already have been briefed on the LWS programs. They will, however, be looking at the Zim Holder to ascertain a sincere intent to do the Love Won Society programs in addition to their ability to organize and set up the structures necessary to accomplish the intended projects.

Appointment Preparations

Prepare your presentation in a three-ring binder, one for each person you want to take to the presentation and one for the interviewer. Prepare to leave the interviewer his/her binder. Use tabs to separate the documents.

The following is a suggested outline that LWS will be using. You will need to adapt it for your own use. This is only a suggestion and obviously, there is no requirement to use this format from the Alliance.

There is no requirement for a Trust to be used for the redemption appointment, however, if you want one and don't have a Trust, the Alliance Agent will have a blank Revocable Trust document that you can use to establish a Trust at the Appointment. All you will need is the Name of the Trust, the Beneficiary, and the Trustee(s). You can request a QFS Account for the Trust so you can make your deposit.

Your presentation

Name: John Doe

Currencies: 4.7 million Dong, 3 million Dinar, 4 x 100T Zim bonds

Country: (Germany)

Requesting:

1. Zim Redemption Rate at **\$500,000** Marks per Zim Bond Dollar

2. VND rate \$24.46 per Dong (or the highest rate available) to be deposited into the new Dong/Dinar account you set up in the QFS.

3. Dinar rate \$26 per Dinar (or the highest rate available) to be deposited into the new Dong/Dinar account you set up in the QFS.

4. Structured Payout

- 100-year term
- Structured Payout payment paid Quarterly.
- 10 percentage points of the Primary Principle to determine Quarterly Structured Payout payment.

5. **First quarterly payment** of the Structured Payout program to be given at this appointment and deposited in the Motherlode account established today. (Motherlode is just a

descriptive name that you can use. You name it as you want; Mother Account, Operations Account, or the name of your Trust)

6. \$15,000 cash to be given at Exchange, if available.

7. Requesting two ORIGINALS of a **Referral Letter, from the Alliance to Love Won Society, giving LWS the recommendation for me to be Contracted as a Zim Benefactor. [The letter states that you are a Certified, Alliance Humanitarian and have received sufficient funds to function as a Zim Benefactor in the Revenue Sharing Solutions (RSS) program.]**

The Referral Letter will only be given to those Humanitarians who are in training to become a Zim Benefactor. (LWS will create a Benefactor Application; submit the letter with the application when LWS asks for it. The second ORIGINAL Referral Letter is for your personal files. [I'm going to frame mine])

Requesting New QFS Accounts

1. **John Doe – Motherload account**
2. **John Doe – Dong/Dinar Account**

NOTE: Debit Cards for all accounts – Exclude Motherload. (No cards)

The Three-Ring Binder

(Tab 1) Your Bullet Point Presentation

Short bullet-point presentation of your Personal Projects you want – 5 to 7 minutes. Once you have given the bullet point presentation, it's time to let the interviewer ask questions. Don't talk unless asked a question. Dress well. Sit up straight. Be positive. Listen closely to the questions and be sure your response is on point to the question. Take notes.)

(Tab 2) Executive Summary/Business Plan (Optional)

If using LWS programs (Tab 3 - 7) LWS Program Docs (Copy the documents, RSS, CAC, NRELS, ESS, and ICCH) (if you don't have enough tabs, separate docs using colored sheets)

(Tab 8) Your LLC or other documents that establish your structure if you have them. (A revocable trust documents will

be made available at the appointment to temporarily use as your structure to receive the funds.)

There are no requirements from the Alliance for you to have a trust.

There is no requirement to use this format from the Alliance. It is only an example LWS will use.

Closing thoughts

Once you have gone through the requests and the bullet points, there is very little for you to explain. The QFS Agent. will probably not want to read through pages of information, He/She will only scan to see what you are presenting. Have it available to read if he/she wants.

Understand that the way you organize your request will be a show of your intent. Be positive and respectful but expect your requests to be fulfilled. Have some questions written down about how to interface with the QFS to set up new accounts and transfer or access your funds. The QFS Agent should give you a website address where it will explain the QFS and how to use it in support of your projects, so put some extra sheets of paper in your binder to take notes. They may just give you a packet of information. Unless you have not been honest in

wanting to participate in the RSS program, your requests for higher rates should be granted. Keep in mind that the LWS programs by themselves will require large sums of money on their own. But in addition, you'll have the need to fund your projects as well.

The Love Won Society Action Plans have been our humanitarian projects to share with you. We will use our funds to implement these plans right alongside you.
