

# **Your Trust's Name Trust**

I, **Your Name** (Grantor), of **City, State**, being of sound mind and legal age, and not under duress or influence, do hereby create this Revocable Living Trust, to be known as the **Your Trust's Name** Trust (Trust).

Grantor has, or upon execution of this Trust immediately will, transfer the following assets as a gift and without consideration:

1. All funds in the **ABC** Account or any subsidiary accounts thereof; and
2. All property of any kind, both tangible and intangible, held in the name of **Names property is held in.**

All assets so transferred, now or anytime in the future, shall be deemed "Trust Property."

The purpose of this Trust is to: provide for the management and control of the Trust Property: (1) for the benefit of humanity as determined by and in the sole and exclusive discretion of Grantor, or upon his death or resignation the sole and exclusive discretion of the Trustee(s); and (2) to manage and fulfill the obligations incurred by Grantor and his Successor Trustee(s).

The term Trustee shall also include Co-Trustees, Successor Trustees and Interim Trustee.

During the lifetime of Grantor the Trustee, as identified below, shall manage this Trust in accordance with its stated purpose.

Grantor expressly reserves the right to revoke or amend this Trust at any time during Grantor's lifetime. Revocation or amendments must be in writing and signed by Grantor. This power is personal to Grantor and cannot be assigned unless Grantor specifically grants such

authority in writing, signed by Grantor, and delivered to the Trustee. Upon the death of the Grantor, this Trust shall become irrevocable and cannot be amended.

Grantor designates **Your Name** as the initial Trustee.

Upon the death, incapacity or resignation of **Your Name**, the Successor Co-Trustees shall be **child #1 name** and **child #2 name (Add more children if needed)** (Grantor's only known children). Rock-Paper-Scissor (one time) shall resolve all disputes between Co-Trustees.

**Child #1 name** and **child #2 name** shall each designate one human to serve as their Successor Co-Trustee.

Upon the declination, death, incapacity or resignation of any Successor Co-Trustee, the surviving Co-Trustee shall serve as the sole Trustee, until the predeceasing Co-Trustee's Successor Trustee reaches the age of maturity (twenty-one (21) Earth years), at which time there shall be two Co-Trustees.

Any Trustee shall be entitled to receive compensation for services provided and reimbursement for expenses incurred under this Trust, as determined by Grantor or his Successor Trustees.

No Trustee shall be required to furnish a bond or other security for the performance of his or her duties under this Trust.

No Trustee shall be liable for any actions taken in good faith in the performance of his or her duties under this Trust.

No Trustee shall be bound by any man-made authority in the performance of his or her duties under this Trust.

All Trustees shall be always guided by Universal Law and service to God – the Prime Creator – in the performance of his or her duties under this Trust.

All Trustees shall have the power and authority under this Trust to take any action necessary to implement the purpose of this Trust.

All Trustees shall consult with their Divine Counselor(s) in the performance of his or her duties under this Trust.

Should all eligible human Trustees be under the age of maturity, Grantor designates Jesus Christ as the Interim Trustee until at least one human Trustee reaches the age of maturity.

Jesus Christ shall have exclusive authority in perpetuity to determine if any Trustee is in violation of Universal Law and to impose an appropriate remedy, if any, to include removal as Trustee.

Upon the declination, death, incapacity, resignation or removal of all human Trustees, Grantor designates Jesus Christ as their Successor Trustee, who shall in turn designate no more than three Successor Co-Trustees forthwith, to carry out the purpose of this Trust.
