And, and let's be sensitive air is a transition, it'll be a learning curve, I think it'll be a very steep learning curve, because it's not a lot that we need to learn to be able to use it. And because of that, they're making it as friendly and easy to use as possible. So if you if you have problems, learning how to do it yourself. The idea with the quantum financial system, excuse me, the CAC committee Assistance Centers, probably or possibly could be co located with a financial service center. In other words, a branch of one of the banks, and we've repurposed that for our purposes. And we have the committee assistance centers. And we're there and can help them with those kinds of things as well as with, they can go over to the the portions where there's a catch here, and they can sit and wait in line or do whatever they need going. Until such time as they get serviced. You know, we still are going to be using cash, okay, we're still going to be using cash, if you want to. It's not going to be forced on you to only use cards, but when you go into there, into the bank, you will have financial service centers with a person there will can I help you? Well, I'd like to get some cash. Okay. How much would you like, this is my account, I'd like to get \$1,000 out of there, or \$10,000 to go buy a car from a guy. So you know, you have to give him cash. So you get cash. How does that happen? Well, the gold certificate digital gold certificate is married to a piece of paper. And so it transfers over to the serial number on that piece of paper. You go and make your transaction or many pieces of paper, whatever it is. And that person over there that just selling you the car they have they have the \$10,000 Now what are they going to do with that? They'll take it to their bank, and they'll put it through that little machine and it'll marry it back to the digital gold certificates. Just a simple little transaction. No big deal. And then you've got cash can use cash coins you're gonna be, I wouldn't say it's going to be a problem. But I think that's why they're bringing the coins back out because we still have a transition, we won't be using them as much as we did. But until there's a reason not to have many more, and I can't see a reason to do that. So we're going to have the cash will be long. Those are the things that if you wanted to borrow some money to buy a car, then you go in and you secure a loan. And you've set it up with the payment for the car on the from your beneficiary account. And so and you just give them the number and then send it over there. And it's not certainly not going to be harder, it'll be very easy for us to do the things that we want to do is just, if our mind can conceive it, and believe it, then we can do it. R Ron Giles 21:31

Okay, this should be very quickly, that very quickly. GCR stands for Global Currency Reset. Now, there are those who use the term Global Currency Reset, or those who use the term GCR. They are using them inappropriately. Global Currency Reset means that all currencies in the world every country is represented, will change their value of their currency to be par value with other currencies. How is that going to happen? I don't know. There are those who are doing all this. And it will be a simple thing. There's, you know, from my perspective, it's not simple. I take a currency like Mexico has pesos. Well, one peso is you takes about, I don't know how many, let's say 100, to make \$1. And so all of that's going to have to be equal to each other. So what is the value of a peso going to be? And is there going to be other currencies or other increments of currencies that will make some of those changes? Because the digital gold certificate does not distinguish between one nation's currency and another nation's currency? It doesn't go back and try and figure out well, I got \$1 us and I'm gonna, it's going to be \$1.47 for another country's currency. No, that's not going to happen anymore. The qf s doesn't do that sort of thing. And so all currencies have to be on a par value with the same with other currencies, all to other nine currencies. So that's what the GCR is, is and it has to happen before listen to this. The Golden Currency Reset the Global Currency Reset has to take place

before we redeem our bonds. Does that make sense? The Quantum financial system does not have the ability to distinguish between one piece of currency and another. So they all have to be on the same value as another currency. That's Global Currency Reset that has to take place before the qf s is activated. And when I say activated before we go in, and we sell our Zim to the to the alliance, and they put money into our accounts, those are digital gold certificates. That means we have money in our accounts. Okay, gold back currency creation. We've already discussed the digital gold certificates. And that's how it's done. There. No need to go through that again. Can bank still operate? Yeah, they will operate as financial service centers. And they're already in a transition to do that. Not all of the banks will do that. they're having any trouble with any bank, they will just be outed, they're going to go, they're gonna go dead anyway, I don't, who would make a mistake, to not be a part of the quantum, or the financial service centers, instead of going broke, I just don't understand any of that kind of mentality.
