

Financial Service Centres

Set up a local FSC in the Portville, NY area utilizing an existing facility to provide banking services to members of the community. Also consider the option of maintaining otherFSC's in nearby communities, (Bolivar, Friendship, Wellsville, Scio, and Shinglehouse, PA)that we expand into.

Work with Local Communities

re: Police, Fire and EMS needs in the Community. EMS would be linked to the Clinics that provide Med-bed etc. and other services. This arrangement would work in tandem with an existing medical staff and be a smooth Segway from what is recent/familiar to the public to what is new.

Water Distillation Project (Ozonation Processed)

Tap water, well water and bottled water when tested have a range of 26 to 310 dissolved solids, (none of the solids are listed on the bottles of water in order of type or weight). Water distillation process using steam, filtering system and ozonation results in zero solids.Presently, a distillation processing plant is not available to Ceres, and the Western NewYork area. We will change that situation to provide clean, drinking water.

Purchase existing/abandoned farms

To produce organic fruits, vegetables and livestock that is safe for human consumption. We will provide these farms to farmers in the area utilizing grants to promote the necessary upgrades, (including equipment, seed, feed, and livestock).

Establish a Sunshine Acres about Body Dysmorphia in the Western New York area that would address the need for individuals through a loving environment to recognize that they were made in the image and likeness of their Creator and in doing so, will come to revere that which the Creator has made. This would be the first of many across the Nation.

Assist an existing Morgellons Disease Organization Partner with (Bobbi D) to

provide financial assistance to aid her in her fight against Morgellons Disease (Graphene Oxide and Nano-bots) that has spread throughout the world. She has been working for ten years at her own expense to help those who appeal to her through her website.

My husband and I have also suffered from this disease and thanks to God's help are presently in the recovering stage.

Set up a 24/7 Customer Service Organization for Humanitarian Projects across the Country. Each site would establish groups that would be assigned to the different time zones to accommodate the needs of the Projects. This arrangement would also eliminate the need for employees to have to work graveyard shifts that impact their lives and the lives of their families. Also, it provides an opportunity for each group to become familiar/proficient with their specific areas and puts faces to the needs of others.

Purchase Abandoned Malls and retrofit them as in-door farms and greenhouses where tropical fruit can be grown in the North and in a controlled environment apples and grapes can grow in the South. Also, Malls provide a secure structure in the event of hurricanes and inclement weather that can and does affect crops and livestock. Canning factories and grocery stores can exist in that environment and it's a great place for children to learn how food gets to the table.

Work with the Alliance to accommodate their needs with respect to other galaxies and universes. A separate account (Bond Account) will be set up in the QFS in anticipation of those needs. We want it known that it would be an honor to serve the Alliance that has served us all so well.

ADDITIONAL BONUSES AVAILABLE*


Thank You Bonus: Each Beneficiary uses their User ID# and their referral approval to sign up new Beneficiaries. A one-time bonus of \$50.00 will be paid for each new Beneficiary.

Registration Bonus: Each Beneficiary will receive an additional \$.01 cent download per minute for every 2 new Beneficiaries added using their User ID#. This amount equals: \$14.40 per day, \$100.80 per week, and \$5,241 per year.

Generation Bonus: This bonus pays a \$.01 cent download per minute for every 10 new beneficiaries signed up by a 1st, 2nd, and 3rd generational Beneficiary that registers under your User ID#. This bonus is useful for large organizations: Churches, Businesses, Non-profits, etc.

Trusts: Each Beneficiary has up to 6 trusts they can have in addition to their single account. Each trust will pay out the \$.10 cents per minute, similar to their own account payout. This can be used for saving for college, kids sporting needs, family members who aren't eligible for payouts, etc. Each Beneficiary controls who is in control of their trusts. A lawyer will need to be hired to do the necessary paperwork.

*All Bonuses are in addition to the initial \$.10 cents per minute download for your Beneficiary account. There are no limitations as to how many Beneficiaries can be signed up. Each new signup must have approval and be 18 years of age or older to qualify for the RSS (Revenue Sharing Solutions) program.



Business Owners Contract Account (BOCA)

The Human Resources Department for each Corporation may scale the Share payout to accommodate the pay structure of the company, starting at 25 cents per minute up to 2

dollars per minute. The RSS platform will call the Share, EC Share-37, for an Employment Contract Share @ 37 Cents per minute payout. Each penny added to the share download creates a 60 cent per hour increase - \$14.40 per day, or about \$100 per week. The local Managing Director will offer contracts to corporations with 20 or less employees.

Contract provisions for Corporations:

1. Binding minimum 10-year contract with options to continue in 10-year increments. Each Managing Director has a sister Corporate Managing Director agent, who will issue a 10-year Performance Bond for the upfront purchase of the company's annual production. If the Corporation has less than 20 employees, your local CAC Directors will do the purchasing of Goods.

2. A 5-year average production = quantity to pre-purchase.

3. The Price we pay for the item will be set at the Corporation's wholesale price, minus the labor set by a 5-year average labor cost. (We are already paying the labor with Employment Contract Accounts, which include employee benefits as well as free family health insurance.)

4. Existing or new Employees execute a 7-year Employment Contract and become independent contractors of the company. Our sister Corporate Managing Director is the contracting Employment Agency and will execute an Assignment of the Labor Contract to the Corporation where the employee will work.

5. Our Sister Corporate Managing Director will issue up to ??? billion-dollar Performance Bond**(see note below) to secure a corporation's position in the contract. (bond amount according to the corporation's economic body of factors yet to be determined.)

6. Corporate Human Resources to use existing chain of command supervision to ensure execution of Independent Contractor's responsibilities.

7. Middle management and below will be offered Employment Contracts. Corporate officers and upper management benefits and salary schedules will be the responsibilities of the CEO and Board of Directors and will be paid by Corporate Profits.

8. At the completion of the 7 Year employment contract, The Employment Contract Account will continue to payout indefinitely and will continue to include free Health Care benefits for employees, spouses, and family members under the age of Twenty-three. If the employee continues to work beyond the Contract term, the one-cent raise each month will continue as well as the other contract benefits until the employee retires. Otherwise, the increases will end when the term of the contract ends.

9. Our sister Corporate Managing Director will make expansion loans available for our contracted companies interest free. Small corporations will be handled locally.

**Note: Our sister Corporate Managing Directors payments will be used to establish an Umbrella Bond account. This Umbrella-Bond controlled by our sister Corporate Managing Director will act as a Double Performance Bond to secure the Company's Interest as well as the interests of the participating local Managing Director. The Managing Director Bond and the other sister Corporate Managing Director Umbrella Bond gives a double Bond to establish credibility in the whole program.

Employee Contract Account

Employment Contract terms:

1. Seven Year minimum with options to continue after 7 years to include benefits and periodic increases in account per-minute-payouts.

2. Human Resources of the manufacturer will administer and control employee relationships with the company. Grievances to be resolved by binding arbitration.

3. Employment accounts will range from 25 cents to 2 dollar per-minute scales to corporate salary levels as per existing structure. Once set-in motion, the Contract account payout will not diminish but will increase over the period of the contract. This is a built-in retirement benefit.

4. Employment Contracts will also include free Health Care insurance for employee and immediate family members or dependents until age 23 years.

5. During the Contract term, RSS will add one penny per minute download for each contract Quarter worked. Over the 7-year contract, the increase in Share downloads would be 28 cents added to the Share download, which equals an additional \$2,800 per week increase over the beginning contract payout schedule. One penny equals a raise of approximately \$100 per week or \$400 per month or \$1,200 per quarter.

6. Remedies for breaking the Employment Contract provisions may result in the lowering of the per minute download up to the deactivation of the Employment account. If egregious enough, the Arbitration Board may penetrate the Beneficiary's account and lower the payout for all bonus increases, such as the Registration Bonus of one penny for every two new Beneficiaries, earned up to the point of Arbitration's punitive actions. Beneficiary initiated Trusts may also be deactivated. The original Personal Share payout will not go below the 10 Cent per minute payout. This Share is inviolable and will not be a part of any further Arbitrations' Punitive actions. A Home purchase increase for the Share per-minute increase will not be affected.

7. Those who break their Employment Contract may begin registering new beneficiaries and Trusts and participate in the Bonus program after one year from the date of the Arbitration's punitive action.

8. An Employment Contract does not stop a person's involvement in the Individual RSS

Beneficiary program, including Bonuses.

International Commodity Clearing House

Statement of Purpose: The purpose of this ICCH program is to: stabilize prices for Food Commodities, Manufactured Goods, and Raw Materials, and to ensure Farmers and Manufacturers receive sufficient profits to stay in business and be productive. Our mission includes organizing a worldwide network of clearinghouses, warehouses, and distribution centers where commodities are stored and then shipped to where they are needed.

The Clearing Houses will be set up on a computer network similar to the internet, with a huge database where commodity availability are databases and made accessible to other Clearing Houses. The network will request and receive distribution orders to move commodities to where they are needed.

Statement of belief: Food should be grown Organically, to feed people healthy, nutritious foods; not grown with pesticides, artificial fertilizers, or hormones to justify larger profits. We need to create a computer network similar to the Worldwide Web, to accommodate the need-driven distribution of commodities. The Economic Stabilization System will be the underlying program in support of the whole ICCH operation.

Example of The Play for Farmers:

• The local farmers or manufacturers will be offered a ten-year contract (with options for more years) to Pre-purchase their entire annual production at fair prices, in the spring of each year. A Performance Bond will be issued to each contracted entity to cover our portion of the Contract.

• The moving average of the, then, last five-year annual production, will dictate the amount of upfront money they will receive for the following year. Provisions will be made to accommodate the local sale of produce at desired (farmer's markets). Paying it forward will be encouraged.

• At the end of the growing season, the ICCH will own the produce and store it in purchased or rented storage facilities or warehouses already being used locally.

• The head of each farm will make growing adjustments to ensure the crops qualify as Organic. Small loans or grants will be made available to restore the land to produce the most nutritious crops available. This is a long-term plan.

• Provisions for the growing of industrial Hemp, provided by the new Farm Bill, will be encouraged with grants needed for new machinery for planting, cultivating, harvesting. and processing of the Hemp crop.

• Each farm will be offered to refinance with the terms offered in the National Real Estate Listing Services refinance program. The resultant Real Estate Loan with the additional Revenue Sharing Solutions with the per-minute download adjusted to cover the Loan payment will ensure that the farm can never be foreclosed on again. (See NRELS, for the refinance process link)

• Each farm/farmer contracted shall receive an additional \$1.00 added to their RSS

Beneficiary account payout (\$525,600 per year) as a contract signing bonus.
No pre-purchase contracts will be given for any GMO crop production. We will partner with farmers to finance the repair of the soil and bring the farm to a Certified Organic Farm status. This should be accomplished in less than three years.

• The Community Assistance Centers (CAC) Directors, who are local to the Famers will act as the liaison between the Farmer and the Revenue Sharing Solutions program. The Director will have a unique User ID# to establish the Employment Contracts and have authority to access RSS Managing Director Accounts in support of the Farmer's contract.

• The Directors will have authority to adjust the Employment Contract Account (ECA) per-minute payout as per the Farmer's wishes. The Director will also have authority to secure loans or grants to assist the Farmer's needs.

Employment Contracts Accounts will be available, for farm laborers to sign, at appropriate account payout levels for the work being performed. Family children of the farmer 12 years old and older may qualify for an adjusted Employment Contract Account up to the age of 18. The head of the farm who signs the contract shall administer the Employment Contract Accounts for those in his/her employ in concert with the CAC Directors. They too will be eligible for raises as per the Farmer's wishes.
An Agriculture Board, made up of experts in soil repair and other Agriculture affairs, will be established to give guidance and education to Farmers to coordinate crop rotations for market needs with emphasis on soil nutrition and the use of fertilizers to maintain Organic certification, most true Farmers have superior knowledge acquired from working with the soil for years. This will only give them help with new soil technology and shared experience from the old blue jeans that have the experience.
The local Farms will play their part in the preparation of food stuffs and the packaging required to support the marketing of commodities through the distribution channels. Grants will be given out freely.

• Farmers will return to the social strata of the old days when farming was a respected way of making a living. Corporate farms will be bought and sold back to Farming Families who have lost their farms and forced out of business by crooked banksters. The above micro example will support the Macro plan of the ICCH in the many varied aspects of food production, manufactured goods, and the raw materials industries. The foregoing example for farmers can be adapted to the manufacturing of hard goods as well as the enhancement of raw materials production in support of most sectors of the Economy.

The (ESS)

The net effect of the Economic Stabilization System will be to stabilize the profitability of all participants in the Economy with the net effect of lowering the prices of items to the consumer. Following the example of the Farmers, the emphasis of the program is to use nutritional processes that look toward the health of the populace rather than profit driven processes that cut out nutrition as the basis of the decision-making process. The same ideas will be applied to preserving the earth and its eco-systems, with the net result of cleaning up the environment from past profit decisions that hurt the environment.

NOTE: Profit; there will be a break even or non-profit approach to all that is done in all

the programs that our sister Managing Directors will implement with the help of Managing Directors. The ESS will use the manufacturing industry to support the famers with the latest technology available, and at prices that are affordable to the food industry. As we get established in the pre-purchasing of manufactured goods, and the use of Employee Contract Accounts (ECA) to support the work force, there will be huge sums of money injected into the economy with no expected profits in return. In fact, there will be no problems for Managing Directors operating under huge losses as a result of our service to humanity. The manufacturing sector of the ESS program will use the present national and international distribution systems to support farming endeavors all over the world. Farmers and food suppliers will have a major priority in the program to be supported with lower costs and better financial services for their success. Because ICCH is international, this will include developing countries to increase their production of food that will ensure that each country has enough nutritious food to feed their people. Having the contracted ownership of large equipment, ICCH will ship farming and construction equipment all over the world to support our farming programs. One of the main problems of feeding people, beyond the production, is the transportation of commodities to where they are needed. Large, responsible road building projects will be implemented to create a ribbon of highways in underdeveloped areas or countries to transport food to the local markets.

Brokers and Middlemen

The ICCH program will work with brokers and middlemen to enhance the effective distribution of commodities. These professionals are essential as proven distribution chains are already established. The ESS in conjunction with the ICCH program, will incorporate and enhance their participation with the use of Employment Contracts at any level needed. The over-all ICCH program will ensure that every person in the Distribution Chain of commodities and manufactured goods will be financially viable, as well as the producers.

Developing Water Resources – a Problem-Solution application Using New Available Funds. Sufficient clean water is essential to increase food production especially in under-developed nations such as the continent of Africa. Massive investments in developing natural resources to bring water to the farming location is a must. Africa, for instance, has a large aquifer under most of the African continent. Thousands of wells need to be drilled to bring the water up to the surface for famers to irrigate crops. Governments don't have the money to do this, Farmers don't have the money either, so it is left up to Managing Directors to provide the money to accomplish this necessity for increased food production. A system of wells needs to be engineered to bring the water to where large farms and villages can be constructed. There is sufficient water available during the rainy season to refill the aquifer and with the long sunny growing season, two or three crops per year may be possible. Clearing houses on the African Continent will collectively be called, PACH, for Pan African Clearing Houses. The 54 countries in Africa will form PACH with representatives from each country. PACH will be the exporting and importing authority in coordination with each country's government.

NOTE: There is a problem in the food supply in Africa. Many commodities are shipped overseas to markets outside of Africa leaving a shortage of these commodities for the African population. Cocoa beans are a good example. Many people in East Africa cannot afford the prices for cocoa from West Africa that European countries can afford to pay. So, they are left out, with many East Africans never having tasted hot chocolate. Increased production with an operating axiom, "Africa first, then export the excess." May be implemented. Many Managing Directors will be needed for this project. There are perhaps hundreds of these types of projects that can be implemented all over the world. This project started in Africa can act as a prototype for other areas. The clearing houses can be the right structure to accomplish the distribution. Other underdeveloped countries have similar problems with similar solutions being the investment of money without a profit incentive. It just takes money and a dedicated workforce paid by RSS bonded Employment Contracts to build up the required infrastructure. The ICCH, with the support of the ESS on a more local level, coupled with the equipment our sister Managing Director can supply, will take on this project with the intensity it deserves. There will need to be a coordinated effort with gualified individuals who have vision to get the ICCH up and running. It may take a year or two of intense planning to implement all phases of the program. Each Managing Director will have an opportunity to get involved in areas that suit their desires and capabilities. ICCH will provide the computer network and we can build large warehouses to store commodities for distribution.

Forward Looking Statements using New Technology. We are of the opinion that new technology will come into play to fill in the gaps in our present technology to accommodate the massive changes to our society and the economy that are taking place.

However, everything should be well thought out and calculated.

For the success of any business, the presence of an ever-growing client base and the good location of the premises are extremely important. The needs of people in the region for such services and the possibility of increasing their number in the future should be carefully studied.

WHICH STUDIO CAN BE OPENED

To open, you can choose the following types of sewing:

- A small atelier for the repair of clothes;
- Tailoring of narrow-profile clothes;
- Tailoring by individual order of diverse clothing;
- Tailoring of designer clothes for subsequent sale;
- Opening a franchising studio.

A clothing repair shop is the simplest and least expensive investment option. It is much more difficult to create a salon-type atelier.

Atelier and shop

This is a union of 2 different directions - sales and tailoring. You can trade clothes made in the atelier, sell sewing accessories and at the same time provide tailoring services. Another option is to buy ready-made clothes in bulk and sell them in the store. This is a good way to attract additional customers and increase business profitability. However, free funds are needed for the purchase of goods and an increase in the cost of remuneration of sellers

Repair shop

You can't make big money here. However, much less investment is needed to get started. Over time, you can develop and expand this business.

Narrow-profile atelier

For this kind of activity, the correct location and the presence of an extensive client base are important. For example, sewing wedding dresses will be successful if the atelier is located near the registry office or a salon for organizing special events. And it is most reasonable to sew overalls in industrial zones near numerous factories that need such a service.

It is worth buying only specialized sewing equipment - this will reduce start-up costs

MASTER OF ALL TRADES - STUDIO FOR TAILORING OF DIFFERENT CLOTHES

This is the most expensive type of garment business to enter. The purchase of a wide range of equipment requires significant costs. Competent selection of personnel is one of the key points. It is necessary to find high-class professionals with practical experience. You can hire generalists, another option is to form a team of experts in their field. With proper organization and proper planning, this option atelier will pay off the fastest.

WE SEW AT HOME



A home business allows you to save on rent, because all the equipment will be installed at home. However, this method of organization is only suitable for a small workshop.

BUYING A FRANCHISE

Starting a sewing business in this way is a costly undertaking. The cost of the first installment can reach 1 million hryvnia. Pluses - work under the wing of a well-known brand, which itself is engaged in advertising and attracts customers. The main thing is to meet the requirements. This method pays off within a few years.

HOW TO ANALYZE AND CORRECTLY DESCRIPTION THE SALES MARKETS

The success of the implementation of the business plan depends on a competent and carefully conducted analysis of the clothing market, a sober assessment of the capabilities of competitors and the correct calculation of the number of potential customers. You should not only study someone else's successful and unsuccessful experiences, but also develop a plan in case of unforeseen situations, crisis phenomena and unfair competition.



DETERMINING THE TARGET AUDIENCE

Location significantly affects the number of customers and their requests. The sleeping areas of large cities are more in need of a small repair shop than a large and respectable salon-studio. It is preferable to place it in the central part.

Only a balanced analysis and a reasonable approach will bring success to any business. There are no trifles here - you should take into account the availability of convenient transport interchanges, parking spaces near the studio. The client will become yours only if he will be comfortable and hassle-free visiting the institution.

WHAT ARE YOU BETTER THAN OTHERS?

Of course, the ideal option is when there are no competitors nearby. But sometimes their presence allows you to perfectly develop your business. The client must understand that contacting your studio is beneficial for him, that here he can receive a greater range of services or a higher quality of service. Studying the mistakes and achievements of competitors allows you to organize your work in such a way as not to repeat their mistakes and improve your level. Find exactly your differences and advantages for business - tell about them in advertising, on the outside of the atelier, in leaflets and business cards. **THERE IS NO ADVERTISING**

HOW TO OPEN YOUR BUSINESS

After determining the direction of activity and the type of atelier, it's time to start organizational issues. Starting costs according to average calculations will be from 120

to 250 thousand hryvnias. Of course, the final figure may change under the influence of many circumstances, but even with the most optimistic scenario, it will not be possible to open a clothing business for less than 80 thousand hryvnias. It is important to consider that the profit will appear later, and the costs will start from the first day. It is necessary not to forget about this when calculating.

HOW TO DOCUMENTS



There are two options for the official start of activity - to register as a private entrepreneur or open a legal entity. In the case of one owner, the registration of a state of emergency is easier in registration and in the further payment of taxes. To pay salaries, employees need to register with the Pension Fund. You also need to open a bank account. You can entrust the execution of documents to lawyers, but this will at least double the costs. Registration costs will range from 2000 to 6000 hryvnia.

WHAT SHOULD BE IN THE STUDIO ROOM

The premises for placing a garment business object in it must meet the minimum requirements:

- There is a bathroom;
- Conducted electricity of the required power;
- Usable area of at least 10 sq.m;
- Providing uninterrupted heating in winter and air conditioning in summer.

WHAT EQUIPMENT YOU WILL NEED AND WHERE TO BUY

The cost of purchasing sewing equipment should be accurately calculated in the business plan, because it is one of the main items of expenditure. It is better to contact a specialized trading company to buy everything you need in one place and save money.



Need to purchase:

- Sewing machine for basic operations -
- for hemming
- Overlock -
- Cutting knives -
- Professional steam iron -
- Ironing boards -

It is necessary to provide the studio with consumables. You will also need to equip a fitting room with a mirror, take care of providing adequate lighting and fire protection equipment.

RECRUITMENT

For a repair shop, it is enough to hire one employee to help you.



However, for the work of the atelier, it is required to attract professional craftsmen - you will need a cutter and a seamstress. An experienced accountant is needed to maintain financial documents. The right staff will help your business grow and succeed. To assess the professional skills of the applicant, it is worth offering him to complete a practical task - this way you can quickly and accurately identify a good specialist.

STAGES AND TERMS OF PROJECT IMPLEMENTATION

First you need to develop a well-thought-out business plan, then find a premise and register a business.

Drawing up a financial plan

The financial plan should contain calculations of start-up investments and fixed costs. To calculate the payback period of the studio, you need:

- 1. Take into account all initial costs for registration, rental of premises, purchase of sewing equipment and consumables, advertising, etc. On average, at least 120 thousand hryvnias will come out.
- Determine the average monthly income. The planned daily income is calculated as follows - the average cost of the service is multiplied by the number of orders. The result is multiplied by the number of working days in a month. After deducting taxes and social contributions, the average monthly income is obtained.
- 3. Divide the sum of the total start-up costs by the average monthly income. This will turn out the period for which the studio will pay off. Usually it is from six months to 10 months. The situation is worse if the payback period is more than 1 year.

ACCOUNTING FOR REGULAR PAYMENTS

Regardless of the profitability of the business, you will have to pay monthly:



- For renting a room;
- For the consumption of electricity and other utilities;
- For advertising;
- Wages;
- Social contributions and taxes;
- For the purchase of new consumables.

HOW LONG DOES IT POSSIBLE TO START WORK

In reality, taking into account all the necessary actions, the average launch time for such a project is six months from the moment the business is registered. This is important to consider when drawing up a business plan.

In order for a business to become successful, it is important to do your job professionally, to treat the problems and concerns of customers with understanding. A high level of service almost always helps to achieve the planned result.

OVERVIEW

Project Structure:

Trustees have oversight of project managers and "Trust Protectors" (basically auditors) exercise oversight of the trustees/trusts. The contract that creates the trust contains the operational definitions such as the founding principles, job descriptions, tasks, etc.. All is defined in the contract

Studies have shown that nearly all ministries that fail never adopt into their foundational structure the following principles:

- Purpose: The reason the ministry exists

- Values: The non-negotiable beliefs that determine our behavior

- Guiding Principles: The values, beliefs and philosophies of the ministry that provides direction in making day-to-day decisions.

- Position: How we want the world to see us. Defines our unique brand and distinct and valued place in the mind of the community.

- Objectives and Strategies, Projects, Job Descriptions and Tasks

- These foundational principles are defined in the trust contract for each project.

Operations:

As one cannot assume to do all that is required it seems logical that the first hire will be a project manager to start on the groundwork of acquiring facilities and hiring the initial people.Common Law lawyers to lay out the basic documentation. Then accounting office manager(OM) and let the OM hire the other accounting people.

Next might be a couple of professional trustees, etc.Next hire is a Personal Assistant(PA) that is multi-lingual to field all calls and keep calendar and other fidgets under control. By remaining anonymous, at least in the beginning, one might find time to

relax and direct the operations from a forty thousand foot perspective.

To keep in contact with the projects, communities, etc., one may dress appropriately for the visit and be the "under-cover boss" so to speak, keeping a finger on the pulse and observing other opportunities to serve.

Securing/acquiring space to work from was covered in the training videos. It seems good to have a base of operations for those admin duties that may remain stationary such as lawyers, trustees, accountants, etc. since we will probably be able to work remotely in a much more efficient manner in the near future, i.e. quantum phones and pads.

Researchers will be invaluable especially in the start-up phase and should be readily available from the younger population. Some of their tasks may be to find areas in most immediate need of our services, locating materials and people, finding the latest tech that is just coming available, etc.

As you will see in the docs, trust certificates are available for distribution to individuals, with certain restrictions. Keep in mind that the trust is a contract and may be modified in any way that suits the involved parties so that what is written is not in stone until signed by the parties.

It is our intention to distribute the trust certificates(TC) to those workers in the projects that show the most desire and commitment so that when the project is liquidated at its termination those people will hold the extra benefit that they put into the project in their

hand/account.

Keeping that the contract may be modified by the trustees at the direction of their boss to fit the situation in each project. As the trustees are hired by contract and that things have changed by then, it is in the contract that they will honor the wishes of their boss.

Although we may see darkly as in a glass, the basic future, the details are not created yet.


The transmission of most of the wealth of donor millionaires is not a transaction but a transition.


All surplus income or capital will be put on the "Surety" account for the financing of related humanitarian projects.

In our multigenerational houses, grandparents, parents, children and grandchildren live under one roof. They develop and consolidate love, human dignity, happiness and health, help and support each other and strengthen family ties.

Every child is given the opportunities for schooling and is prepared for a future profession.

You will learn and consolidate the traditional values of the Filipino generations. You use and maintain your cultural heritage, do sports, and keep your body healthy.

They learn about the values of nature, care for and protect nature and the environment and use their yields and natural products for a healthy diet, avoiding unnecessary waste. They engage with animals, learn to love them and consider them an important part of their existence.

Philippines: An end to the throwaway madness, an end to hunger and poverty.

Thunderstorms, typhoons and flooding

Storms, typhoons and floods constantly have devastating effects on people and their quality of life.

Shoddy shelters, tin shacks and constant danger cause hardship and fear

Philippines - Food from the garbage dump In the Philippines, more and more food is being thrown away. But many poor people are forced to look for their food at garbage dumps.

Every day, the children of the slum enter the water again to fish recyclable items or plastic waste from the bay, which washes the city's waste directly in front of their huts. 9.3 million kilograms per day is produced in the cities and suburbs, according to the Ministry of Environment.

1. business idea

Our project is a humanitarian, social project. We will build a housing estate with multi-generation houses.

Components of the project are rooms and open spaces for childcare, school and education, culture, sports and recreation, agriculture and animal husbandry, as well as medical care, catering and various courses.

"Hunger and poverty under palm trees" - this is the shortest way to describe the situation in the Philippines. The bitter poverty of the population stands in stark contrast to the vacation paradise for tourists on dreamlike beaches with turquoise blue sea.

44% of the urban population lives in slums. Entire families, who have lost their livelihood in the countryside, dwell in garbage heaps, cemeteries, along country roads, on embankments or under bridges.

In the multigenerational houses, grandparents, parents, children, teenagers and grandchildren live under one roof. They live and deepen social contacts. They learn from each other, care for each other and help each other.

We prevent hunger and poverty by creating areas for the cultivation of vegetables and fruit, as well as animal husbandry, and create conditions for clean drinking water and adequate sanitation, showering and washing facilities.

We have partners who provide training on more sustainable farming practices and efficient irrigation systems, and help with drought-resistant seeds.

During and especially after the completion of the project, about 20 jobs will be created, which will actively participate in the implementation of our business idea.

Activities, as craftsmen, caterers, service providers, teachers, kindergarten teachers and instructors, event managers and staff, course instructors, administrative and office staff, IT representatives as well as course instructors, medical staff, animal keepers and caretakers, farmers and fishermen.

There will be training rooms and ample space for childcare. We create opportunities for nature-based education and training. Courses for learning about flora and fauna, herbs and mushrooms for nutrition and health.

Various spaces and open areas will be created that can be used for learning, childcare, interaction with plants and animals, conservation and protection of nature and the environment.

Children learn about the plant and animal world, are engaged in handicrafts and agriculture, participate in the production of natural products and learn to eat healthy. In addition, there are various courses, outdoor lessons with practical relevance, enjoyment of work and preparation for vocational training.

3. humanitarian goals

Our goal is to enable the people who use and contribute to our project to survive in dignity and safety, to give them a perspective on life and to alleviate human suffering.

Our actions are directed to the protection and care of people who are currently in a humanitarian emergency. On the one hand measures for first aid and with the completion of our project there are possibilities and conditions which go beyond first aid.

The children and young people learn how to produce environmentally friendly products themselves, how to live close to nature, which herbs and plants are given to us by nature and can be used for healthy nutrition as well as healing purposes.

Children and young people learn things that you really need.

- Nonviolent communication folk and natural medicine
- Truly healthy nutrition Self-care
- Rules of honest success Direct democracy
- Free energy Survival in the wild
- Herbs and plants as food Loving and caring for animals

4. climate and environmental protection

In the project, alternative environmentally friendly options for energy production and use are applied. Each house has its own environmentally friendly energy supply and water supply.

Reusable bottles are used in our own water station, no plastic or environmentally harmful tableware and transport material.

There is enough drinking water for every resident, but also enough water for the animals, as well as for vegetable and plant cultivation and fruit growing. In the process, rainwater is also collected, stored and used wisely.

Environmental protection means the future, therefore sustainability has a very important meaning in our project. For us, sustainability means that we are constantly engaged with nature and the environment, learn from and with nature and study and maintain the knowledge and experience of our ancestors and ancestors and pass it on to future generations.

We create areas with lots of greenery, trees, herbs and plants, but also permanent cultivation of fruits and vegetables for their own supply and sale. The people who are themselves involved in the cultivation of plants and food have a completely new appreciation of nature and the environment.

Organic waste is composted and residual waste is sorted and separated for possible processing for reuse or environmentally friendly disposal

5. The sustainability of the project

Growing poverty, inequality and injustice, are not unique to the Philippines, but a

worldwide problem.

Our goal is to contribute to the fight against extreme poverty, to improve the living conditions of the people living in our project in the long term and permanently.

To this end, we link a total of three dimensions of sustainability that are inextricably linked and mutually dependent - social, environmental and economic.

We oppose discrimination, including people with disabilities. We treat all participants in the project equally, main principles are mutual respect, help and support, selflessness, love for people and animals.

The founders of the project act as stakeholders and closely cooperate with other groups of people and strong partners. We sell fish and seafood, fruits, herbs and vegetables from our own cultivation.

We organize excursions for interested people and support them. We organize lectures and courses on health and nutrition. With our project we also pursue the goal of involving people from the surrounding area in the cultivation, care and harvesting of our vegetables and fruit.

6. perspectives for the residents, especially for the children and young people. Our multigenerational homes offer unique living conditions where older and younger people live together every day, learn from each other and help each other.

They take advantage of various opportunities for education, further training, sports and cultural leisure activities, which we see as an important part of our project and include in our daily work. The residents of our residential complex are actively involved in various measures. Healthy eating, courses, games and fun are on the agenda.

There are rooms and areas for the care of the children when the parents are working, but also the grandparents living in the house take care of the children and teenagers. They go with the children and adolescents to nature, to farmers, fishermen, craftsmen and entrepreneurs, where the children and adolescents can already engage in economic and agricultural activities, are actively involved in simple activities and work and produce their first consumer goods or products themselves.

The goal is that the children and young people have joy and fun in the activities and in the work, that your interest is aroused, that you yourself would like to use a vocational training, in order to be able to earn your living later and the living of your family, their children themselves, to be able to work independently and autonomously.

The planned approx. 10 jobs will primarily be filled by our tenants and they will be trained or qualified for this purpose.

7. recreation, learning, training, getting to know nature and the environment.

Hobbies are great and important. They're fun and help build social connections. They also promote development:

Music lessons, for example, have a positive effect on emotional and cognitive skills, sports train motor skills and are healthy.

Filipinos love singing, we encourage singing in groups, at KARAOKE, and we encourage learning instruments.

On the planned sports fields are sports and games to promote regular community activities, healthy lifestyle and exercise. Gymnastics classes in the pool, swimming lessons for children and much more.

We offer various courses in the rooms and open spaces, in nature and by the sea, where all generations in the project can present their experiences and learn from each other.

We offer different cultural opportunities in the form of various events. Theater concerts, among others, to preserve and promote cultural heritage. Together with our residents, we create smaller nature reserves where small animals, birds, beetles and insects can gather and develop.

We publish the results of these actions in the media to influence that the participants are proud of their results and experience appreciation.

8. planned measures

An essential condition of our project is the construction of a housing estate with multi-generation houses for 30 families with 3 and more children.


With the funding we want to acquire a central plot of land on which will be built the apartments, outbuildings, sports areas, pool and outdoor facilities, areas for recreation and relaxation, for growing vegetables, plants and fruits.

Part of the land is used for the cultivation of various local vegetables, plants and herbs. We plant fruit trees and create areas for the cultivation of fruits. A small pond with freshwater fish, for small animals, frogs, crabs and shrimps.

In the adjacent areas, the creation of stables on a natural basis and open spaces for various species of animals such as chickens, sheep, goats, pigs, etc. is carried out.

After completion of the project, the project is supported and financed by the rental income, for maintenance, ancillary rental costs, personnel costs, energy, water and events, purchase of sports and leisure articles, design of outdoor facilities, technology, transport costs, gasoline, as well as remuneration of mentors for courses and further training.

With the fair payment for the work done, the co-designers of the project and the employees receive, in addition to their professional activities, essential monthly income



Build Hope Community Centre CAC#117

The Community Centre will be an extension of the facilities offered by the Church of God 7th Day in Moore Street Derby.

The Church has been on this site for over 25yrs and facilitates events such as weddings, funerals, and baptisms within the Christian ethos.

Historically, Conventions, Seminars, Training Days, workshops and Health Promotion activities have been held at the church. Since Covid 19 pandemic started, online sessions have been held locally and internationally. A soup / sandwich outreach facility operates from this site weekly.

The venture is supported by several volunteers, in taking this project forward the Elkanah Trust aims:

- A weekly soup kitchen / sandwich operates from the church, serving over 100 portions on a weekly basis, Monday between 5 and 6pm. This is well received. Staff are trained in Food Hygiene. I am aware that a service operates nearby on a Friday evening, but does not conflict with was is being suggested To extend and further support the nutritional needs of the homeless through the development of restaurant facilities and other socially disadvantaged groups –
- To support training facilities for deprived communities with additional educational experiences
- To provide Bursaries supporting the education of individuals into education opportunities aim at improving health and social outcomes locally. National and international

Action Plan:


- 1. Begin with a Community Centre- to promote the gathering of information, sharing of information, and training. By creating the foundation to establish needs and interest in the community, tailored training can be provided.
- 2. Move into the area of agriculture and farming- focussing on preparation of land and investing in organic seeds and plants to promote healthy food. This will include small

scale home gardens and larger scales to support the wider community and export.

- 3. Construction and repairs. Seeking out people whose dwelling can be repaired and those who might need to be rehoused and housed for the first time. Creating a community of helpers within the community, under the umbrella of the Beneficiary.
- 4. Create Health Centres, to cater for –Mental and Physical health and wellbeing within the community. Most of this information will be channeled from the Community Centre.
- 5. The next three steps will follow accordingly. Leisure centre to continue building social skills and etiquette.
- 6. Food centres and restaurants provide the community with healthy organic meals and food from the farmers for personal choice of preparing their own meals.
- 7. Established Educational Centres for all ages- to promote and develop skills and interest for greater empowerment of the community and other communities at large.

As shown in the illustration attached, these are some of the intentions in a summary of my plan to support humanity.

I am sure it will involve much more than the skeleton plan or steps above, but with the help of the Alliances and my Angel, I am ready to put my shoulder to the wheel for the greater good of humanity.

Application for projects for implementation in social welfare centers in the regions of Russia:

1. Academy for the training of teachers of the spiritual and moral formation of family values of various ethnic groups of the world.

2. Family planning center with the latest medical technologies, psychologists, teaching and medical staff.

Additional bonus program to encourage the creation of a family.

3. Center for technical creativity of different ages: preschool, school and adolescent with equipped workshops and personnel with a security system, emergency medical and psychological assistance.

4. Vocational training center for schoolchildren and adolescents with equipped training rooms with panoramic TV and vocational training and support, workshops for practical training in various activities of the society.

Additional bonus program to encourage the development of professions.

5.
