And it has to do with the SKR's. and So Ron, can you talk to us for a moment about the purpose of this alliance program that was presented to you,

let me let me address that. First of all, there needs to be a definition of fkr safekeeping receipts, I alluded to that in the document in that fkr shares are prevalent, they're used extensively in the bond market. Very few of us really get involved in the bond markets. But people have 1000s of, let's say, Zim bonds, and instead of keeping it in their home, they can turn it into a bank, and the bank issued them a safe keeping receipt. Now, that's a little bit different than you know what you'd get from a bank of deposited money. It's a safekeeping receipt, meaning that they're, they're doing this as a service to the holder of the bonds. So that safekeeping receipt can act as if they had the bonds right there with them. If they were to go to a redemption center that probably allow that to take place, simply because we're using the Cabal or excuse me, we're using the Alliance to to get the money for the bonds that we're using. I won't go into that, other than just understand that the SKR is a safe keeping receipt. Our dition to this is through the goodness of everybody's heart, when we opened it up to send things to give to other people or to send to other people. We had some really, really big bonds 100, your Lilian that were given to us. I don't see that there's too many people who can effectively use a 100, yodalillion bond. And as 500,000 the amount of money you'd get is just astronomical. So one of the problems we had with what we received is that to send out what we got is going to be counterproductive in my estimation. So I asked the Alliance if we could divide the larger bonds buy a lower bond. And in our case, it was milillions. The milillions our three hand, 3 million zeros. And we felt that was high enough, big enough so that we could do an awful lot with it. And those who did want to go and buy their own your little users zetalillions or whatever they want to buy could do Show and, and we're not going to get involved or tell them that they can't do that they got to do this No, that's it's everybody's way of doing what they want to do. And they prepare themselves for what they're going to do. And of course, we're encouraging people to ask their heart for the rates that are necessary. And I wanted to just briefly say a word on that. The Cabal's way of working on an economy, they don't want you to use your heart, they want you to use your mind, all of the stuff that we've learned through our schooling is to increase the capacity of the of the mind, they want smart people that don't use their heart. The Alliance wants people to use their hearts instead of their minds. Because the heart will do things in a different way that will be productive for the entirety of mankind, rather than just the individual. So its service to others that is paramount in what is coming. Making money for yourself is not where it's at picking money and helping other people is good. And yet, there can be some greed involved in that. And so if you're using your heart, then greed is not going to be a problem. If you're getting the ideas that, well, I don't want to be greedy to do that, well, you're still thinking with your mind. And don't bring that stuff into the

new economic system that we're creating. So okay, that's just a brief word on them. What is the purpose of this alliance program? There's a major problem that we had in trying to send bonds by mail. And I put two in in a letter form and just said that I don't have a tracking number for it. And then I just assume that the postal system in that country will deliver the as if it was a letter. But that is does not happen. And you go into some of the smaller countries, or the third degree, third, wherever the countries and they have very little postal service, if any at all. And you send something to an address there. And I sent some bombs to a person in in Africa. Well, he had two addresses, he gave me two addresses, I sent it to the first one he gave me. But the reason he gave me the second one is because they're both places for the FedEx as a hub. And he got upset with me, because I send it he didn't, I didn't know what to send it to, I didn't know which I had already sent it to. But he's concerned about that, because he knows that which hub it is. And you know, you got to have that city over there and another one in that city over there. And you're sitting in the middle of it, you got to go to find which one it came in. And because I didn't send it by FedEx is going to be lost in the mail. That was a problem for us to move forward. In the third world countries that do not have postal address, I sent one to one our sweet ladies from that helps Tracy with our videos. And I didn't use a tracking number. There she is going to the place where they have them and they're supposed to go pick up their mail. They said well, you don't have a tracking number. So we don't know if it's you. And they wouldn't give her the bond. There are only a couple of three of them, I think. And so that's that's the problem that we ran up against. Okay. So the way we figured this out, we create a digital fkr that we can send by email. So this young lady over there can have all of the zoom that she wants through this fkr program. And we just email it to her that email you can print it out and take it into your redemption appointment, and they will honor it as if you had the Zim bonds that those SKR represent. I think that that was fantastic. Now, in addition to that there's the lack of money required to send FedEx charges 152 \$200 DHL is saying to send to it cost us \$291 To send the sub Zim to South Africa, when I sent this to the Philippines, it cost us \$180. So those are huge amounts of money. And so we were looking for extra money for that. With the fkr program, there's none of that at all. We just it goes by email. And it's just as valid as if they got the cards themselves, the bonds themselves. So the purpose is, is a convenience, I can send if it's this, the, if it comes out that you're going to have your appointment tomorrow, I can, you can request the fkr. And I sent it to you by email, and you have it, immediately take it into the into the appointment and, and and redeem it. So there's no time factor involved, we don't have to sit around and wait. Now in addition to that, if you have bought Zim from companies, like in Japan or or not Japan and Australia, that takes six to five to six weeks to get here or China. You have you take that receipt, if the Alliant if the redemption appointment comes up, and you haven't got your bonds, yeah, then use your receipt as an SKR. And they will they said that they would honor that. And and that's the same as if you had gotten the SKR for or if you had the bonds. So we're solving so many different problems with this new program. It's it, it's just a marvelous opportunity for us. A problem this many problems are solved with this. And the biggest one is that we get the bonds to the people in in foreign countries. And they can like Africa, this Nigerian, bless his heart, we're going to send you some SKR's. And you'll have all the money in the world that you need to do all of the stuff that you want to do as a humanitarian. It's opened up that for all kinds of people like him, bless your heart. And that's going to be kind of fun for everybody. Okay, let's go to the next one.

Well, let's, let's include that second person question. program is being implemented now because the major problems have surfaced. And we didn't know how to work with it. And so I was told, go ahead and figure out the best way to do it will guide you and your thinking and, and then it was kind of downloaded to me a little bit at a time, took about a week together law. And then we started working with Tracy to figure out how to keep track of the accounting process and a certain amount of automation so that when the request comes in at the SKR is automatically created a cent. And it keeps track of how many people have received SKR and what was on them. So all of that has been taken care of. It was implemented now, obviously, because it had to be for us to move forward. 15,000 people out of 30 have already found love won society. We've got to get to the other 3030 15,000 in order for us to be prepared for the RV to take place. You think they're waiting for that? You think the alliance is waiting for those other 15,000 people? You think we're fully armed as an army of humanitarians without half of our army there. There's a good likelihood that they're going to wait and tell that takes place before the redemption can happen. So we put out earlier finding the people and I don't I don't understand how they under figure it out. But they started sending us the information, I sent them a letter that they could send out. But they sent, they kept sending these people to us, as if we're going to solicit them to join love won society. That was the purpose. If you if you know, if somebody knows you, and they don't know us, they get that letter from us, they'll just disregard. But because there's a relationship with you, they'll read it and maybe move on it. And that's the point. So don't send us the names of people that you want to have as Zim benefactors and love won society. You send them the letter that I created for you to send to them. And then hopefully, that will give them enough information, their website, and so forth, to get involved and find out what's going on with what we're trying to accomplish. And if their hearts are humanitarian, there's a good likelihood it will resonate with them. And they're gonna have a hard time letting it go until they act upon it. So that's the reason. This is what the program, why it's being done now. Because we got to get those other 15,000 Zim benefactors on in line. Did I do both of them?

Most people don't even believe that there's people that are alive in those stars as quickly in the skies, that represent star nations, and maybe planets there within those star nations. But they are there. They're God's children. Many of them are human. We're starting into the golden age of mankind. Are we leaving those people out? If you have some just suggestions that the implementation of our programs, then that can be shared. But don't be trained to teach me things. And by the way, I don't mind people sending me videos and stuff to watch. How many videos can I watch in a day, I have 1000s of them that come through. I spend all my time watching videos, I don't do that. Law one society is my job. And that's what I have full time with. And I don't very seldom get into other things. I go to bed at midnight, I get up by 10 every morning. I can't, I don't sleep very well, so I have to sleep longer hours. So I'm at the job seven days a week. I don't take days off. I'm not saying that for any glory or anything like this. Just don't make it worse by sending a bunch of garbage to me. When I say garbage, it could be very good, could be really good. But this is not the time for me to be implementing that into my life. So please honor that request. So this is why, let's see the program is implemented now. She'll go to the next question.

You have to be part of our email. You have to be getting the emails that we send out, because that's where you're going to get your job form. And it'll come out as often as we feel like it's necessary there's I'm not sure that it might just be a permanent thing for us because let's let's put it this way we have 180 million each million has 3 million zero As each of our Zim benefactors are entitled to 180 of those millions, and they can only come to you by the SKR unless you buy them on your own. So you have to have, you have to be registered on our website, and receiving the emails, if I have one big problem with emails is that they get lost in your spam folders. And you think you've been eliminated from our program. That's not true. The email system is done by a company. They're the ones who email everything out, we just give them the stuff, they send it out. That email list has not changed, unless you unsubscribe or there's new people. And by the way, if you're new, and you're getting emails, videos, and so forth, from back in August, when we first started, that's the way they do it. It's an automation, you got to start from the beginning and go through all of the ones that we have created over that period of time, you'll get other emails, like we get with the job forums, and so forth. Or other specific things that don't go through the automation system. But if you sign up, you're going to start at the automation system. So don't complain to me, because you're getting stuff from September of last year. Why don't I get the new stuff? Well, there's not new stuff all the time, there is some new stuff, some from from time to time, but you're gonna get one video a day, and tell you're up to speed with everybody else. So don't complain and don't write to me. If your email stop and look in your, your spam folder. And then if there's some real problems, then email and I'll send it over to Tracee or Dom sometimes, but and they'll take care of it. emails for me, basically, Tracee does. Now, trying to get into telegram has been a problem with some of the links that we have. And so we're trying to solve those kinds of problems as well. We want you at this telegram program, because this is where we can give our latest and up to date stuff. We'll send it through the emails as well. But this is where we can talk, mouth to mouth, and listen and learn that way. So the reason we are keeping it the Zim or excuse me, the SKR within love won societies is because those who are in humanitarians involved with love won society, are going to be the only ones who would even think of asking the higher rates. You go through all of the gurus and see what they're telling their people ask. And they say if you have a 100 t now you're gonna get \$11 million. B Yes. Well, I shouldn't say that. I say well, that's what's that's what those people are trying, or we're will read expect. They'll expect the level and so they get a buy a whole bunch more. And then they Oh, well, you can't do that you can only have 10. If you have more than 10 Give it away. The only people who are asking for the higher rates are those who become involved with love won in society, because they have no idea that there's high rates for a \$100 trillion note. A trillion dollars. There's 100 of those in a \$100 trillion. And they're only getting \$11 for it. Do you think those people are part of the Alliance? No way. The Alliance wants us to have all the money we can get now. And the quantum financial system there's enough gold in storage to accommodate enough golden gold certificate digital gold gold certificates to cover the entire universe. So I asked one time I got a yo Lilia and they said I'd like to ask a million dollars for that. Is there enough gold to do that? You kind of hear a little giggle all that you want because they got the gold to do it. Now the gold search difficult, the digital gold certificates. So there's still more that I can activate or put in that list and they can be activated and they become Spkr. Right now, we're only using 30,000 3000. Zoom. So we'll take a look at that when there's a problem. But I want everybody to understand you're using those them for you go through and you redeemed them at the rate that you're redeeming all of your other Zim bonds, and SKR's. And then you go activate all those these others and they can be put into an account. That is not part of the structured payout system. If anybody really wants to understand and understands the structured payout system, the money for the entire 100 gears for you to get those 100 or that 55 quintillion is put into that account. In the beginning, when you leave that office, there's 500 quintillion put into the structured payout account in your name. And the quantum financial system the Alliance administers that sends you out five quintillion a year for 500 years, the money is already there. Well, first of all, it comes from the email, and it will have a pitch a jot form. Why don't we use jot form, you write your name and address and all the information down there. The jot form will distribute it, you send it in, and it will send the information to the spreadsheet. The spreadsheet is where you, it'll take down all of the information you ever asked, how many zim bonds you've asked for. And by the way, the 100 quintillion is just an upgrade. People are looking at the 100 quintillion, one excuse be the 100 keynote as the basis or minimum they're the kind of afford or have that think that that's going to be fine. And yes, it'll be fine. And go ahead and redeem it. We're not substituting one for another. But the 100 quintillion is part of the fkr request form. If we're not getting rid of them fast enough, then we will open the the the forum to be able to do more than five and not go to 10 we'll see we have to manage it and be sure that we're not taking everything now where some of the people from the last 15,000 are going to be left not getting their full 100. Well, the same thing is going to happen for the SKR request form. It will be populated on the spreadsheet and automatically sent a send a request SKR for you with the information that you put on that that form. And so what we're trying to do is making this easy to do so there's not so much work involved. The the work really is behind the scenes where we have to keep track of how many millennials we have and how many, what we what we need 54 million of those. So we have to keep track of that. I said, Well, why do we

have to keep track of that? There's so many, we'll never run out of them. And I was told it's the right way to do things. Keep an accounting. Okay? We don't so we figured out, I didn't know how to do it. But Tracee and her assistant did. That's where it is. We'll probably be sending those out today. That's what happens after the fill out form. Well, I told you that,

So I throw that in there as well but the reality is is that the milillion is the one that you want to get, because you got 180 of those. And here's another thing when you go to your appointment if you have 180 and you have a bunch of other bonds you in some of these larger bonds are not going to be going through the structured payout program. So you talk to your counselor at your

appointment, and, and discuss what you want to do with those, how much you want to put in there and how much you want to spend for your own humanitarian activities. That's, that's going to be a really important decision to make. Some people are going to want to take keep it low, those who don't really understand what's going on in the future, but I'm using their mind. But I say go for the gold, go for the highest that you can get. Talk about the rate that you want, two or 3 milillion. For a Yodalillian is just astronomical. But you're entitled to ask. And it's going to be helpful if you have it in your mind, and then discuss it with her, your counselor who will give you some good ideas. They're not going to try and restrict it.

It's a very valuable piece of paper for you. I would print it personally I will print it and

then use that that printed thing and I will put it I'll put it in a safe keeping with my other Zim bonds that I have already gone. And then when you go to your appointment, you take it all with you. And that fkr count will be redeemed as if it was the bomb that was represented on there. The bonds and so there you go. You've got the request that's processed and they send you back the SKR take the SKR and take it into your appointment and redeem it as if it's bond.

And so we did a testing of the job form where we filled out the form and sent it it came back as a follow up email that we listing the amount that we requested. And then a similar email came out a day later or so maybe that that evening time stating that we have the SKR So is that kind of the process that you see as well.

If you're having problems with the emails, register again. Okay, just simply register again, the system will start you on, you're the first one that we did back in August of last year. And and then one per day until they're all sent down as there's over 100. So that's, that's the that if you're having problems talk to us, if you're having some problem, it's not getting the job for let's, let's send it in. And let's, let's solve that problem fairly quickly. And because you're starting with the the videos from last August, and you may not be getting the zip, you're gonna get what was sent out in August. And you may not be getting the Jot form to fill out for the SKR's. And we want to be sure that you can do that. And so that can be a separate email. And maybe Tracee will keep a list of those. I'm not sure how she wants to do that. But I see that as a problem, I can see it as a potential problem that needs to be resolved. And we'll, we'll resolve it.
