Yeah, here's here's what's what's happening with him. We haven't, we haven't got it set up yet, but I'm, I'm letting this information out. If you don't have Zim they purchased him two or three weeks away from getting here and the RV to place, I am saying to myself, I'm saying, Okay, first of all, there will be a request. The request means that this is what I would like. And it'll be on a job form that we mail out there, just fill that out and and tell us what you'd like. And then we will send it to you. email, send it right back to you as quickly as we can do things we're going to have to set up for that too. And we also you need to be there certain qualifications you need to be in love won societies program. And to have a registered and have an email that is registered with love won society, on the on the QFS 2020, saying, so we have a certain way of taking care of, of our people. But the point is, is that it is done through the email, not through the postal system. And I don't care if you've ordered a whole bunch of zim, or zim 100 notes or, or some of the hires, I don't really care, what was donated to us, we cannot use up with this present program. We've done all of the figures on it. And so we're at the million stage, which is 3 million zeros. That's our highest. And you can get five or 10 Oh, you can get a bunch of them if you want. So those who do have some of the larger bonds, this is in addition to that. So if you're having problems in Africa, getting a delivery of your zip, if you've got a phone and it's on the internet, we'll just email it to or send it to you. And the alliance will accept that as if you have the card. The cards over here in my files, I send you the SKR and they're accepting that because they know that there's no dishonesty involved in this. And I said, Well, there's so much that we've got to do I have to keep track of? Absolutely, you have to account for everything. So that we know that you know that it's all safe and secure. And then it works. So the way that it's going to work out for everybody is we're going to, I would like everybody to request to have at least a 100 quintillion. And that gives them that's what the Alliance wants us to move up to. And then going from there further on up is dependent upon your heart. So that's where it's going to work at the request amount and the email request will come out in the email and you will fill out. That's the only place to request. So the job form has information on it, it will go into the spreadsheet without us having to enter all the information. And then we'll go from there. That's what we're trying to set up now. You'll get everything on the academy.

SKR stands for safe keeping receipts. Now, it's used, there's a sting operation a couple of years ago. And Charlie Ward was saying that, send in your make appointments with the Alliance over in Hong Kong or wherever. And take your Zim there, and they will give you SK ours. So you take your huge amounts of Zim bonds over to Hong Kong. And in one or two airplanes. That's how greedy these people were. And then you turn them in and you what is your request? Well, I'm asking for five cents present. And held that's how they established the concept of the SKR safe keeping receipts. Now we're changing different. We're changing it around where I have the Zim and I'm sending you the receipt. And the alliance will let you go back and redeem then we'll let you go and take that to your appointment and redeem it for you. This is this is one of the most monumental things that the alliance has done. You know, to me, it's as important as any one of the five programs that we have for love won society. Because anybody in the world, if they're on the internet can get and ask they go sign up and you know, it has to be qualified, that anywhere in the world can can get the gym and your friend, hey, he's getting the emails, then that's coming and he's registered and love won society on the homepage of the QFS2020 website. That's all it will take. The the request form will be a jot form that will be sent out through the email, the emails that we're sending out, everybody. We've got over 15,000 people now. Yeah, it's kind of fun. But we're still looking for another 100 or 15,000. So we're about halfway from what I've heard, are the the number of people who have callings to become humanitarians and receive their funds. So we've got a long ways to go and we're going to get to everybody. We're doing all that we can do. And so this is one of the major things because we don't have to wait for the zoom to be here. Going through the Postal Service, and then the Postal Service I sent lady over in the Philippines. And I just sent it in a letter of A to Z, and we're in the letter. And they said, Well, we can deliver it to you because you don't have a tracking number. Well, I just sent it as a letter, why can't you just give it to her? No, you got to have a tracking number. We're not giving it to her. I said, well send it back, they won't send it back. They have no integrity. So that's typical of many postal services for larger for some third world type companies, or countries. And we're, we're going around all of that, and it doesn't cost them anything, doesn't cost you anything for the zim. It doesn't cost you anything to get it sent to you. And that was a major thing that I was facing, because we're looking at FedEx or DHL, and it costs 150 to \$200, to send to the Philippines, and they can't send it again, because they don't have the \$150 that FedEx or DHL requires over there to travel around. So, you know, I may not cost that much. But that means that those persons who I sent 100 to and they were going to send that to other people, they can't afford to do it.

redemption, and we are starting our CAC, before the building is up and running, what I would like to do if it's permitted. And I know I'm the sovereign, but there are some kinds of kinds of rules that we need to adhere to, I understand that. So my question is, would it be okay to put my revenue sharing solutions, invitation card, in a private message to my personal contacts, about 100 of them, and send that to them so that we can get this started out into the community. And then from there, they would be asked to delete the email after they sign up, so that they're no longer using my card, they would use their own, and that would be explained in the email.

I have not really given that information to them. But I'm sure that they've got some ideas and as they share them with me, then we can say yes as this, do that, and then it'll be done. But the RSS program is designed for families, the family is the most important structure in the world. And if we do a good job with what we're doing, we're supporting that family unit. And that unit with the love is the way that the next generation will be born. And if we can do a good job and be sure that they have the funds that are necessary to have a life, then we've we've really done our best. And I look towards that next generation, having their DNA structures changed, and repaired. And we get ours changed and repaired and are able to help them to grow those children to grow and develop. greater things that I've done, shall you do, and that's where these people are coming from. I just want to make sure that our beneficiaries get to use all the funds that they have.

The trust document itself determines what the trustee can do with the funds for the beneficiary. And if you don't have a specific, you know, you can call it your travel trust. And that means that the money is going to go for traveling. But who is going to be checking that out. This if you go for travel and you get a flat tire, then you can pay for your flat tire to get fixed. If you're going on a trip and you have an accident, then pay for these these, you know whatever. It doesn't even have to be associated with the trustee because the trustee has the ability and and purchase put into the trustee has the ability to use his discretion as best discretion on the use of the funds. Just as so simple, something like that. And it couldn't be just

trust one trust to her Bob's trust, one trust to Bob's trust. It's just so simple to do. And again, if you set it up, then the only people who will have a chance to respond to that if there is any response needed would be the alliance. And I really don't think that they care. And as long as you don't set it up to where you can you're trying to do things that you haven't set it up to do, then then there's some integrity involved in that and you don't want to break your integrity. So set that up properly in the beginning so that you can you know, just says a little phrase like the, the trustee is authorized to use his best discretion on the use of the font. And then growing up, children growing up, you want to give them their braces and all that sort of stuff. I don't know if they need that. So let's put it this way. Lillian is M I L L I O N, millillion, it's 3 million zeros. And the number of millions that we have, are in the millions available for people to use. And I'm saying I don't want any of that still left when the redemption comes. And we go in and redo, redeem. And I've got all of these milillions and millions of milillions that I have no idea what to do with. I've got sufficient for my needs. But people have donated these, and let's get them out there. So there's no limit to the amount of zoom that you take with you to and, and 500 to 1000 or a million. I don't know, whatever your heart tells you. As far as our rate is concerned. I just know that the Alliance wants us extremely more wealthy than we think we can have. Because there's nobody else to have it. There's only a certain amount of Zim the humanitarians who have a calling from God to get this money. And I think it's somewhere
