So we're going to start with level one society programs start with the RSS program, a financial flow of money to as many people as can be signed up, a sharing of wealth is a system created in the QFS making it available to all?

R Ron Giles 05:29

Okay, there's pretty self explanatory. The RSS program is our way of getting money back to people. We assumed benefactors go through the redemption appointments. And we get the we take our resume and we ask for a certain rate. And then that rate is given to us if we're humanitarian. And that makes it so that we now have the funds that will pay for the RSS program. So the downloads of that program, the beneficiary program, let's call it that the beneficiary program will be you start at one with one person as in benefactor, you start, you know, my one family member or something like that, it doesn't matter, then that person signs up, they now having an ID number, and they can go and refer other people. And in referring other people, they get a \$50, signup fee of \$50, thank you bonus should say. And if you get two of them, then you get another penny for your download a penny per on the download is \$100 a week, \$400 a month. So it can be substantial for you to do that. But you want to share anyway, we're just giving you a little bit more incentive to do it. And some people will make a job out of it. And it's okay. It doesn't matter for each individual, it's the number of people that sign up, that's important, because that's getting the funds out into the society, into the communities that we want to support. So it's going to be fairly easy to do, by here, a lot of well, we're going to approach this and we're going to do this and we're going to spend a lot of time, just you go set up your community assistance programs, that's where your humanitarian work is done on local basis, that people will refer and get people you might start out in California. And in a two or three or four or five days, it may be and you got others people in Arkansas, another person

over and in Texas, and then another one in North Dakota, just where people refer people to so you have as a Muslim benefactor, you have no and I kind of giggle about this. We have, it's, there's no control. So throw out the word control because you have no control over how that's going to grow and where it's going to grow. And it's designed that way so that you don't have to manage it, you don't have to do anything to it. It will just happen and grow by itself. So it's a financial flow of money into as many people as can sign up. Is there a limit to an individual? No, there's no limit. You can refer hundreds, perhaps 1000s of people as you go through and you might be one of those who go and get involved with the churches and and have the sign up the minister and he signs up all of his people and then you get overrides through the generation bonuses so there's a lot of things that you can do. Okay, start your project as an LWS member with the RSS. Are we talking to the gym benefactor here or just a member you become a member by starting the the RSS program, we call it member you've said you've called it a member but they're a beneficiary. And we as benefactors just have to get one person referred and then they can start referring other people. So we start are the beneficiaries. The people in the world become members of the RSS program as beneficiaries. And that's available for seven and a half billion people, whatever. It doesn't matter to us because we can fund it. There's no problem with it. It's a horrendous amount of money. But yes, we'll have all will have more than the horrendous amount of money Need to do so. And we'll get to do our other programs as well. It's a system created in the qf s, making it available to all the QFS is the one that will have your accounts. And, and it is there's no limit to the number of councillors who can have an account, everybody in the world will have a QFS account eventually. And that's not going to be a problem and getting it started. So but this is what secure fest is in place, a quantum financial system is in place, it's a financial system for the whole world. It is private. When I say it's private, you have complete anonymity. If that's what you want, nobody's gonna know your finances, in the quantum financial, nobody's gonna know how much money you have. There's nobody, there's going to be getting in there to collect income tax on all of that garbage, because all of that goes away. And so when we get involved with the IRS program, you set up your account in the quantum financial system. And then you can ask for certain amount of money to be downloaded into your account, which goes into your account in the quantum financial system. And there's, there's more things to this. I'm just kind of talking a little bit, but let's go on with the next one. And we'll see where we go.

wondering, and let's just say in the process that the RSS takes a period of time to get set up, that during that interim period, if someone were to contact or they would make contact with an individual that needed money immediately, how would we implement that process before the RSS or even afterwards, when we have a CAC? How would that be implemented? If a person just needed a loan temporarily, till we got the RSS set up?

Okay, the quantum financial system has the ability to download into a bank account. You were in charge of your account in the quantum financial system. So you've got this huge amount of money that you got from the redemption? What can you do with that? Well, you can download it to a person in their private in their personal purpose. It's like a wire transfer, although you do it yourself, you just download the money to them that how much they need. It's not going to be a problem for us to do that sort of thing. And it doesn't, it doesn't take the RSS program to be functioning to do that, as long as the quantum financial system is up and running, which it will be before we even get the money so that we can have our money put in the quantum financial system at the time of the redemption. And our first tranche from the structured payout program, the first tranche, the first payment will be given at the appointment. So if you've got a 100 T note, and you asked for \$500,000 You're gonna have 1.25 quintillion dollars walking out of your appointment. And from there if you have more gym and you ask for higher rates, then it's all gonna be the first time you're gonna get it's what you get will come that the appointment so you'll have money to loan to people or to give to people, whatever you'd like to do. Now this is this is a new way of being. And it's going to take a little bit of time and we're going to have a tendency to want to get our money out and there can be a certain amount of ego involved in this where I want people to love me and I'm going to give them money. This is this is not what this money is for is to it's not there to pad your ego. So you have to be wise. I don't like being like a banker, but you have to kind of look at things. Assess the situation. How much is it that you're going to try and give them? Well, remember that \$100 is still a lot of money, it to some people, that \$1,000 is more money. And that's, you know, but if you've got quintillions, that's not \$1,000 is not going to be anything to you, you won't, it's not even a drop in your bucket. So be wise in how you do that. And I, I caution that because we want to help as many people we can. And we think that money is the best way to do that. And oftentimes, if we are not wise in the use of or spreading of our money, then you're going to become you're going to have people becoming dependent upon you for I didn't do things ever the way that I should have done this man. So I'd need to go get money from dad. That's not what the kind of you don't want to create co dependencies with with your money. So Can that be a problem? Yes, it can be a problem, do we think it's going to be a real big problem, I don't know. Each individual is going to have money that they've never had before. What they do with it is going to show their colors, and the way that they think and the way that they feel. And the structure with love won, society provides all of that for you. And it's really safe and secure for you to just get involved with that. And use that structure for your work. If you were to get cut from your appointment, do you come out with all your money? And you wanted to give grandma on it, pay off her loan? Want to do this? You want to do that? Just read a pasture. You're the person who's going to be helping you with your stuff. Your counselor forgot the word, the counselor just ran it past them saying, Are there circumstances that I'm not aware of with this particular individual that bear on me giving them money? What do you go? What do you mean by that? Well, are they? Is this going to cause some problems? I can't see the problems from here. Yeah, it feels like you're looking at things the right way. So go ahead and do it. That's what you'd like to do. And see, when you get involved with these kinds of people, as in those who they're going to be

flesh and blood. They're not going to be angels with wings, and all that sort of stuff, we don't really know how that's going to work out. Because they have no restrictions on their lives, like we have. So they're going to be there available to you, how you work out your relationship with that person is going to be very, very good. And you go in there with something and they're going to ask you a little bit about what you're trying to do. They want you to talk the way that this works for me with with the Alliance person that I discussed with? What do you feel about this? I say, Well, is this a good purchase? He says, What is your idea? What is your what do you feel? What do you see inside feeling inside see out there, that's you're going to be determined to be a good person or a bad person. They get you to talk about it. I've never once had anybody from my directions from the Alliance or person for the counselor from the Alliance tells me that there's a bad person. They won't do that. Because that's judgment. They're not going to get into judgment. But they're going to say something like, Well, I like the way you're thinking. I think you're wise in your move. And then you make up your mind from that. It's very subtle. I think you're thinking I think dancers, I think that you've thought this thing through and you can see that you're feeling some certain things or some reservations about this person. Okay, we'll honor your feelings. Those are the kinds of directions that are going to give be given to us and you'll get used to it. And you'll love it the way that that works out because you are the one that is making the decision. Is that a good person or a bad person? But they're not going to tell you that they're going to ask you what do you feel? Well, I like her thinking I think has good i Gone to somebody that I've sworn up and down about. I mean, just chewed him out royally. I said, Well, I was that wrong to do that? Well, how do you feel about it? Well, I don't like getting that angry. Well, we can see that that deteriorates your or lessens your vibration. Yes. Was it appropriate? Well, I felt like it was appropriate. Okay, well, I like your thinking, even though I use some really bad words. Question there, their heritage and stuff like that. So they're going to counsel with you. And that's the way they'll do it. Okay, some good some good questions here. As far as when, if I were to give you that information, I would not be speaking for the Alliance nor be speaking information giving out the information that is from the alliance. The Alliance does not give out dates. Anybody that gives out dates is not talking for the Alliance and probably isn't talking with the Alliance. If they give a date, now this is a this is a catch all if they give a date. It's either military deception, it's a sting operation, whatever. But that day means that the alliance is not involved in it. And so if you want to believe military operations or sting operations and things of this nature, then go ahead and believe it's true but it's not because it came from somebody that didn't know or they got the information from the alliance was no it's only a sting operation and you're passing around as true or you're passing around as appropriate. So number one, the Alliance does not

tell date Do I have any clue about when that's going to happen? I have my own feelings about things but the program will be ready when their redemption takes place. Your past everything all of the things that have to take place in the queue if's Global Currency Reset all currencies have to be par value with one another has that started you go Rosetta telling me that the qf s is already up and running as they gone have we gone through the Global Currency Reset? Is a is \$1 the same as a peso go try go down to Mexico and take the dollar how many patients you can you can Aloma Look for that little lot of pesos for that dollar is that currency on par value with one another? No, is the quantum financial system up and running? No, we haven't gone through the Global Currency Reset. Without a Global Currency Reset, it's not going to happen. And there's a bunch of other things, the price of gold has to be put into the quantum financial system, and it is married to a particular amount of money, so that they know that kilo of gold over there, that hidden not hidden, it's in the library system accounting system, so you can go and find out where it is, it has a certain amount of value to it, that value is set in time and then from then on, that value remains. So kilo might be \$3,000 worth of value in terms of the number of pieces of currency that it will, that it will back. And it has to be that way. And once it's done, and that's a different thing, too. So that's kind of happened to so as long as they've got price of gold is fluctuating and we offer the market, but it won't for the quantum financial system, and the gold that's in there. So those are just some little tidbits to go along with now in agreement or view the wealth management series videos before, I think that it's important, the wealth management system. Does the lion's think that's really good. Absolutely. We're not allowed to launch a revenue sharing solution. Till we have a the ability to put videos in the private office or the personal office of each beneficiary has to be there. I've always thought there was going to be eight but it looks like they want first and second loan combined. And then there's there's going to be 10 total. I don't know what they are yet have been given that information. So the wealth management series is given to us so that new people who have not had a lot of money, do not go crazy. There's some wisdom in the in the series as Kevin, it's given per every person who receives money through the revenue sharing solutions. Okay. So I highly recommend that there's more to come. And I'll be it'll come before we actually launch. Okay, agreement between LWS and each managing director. That contract we're trying to arrange for some funds so that we can begin that contract. The problem is finding a lawyer, not an attorney, bar attorney is not what we're looking for. We're going into common law. So the contract that you have will be valid within the new system in a way that all of the garbage that's involved in legalizing things like, like, you use this word, because that means something different in the legal system than it does to normal conversations. We're not having that crap. It'll say what it's supposed to say. And you'll be able to understand it without having an attorney there. You're welcome to do whatever you want to do. But it will be it won't have all of the legalese garbage that is oftentimes associated with contracts. We're finding the right people to do that. And that contract, hopefully will be in place so that I can send it out to everybody. Because I want you as as in benefactor to see what you're going to sign to become a zim benefactor or managing director in love won society, in the revenue sharing programs, and so forth, I want that. I want you to read it, digest it, understand it. Have questions about it that you can ask at your appointment. It's not going to be a surprise for you. I don't like those kinds of surprises. This is a life changing event with this contract for you You. So there may be those people who have pretended that they're humanitarians. And they'll see that contract. I don't care. Maybe I'll change my thoughts on that as we get into it. But I don't I want people, our people to know what they're signing before they sign it. I want them to know that they're going to be referred by the Alliance agent. Because they are a UN humanitarian, and they have sufficient funds to be able to do to be a managing director, Zoom benefactor, in the RSS programs and and the love won society's programs. So I don't have to ask anybody, and I don't have to take their word for it, or somebody that will judge them appropriately, perfectly appropriately. So that agreement will be forthcoming. There are, you know, in these kinds of



things, maybe the basics is, what is your responsibility and what is love won society, love won society is to basically keep the RSS platform up and running, and effectively take care of things. So there's a problem. Now, along with just having said that, please understand. And this kind of goes with before we were talking about how much time is contained. The Quantum financial system was created by God consciousness level one society was also created by that same God consciousness. Just because it came from me doesn't have, it's going to be used in third dimension, so it has to come through me. It's inappropriate. The Alliance has, there are those of the Alliance who are non physical, non physical means that there's no space or time where they live. So they can be over there doing the love won Society programs, and doing everything and all getting it up in shape and everything, and then all of a sudden, pass it through to the third dimension, and here it is, in all of its glory. And then I say to them, I can't do all that without the the contract being signed. Thus, we have to get the contracts, and all that ready to go so that that all takes place. In a very, we can have the RSS program in a week. We could have within two or three days. And it's just a matter of getting the the signing of the contracts, the referrals for the contract, and for referrals for the individuals who are going to be exempt benefactors. Or excuse me, Jim, Yeah, same benefactors, and Jean directors. All of that has to take place in a very short period of time. I'm telling them. I can sound like I'm a little bit bossy that's about this. I'm telling them what I want. And let's do it appropriately. And it's still a long time in a timely fashion so that we don't have to sit around and wait. We can start in on the program fairly fast. That contract is key as far as timing is concerned. Okay, well, let's start with the first one. will it grow on its own hard to control, I've already stated that it will grow naturally on its own as people share one with another. And in private conversations, there could be 1000s and millions of them at the same time, they're talking about signing up for love won society or the revenue sharing solutions program. As a beneficiary, it's going to go so fast, there's no way for us to even control it or even know what's going on unless you have a part of the platform and see what's happening. Very few people, if any, that I'm aware of on this earth will have that opportunity. Okay, so it's gonna grow on its own, it's gonna be hard to control absolutely can't control. It's not hard, you can't control. So will need to have a large rate of Zim at redemption to fulfill to fully fund the RSS program. It's an interesting question. If I have a 100, t note, and I asked for \$500,000, which I suggest as your minimum, you're gonna get 1.25 quintillion. At that level, you will be able to fund all of the revenue sharing solutions, programs that you want to get involved with, you'll have all of the money you need to do that. There won't be a problem. Now let's say we get the 30,000 people who are managing directors, zim benefactors. How many are you going to have as part of your RSS as beneficiaries in your RSS chain of people? It's not going to be in the billions could be in the billions? I don't know. We'll see. Or you'll see but maybe you won't. It'll just happen in there it is. So you go in with what you have. Now, if you have more Zim. Let's say you get into the yoga Lilian. And by the way, the yodalillion is a 300 sextillion zeros. We have no idea what that means. I don't. And I've been studying this for a long time. Let's just say the My relion has 30,000 zeros behind it. Now if I have 30,000 zeros behind it, and I go in with a \$500,000 presume, and that's the rate that I want. I haven't done the math for that. But I'll tell you it's really, really, really, really big. Now, what do I say about zeros? zeros are opportunities to do things. The more zeroes you have with your funds, the greater opportunity, you will have to be a humanitarian that's fulfilling your responsibilities, responsibilities, you're fulfilling your potential as a humanitarian. So you have the the zim, and you have the rate. If you don't have enough zoom, then get more, then raise your rate. You want it to be in the quintillions. That's all I'm asking. or higher. And \$500,000 with a 100 quintillion, excuse me 100 trillion, you're going to be good for most anything, you won't be the one that they come down and talk to the alliance comes down and says we need some more money. Those who for the people who have the yodalillion and ask for a million dollars present. But there's that's going to happen. And there are people that will be prepared to do that. All of us are, each of us is an individual, and that is honored. And we're going to have opportunities to serve. And if we start saying Alliance, I'm here if there's anything that you need from me, I'm willing to assist. As long as it makes

sense to me. Tell I'm the boss of my money. So if it doesn't make sense to me, then you know, the answer is no, you know, smarty pants, your work with the Alliance in a very loving way, because that's who they are. And if there's something that they're not going to come down to you unless you've given them permission. Did everybody hear that they're not going to come down to you and ask if you want to participate in something unless you have given them by permission, the opportunity to come down and talk to you. So I say I'm giving you the whoever is involved in the in projects, I would like to be involved with them and I give you permission to come in contact me if there's something that I can do. That has not come across my understanding yet as a possibility for me as he humanitarian. I'm available. Okay, we got one over here that just gave us permission, and they'll write that down. And there you go. You'll have opportunities to serve your RSS program with to fully fund the RSS program will offer the individual and contract downloads for each beneficiary. Contracts maybe or employment contracts, maybe they'll begin their RSS program, their beneficiary program can have their six trust, they can go out and bring other new people in, and they their bonuses are there and they can work as best they want to do. If you don't want to work, there is no requirement for you to work and get an employment contract. But I asked you if you're gonna sit back and watch the whole world all working together. And you think you're just over here just earning all this money and I don't have to participate with working or doing something from my uniqueness as a person. Uniqueness meaning I have interest in. I don't want to I don't want to be pushing a pan for somebody, I want to be out doing something physical, I want to start a dance studio. That's your uniqueness. And it's everybody working their uniqueness and contribution to each community that things work out really good. But if there's those who will just sit back and let other people do everything, and think that they're gonna get away with that they're going to have some serious problems in their growth and their development. Did a problem for somebody else? No, it's not, we're missing out on their uniqueness, yes, as a community. But you're the one that's going to have problems. And the sooner we can get that idea out there, the better people will be when they start getting money and want to do things with it. Find your labor, find your contribution to society. And it might be as a contracted employment contract. I think that's okay. As long as you're happy and doing what you'd like to do, if you're not, then don't sign the contract, find something that you want to create yourself. Everything will work just perfectly, because there's so many of us. And if we're all working towards the oneness of a community that functions in harmony with each other, we're gonna have problems, like the way my neighbor cuts his lawn. It's none of my damn business. And if I start saying something about it, then I'm wrong. So we're going to learn how to honor other people and honor and respect their dominion their domain, their kingdom, or queendom, we're going to learn how to do that. Or we're going to really suffer greatly. And we want to be a contributor to the hole. That's what we are creating that has never been available for us before. They don't want us to contribute. They didn't want us they wanted this slaves to boss around. And, you know, somebody wanted does not have the education, to create businesses of our own, just educate people. So they'll work for somebody else. That way we can control them. It's in their literature, people who haven't read it, don't worry about it just don't. Don't be resistance to the reality that they did make those kinds of things. And they did, created an education system that's designed for us to be slaves. You don't have to read the literature to know that just listen and see what's taking place and observe. If you think you need to go back and read all of their literature, it'll take you a long time to do that. But then you'll have a greater understanding of the disgusting things that they have done to humanity or to us as a human race. We're getting rid of all of that. And we're coming into some things that are really going to be a lot of fun. Okay, let's go to the next one.

The other thing that's floated around is this question of advertising the RSS, and we don't actually have it in here. But this is a good place to ask you to spend a little minutes explaining to us what you mean by no advertising, because that has been a point of confusion for a lot of people.

We take that from the network, marketing them and marketing. They all have laws against public advertising for their products. And the reason for that is because of their products. You're you're getting people all if you have the money, and you can organize and advertise and you're gonna get the lion's share of what's there. That's inappropriate, you're greedy. Why would you want to do that? Why won't my money? Well, you get it by referring people to talking to people, you and you tell people about what you're selling, that's the idea of No, have no advertising. Okay, we're not going to advertise, because who do you have as a referral, and the ID number up there, you can put that up there, too. Those are those private stuff. I guess there's no real damage that can happen to you as if you did that. But we're saying don't do that. Don't go out and advertise. If you work out some kind of a card, like we've got, we can talk about the cards and a little bit because it's in here, we'll talk about cards and how to use

the cards for the right purpose, then there's no problem with that, because you have to give them out. And giving them out is not advertised. And the card itself refers them to the revenue sharing dot solutions. They can go there and we have a place for the guests, they can go in and look around and there's some videos, it'll be up there. And they'll show how the program is working and, and take photocopies or video of the actual downloading of the 10s hands per minute and, and you know and how much was done in an hour. And it's still going and then the next day is going to be \$144 from the from the moment that you started to 10 cents per minute. So in 24 hours, you're going to get \$144. And we can put that in videos. That that's that's the prime thing for that. Love won society is a private organization, and you have to have a referral from somebody in the organization to be available to get into it. To get into it to pay your \$10 Was it \$10 By you buys your account in the quantum, excuse me enter revenue sharing solutions platform that \$10 is not paid. You don't get one, you don't get one. Now I'm saying to people don't be out there paying \$10 for everybody that you want to sign up because you can get 50. So every one you sign up, you can get five more. What the \$10 is really for is the individual says I have paid the \$10 This is my account. The money that comes into my account is mine. I own it. I'm deserving of it because I paid all of the prices that were necessary to get that account. So you can't come in tell me that it's just a doll or free from the government or something like this. No, it's not. It's yours. You pay the \$10. There it is. It's yours. Nobody can take that away from you. There's a psychology involved in that. Because when they go to spend that money and they think it was given to them inappropriately. They're still going to take The money and use it but it will not have the same energy to it is the appropriate energy that brings joy and happiness. And if they don't believe it's theirs, and it's somebody else's and I can't do anything more than say pay the \$10 I can't do anything more than that to get them to do to have the highest value of what's coming from this money. Okay, so that's
