I have a question about that. When we go to an employer, how much power does the employer have in designing what their employee is going to get? If it really is the Benefactor that sets the rates?

Well, I don't believe it's a benefactor that sets the rates on these things. The Benefactor may have a, you know, between this amount and that amount, but I wouldn't do that I would, as a benefactor. I want to delegate that responsibility to the person that's out there represented me.

I believe, I think that's the appropriate way to put it? Yes.

And then so how did the directors and the employers work together to create the contract? Or does the employer simply have to agree to the contract that the director presents to them?

Well, that's an interesting question. I don't think that if we create a contract appropriately, it's always going to be of benefit, or the greater benefit will be to the employer. As well as the employee, shall, we're not going to go in and dictate something that goes against what the employer wants, as far as a contract is concerned. That's why you discuss things and not, we're not there to dictate to the employer what he's going to do and how the pay is people. That's his determination. And so we want that person to continue to serve as a community. So we're not going to go in there with a heavy hand because we have the money and tell him what to do. That's inappropriate, that's over. That's crossing over dominions. And we get into that kind of stuff, crossing over dominions, and we have some problems with the Alliance. Because that's, that is not tolerated. So we don't dictate to these people we negotiate, we talk about it, let's come to the right conclusion. Is there a right conclusion? Yes, there is, let's talk about it, let's find where the common ground is. And if we understand that, the contract might have, you know, you've got it on the computer. And you've got elements of the contract ABCD, and all the way down, and they may not all fit into the contract. So we go by paragraph, well, let's include this this include that. What do you think about this? What do you think about that? Would you like this for your employees? Those are the kinds of things that you negotiate your work out with the director working out with a business owner. When we get into the ESS, then there will be different sets of circumstances where the lawyers get involved in creating these contracts, because some of them are going to be very different from another one. Especially when we get from one industry to another. They're all going to be could be different, but the same idea as far as US buying what they produce and how to do it, and how to determine all of that sort of thing. And how we're going to do the bond accounts and you want it in an escrow and you want to, you can in some of these larger ones, and I've said this before, if you're doing a contract with let's say, Ford Motor Company, and they're building 800,000 a year, and there may be spending \$160 billion to do that, and you buying all that upfront. Well, that's that's that's a game changer for that country company. And So they have to have the ability to, say the ability, that the credibility has to be established that they want to be a part of that. And so it's

our job to do things in a way that they feel comfortable, it's a tremendous opportunity for them, because they have guaranteed money every year, guaranteed income every year, and the amount of cars that they we might, we might need them to build 1000 cars instead of 800. Because we have a way of, because on the other end of things, we want to get rid of five year old cars, and junk them out. So you trade those in for new cars, well, that means that people are going to be driving around in newer model cars, rather than the old ones that are polluting or not as safe as others. So there's a whole bunch of things that will come into play as we negotiate with the larger corporations. But there's, there's things in the elements of a contract with the business owner, perhaps I haven't thought it through yet. But we all have the people that'll do their thinking through and be sure that it's what we presented is going to be acceptable and, and benefit and value to those that we want to contract with. Our underlying thing is we want business to continue.

And also, another large group will be completely illiterate people who will not be able to even handle a computer platform or software like the RSS platform. So it will mean that the CAC director will have to literally hold them by the hand to put them through the platform. I know, once they set up the accounts, they go back home, does that mean they have to come back to the CAC center anytime they

want to download their money into their bank accounts? Or can it be set up in such a way that it will just be downloaded directly into their bank accounts, especially considering the literacy levels here in Africa? Thank you.

I feel like I understand what you're saying. What you've got is a situation where it computer computer literate is is a problem. So but the point is, once you've signed up once you've registered, you don't have to go anywhere unless you don't have access to your account, through a computer through your phone. And my understanding is that we're going to all get new phones, that will make it really easy to get into the quantum financial system. So the RSS program is in the quantum network, the new quantum networks, so you're going to be able to have access to that. Now there's a transition where they may have some problems. But the most important thing that you can do is hire your directors. And help them to understand that it is in their best interest to have to help train these people to be able to function within that environment, so that they can get in and know where they can push this button to get my money into my account. The Alliance has said that they will help us to embed in our, our RSS platform, the the stuff, the applications, whatever you want to call it, you go into that and you click on and you can establish your own account and the quantum financial system. It's not a big deal. You just have to click on that and you'll be able to establish your account. Instead of having an account in a bank, your account will be in the quantum financial system where your money will be when you request it to be downloaded into your your account. You'll just go into your you set it up in your your personal office in your account on the RSF platform and you desire to have \$100 brought down into your quantum financial system account. You just push the buttons in it doesn't. It's an account to have count transfers will be very, very fast. One of the biggest problems, not necessarily a problem, but the end of transition, people will not will not know how to establish their own account within the quantum financial system. And we're helping them to do that when they sign up as a beneficiary. But the directors are going to be the ones that will help people. Now, obviously, the beneficiary is not directly associated with a director, but in the CAC programs, you allow for the training of people. And that could be a big thing for for you to do in a country that's not computer literate. But those people need to come up to, you don't just allow them to remain ignorant of these things, you need to train them. That's part of the education process. That's what the money the wealth management programs are for, to help people to learn how to manipulate money, are you to use not manipulated to use money in appropriate sort of way that will be a blessing to them rather than a curse? So there's, you know, there's quite a range of difference there between the curse and the blessing. But our idea is to train the people to use their money, have it available for them and train them, how to get it and how to use it? And that's part of the whole process. So it's not just Nigeria. All of Africa has have problems with computer illiteracy.

See, in his country, I believe that maybe his CAC would be benefit from putting up symbol that would show you you know, like the money sign, you want to download in with an arrow going down, and then they could kind of explain it to them. So it doesn't really have to be something that's read every time that they go into it, and possibly set your people up with cards, even if their gift cards or whatever exists at the point that we do this

is a good, it's a good idea in the transition, but people will hang on to that. And that's the only way that they'll do it unless you're challenged to do more. So education is something that we really need to focus on. We don't want them stumbling in the transition, but the idea of learning how to do things the right way, especially if they have an incentive to do it, like this is where I'm gonna go get my money to go buy food, or pay bills, whatever. That's probably a better way than to use car in my opinion. And but let's talk about transition because transition is important. But the transition may be the cards might be placards or something like that to help them. But they're also along with that needs to have the encouragement to to learn the things

that they need to do to get along in the new society. And I think that they will do that. Education is not a hard thing to do. And in Nigeria, as in most of Africa, there are those who are, are very, very well educated and can act as mentors. The problem is the leaders in Africa have been pillaging from their peoples for so long. There's not a lot of credit ability in other people to help out. But that's something that's going to be changing because all governments need to be GESARA compliant. And if they steal money or something like this, they're not going to be able to use it because the quantum financial system will block them. So changes are going to take place, but in the interim, and to recover from the problems from the past, it's going to take a little bit of time. And I think that that, that time can be well spent, and money can be well spent in educating people. Most of that education needs to come from the Nigerian or African people themselves, who are the more educated? And how 10 How can they help their fellow human beings in their countries to to get along better in life? There are those who will pick up the ball and run with that, as far as education is concerned. Now, is that an opportunity for employment contracts for directors to go after these people and find them? I believe so. Great, if there's one, there's 1000, NGOs, non government organizations that are trying to teach people how to how to read and write and, and that sort of thing. Find those people and pay them well, to do that. Provide them a school room, provide them the opportunities that they need to do a really, really good job, the kids love it, the kids love to learn. It's a social thing for them. They love to get up and go to school, they will. Because they see that it's going to be a benefit to them. So there's a lot of solutions to problems that will come as we get into it. Just be open to the fact that the heavens will produce and give the results that are the education the ideas that you need to move forward and solve problems. It's a great resource and as benefactors, we'll have our counselor to help us as well.

example. So the business owner can look at that and say, or, for example, will the performance bond if we had for proof of funds letter, to show a business owner that were capable of handling the amount of funding they would need to handle their labor and benefits and health insurance? That if there was some type of document or even using the performance bond or proof of letters, or proof of funds letters? Can that be something that we share with the business owners? To get credibility question,

it's a good question. In the contract, themselves, especially their business owner contract, those kinds of things tend to be spelled out and agreed to by the owner solving particular problems. But as far as is having letters, ask your ask your, your assistant or your counselor to if that's the best way to proceed with a letter of some sort, that indicates that you have sufficient funds in their will, in that contract, I perceive and in, you know, if I get my way, that there will be something about the bonding of each contract that we perform, that we ask people to sign so that that contract has a performance bond that's associated with it. And once it director signs it, then that's giving the authority to use that beneficiary or excuse me, that benefactors bond account, to take care of all of the things that are necessary from see the bond account at that level, is part of the the structure of the RSS platform. So if there's insufficient funds in that account, then the computer will go over and draw down account from that bond account that the Benefactor has set up, so that there's money that can flow. So if there's a problem with money in the master account that's not there, and somebody draws on it, it will go to the computer, the computer will go to the bond account for that benefactor and draw from there with a email or some kind of a flag of some sort indicating to the Benefactor that he needs to put money or she needs to put money in the account. So it's got to be written. And rather than just a letter, that's my opinion, ask this. Let's go ahead and ask the your counselor at the point of time when what is his preference or her preference to be able to do that? Kieran You're welcome. You're welcome.

Okay, well, let's let's attack this a little bit. The farmer is, is the guts of our food supply. If there's matter replicators that come along and help with food, I think that that's appropriate. But from what I have received, the farmers are going to continue to be needed. And the food represents a different, you know, in key areas where there's very little food available fresh fruits and stuff like that, it's, it's, it's going to be difficult. So those are the areas that they're mad replicators will be of major value. But to a society that's functioning, farmers should still be in a position to their to grow crops and do the things that that are necessary. So I believe in my mind that the farmers will, will last for a long time, I could be wrong. If it doesn't happen that way, that there's different things that will happen for the farmers. We'll see how society moves forward. How does it work? signing bonuses and downloads, you'll you go to the farmer and you offer to purchase all of the things that that farmer can produce? How do you determine that? Well, you go back five years, this is your average. And this is and so on, so forth. This was a bad year. And and this was a good year, and all of those kinds of put it in a format and come up with a an amount of money or the amount of product that that person can, that farmer couldn't that farm can produce in a period of time. And okay, so we buy everything that personal can have, do we use it ourselves? No, we just send it through the same distribution system that is already in place, it's just that we own it, rather than Pharma. The net project after that idea, the net idea is that we if we own it, we control the what we require as payment for that firm for the food. So we can sell it at a price that is that we feel as comfortable as why at that level, we have to have one central control. When I say that that's going to be loved one industries for the ESS program, which is a farmers that have come under. So the idea is that we use the same distribution system and get the food to the people and that gets into them and then timely manner and where they have fresh vegetables and so forth in the stores. So yes, there is a signing bonus, I believe that the bonus should be given as a as a download. So it's not just a one time shot. And my ideas is let's give them \$1 Download per minute, when they sign the contract, that's going to be over \$500,000 that they're going to receive. In addition to signing the contract with us. I want to make pharma and farming one of the better industries that people can get involved with. I want families to come back on the land instead of corporate farmers. These corporations these large corporations are highly involved in GMOs and GMO seeds and all of the stuff and all of the garbage that they spray on them. All of that. I like that to all go way, get rid of the corporate concept, and all of the Monsanto garbage that goes with him. So that we get to have nutritious food that tastes like real food. I had a tomato yesterday, there's not much more flavor in that than just the plastic that it looks like it is anyway, I was really disappointed. Doesn't taste like. So we're gonna get rid of all of that stuff and start having food that tastes right. And it's nutritious. Well, we we manipulate that by saying we will, you know, there's a certain amount of time when you need to upgrade, and will help you pay for the upgrades and repairing of your, your, your soil. And here's a place for the directors can get involved in this and provide whatever the farmers need for education, if they do need so they can get together, the director can get together and say organize things in a better way than they do now. They don't do it anyway, farmers talk. And then well, I'm going to, I'm going

to plant beans is here. And that's their craft cash crop. Those are the kinds of things that can be helped with a director. So I think that we should sign have a signing bonus to be sure that there are that they're really happy with doing business with us. Let's put it that way. So that's how I deal I think, in my mind to deal with the farmers, the NRA ELLs for land and buildings. Can that happen? Yes. To an extent. I look at it in a community, it may be a few farming community or something of this nature, where there's people are growing crops and stuff like that. Or they want to build land or use land for development for homes. There's land developers around where you live. And if there's one, there's 20. They're looking for land so that they can build homes and make profit. We need an inventory of homes in the NRELS, we need more than we can sell. So we can buy them and bring them in and then put them on the listing service and sell them that way. But we need to have people out there building homes. So you go to a developer and say, What have you got in the conference? What are you working on now, we can supply you the funds to do everything that you need to do. And we can offer employment contract for all your workers to do the concrete and the pipes and the sewer and sidewalks and all that sort of stuff. And help you with building the price of costs of building a home. We have funds available for that. And at the end, we will buy the home from you at market value. And so they'd say we don't know what that is. Yeah, well, yeah, that's true, you don't, but we'll buy it from him for market value. So keep your keep your wits about you, as you're building your home, because high end home, then that's, that's fine. There's some people that want that if there's low end homes, and that there's certain areas where that's appropriate. And there's also certain areas of that are appropriate for multi family units. And we turn them into condominiums all of that stuff is available for us to to work with and invest money into these people's hands so that they can provide a service for us that we need as far as building new homes. Remodeling we need contractors who will go in and teams of contractors will go in and remodel houses. And we need appliance centers, local appliance centers we buy from them and put into our homes, and that's money in their pockets. And, and obviously from the other side of that we're helping the manufacturers GE or whatever it is to build washing machines and dishwashers and dryers and and those things and then we control the cost of those to the people who are distributing them. So we're at the both ends of this thing. And our money is going to be used wisely. And it's going to be towards the benefit of the consumers. So hit our ELS land builds and for buildings that can happen. Yes, absolutely. And I believe in my mind, it's essential that we get involved in at that level. So we get more homes Okay, and then for farmers, it looks like he got grants for seed production and soil preservation. I also think it's not just soil private preservation, but for soil repair. And there's ways and products or plants, you get into the hemp building of using hemp and, and that restores stuff to the soil. So your hemp crops are going to be a part a major part of soil repair. And there's some other technologies and we'll find some other ways of growing things from the ET's. And there's a lot of people right now that already know how to do some fantastic things. So we get that involved as well. So soil preservation, soil production, or repair. And then we purchase of goods and crops. And we do that on a five year average, at the prices that are that are being asked for now. And so the farmer is sure that he's going to get his crop sold, what if they have a water damage or a drought situation? We absorb that the farmer doesn't have to. They don't, they're they're out there, putting their whole life at stake every year, with buying their, their, their seeds, and everything that's necessary to prepare the ground on all of that. And that's an investment, it's a risk for them every year. Obviously, there's good years and bad years, loved one society will be a buffer from a good year. And if there's a if there's a good year and we get extra, then that's fine. We don't, we'll pay for it. But if there's less than what we anticipate and we'll be the buffer, they'll still get the full amount. We don't care, we buffer against all of the problems that can happen for farmers. Because I never want a farm to be foreclosed on, again, because of lack of ability to make payments. It just I just don't want that to ever happen again, for especially a family farm. It's in their blood, he loves to farm. So we take care of them. And

that's going to be one of the better businesses to get involved. Especially if you have a family that's lost your land and you'd like to get back farming again. That's fine those people and get them back into farming. That's what they love to do. So, okay, that's employment contracts for farmers who, sir, any questions about Pam?

So we're gonna go now to employee contracts for local businesses? Who is the contact for all small business discussions, the directors, the assistant directors, what's the best approach to promote this to business owners and decision makers? And finally, techniques for meeting with businesses? Do we use the Chamber of Commerce, business gatherings, social events, et cetera?

Who is in who is the contract for directors and assistant directors? How they do that and go about that is it is the question as owners, and decision makers, I think the best way to do it, we have a program that is here to assist. Okay, this is this is pretty small businesses, local businesses, we have a program to that will assist you to stay open for business so that you can be of service continue to be of service to the community. And we'd like to some time with you, if you can come in, we can come to your place, you can come to our office, and we'll have a discussion. We'll have a little presentation, video presentation that we can show that explains a little bit about our programs so that we touch on each of the different points that are necessary for them to understand. And then we we have that discussion with them to decide whether they have an interest in doing this or not. Most of them will find this a little bit more than they want to. Then they understand now when they want to think about it. I think that's appropriate. We're not here to sell them on it. Think that if they show that we show them the advantages, they will jump at it, especially if we're paying all of their labor costs. And and giving them to twice as much for their business. There's no reason for them not to go with us. And again, that's the biggest thing there is that we bond our participation in the contract. And they'll have the opportunity to be sure. And let's show them how they can be sure that we have the funds available. Okay, now for the techniques for meeting with businesses, Chamber of Commerce is a good idea, business gatherings, social events, I consider them to be resources, and use them as often as you can do have, and create some of these business opportunities for yourself. Let it be known that you're going to have a meeting for business owners, and present some new

ideas and ways to stay in business and enhance your business. And we'd love to have you come and once the first one, you might get 10, or 15, guys out of 100. Or maybe less, who knows. But the second being you have a consistent every Tuesday or Thursday or whatever the next meeting is going to be, you're going to have more there because of the word of mouth, especially when you sign somebody up. And they go to their computer and see this 10 cents per minute download, or whatever downloads, I mean, you're presenting both areas at the same time of beneficiary account, as well as an employment contract account. So you're going to have the directors, the one that's going to present that and the director will work out who gets the credit for it for the beneficiary accounts, and maybe share that with each of the the assistant directors and so forth, so that everybody gets a chance to grow and develop in their funds. I've heard it said that the directors that the employment or the benefactors might not want their directors doing that. And I say why? Why not? They're working for you that let them earn some more extra money, or problems with pay them well. Could a director become getting a million dollars a year? Yeah, I think so. And if they're not, then they're not doing a really good job, in my opinion. What about a million dollars a month? I don't know that might be a little bit high for a director, but there's others that will do it. So Where where are you have your businesses have your meetings, the CAC, itself, the structure itself, if you've got a big enough room to banquet room type of thing, that you can invite them over for a catered dinner or something like this and have dinner and then you can as they're eating, they can present things and and then after the presentation if you have the question and answer and the outside is individual desks so that you can have two or three or five or 10, whatever assistant directors at the meeting and and they can sit down and answer the questions on a personal basis. These are the kinds of things that you can do and are desirable for the directors to participate in and the the Benefactor needs to be involved until it gets beyond what the Benefactor has control over. So he has to really delegate responsibilities. And that's where you have the structure of the CD CAC, where you have a director over a city rather than just over community. And then you might have a bunch of directors, a director over a bunch of city cities and where you set up the CAC of those cities, then you might have a state or a county or a state, whatever. But you always have a structure there so that there's more people that can be involved. And so one community's assistant Senator can have a meeting on Thursday and a whole bunch of people come and another one on Saturday and a whole bunch of the employees of the CAC program can come and be act as counselors at that particular point in time. Okay, let's go to the next one.

one of the things that I got really excited about is when I talked when I looked into the possibility of a church congregation, let's say 200 people in the congregation, and you have a minister, and perhaps if it's Protestant, then you have a board of directors that's in charge of the, of the preacher and that sort of thing. So there's structures within that. And that's what precipitated the generational bonuses generation bonuses, so that I, as an individual could go

to a minister and say, and make a presentation and sign the minister up. And then the minister can be in charge of this, or the board of directors, whatever, can be in charge of signing people up in the congregation. And you appreciate the congregation that you'll have things prepared to videos and so forth, you could show and they can have a banquet night where they come and learn how to do that. Well, the idea is that the people in the congregation all sign up underneath the church. And then the church gets the benefit of the two for one, the registration bonuses. And the minister, the board of directors are in this, the generational bonuses and making get get paid as well. So but you want to be sure that first person that's introducing it still gets at least one level of the of the generational bonuses. And that's why I've set it up. And if we have problems with that, then we'll go another generation, I don't care. Maybe the fourth generation to be sure that the person that's introducing it gets paid a generational bonus. So there's, there's ways that can be handled, we can fluctuate, we needed to but I, I thought to myself, there's a there's a church in North Dakota, it's got 6000 people in it, as if they all signed up together what that church could do. And see, normally churches pass the basket around and give their donations. So that's how they pay for all of their expenses. When you do something like this, they have an income for 200 people, that's one for every two people, one penny for every two plants, \$1 and \$1 is 500,000 over \$500,000 for a year. So that means that that church can have a new roof or can expand or do whatever they need to do to remodel and or do humanitarian work in the community. And they don't have to pass the hat to be sure they got enough money to do it's just a matter of budgeting. The minister can get he's already getting paid. And he might have his beneficiary account with six trusts. And so that's going to be a boost for for the minister or her whatever it is. It's just going to work out really, really good for everybody. So you meet with the leaders, and can we offer them a signing bonus, don't ask me. If you want us give them a signing bonus offer to him. That's that comes from your gym benefactor. So you can work those kinds of things out. And if you're just an individual beneficiary, going to a church and doing that, and you might invite the director of the CAC in that local area to come along and and be a voice or be available if there's benefits for bonuses and so forth. Yes, get it set up ahead of time, and then give them a nice bonus. And that really works out well. Okay. Incorporate the RSS into their organization. So I've discussed that. Grants for each the scholarships, certifications, projects, infrastructure. If you have a CAC active in that area, then that's your that direct who would be the one to go to for grants. Set up a scholarship so program of some sort for the congregation and maybe the congregation can can set up a scholarship for needy people in their community, but we're thinking about needy people and poor people but you know \$26,000 20,000 dollars a month is going to solve a lot of poor people's problems. And if they're a husband and wife, that's 56,000 a month. So that's \$364,000 a year between the two of them. So at any rate, you're getting a getting into a lot of income. So are there any poor among you give them an RSS account, sign them up. And they don't have to be poor anymore. This is the whole idea of this. So. So grants for scholarships, certifications, projects and the infrastructure. It's all there. But most of that would be on in terms of the the, either the direction of the director and assistant directors. That's my understanding, or that's the way I look at it from this point. I'm certainly willing to have my eyes opened up for other things. But that's it.
