Okay, the gap discussion, can you explain this again, there are people who are running the government who are doing or employed by the government doing this specific job. Sometimes those people are just government employees, other types of people with passion, trying to help out. And they've organized the government to give them a certain amount of money for Boys and Girls Club. And they never have enough money to do the things that they need to do. So along comes the director, and hires people within the government agencies and gives them government assistance programs could be under the the benefactors account, we set aside a certain amount of money download for a particular purpose, or they can do it in trusts where you have, you might have a fire station that you give them a 10 cent per minute download trust. And that trust can be the captain of the the fire station can be the one that's in charge of as a as a trustee, and have an accounting and so forth. And every government agency has every government has an accounting auditing system. And you just put it under the auditor. And so occasionally will, you know, if I were involved in I occasionally go in and audit the the trustees to be sure that the money was not being misused. But my idea for a fire station, pay for their food? Do they need new equipment? Do they need the latest equipment that they have to save up to get? Well, there's can be grants for that they've they've used the idea of squad cars having bulletproof windows so that they the police don't get killed out? How long is that going to last because all of the bad people that would do that sort of thing are going away, but there's a transition that we're going to be going through. And there's no waste of money by putting bulletproof windows in squad cars. There's no waste of money, even if nobody shoots them. But what if a big boulder came along and they were driving the freeway and a big rock kicked up from a track and went through the windshield? Well, it could happen. And if it did, then that would cause a problem. But if it's bulletproof, it wouldn't cause the same problem. So those are the kinds of ideas your mind if you start thinking, your mind will come up with 27 different ways of helping programs within the government. Keep in mind that, from my perspective, when the Sarzana is implemented, and they're only on sales tax 14% is going to go to the federal government and 3% of sales tax is going to go to the cities, counties and state. That's they're going to be their budget. And so they can't live on that for a while. So there's a transition. But these people and some of the programs that are doing that are really good, may need to be subsidized by us. And let's not be hesitant to do that. We don't want to enable bad projects that have been started with with ill conceived ideas, so that the big guys at

the top get paid a lot of money. We have the tracks here in Salt Lake. And the people involved with that are making a lot of money. And they say, well, that's commensurate with other location. Well, why are they getting that much money when they're sitting around at a desk? And all the decisions have been made? And what do they got to do? I don't know. I don't know. But if you don't have the money to do all of the pay all of those times, then where are you? Where are you going to get them? I think that public transportation should be free. It's my opinion or very, you know, a nickel or something to get on. But those are the things that can be made at a local level. So that's what the gap gram is government assistance program, to give grants and other things that are necessary for the government to continue to give the services that they need to provide for the communities and again, it's a community I hope that out to answer some questions. Now let's see if somebody has some basic questions for either of these three.

Yeah. Thanks, Ron. Thanks, Kerry. We have a lot of people here that are new. And we even have people here that may not have ever run a business and are wondering on the CAC. How exactly through employment contracts, and how basic is this resource going to be able to help the communities that they're going to be servicing and so I have a thought I just want to throw it out there. I've done a lot of work on this over the years, and it really does work, I go back to miss Betty's comment earlier in the chat about building relationships and having trust. And, you know, we're going to need that in our communities, it's very important that the communities slowly get healed from the process that we're all about to go through. But as we work through the employment contracts, and through just the relationships in our communities in general, I want you to think about this for a second. So let's just say the average small business has \$1 of revenue that they've generated. In other words, they've run their register for \$1. Out of that single dollar, on an average 40 cents to 50 cents of that comes from the following. That means out of the dollar, that they just put in the register 40 to 50 cents goes to wages, benefits, taxes, social security, health insurance, that 40 cents that they normally have to pay out, we are now paying for them. So Ron mentioned the taxes through just Saara, I'm talking about payroll tax, there won't be payroll tax any longer. I'm talking about not worrying about wages, I'm talking about not worrying about the benefits, not social security, because they'll have a retirement plan every single thing relative to what a business owner has had to pay relative to their labor costs, labor concerns is going to come from us. And so they are not going to have to worry about that. What does that mean, that 40 cents that they would normally have to pay would stay in their drawer. And so that's profit. And so when you think about that, and all that we're taking away pressure wise from the business owner, is going to be that much more of an opportunity for them to stay in business. That's all I want to say about that.

with the Hello, everyone. I apologize. I'm in the store. So I'm going to try to make this quick. I only have one question. When we are approaching the small business owners, or the ESS, I'm sorry, pretty easy as how do you suggest we approach them? And what I mean by that? Are we focusing on the E and the s? Or are we mentioning the RSS like, what is our focus here? Because I'm thinking that one may, quote, compete with the other. And maybe we should just focus on, you know, the ECS. So I appreciate you all. Thank you. I'm going to mute now.

It's a good question. And competing is one been one of the biggest concerns, we used to have 25 cents per minute download for the beneficiary. We changed it and put it down two cents, 10 cents a minute, because we didn't want to compete with what they can earn without going to work. And so in effect, one of our programs was competing against the other beneficiary competed against contracts, and we wanted the people to have contracts, we want them to stay busy and produce for the for society. So that's why we changed the beneficiary down to 10 cents per minute. That said, if they get six trust, and it's still competition, isn't it? So keep that in mind that we want to be sure that they're getting paid sufficient amount of money for things that they enjoy doing. I don't see contracts for people who don't like to do what they're doing. Why would they want us to continue doing something that's not enjoyable to them? When they can stay home and get to When \$1,000 a month, those are good questions. And so we have to design our approach to these people with contracts, to be sure that they're sufficient and getting enough money to do what they want to do, or give reason for them to continue to working. So it's, it's a, it's one of those things where we want to be appropriate, but we certainly want them to continue to stay in business. So that's a real approach for us to use more money than we thought necessary, so that they will stay in business. That's part of the negotiating thing that you do with the business owners. Some business owners have been struggling for so many years, that they're burned out with their job. They may not want to, to continue. Now, keep in mind that that business owner might have employees that he wants to keep going. So we're not asking the business owner to continue to take a wrench and tighten up or change tires or whatever he's been doing in the past, he can hire people to do that. And that's the thing that we want to impress on him is that he doesn't have to do the work or she doesn't have to do the work that she's been doing laboriously for a long time, just to make ends meet. Because now she can make ends meet and enjoy. Sign the contract, keep the business open. And if you want to have more employees, then talk to the director and see what's available, find some new people to come in and help out. Those are the kinds of things that are left open for the business owner, especially the older ones. And then the younger ones, they would like a long term contract to stay open, because they started the business thinking that they can have a lot of fun with it. Those are the kinds of things that we're looking for. So be inventive. You have the money to do virtually whatever you feel like you'd like to do. And just

be sure that it's appropriate. And then we're not buying people, people with bad idea. So we want them to have a contract and, and be in business and be viable in the economic system. Each one of them. So we'll go to the next question.

Because if I tell them that I'm working for billionaires, but yet I'm getting paid something different than what's normal? How do I explain that?

It's a good question. It's not required of you to tell a whole lot about a new job. I'm working for an organization that it's a nonprofit, and that we have a program that's just been set up for us to use. And I'd like to explain a little bit more about that. You can be a resource rather than the one who has the money, how much money you have, and maybe the that will be visible to your friends and family, that you might get a new car and so forth. It's just part of your job. And it's just part of the things that you are qualified to do. I qualify, qualified, I applied for it, and I qualified and so I have the job. That's all they need to know. Who do you work for? I'm under a nondisclosure because there's money involved. That's all you need to say. If they have if there's a hiccup after that, then let them have a problem with it. But you don't have to tell him anything you don't want.

Hello, everyone. Hi, Ron. Thank you for everything that you do. I'm happy to be here. Okay, so I just have a little bit of it's a question, it's just kind of something that I've ran into myself, just I just recently moved. And so I've been trying to just kind of do a little bit and help out with some of the homeless in my area. Now with the I'm finding so just with food, for instance, the government has their hand in in everything. So at this point, and in as far as the food situation like, they won't allow me to even prepare any food to give to like, it's not regulated by the government, it has to come from a commercial kitchen. So I even went to one of the non for profit places that they they help out families and some of the homeless people come in, they line up and they give them sweater like things that they need. It's just a really tiny little place. It's a beautiful thing they're doing. But they're limited on the type of serve, like the help that they can get from the community. And they're afraid of being shut down. So how do we make how do we get people feeling comfortable with kind of, are we getting away from we're going to be getting away from the government situation and how they're regulations? Is that correct?

That is that is keep in mind that that company, that government that local government has to be GESARA compliant, and that their laws are not inconsistent or not, if not consistent with NESARA or GESARA, then they're going to have to change. And that change doesn't come from us. It comes from the governmental authorities over. And so these rules and regulations, you know, I think that sometimes it's pretty wise so that you don't you don't go and feed the homeless, vouchers are a good way to do that. You can give money to the those organizations that provide that. And within that organizational structure, there may be some opportunities to enhance it, so that the people can, you might have a place where that'll sell bouncers and you just give those vouchers to people and they can go over and get a sandwich or something of that nature. So you can, there's ways that you can do that, instead of just having you do it. If you understand what I'm saying. You're going to have so much money that you can do a lot of good for the people who need it. And that's what the CAC program is about, you know, if they have laws that you have to be a food handler, to be able to handle food for people, then let's let's work within that structure. Food Handlers can get a food handling permit, and you can set up things that will kitchen or something of this nature with local governments, they'll help you to do it. Because there's problems within their within the communities. They're having to deal with homelessness anyway. And poverty. There's always opportunities to give money into those organizations, be very careful that you don't give it to somebody that's milking it, and using it for money laundering and things like that. So there's opportunities there, you just need to go

find them. And they'll just ask if asking, it shall be given boy, if you ask, there'll be a lot of opportunities that will come to you. Because they haven't need this taken care of. And you have to ask to receive.

Now, with the business owner contract account, we're asking them, or negotiating with them maybe what their best year was or the last year was and then we're doubling it. So is that what we set for download for them basically, with equal to the best year? How does that work?

Well, you can do it, the best year you can really last five years is I don't have a problem and taking their best year and doubling that. It's just money. And we've got plenty of that. So we can do it. Whatever you feel comfortable doing. Now, keep in mind that you're going to you're going to overwhelm some of these people, because this is too good to be true. And you say yes, it is too good to be true, but it is true. And all we need to do, all you need to do is sign up and you will find out how true it is. What is there to lose if you signed the contract. And if we don't perform on it, then you can walk away from it. Because as part of the contract, if you don't perform, then there's no contract. So just sign the contract. And let us perform for you. And we'll show you we can do a really good job.

So when we approach the small businesses in our communities, if they're the service oriented businesses, and they have to be not a corporation to have a business owner contract, or can they be registered as a corporation, and we can still offer them a business owner contract account.

**R** Ron Giles 23:33

Usually a business owner is a personal person, you know, obviously, and it would come under his control, or her control as the business owner, if it's a corporation, you still have to do it in

his his or her name. Because we don't they can't have an account on the RSS platform if they're a corporation. But if they're a nonprofit or something another organization like that, then it's permissible. So that's what the RSS program, but you have to be you have to have an RSS account in order for a beneficiary account in order to receive a contract. Otherwise, there's no place to put the money there is no place for the download. Yes.

Okay. One of the questions. So in the RSS program, there will be in addition to the RSS RSS download, there will be a spot for the business owner contract account and an employee, contract account, employer or no employee, I mean,

well, the contracts, whomever business or if you're a worker, those come in, they're in a separate section than the beneficiary account. It's just an accounting section section. And then the front page will have a conglomeration of all of the money that's available. And yet, I'm not sure how that might work. If we get into trust, it may be that the trust will have to go into the quantum financial system on their account to be downloaded to them. We'll see how that how that ends up. I'm going to be discussing that with my counselor, to see the best way to do it. I'm I'm more inclined to say, here's how much money you have and requests so much for a download, or not download, but to be drawn down from the master account into your quantum financial account. I'm more inclined to go that way rather than the individual. This is an evolving thought. Because I thought that in the beginning, I was not aware, in order for you to get a bank account, you had to have an EIN. That means that you have to an employment identification number. And that's because that was required by the IRS. And if you had one of those, then you could go to a bank and get an account. And without that, you couldn't get the account. But now we're going to use a quantum financial system. And I'm not sure if that's so important, whether we just leave it up to the Alliance to manage or to oversee it. So that the con so that a trust account is being used for the right purposes. I don't know. We'll find out about that. And that'll be part of the implementation of what we do. From that time forward as we fine tuned the RSS platform with with the Alliance.

And of course, when we have our appointment, I want to go out the gate and sign everybody up on an RSS program. But I have some underlying issues going on. Like in my town, we suffered greatly through a really catastrophic hurricane. And most businesses, most all businesses are still looking for help and can't get it. So if I start going out before I and a director goes through the training for, you know, everything along with the CAC program, one of my concerns is, Will I mess up the economy, even worse than what we're dealing with? I'm just trying to see how this is going to overlap. Because of course, you know, we're not going to know until we and our directors go through what you call the training process, right? To get the businesses involved in such.

Yes, well, it's a dilemma, how much training going to be training. And then we've got people assigned to create a curriculum for that. And hopefully, we'll be able to go through the redemption appointment, get our funds, and have that available for us to be trained to do that. Keep in mind that you cannot screw anything up really bad. You're working with people, how you might set a precedent that you can't that you don't want to do. It's okay, it's not gonna hurt you. Now as a benefactor, keep in mind that you're going to have a huge amount of money every quarter to help people with to use to help people and the RSS program as Zim benefactor, I would not be taking it upon myself to go out and get people involved. Find a few people and tell them to go and refer other people. If you do it, if you sign people up, then you're going to get the bonuses. And that's not really what you want to do unless you want the beneficiary account, just to use as your own budget. And that's what Okay, you're the one that's in charge of your own humanitarian work. But I would be sure that my master account might be used one or two times in different locations, and then just let the people refer. Once they know that there's money coming to them, and they can see it on their computers, you will have a hard time keeping the beat the people away from signing up, because they know it's a real thing. And like I alluded to before, when you say there's nine billionaires that are putting this program together, and they look and saying, Oh, gee, that's a lot of money. How long can the benefactors benefit the billionaires be able to support us, we better get in as many people as we can. So they go out and start signing people up really fast. And don't question that just just enjoy the funds that you get? Well, we know from the other side of things that we can't spend all of our money, you can't do it, it's not going to happen. One person getting one quarter of a payment of 1.25 quintillion, it's only going to take about 40% of that first quarter payment to pay for everybody in the whole world. They have beat us beneficiary account 7.5 billion. So if you're not, that's not going to be a problem for us, we'll have plenty of money, it's hard for your mind and my mind. And most of us who have not had money to even comprehend that amount of money. So we don't need to comprehend it. We just do it. I don't know how I don't know. I don't need to know how a car engine works. I just started up and drive down the road. And I have no consent, concern or care that all of those things that are making those pistons go up and down and staying where they are. And there's all kinds of explosions going on. And I thought, well, I should make a lot of noise, but then they put a muffler on all of that sort of stuff we don't have to concern ourselves with, there are those who we go to that do know. So we don't really have to know our minds do not have to wrap around how a car goes down the road from just from gas. We just do it. And in doing it, we get to know what we're what our job is about, and what we have how much money there is. And we just know that the

alliance set this up so that we would have our tools to work with as humanitarians. And just let it be true. Allow this to be true for you. Just simply allow it. I believe in this. And make that instant, I believe this is true. And you'll watch and see how much fun and enjoyment you will receive from all of the people who are just tickled to death. And you may not they may not know you and you're the one in charge. In fact, that's the best way to do but you'll just find in your communities that things will just get better and better. People will be much more happy. They'll have plenty of money to have a lot of fun and enjoy things and go out to eat and do all the kinds of things that recreate. You might movies industries will get good movies instead of other garbage has been. Some of them are really good. I'm not saying that they're garbage. But there's a whole new way of living that's coming for us. And so don't have to know everything about it.

The thought crossed my mind yesterday about the people who are working in university can we make a contract with them about the project they working about? Or this contract should be about all university? Have you ever think about it and what's your idea about that. Thank you.

Ron Giles 35:05

You're welcome. And thank you for the question. I don't have a lot of faith in any university at the present time, because I believe that the curriculum has been set in place to train people to work for somebody else. And I'm not sure that that's the way that the economy should work, we should work jointly for each of us on our own for the benefit of and service to the human to the community. Universities have been notorious now for preaching communistic type, or other types of political aspirations. And it's tainted the way that people have learned how to think. They, people don't learn how to think for themselves, they learned how to think for other people and be subjected to an employee or a boss over them. So all of that kind of an education changes, when the Alliance creates the quantum education system, with a curriculum that came from the heavens. Now, how's that going to be implemented? I don't know. If you find a university that's implementing that curriculum, I would have more faith and trust in them, as well as the individuals that are there to do it. But universities is something that's, that could be very tricky. You want to look for a lot of progressive thoughts in terms of the new way of doing things. And if they're willing to do that, then you can kind of you have something to work with. If they're not. There, they're, you know, these are, are very proud, highly proud people. And they think they know everything. If you don't believe me, just ask them. They'll tell you, I know all the things I need, you know. So they're very arrogant and are hard to change. If they can change, and realize that they've been really doing a bad thing for society for a long time, then maybe you got something to work with. But we're going to have a new curriculum, regardless of what universities accept or not accept, and use, if they don't accept it will go out of business. Keep in mind, if I'm a student, and I'm going to college, and somebody comes in offers me, a beneficiary contract with six trusts, that's going to give me \$28,000 a month. Tell me what university I can go to that can teach me how to make \$28,000 a month. And I have to go there and pay for all of their stuff. The point that I'm trying to say is there couldn't be a lack of students going there, because they're charging all of this big money thinking that because they can, they want everybody to have a degree to work for somebody else. When they can be entrepreneurs themselves. And they get married, and they have two incomes \$56,000 a month, things change. So we're going to change the way that education is happening, not just loved one society, but the alliance is going to be doing that and being very heavily involved in that. So universities, they may or may not survive. And in my opinion, just let them go their way. Because they have been destroying us as a civilization for a long time with their, their errant thoughts and their ideas about the way we were supposed to be governed. That's just my own opinions. And I'm not I don't have a crystal ball to know what's going to happen in the future. But I see things changing to such a drastic degree, that those who are arrogant and proud and don't want to change will be left behind. Thank you. I hope I hope that helps. Thank you. And I'm like can't even take care of my own paperwork, let alone 40 or 50, other brokers or agents. And right now I'm starting to a little bit feel the same way. You know, I'm like, so excited about, you know, jumping on and helping humanity. And so, my like, so I get a little bit overwhelmed with, I'm gonna hire a director, then I'm gonna hire assistant director, and then you know the CAC and all the seven projects I've got going on, it could be a little overwhelming, it's all good problems. But my thought was, and I have two questions here. My thought was, I'm gonna hire a director two directors at the same time, so they don't get overworked. And they can split that, and I'm gonna hire two assistant directors, and I'm gonna hire someone under me, that's gonna, you know, so I can take a break? And can you help me organize my thought, you understand where I'm going with that one?

I believe I can. And I believe I understand the problem, not a problem, that concern that you can seem to think is going to be working itself. You're not the you don't have enough time, you don't have enough energy. You don't have enough hours in the day. To do everything yourself, you're going to have to, you have directors, let the directors hire their assistant directors, they're the ones that are going to have to be working with, okay, and let them and if a director is so busy, then let him have more than two assistants who may, you may need 10 or 15 in a larger area. Give them the authority to make decisions at their level, you can give them guidance, and you can give them policies and things that you'd like to work with. And that's basically what we're looking at, with loved ones society talking now about these things, you're working out policies, and then you let the people do the work. And, and then you require them to account for the decisions that they make. That's a good way of doing it. And so, from that perspective, your job is to find the right people to do the jobs that you want them to do. And you ask and they will come out of the woodwork. That's the promise has been given to us by the Alliance, you, you already have directors, assistant directors and a whole organization that is preparing themselves on an individual basis to participate with you in accomplishing what's going to be taking place. And in other words, Spirit is moving on these people. They'll come up and they'll be the right ones for it. And they'll just, they'll just show up. And there they are. And you can bring them on and train them and do whatever you'd like to do. And then let them have a free rein and things were not so uncharged that we have to be in the trenches doing all the work. We have to put away our gloves and put away our dirty shoes. And perhaps put on a suit if that's it's just a symbol, the idea of it and be the management rather than be the worker. And if you separate those things, how can I help other people do what I'm doing? And replaced me move up to a higher level and get more people involved? question and answers or to do videos, because I don't like my voice and somebody says, Well, you can do a good job. Just give it a try. So I did. And now I'm saying, Well, I'm not bragging or anything, but I'm saying it's sufficient for what we are doing right now. People are happy with it. I hear a lot of good things. I didn't know that was in me to be able to do that. And you are going to be the same way, you don't realize what you have in you that will be just perfect for the job. So just believe in that, let it be true. I keep saying let it be true. Just simply, I believe that this is true. And go from there, and you'll find that things will happen. Very easy.

Well, my first thought is land requires ownership. Participation, and you don't want to buy too much land without because you'll be an absentee owner. You know, it's a corner lot that's always got the weeds in it, because the owner lives someplace out. You'll be able to accomplish what you need to do if your heart's in the right place. If you were to say to your counselor, you know, I want to buy up all the land, like get what do you think. And then you have a discussion, it may be that one step at a time, one property at a time, at a time, make sense, who you're going to have worked the land, you buy it from the farm farmer, and then he's gone, who's going to do the land. So at the same time, you want to buy more land, your process is to have the farmer steam stay on the land, if they don't want to then find someplace that has a way to find families that have been put off their land that would love to have a chance to start farming again. There's all kinds of different ways to look at it, John, and it's up to you to ask and it shall be given and, again, the people and the land and the opportunities will come out of the woodwork and you'll say, Oh, this is just so fun. This is great. Look, I found somebody that wants to stay on the land and they're having financial problems. I can come in and solve those financial problems, and help them stay in their home.
