R Ron Giles 00:59

Well, I do in intend to beneficiaries have a whole difference information. And we don't as young benefactors, we don't have to give them all of the stuff that we've been learning, because they're not involved fully. They're only involved in the beneficiary program, and the bonus program, and that is going to be covered by a video. And that video will be on the guest side. Well, as well as the other side, the guest side. So if people come here looking on our revenue on the RSS platform, then they can go there. And there's three choices. First choice is to, for guests to go there, and they can get to watch some videos and do whatever they need to do. The second thing is the registration. And the third thing is a place for benefactors or beneficiaries to put in their ID number and go into their own personal offices. So that's the way it's set up for now. So there is a separation of education so that the benefactors have one and the beneficiaries. They don't need to know everything that's been going on with the benefactors. In fact, we don't really want them to be in there involved. So hopefully, that will and that question, but we'll probably have some more about that, as well. Next question,

Well, it's a it's an interesting question. Now, I can see that you haven't really read up on that, because the alliance will be the ones that are, are contacting us to set up our appointments. We have nothing to do with it, the alliance will contact those people that they want to give money to. So if you get contacted, then that's because the Alliance wants to help you get your funds. If you don't, then you don't qualify as a humanitarian. Is that pretty cold and dark, and I don't know how it's going to work fully. So there's some things that are really good, and others that are going to be pretty stark. If people have not been honest with themselves. However, only those who are supposed to be a part of us will have our phones. Now I suggest the husband and wife, they're going to work on projects together and some have their own and in some of the projects might be working on together so but I suggest that they each person, go through the redemption process and receive their counselors from the alliance, the ones that will help them to be humanitarians. Now, if a husband and wife do it separately, then there's two accounts. There's two counselors there that they can work with. I also think it's important that each person stand up and be recognized on their own value as a humanitarian. In other words, they get their money and they are the ones that are responsible for it as a stewardship responsibility. Now, you can go ahead and do whatever you want to do. You can go into business with your husband, you can joint venture some other things with other people. You are the one that are in charge of the money. And every time you want to do something then you have a counselor that you can go and counsel with, your husband would have the same thing, he could go to his counselor. Now, that's four brains working on the same projects. And I think that that's a great way to go. If you only have three brains working on the concept, well, then the husband or somebody like, you know, the power person in that relationship is going to be the one that carries all the weight. That is not what a stewardship responsibility is about. If you don't want to do that, and that's okay. I'm just saying that 100 years is a long time. And most projects are going to be over within the first one or two years. So you're going to have other things that are going to come up to take its place. And you have continuing projects that you will be funding as well. So it works better if everybody gets in to the redemption appointment as an individual. Let's say it has to be that way. But that would be better for each individual to be accounted for their own ability to do humanitarian stuff. That's why I have that position or hold that position. Yeah, I wouldn't leave a pile of cards anywhere. I don't think that's appropriate. Now, I'd like you that to talk to me about the difference between the Zim benefactor and beneficiary, Zim benefactors that a lot of us who want to be Zim benefactors are taking upon ourselves a responsibility to the Manage or to think that it's going to be a really important thing for us to get out and get people involved in the beneficiary program. And there's all kinds of people that say, well, we've got a lot of stuff that people just are going to have a hard time believing in this. And I'm saying, watch them believed in it, when they get the money. And their ideas, maybe let's get in and get the money as quickly as we can, before that runs all out. And then they just continue and it continues, and it continues, and it goes on and on for the next 100 years. Where are they going to stop and say, this is a good thing, I guess. Come on, you're getting money, you're gonna have 24 hours or 24 hours, you will have \$166, that's just from the beneficiary program, then you've got the trust, and so forth. On top of that, it's going to happen really, really fast. All you have to do is show people the money's coming into their account. And

then you can draw it down into your bank. And there it is. And you can, you can do that easy. Now, when I say bank, we kind of have an idea that the banks can still sort of quarter sort of could be around. But it's a quantum financial system. And we're going to have financial institutions, financial services, institutions, and financial service centers, it's going to be a whole new industry. And it's part of the quantum financial system. So you're going to draw your money down into the financial system. And if it's a bank, then it's there for a little while. But the banks would be okay by the end, because they're the bad people are getting pulled out. And then the people who are still there are going to be part of the financial service centers. Well, you're going to have a very difficult time doing a CAC without being a zoom benefactor, and having established yourself in the RSS program, period as the beginning, if you don't do that you can't do your employment contracts. You can't do grants, you can't do a whole lot of well, I guess you can do grants. But you can't do the things that we're supposed to be doing in the quantum in the quantum or excuse me in the Community Assistance Center. And I don't know who is giving out this kind of ideas. I don't present that. I've heard some holders say that they don't want to start developing well, they don't understand the program. And if do I have do I offend somebody to say that? I hope I don't. Because those who don't understand the program need to get in and find out what's going on. If you if you're going to drive a car, you don't really turn left. Oh, I know. I don't know how to turn right well, cause learn how to drive the damn car. Work it out. Learn the whole program and not just pretend like you know it and start making decisions about things that you really don't have an understanding about. It's hard. And I understand that. And why is that true? Because that's what they're looking for. They don't have the bigger view and picture in their minds. The employment contract here as it's an account now, that that will be controlled by your, by your directors, or you can do it yourself, whatever, it depends on how you delegate responsibilities. So let that just happen in it can be done just perfectly well, the, the Benefactor has benefactor accounts. And they can do that for whatever the purpose they want. And it can just go right on in there. And they can sign up for \$1 per minute, whatever they want to do, that the benefactors can do that. And if they give that responsibility to their directors, then they can do that as well. Delegation, and there'll be ways to do them through codes and so forth, so that you put in and then it works out just perfect. Next question, please.

But you put it in specifics, and I'm not sure that specifics are going to work that way. Just double their income and pay for their. And they may just have the ability to with the beneficiary money, they can remodel and do a bunch of stuff that will make things a lot better. the way that we're gonna find out where the local governments are, and whether they are just are compliant, is if they try to exercise control over us and how we do things. And they're, they're gonna, they're in losing territory, because they're, they don't, they're not going to have income tax, they're not gonna be able to tax people the way that they were before. So there is if the state becomes DisArt compliant, and the counties and the cities don't, well, then they'll counties and cities where they're going to get their money. They can't continue to do employment contract or excuse me income tax. So it's going to everybody's going to have to be GESARA compliant, or NESARA. compliant. It's not just the state, it's not just a nation state, it's not just this county or city. They all have to be because there's no money, there's all no income tax available, the only tax that they will get any money from is the sales tax. My understanding is 14% for the federal government and then 3% for the state, the states have to

divide that between this counties in the cities. That's why we as Zim benefactors can go in and really be of some value. Because we have the money. They don't. What that has done is it is taken away from them, where they take and tax us. And then they make up their ideas of what they want to do with our tax funds. We have the money, they don't have the money, they're not going to get the money. So we are in control and the government's are going to have to capitulate to us, in order for us to be able to go about what we're going to do with the CAC and the other programs. So we've got some major changes that need to take place in the minds of these people who are perhaps of our we don't know what the white hats have done. We don't know what preparations are already being made. My understanding is that the white hats are in total control of every country on the earth. Okay. Yes, I do. And I am the one who said per second, and third for the 10 cents, or 10 penny per 10 people. The first generation is the one that you out, go out and you share with other people and they join and two of those people, you get another penny, that's fine. You're first generation, second and third generation. So for those who get out and start making money by by sharing with other individuals, or larger corporations, or churches or whatever, corporations, but churches, yeah, I was wrong. And it may be that I'm not sure if Dominic really understand what like what the change has been. But the first generation you get two cents, one cent for every two people. second, and third is 10 cents for or 10 people, one cent per 10 people per 10 people that do sign. That's the bonus.

Okay, now, there are three categories. There's a personal, a nonprofit and a trust. And if a company has a trust, and they sign up, then you get a bonus for that \$50 bonus for each trust that said, that you sign up as beneficiary. So a trust that signs up as a beneficiary, they cannot make other trusts from

that trust, period. Otherwise, you'd have all kinds of problems. I think I'm thinking I'm thinking this thing through clearly. Because I've said that trust cannot create other trust. Well, and that's got to be the case. So if you sign up as a beneficiary, and you have a trust, then the person who signed you up gets \$50 For that, for that beneficiary. Call it a trust, call it what you want. And if it's been envisaged trust, you get the \$50 for that, by the fifth benefactor or beneficiary. They also get 10 or they get it cost them \$10. But they get \$50. Back when they create their trust which is another \$300 \$50 each one. Next question.
