It's a good question. At this point in time, I'm not sure how to deal with that. If you're a benefactor, there's going to be some liabilities and so forth. So you can't just die and go away. You're gonna have to have somebody take over your responsibilities. So your counselor will have some real good ideas on that for you. And as we get a little bit closer and get into the med beds, and that possibilities and things will open up for us to have a clear track to run on. So let's this question is a little bit early, but it's there. And we'll address that sometime in the future. Next question.

I live in a very liberal state, many neighbors and coworkers are in one secret society or another. I believe I should still introduce them to the RSS program. Do you agree?

R Ron Giles 01:22

Yes, I agree. The RSS program is for everybody. And it doesn't matter what your political

aspirations are. It doesn't matter. Yes, you're right. God's children. Next question.

Once the RSS program is released, it will be easy for people to learn about the entire LWS platform. And all programs, people will be able to figure out fairly easily who a benefactor is, especially if we use the lines you and Tracy suggested in the training videos to address this. Do you recommend that CAC sign NDAs? Regarding who hired them? How about other love won Society programs? Do you recommend those participants sign an NDA regarding who hired them?

Yeah, I think it's a really good idea for all benefactors to be anybody they work with, should be under an NDA. But you talk about, you know, if you're the one that's hiring the directors, which obviously you are, but if you delegate that responsibility to somebody else, then that's leaving you further and further behind. And better, I think it's important that you go ahead and sign NDA. Yes, I do. Think that they're very effective. People won't be messing around with you. If that's your job. That'll be all right. Want to raise an issue about the NRELS program in D lawns recent and very helpful LWS action plans summary of each plan. In part three, section 15. He writes that an owner may resell the home at the same purchase price they originally purchased the home for I see two issues I didn't see before. The action plan for NRELS on QFS 2020 says that a registered appraiser is required to determine the sale price of a home. This seems straightforward for the first time a home goes into the NRELS system. However, when the home is to be sold, the homeowner is locked into having to sell the home at their original purchase price. Wouldn't we use an appraiser again to set a new sale price plus any improvements to be done. This question then raised another issue if the homeowner improved the property by putting on an addition to the house or added a garage for example, the value of the house would increase. If the owner is locked into his original purchase price, then he has no incentive to improve the property to his needs or desires. A simple solution would be to have all homes appraised whether an NRELSowner wants to sell or a buyer wants to buy and whether that home is new to NRELS or a home that has already gone through the NRELS system.

Those are really, really good questions, and I have no problems answering them. Here's my problem. The NRELS we've set it up the way it is. However, when we get into it, there may be changes that need to take place. And I'm not going to be locked down to what I have said in the past with the exception. If there are problems, then we will solve the problems. We don't want people getting into our houses NRELS homes as a center as an incentive to make money. It's a whole it's not a it's not an investment for them to make money on and buy and sell them that In real estate, at its worst, in my opinion, and I don't I don't agree with the idea of I do like the

idea that if they have equity in a home, that that's helpful for them. And if they want to go ahead and at a point in time, maybe 1015 years, 10 years after they bought it, they don't have to sell it for the same price. The only thing is, is that if they don't, if their incentive was to just go in and get a price, and then turn around, sell it make 20%. I don't agree with that. I think that that's wrong. Now, how do we enforce that or police that process? That process, I don't know yet. So there's a lot of decisions that need to be made, we want to make it for the best good of all people who are going to be involved in buying homes. And one of the biggest problems that we're going to find is that there's not enough homes for people to get into. And so it's going to be a lot of people are going to be going out into the you know, somebody puts a for sale sign up. And they would think they'd like to buy that house and they go and talk to the real estate people and say, I'd like to buy this house. And now we have a seller that's already prepared. If we buy that house, through the normal channels, then there's the person who can tell you what kind of colors they want on the walls, what kind of floors and, and all of the improvements and this sort of thing. And if they'd like landscaping, and that there's a person who's going to live in the home, who can make the decisions for all of the colors and things that people like to make decisions for. And I think that's a wonderful thing. I anticipate a lot of that. Now, then, are they doing all this so that they can buy or sell a house to somebody else? This is there a incentive? I'm not I'm not really sure we want them involved in our homes, we're buying a home, they're giving them that we're giving them a home, making it so that this is an opportunity to put it for them that they may have never had before. And if they abuse that, then it you know, what is it? What are the ramifications of that? I don't know yet. And so we're going to take a look at that. We'll create a NRELS Council. And we'll go through some of these things and determine, but at this time, we haven't done that. So the NRELS is, is floating out there. And yet, we're we're doing as much as we can to get it tied down to where it's going to be a functional thing, work for everybody according to the way that the alliance would like it to work out. So I hope that's good enough for now. But it's the only thing that I can say. Because if there are things that need to be changed, they will be changed to solve problems. So that's my real commitment to you. We're going to solve problems. And hopefully, it'll be in the best interest of everybody. So and some people might have a problem with it. That's okay. Where did you get free houses? complain about that? Oh, come on. Give me a break. We'll do what's right. Next question.

Well, I think that it's a good idea to collaborate. But he love won society, we've got 209 countries in the world level, and society has an obligation for all of those different countries. And we can't just be focusing on certain areas, where there are benefactors who are there making up their minds and doing the things that they would like to do as projects for their country, or for where they live, or that sort of thing. We'll see how that all goes. But there is a certain amount of cooperation, that's very helpful. And other times, it's, it's a, a process of people trying to make a decision for other people without giving the other people the chance to give their input. So you're, you're you're talking about some interesting things, I don't know what governments are going to be like, you know, keep in mind that every place you go, there's been a government over those people. And they have put out their way of doing business than the way that they would like you to build houses. Certainly areas are prone to hurricanes, or things of this nature. So they build the houses a little differently. And they and I'm aware of that, because I lived in Australia for a number of years. And we built a few homes, well, certain locations, you have to have tie downs for the roof. And otherwise, those are the kinds of things that are local. And local people want to be sure that they've got things taken care of. So we have to honor that to what degree it is, we get all kinds of fancy ideas about what we want to do. Maybe that can happen. Maybe it can't maybe there's water restrictions for building homes in certain areas. Those are all kinds of things that that needs to take place. I know that Africa has a huge aquifer underneath most of Africa, where you can drill down and a column bores over there. And why do these wells create these wells, and have the water come up and then you've got long growing seasons, you've got all kinds of stuff. And then during the wet season, it rains enough to refill the the aquifers backup firm up to the top again. So those are the kinds of things that we can get involved with, but we need to know locally where those concerns can be. And we will honor that. So always we have to go along with what's going on locally in the area so that it's not gonna cause problems. Just because we have money doesn't mean we can solve problems. Or we can create problems that can't be solved unless we'd have to be smart with our money. I think you understand what I'm saying. benefactor because I'm able to satisfy recurring financial. Now this is something that you're projecting now. I don't know that there might be circumstances. But that means that somebody in the financial system has failed us. And I don't think that's going to happen. So what benefactor may have done something wrong, that they're not going to give them any money anymore. Yeah, that's why I've said that love won society will be doing a double bonding for people. When I say that, we've got sufficient Zim to be able to function at a very high level. And so we're going to be in a position to do double bonding for all of the things that we have put in place. One of the biggest problems that The world doesn't understand, and especially these goofy gurus, if we go into let's take the IRS, the National Economic Stabilization, or this program where we do a lot of stuff. And, okay, we have a corporation, we we buy all the cars. And I've used this before Ford can sell 800,000 cars, maybe, let's see. And we go in and buy them all. And we buy them in the beginning before they're even made. So we have those. Now, when we bond that we're doing a 10 year bond, what? How do you do a 10 year bond, without putting the money in place 10 years before, or for a period of 10 years, to bond your participation in the contract. Well, I say them, you don't know what we're gonna do, we're changing the world, we're changing the way we do business. Yeah, and then all the rest of the mountains. The whole series, the whole structure. No, you're gonna have to have the higher rate. Okay, so this is my big thing for the higher rates, but that's exactly what I'm talking about. You have no idea what's going to be required. So in terms of the benefactors, if there's somebody that goes south honors, either love won society or somebody else is going to take over that position. Nobody's going to be it's so important that we can overcome the liability of it. If somebody passes away or dies or whatever, they miss out

on the med beds. I don't know what's going to happen with those things. But I don't believe that they're going to be something that we're going to have to deal with on our own love won We're involved with the Alliance, the alliance is involved with us solve the problems. Understand that that's the way it's gonna happen. We're solving problems. Okay, let's go to the next question.

I would like to discuss the eligibility age for RSS the eligible age qualify for an RSS is 18 years of age, what is the rationale behind a team, perhaps 15, or 16 is more humane so as to empower younger people a chance to live happily rather than work 70 hours a week in textile factories, labor in mines, or be forced into young marriage pregnancy in the hospitality industry? I was reading this earlier. And I thought, that is a great question. Because for the United States, you know, I mean, the kids are in school, and they graduate from high school when they're 18. But in other areas of the world, they use child labor. And so I thought that was a really, you know, interesting question, or valid question.

And, you know, as we change, as we go into this, we're gonna get counseling and advice from other people, from our counselors, they would better know what's going on in that particular country and identify those kinds of problems in certain areas that are different than other areas. And so we can change things as we need to, nothing that we have is set in stone, if it's causing problems, we didn't create these things, to set them in stone to cause problems, we came here to solve problems. And if what we are trying to do is causing problems, then we can change and will change. And it's going to be wise for us. And we'll have the ability to make the changes so that they will affect the right areas of where we're working, is maybe not every country has problems like this, we'll see. But, you know, I say something and people say, well, that's Ron said this and, and I'm, I'm thinking, Oh, gee, I better watch what I say, because they put these things in stone, or I give an opinion. And now all of a sudden, I have to live by that opinion for the rest of my life. No, that's not the way it's gonna work. So we're, we're adjusting as we need to, and if there's a solution to problems that, that make it responsible for us to change something that we will. Let's just be sure that we're doing things in the right way for the right purposes, not some kind of an ego trip that we're on or anything like this. We're here with the Alliance to do the things for the people. That's my commitment. You're gonna solve problems, if it's if it needs 16, or whatever, 1560. Because if we're not Zim benefactors, again, hopefully we're chosen, then we'll sign up with you to receive our ID numbers to be given out. So we then we can only just go sign up people everywhere and make money that way. Plus, they'll be

Ron Giles 24:06

Well, I think that your your, your project team, some problems that don't exist. When I say that we've got about 11,300 people that have signed up, that are being given the chance to change or to train to train for zim benefactor. My thought was, what percentage of those people are going to be vetted as humanitarians? And maybe you don't understand if you're not vetted as a humanitarian you won't get funds from the redemption of Zim bonds, or any other bonds. Even if you got historic bonds from Chinese railroad bonds, or Russian bonds. If you're not a humanitarian, you won't get those bonds funded period. Exclamation point. Let's say that again, if you're not a humanitarian, abetted humanitarian, if you're not a vetted humanitarian, you will not be getting funds through the redemption of Zim bonds or any other bonds. Period. Now, once the benefit the people who get these funds because they're that had humanitarians, then that criteria stops. And you can deal with people according to what you want to do. In other words, you are a valid humanitarian, you got the funds, not everybody you're going to work with is about that humanitarian, they will get funds from you and start doing the things that you want them to do. It's like a job. However, there's a whole lot of stuff that's going along with that. 86% of our 11,300 will be approved as bedded humanitarians. 86%. I think that's going to be true for quite a bit. So if you're not one of those, if you're not in the 86%, then there's some things about you that determined that you do not qualify to have the money. And I don't know what those qualifications are. I've not been given it. And that's why I say I don't want anything to do with the judgment of people as a humanitarian. I want them to come forth as humanitarian. I believe that most people who have Zim were inspired to get it, and therefore there they are, or where they go. So the reality is, is that if I'm not picked for a Zim benefactor, I want you to say to yourself, I am a Zim benefactor, because I am a humanitarian, I will be picked. I'm creating that for myself. And that's your heart knows who you are. You're going to find out if you have a question in your mind, maybe you're doing some things that are not appropriate to be considered humanitarian. If you have those kinds of feelings, and if you question your ability to be a benefactor, picked as a humanitarian benefactor. If you're if you have a question in your mind about that, this is more important than that whole question. Okay. Because if you somehow feel that you're not qualified, why would you not be qualified? You're coming from your heart. You're coming from Laos, then are you not a humanitarian? If there is some ideas in your mind? Well, I want the money. I want to be powerful. I wanted to be rich, but I'm going to pretend like I'm a humanitarian. So I can get that. Those are the people that are going to be very, very sad. So there's a lot of corporations that you know you I look at Ford Motor Company, and I also look at General Motors. General Motors is a terrible company. They're their people, their their their upper management are the ones who have caused problems. Many, many problems. Now, is that a judgment? No, I'm just saying that there's Ford doesn't do the kinds of things that the GM will do. Are they better cars? I don't. I don't know. Are they I just don't know those things. And that's where politicians, they the Social Security is this and this and this and they will the Social Security money, doesn't go into Social Security, it just goes into the general funds and it gets spent some other place. And somehow we have to have enough to take care of our needs. Now, we're not that disgusting in our abilities to keep on track. So all those kinds of things are going to be done over and gone over again, governments are not going to be that strong, they're not going to be that that financial, they've only got a certain amount, and they can't go and borrow money to pay for things they're not going to do that just aren't compliant is is where everybody is paying their their bills, and doing things appropriately. You don't have money for a war if you don't have it in the budget. Whoa, that's a that's an interesting sort of thing. Now, we're not going to have horse we're not going to have those kinds of things. Up in the pieces, the responsibility of the government, not to build roads and do all of that sort of stuff. We can do

that. We will be doing that. Governments will change how they will change. We'll see. They're going to change within the next 510 years. They're better be changing. because they're going to be working on sales tax. That's their income. So they're going to get rid of they have to get rid of a lot of the garbage the that's in the government. We're not going to have all of the stuff that the cabal thinks they need. Things are going to change with the NESARA GESARA all over the world. It'll be fun. No, no way for universal basic income, whoever's wanting to do that. Nice idea, but it's very, very. So there's some stuff in there, that's hard for me to understand, because you're getting that from somebody that doesn't know what they're talking about. Yeah, I can do that. gold backing, the the gold that is used to back a currency has to be identified and cannot be taken away from where it is and sold. That's the difference between gold backing and the gold standard. We put money in Fort Knox. And the alliances are the feds come along. And they give the loan to the country and they have to pay it back the pay the interest in gold. And as soon as the gold is gone, then they foreclosed on the country. That's not the gold backing that we're talking about. Now it's the gold standard. That's why Nixon was able to mess us up so badly. In such a short period of time. Gold Standard is not a secure way of having a financial system. Go back he this is the way it's happening. So all of the gold that's going to be used is put into a system. It's like a library. Each one of those gold kilos has a serial number on it. The Alliance has created a digital gold certificate. That's digital meaning it's got a bunch of information about it. And in that information, it refers back to the actual gold that backs that particular currency. So if I take a digital gold certificate, and I'm able to figure out what's going on, I can take that. And I can go into the the vaults that are like a library system. And I can go through all of the different locations and I can find the exact piece of gold that's backing that currency.
