Okay, in regards to setting up a trust in the back office, once I've inputted my info in the trust, do I have to notify someone that I now have a trust and wish to receive the 10 cents download for that trust? If so, who do I notify, and who downloads the 10 cents a minute for the trust?

Ron Giles 00:39

Okay, when you decide you're going to you're you're already signed up, you're a beneficiary, and you have an account, and you know, that you can do these trusts, where you take the trust, fill out the document, give it a name, and put the \$10 down in the registration or the word, you're able to start on the RSS platform. And that will, all you do is just sign up and put your thing your information. And there it is. And you can do that, obviously, six times, just pay the truck, pay the fee, and, and then it signs it up and and then it starts at 10 cents per minute. As far as the trust is concerned, it is a trust, but you do not register it. You don't even have to tell somebody about it. In this particular case, the Alliance knows what you have done and you have initiated and began the trust. So as far as we're concerned, we just simply accept the fact that you have done everything you need to do. So if you're going to be set up a trust, and you have not done it correctly. If you didn't do it correctly on your own, then that's that fraudulent. But if you did whatever you can, and there's some things that are missing in it, it doesn't matter. So don't get all upset or worried about it or concern. But there's nobody's going to review your your trust, it's not going to happen, we're not going to do it. And I believe I don't believe that anybody from the your, your counselor might have some ideas about it. But other than that, there'd be nobody else involved. So you don't have to do anything other than just do that. And it's signed up and registered and away it goes. Next question.

there's nothing you need to do, you just act it you're just activate whatever mean? Here's, here's the money coming to you for the trust. If you're the trustee, there's somebody coming to you and you do certain things for your children. Once they turn 18, then you don't do those same things anymore, because they have fun to come in on their own. And then they can you can teach them how to do the truss or whatever you want to do. So, but once they minor reaches 18, they get a chance to sign up themselves. and away it goes. Oh, be sure that you're careful with this. It might be that you could do things and get by. But if it's not actively propriate, and you're doing something that's not appropriate, you're going to have some problems with the money that you get with that, when I say you're going to have it comes in a blessing fashion. If you've done it correctly. If you've not, then the money that you think is is going to be helpful for you will, could even turn out to be a problem for you. So it's always best to do the right thing, always best to do the right thing. And do it properly. And don't try and and and make it different than it is. So once you've done that, then that's that's there's nothing more that you need to do. Again, just release the 18 year old it goes into does his own stuff and now you get to keep all the money or do whatever you want to do with it. It's up to you anyway. Okay, next question.

So my my impression, there are my determination there is yes, we'll have we'll have videos that that take care of that appropriately.

Oh, okay. Cool. Okay, next question. Well, we have a chance to meet you in person, just wondering if we could get the chance for a big hug.

Ron Giles 06:05

Well, it is going to be interesting. I'm just one person and I, if we have an organization, or we have some meetings or something like this, that I would like to attend. I'm a huggy guy. And I have no problems giving people a big hug. So I would be more inclined towards that. Unless it was a big to do and I'm not sure that I I would rather just have as I say that, I'd love to hug people. So let's just say it that way. And we'll go from there.

Okay. All right. What is a low rate given you say go for the higher rate?

Ron Giles 06:56

the higher rate is, is at least \$500,000. That's what we're saying and recommending as the minimum. Now, if you have a 100, Tino, just one and ask for the higher rate of \$500,000, per Sam, and you're going to have 1.25 quintillion, every quarter, you're also going to hit that will be equivalent to five quintillion every year. So we're not talking about a lot of money here. I mean, we are, but we're not getting up into the Maltese. So you're getting into the quintillions. But you're not getting into the scepter billions, or the sex aliens are set to aliens, or some people are going to ask her more, it doesn't matter. The Alliance, they're not going to when you say when you get up into those higher rate, if you've got a bicentennial is something like this. By Sinn tealium, then you're you can ask for a million dollars and you'll get it. The money is not the most important thing, but the fact that you're getting the higher rates means that you're positioning yourself to do more than the others who have not got those extra those rates. So what is the lower rate? Well, I don't know anything below \$500,000 is lower rate. That would be somebody's asking for it. Now, if you were listening to a guru, this is a thing that I really want people to know. A 100 T note. There, the gurus are offering somewhere between 11 and \$33 million for one of those. If you want to be a Zim benefactor and you want the the higher rates, then get yourself ready for it. Is it available? Yes, it is available? Does the Alliance want us with 33 million per 100 keynote? Or do they want it with 500,000 per Tina? out Pertino that 500,000 per Zim for one letter, Tino. If you, if you don't prepare yourself the right way for this, then it's going to be very sad for you, if you are listening to those who don't know, what the hell they are talking about, and they don't. And they're trying to keep away way down so that you don't get your money that you can do good humanitarian work with. So just understand they're trying to stop you from getting what you can get. And if you let that happen to you, then you're gonna get 11 million per 118. But the problem I have with that, just that concept, or the hell will you go for that it's not the alliance, the alliance will not participate in that. So these gurus that are saying that sort of stuff, are telling you to do things that are not appropriate, and therefore you're going to go someplace and do something and try and get make some sense out of it. But it doesn't make sense. Don't get away from the girls. Get away from the girls, quit listening to them. Don't even listen to their daily parroting of other people's ideas and concepts. Can I use the love won Society program to be involved in supporting local councils and to build up the infrastructure? Or do you think governments will have enough money in their hands coming from Vat or new product tax to cope?

R Ron Giles 13:31

Well, VAT Value Added Tax, they're not going to tax you anymore. They have a sales tax. That's the government's only source of income. Yet that mine, so any of this other stuff? They have no way to tax you. Now, are we going to help them out? Yes, we can do? Can you help those people? Yes, you can. If you feel you'd like to help out the government to maintain their programs, as they watch their thing, their income tax go away. Just simply goes where they don't have it. There's no way for them to spend it. But keep in mind. Every government agency that has a corporation's structure behind it is simply going to go away. That's the that's the country origin. It's the each state or province whatever. Or every city and county and whomever is functioning as a government agency at that is called a corporation. All of that goes away when the NESARA is in place. If your city government is not just Psara compliant, and your country is compliant NESARA compliance as far as compliance, then that company is out of whack. And I would not be supporting them at all, until they have allowed themselves to become your Sharia compliant governments. And that has to do with every level of government that is available for people, corporations are gone. That's just, you don't have a government. That's a corporation anymore. But how do we access a reasonable figure of support? When there has been no real previous years of crop profits? Do we simply go to the most recent figures? And do we work more closely, maybe every quarter to support them?

### Ron Giles 17:08

Well, it depends on how willing they are to be involved. If they're interested in changing, then you can't force farmers to do anything that they're not ready to do. So you've got to come in there with an attitude that you're there to, to help them to get through to a new way of growing and, and planting and harvesting. If they've if they're been growing grass for people, and that's that there's nothing wrong with that. I think anyway, in my opinion, why our crops more important than the last on your grass on your farm, or on your on your side, or on your lawns. So I'm just trying to think about what you're asking. We're going to be in a position to do things. And we don't know how to do that yet. Because how do you know what to do with a farmer? How do you really know how to help him? You're going to have a counselor that really knows how to do that. This is a kind of question that doesn't really have a good answer until we get there. You know, I'm asking you there's a there's a bridge across the river over there. Well, we don't know what the bridge looks like. Maybe he's gone through another storm has been washed away. And you're thinking well, I mean, again, come and get across there go across there. Well, you may not. That's just the way it's going to be. So you make the decision when you get to where you are. And you assess things and look around, and you do the best that you possibly can to help the farmers. But don't go in with preconceived ideas and notions that you're going to save them and they have to listen to you because you know everything because you have the money. Don't be a fool. These people know what they're doing. They just need a hand up and a leg up whatever you want to call it. And so you start working with them and providing the funds that they need to do the whatever is necessary. So you're going to find out the best way is to wait until it happens. Next question,

## Tracee Gluhaich 19:47

I add something to this one since you know for me it is very near and dear to me. Okay, so I think what they mean by this is that, like I know in the US the Bill Gates and you know that that whole agenda they've been paying farmers to destroy their crops. So I'm assuming that in the UK, they're having them grow grass instead of crops, and so like to create this food shortage, okay. Okay. So what I would do if it was me to answer your question, I would say go back to before they started growing grass, figure out those numbers and find out what the incentivization is that they are getting paid right now. And then that way, you have a base point that you can start with so that you can offer them more than they're getting paid for this instead of bullshit, oops. And give them a little bit more than that. And tell that I have a potty mouth. Try not to most of the time, but this stuff really, really makes me mad. Especially in

California, because they're dumping our water into the bay, and then they're not giving the farmers their allocations that they need. So they've created dust bowls, where there used to be beautiful farmland. So it's a big problem.

## Ron Giles 21:14

Well, there's keep in mind that those kinds of people don't coexist with happy people. If they're trying to do something like that, then they'll go away. Because they won't, they're they don't fit with us. Much of the stuff that we have, if we're changing over from one grass to crops, or something has to do with the equipment, and how, what, what the farm equipment that you've got to have Reapers, all that sort of thing. And sometimes you have to have some people to come in and help pick the crops. It's all, you know, you'll find out more when you get there. And that's the point that I'm trying to say. Because there's, there's stuff here that has some openings, possibilities of things. And yes, you can, you can open up and give grants for trucks or tractors or whatever. And get them in a different venue to where they're growing food. And that's good, it's not a hard thing to do. So we're coming from our heart, but we're going to sit there and understand that, let's work with them, not tell him what to do. He tells if you tell a farmer what to do, he'll invite you to leave. And your money is going to be wasted your waste of time, because you're trying to buy yourself into a position to help somebody. And if you go in there with some reason for doing it, and it's not appropriate, then you're not on the same sheet of music with him. So we want to be sure that we're asking and, and working with the people and asked what they want. So that they need, you know, they may not have been told to do what you're assuming they're doing. So let's just find out what's going on, find the truth of things and then see how we can help out. Because many times, they're waiting for something, but if we come along and and start telling him what to do, they're gonna have some problems with this. And this isn't obviously obviously, this isn't all the, you know, everybody's like that. Let's just be sure that we're not crossing dominions, meaning that we have the money so we get to judge you, and do what we want to do with it. To some extent, we can do that. But are we in happiness with everybody else? That's a problem. And I think sometimes we might be on the wrong side of that track. We're gonna learn real fast. Just make a few mistakes, and then we'll solve a problem. Next question.

Okay, this may be a duplicate question, which it is, after becoming an RSS beneficiary when the sponsor is different due to the employment contract, can I change the sponsor by placing the employment contract as the number one priority? In such a case? If there is such a system in QFS or if there is an emergency contact network between sponsors, it would be easy to change sponsors. What do you think of that?

## Ron Giles 24:45

I don't think you can change sponsors. I'm not sure what you mean, when you say sponsors. If you've got a beneficiary account, and your money is going into your account, and you're able to spend it and somebody comes along and offers you A contract? Well, the way that you get paid is through the, the individual, let's say, benefactors master ID number. And the computer follows the master ID numbers. So if there's a way that the you have a contract in your

account, and it's being paid by another person, that computer will automatically do that at a different level of, of accounting, then you're totally aware of right now, it's just simply going to be taken care of. So if you do have one of these accounts, that are separate from your beneficiary, and that account means you have a contract, then that person's master account will come through and they will pay for that. Now, I'm not sure what else you mean, where's the problem? Why would you want to be changing something? If you can't change it, you saw you sign the contract beneficiary account is for the person who whose chain your end chain of beneficiaries you're in. So I'm wondering, in my mind, where are you coming up with the idea that you can change number one? And number two, why would you want to change? The money's just going right into your account. And you can enter, it doesn't matter whether it's from one zoom benefactor or the other. It will show up into your account, and it will be put into your cash report box. There it is, that's how much you have. So from there, we'll have some other things to do. But we need to do things according to the way the plan works, when we're in the plan, but right now, things are a lot different than they will be, we know that. And so we're going to make adjustments as we can. And when the time comes, we have the money and everything's all put in place, then we start working and doing a very good job with him. So, again, there are things that we're going to have to adjust. And when we do, it will be because there was a problem. So we found a solution that works for everything. And that's what we'll be doing the whole time that we're working on our humanitarian stuff. Let's go to the next question. Okay,

Tracee Gluhaich 27:38

I am an 86 year old widow and disabled, I have no way to get to a redemption center to redeem my Zoom. Do the Alliance representatives do redemption meetings in homes?

Ron Giles 27:49

I don't know if they will or not. I really don't. Obviously, for you, that would be perhaps even the only way to do it. But you are and you are if you're a humanitarian, they'll get you to where you need to go. And it may be that you get to have your redemption appointment in your own home. Let's just say let's leave it up to the alliance. I can't speak for them. And especially on a personal basis like this. But I can't see, I can see a way for that to happen. Let's let it happen. Whatever way the Alliance wants to work with you. Next question.

Tracee Gluhaich 28:40

And I always say asked, because if you don't ask the answers always no.

Ron Giles 28:46

Well, it's assumed to be no unless you ask me oh, well, yeah, we can do that. So always leave it open.

Tracee Gluhaich 28:53

On a recent programs Q and A session Ron meant to support our own humanitarian project efforts, and therefore I assumed it included employee contracts. I'm feeling a little frustrated after spending countless hours designing each of my projects around the LWS system, I thought was in place for me as a humanitarian only to find out now, I won't be able to pay my team's using the RSS and employee e contracts. My question is can you please reconsider the utilization of employee contracts for your own humanitarian projects?

Ron Giles 29:48

I would like to ask you just one simple question. Who told you that you can't do that? I have never said You can't do that. You're you're taking the program and somebody's saying, I don't think you can do that. And then now you're you're up in a tailspin, you don't know what to do. I never said anything like that. And for people to put that out there as if I did is absolutely incorrect. That is, employment contracts are the basic way that we work besides the beneficiary accounts. So what you're asking, what you're saying is, you've listened to some wrong information. And there are now up in a tizzy, because it's not gonna let you do what you're planning on doing. And I'm saying, you're planning on doing that, because that's where it was supposed to be? Whoever said no, gave you some bad information. So when you want to do your beneficiary accounts, in the CAC, or whatever, you can do it, we're not here to tell you that you can't do it. If you want to do it, you will do it. And you will have every thing available in our love won society programs to assist you in your humanitarian work in your projects. That's why you're with us. That's why we're here. So don't listen to people that are saying things like this, because it's totally wrong. Totally wrong. And your understanding is totally right. So everything back in shape. Next question,

when you have when you have somebody that decides they're going to get involved? And they don't have a real? You might be somebody's already in the business? Somebody who's already in the business knows about all these things. Very seldom would they have any understanding of the Alliance. You have bonds that are valuable. But who's going to who's going to pay them who's going to redeem them? You take a Chinese railway bond. That's it. Most of their bonds aren't Chinese railway, or ancient. They were put out there by people who no longer exist. And so the only people that are going to come by and help you with bonds are the Alliance. So I don't know what this individual is and why he thinks he's in control. Because he's not if he's, if he's part of, you know, just one of us. The Alliance doesn't use people like this. And say that straight. They come on here, and they say that they're, they're the ones that are in charge. Well, I say, Okay, go over there and, and stick your head back in the ground. And you can see if you can grow a little bit, because you're not part of our program. You're not part of what's real. We're talking about real money here. We're not talking about somebody who has absolutely no control over it. There's no position for these kinds of people with the Alliance period. And so somebody comes by and say that they're, they're the global master contract holder. Oh, I'm really happy for ya. Go get over there and leave us alone. We are controlled, we are responding to what the Alliance tells us. And you're thinking that you're in charge. There's nobody in charge of the money except for when you go into your appointment. And you are there with your assigned individual who is your contract or is your counselor that's the way the alliance is set it up. Where in that whole venue. Can you have somebody that's the global master On Track Kohler either Ellis you know, I woke them for listening. But, brother, you're preaching the wrong gospel. There's no gospel according to you, period. You're not You're not qualified to be in involved. Now, no, I would just simply let that go. Because I don't know anybody who is in charge of the Alliance. Yep, Jesus. Next question

## Tracee Gluhaich 35:33

I have a lot of notes, and I have given a lot of good people the possibility to become members of some note holder groups and have them all organized without any financial gain for this, how will such groups be handled? Will every member of the group have a meeting or only the chosen representatives of these private groups?

## Ron Giles 35:58

Okay, what's your shoe? What you're asking is there are people who can go in and redeem notes for other people? Is that what I'm asking? Is that what you're saying? If that's the question you are given as an individual, as a person, you're given a stewardship responsibility from the Alliance. If you're trying to redeem bonds for somebody else, then you're in the totally wrong position. Because it's an individual, not a group, not one person can be reached, redeeming for other people, that is fraud. Because only humanitarians can have these funds. And they have to go to the meeting themselves, and get the funds when they asked for the

rate. And so everything that we have said, This is not part of what we're doing. So when you have a group of people who are saying, We will redeem for you run with your Zim bonds, or golden bonds, or whatever, somewhere else, because these people are frauds. If you get involved with them, you're gonna have that font, you're gonna find it out real quick. You will sense it and you're saying, Oh, what the hell am I doing here? I'm personal. I'm not going to go with anybody else. I'm going to go to the redemption appointment, I'm going to take my exam and everything that I have, and I will be redeemed, I will get a structured payout payment every quarter or every year, whatever it is, whatever I've asked for these people who think that they can get somebody else to do all of their work for them and get go in and get redeemed, and then give you your money. Unless your if you do that, then you're you're making a contract. It's not it's not legal. Because the Alliance won't do that. It's personal. There's nobody else you're trying to go in with somebody else. Did they are fraud. Now, how is that too? I, you figure it out yourself? If you're not a humanitarian, and you've given to somebody else, you're exempt to somebody else. And you're sitting back saying, Oh, good, now I can get my money. Well, that person has no, they can't tell you what they got. You may it's a fraudulent situation, the alliance would not permit it. Those who say it that way. The Alliance works with individuals, not for groups, tough. Tracy wants to go in and get money for her husband. Well, she can go in and she can redeem herself. And then if she wants to include her husband in with all that she's trying to accomplish, then that's her stewardship responsibility. But if she's, he's giving her them so that she can go in and redeem for him and then give him a certain amount of money. It doesn't work because if he's not a humanitarian, he's not entitled to the funds. Okay, that's by that's the way that they Do things now. If you if he doesn't have them on his own, which he doesn't, I don't think, and he's not having you do it for him. There's the there's a kicker right there. You can't you've got, you're not going to get the funds unless you go into the appointment yourself. So I'm talking around a lot about it, but a tell you, these people who are gathered together with others who are going to redeem for them, you'll find that the alliance will not participate with those people. And where are they going to get their funds from? I have told people this time and time and time again. If you're not going to go in and get the funds yourself, then you'll just have to sit around and wait for opportunities from the people who actually do get the funds. And then they might work with you. But you'll find that there's a counselor for those people who go through the appointment. And if you're one that's not it, I'm just looking at so many different things that are messed up by people joining together, you know, you might go in with your husband and you you know Tracee is a humanitarian, her husband, probably is but he doesn't know about it. Yeah. Well, there's an opportunity to for growth and development and working through things. However, there's people who know that they're not humanitarians, and they want to go give their, their Zim bonds to somebody else. And they though somebody else are going to redeem for them with an agreement that the person is going to give them money, personally. And the point that I'm trying to say is, first of all, your your funds, your redemption, funds are going into the structured payout system. So you're not going to get the funds because they're not available to you. So there's so many counter measures that are involved in you doing something for somebody else. I just, I wish I'd had this question beforehand, I could do it better. But I'll tell you, this is going to be a serious situation. Now this person isn't really with us anyway, because she's still looking at the 800 numbers, or some other communication, let them know how or where to redeem.

#### Tracee Gluhaich 42:48

I don't know if you're still accepting questions, but in case you are I'm wondering about friends and family who have humanitarian intentions have currency some have Zim some do not. And are still looking for 800 Number emails or some other communication letting them know how

and where to redeem. Do you have any information for these people who are too drawn to LWS? I'm gonna guess not that word right there is you're not drawn to LWS. I would just point them to LWS because clearly they're listening to other gurus.

## Ron Giles 43:25

Yeah, and it's, it falls, you know, I just have to simply say, I don't know have given you the love won Society Program. You're gonna go in there and you're going to redeem your bonds and you're asking for a specific rate, you're going to get it. If there's somebody else who hasn't gone through all that they won't get funds. If your love won society, then come with us. If you're not, then don't pretend that you are because you will fail in your responsibilities as a gym, benefactor, or Zim holder to get become a gym benefactor. You've got to do it yourself. I've seen this problem problem. If you can understand how frustrating this is. I just simply say, I've got it all in there. QFS2020.com. Is your ticket to getting in to the redemption appointment. And knowing what you're doing while you're there. And if you don't do it that way, I can't help you. I can't. I don't need to even speculate. Because those who are following what I have asked will get their funds. If you try and go around it in some other different way, you're going to have some problems. Let's just leave it at that. Next question.

### Tracee Gluhaich 44:52

Okay, so let me just clarify for this person. Like they're trying to point them away from that their, you know, family or friends away from that to something else. That's why I answered right away. Because that's actually how I found out about all this, you guys, I found out. I didn't know anything about anything until I found Ron. And so that's all I knew. But everybody else, you know, finds different so. Okay, I'm gonna move on since we have 10 more minutes. Do I have to check telegram to find out when these live events are listening to the questions though, I think my time is better spent listening to the recorded version. I do appreciate you constantly taking your time to repeatedly drill the same information. So that we have an army of humanitarians hasn't been created yet to identify areas of CAC, if so where do I find it to add in point of reference?

to apply for approval. And he sent me the info and I said, I think I may email this out, what do you think? And he said, here's my concern, and it is shared by others as well. Of late, it seems that people are coming into the chats by just being forwarded the telegram chat link without having gone through the qf s 2020 website and evaluated and decided for themselves whether they would like to be a humanitarian. They then arrive on the chat and see all this information thrown in about spreadsheets with vast sums of money, and then start asking questions. And of course they want to join, they then start posting questions that have been asked time and time again. It also takes up a lot of yours. And Ron's time because the questions are very repetitive. And I find myself skipping past a lot of the questions that had been answered ages ago if only people had bothered to go through the material. So back to my point, I do want to be very careful about people who are able to access the map, and have even considered taking an extra precautionary step of removing those who have not posted on the forum but only want to see the map. Both chats have been infiltrated by bots. So I am cautious about the information I give out. Another reason I am extra cautious is because there's no way I can verify whether anybody who comes into the forum is a member of Ron's email list. So any one including a hacker could register and get into the forum, if they discovered the address or have someone in the chat, send it to a friend, or if a person's phone was hacked. That is the reason I changed the security so that a person would need to know at least the basics of LWS. So with all that said, Ron, my thoughts after reading that from Francis this morning, would be that after the RV and after the benefactors or whatever, you know, send in their proof of funds to LW s then we can start building that map again.

And the best way to do that is to just simply ask, we need to work it out so that if you have your referral card, your referral letter, then you are part of the program. If you're not, then you're not. And so let's just not let anybody in on that map. Otherwise, it's it's totally irrelevant. And I don't want that. Nobody wants that. So I'm hearing with people inappropriately, if you if you have shared our website, our Telegram, our single source telegram with somebody else who's not really involved with love won society, then shame on you for all of the crap that you're causing for everybody else. You're opening it up to other people. And they come in and they they're the

ones that are causing us problems. I didn't know that. If you're just simply giving the the chat or the chat as a link to our stuff with people who are not part of us. Shame on you. You're not part of our team. Wow.
