Good morning humanitarians Institute Rothschilds. I'm here with Tracee and we're going to do a q&a today. The date is Wednesday, August 10 2022. So we're excited for this. Let's go ahead. Tracee.

Okay. Ron, I wanted to know when it's time to pay the people in the RSS program and the employees in the CAC program, how will this work paying these people on a weekly basis, when our accounts are in the queue ifs?

The RSS program has places for your contracts. And that's the best way to pay the like, imagine, you're not worried about it, they're not worried about it. If they need some money for a moment, then they can go in and download the money that they have, you don't have to wait for a check. So this is, in my opinion, this is the only way to pay your people, period. The only way? Next question,

do I have this correct, a business owner can be signed up personally with an RSS account, a director can also sign that person's business up with an RSS account. So in effect, that person has two RSS accounts with 12 trusts, in addition to that director gives that person in his employees employment contracts to stay in business. So the business owner has two RSS accounts 12 Trust and an additional employment contract download. Is this correct?

Ron Giles 01:25

Okay, well, yeah, no, it's not. Where did you get the idea that, uh, that a business owner gets a personal personally with the RSS account, which is a beneficiary account, they have to have that in order to get a contract, the director comes in with a contract and signs them up, and that goes into their back office of your personal office. And, and it's a different accounting portion of it, but it all comes out the same that goes to the same place where they have a total of what they can dry out. So the contract that they're gonna get is in addition to the beneficiary account, but they're not to beneficiary accounts. They can get the 126 Trust for the one that they don't if their wife signs up, and they get six trusts, but we're not giving them six trusts because they're only beneficiary trusts. They only for beneficiaries, not as a result of a contract. So I hope that helps. Next question

The national real estate listing service is not the only place to buy properties. And so we're interested in not first, we're not interested in second homes for these people. We're interested in their first home and if people want to get a second home and they've got the money to do it, then go ahead and talk to brokers or whomever you can use the brokers that got you into the home. That's okay. Because that's the work that they do. However, we are not interested in second homes for people. There are 1000s and 1000s and 1000s upon 1000s of people who have never had a home. Those are the people we're serving, not those who want a second home through this program, period. Oh, I don't like that kind of greed. And they're gonna say greed, and yet they don't understand. And maybe this question is a little bit misunderstanding as well. So we don't have real estate brokers within the CAC were within the CAC areas perhaps, but real estate brokers within the CAC not sure where you got that idea. And maybe you're just trying to say NRELS. And then then it works. But we don't have brokers in the CAC, specifically brokers for doing things. Next question.

Well, it's not a it's not for each individual benefactor. It's not for each managing director to start going out and purchasing banks, that's not the way it works. If you have a lot of money, and you have an interest in there, there will be a time when the alliance will ask for those who have an interest in becoming part of the financial services industry. It may be that required from the alliance that you're embedded, and you have the money to do that, just like it is with a love won society. This is major, not some small thing that those who don't have experience can do. So it's just allow it to unfold. But I would not be getting myself geared up to purchasing banks or anything in my own service in my own area, or any other area. Because the quantum financial system or the excuse me, the the alliance is in full charge of what's going on and they will allow us to participate will allow without our participation, it won't work because we have the money. So let's just let things germinate and let them fall out. You have an interest in becoming a person who is assisting in the financial service centers, and you would like to be a part of it. That's all you need to state now who listens to that? Who listens relations sent to your home and your house. And this is what we'd like to do. who's listening to that? The alliances and especially the Alliance agent, that will be your counselor. Your name is on that list, but you have to put it there as in I want to put my name on that list. You're asking two things here. When love won society has been activated into the quantum financial system, the quantum financial system will not I just really want to make sure that everybody understands the quantum financial system is not now functioning as a financial system. It's like an accounting ledger with books over there. And those books have not been activated. There isn't one digital currency, one piece of digital currency that is active in the quantum financial system. When When did they have a final price for gold so that that digital gold certificate that's going back to that kilo will know how many key how many digital gold certificates they can have for that one kilo that hasn't been laid down. No, no, the Benefactor managing directors will have their on their map, but you are not available to contact them. Unless they give you permission. Period, you're jumping into somebody else's domain. And that's trespassing. And let's just be sure we understand what trespassing is because we don't do that. The higher levels of understanding and they those on the other side of the veil and so forth, they do not cross over into somebody else's domain yet. If you wanted to fly to some star nation and the universe, you have to get permission to go there. Otherwise, you're crossing domains. So you're not going to be given I'm not going to be giving out anything. If you want to contact him, then you have to ask them, I don't know how to contact them without to ask them to ask if you can contact them. That's the reason why we're not doing a lot of people are not doing it because they think that they're being compromised. So no, there's no, there's there's no way to do this, unless you know who they are. And if you're waiting a reasonable time, what is reasonable? I've been working on this for six and a half years. I thought it was going to happen a year ago that I was ready level one society was up and able to run and function and then somebody said, Well, you need to share that with other people. Well, we're doing that. And we're showing away for other people to become compliant with the Alliance's plan of redeeming Zim. Couldn't happen till now. So I hope that helps. The reason I can talk to you the way that I do is because you have signed up and you're in training, and it's my responsibility to help you to get there. Otherwise, I couldn't do it. One to One on a level playing field as far as the QFS is concerned, yes. But one country has a certain amount of gross national personal product or income. And we have to be sure that we're not causing problems within that country by us downloading a large amount of money to people who have never even thought about that kind of money. If I if I'm used to making \$20 a week and then and in Africa, that's possibly what it is. I don't know for sure. Even if it's \$100 a week, and I'm giving them \$1,000 a week. And then they can go and get trust and come up to \$7,000 a week. We're going to blow people's minds. think this thing through? It's a nice question. But you've got to think through what's what's real. And what we're going to try and

do with the funds that we give them. It's got to be appropriate. We have to go with the training of how to help help people with our wealth management or wealth education programs, we have to do things appropriately in order for us to function in harmony with the Alliance. It's all going to be in an alliance harmony with a live harmony with the heavens. So there's the other issue that we're not going to really address. But that's the prosperity packages that are associated with SR are supposed to be giving billions of dollars away. Is that going to happen? I don't know. Ron Giles 25:20

It's a good question. That's part of the love won industries program is introducing hemp to farmers. There are some really good people who know how to deal with him. From our perspective, hemp has not been around for a long time, trickled down to Kentucky, they have hemp farms, not a lot. They have hemp farms, and the money that they the currency that our dollars, the actual paper is made through there. Those are hemp dollars. Hemp paper that uses is used for dollars, because it's where so well, well, those people have a real good idea of what works and what doesn't as far as the growth of, of hemp plants. So there's a place where these, this information can be found. And there are those that I'm aware of that are fully engaged in the hem process, and are working out all of the details to try and get. So when the money comes in, they're well on their way. And what they've done, or what they've shared with me is I think is marvelous. So hemp farming is going to be worth worldwide, when but it's not a responsibility for loved ones, it's tiny. Ours is structures that can be used for that. And it's going to be interesting to see how that how quickly that goes all over the world. Let's start here at home first with what we can do. Other countries are going to be very much involved, we'd like to be very much involved. So we have a void of hemp products right now. What we can get an overload of hemp products and not have enough food. So there's things that have to be balanced out. And we've got some good people, I'm sure that we'll have some good counselors coming down and helping us to do the things that we need to do. Next question,

That's why we went to three levels in the organization. And when there's 10, people sign up, you get a point. If you take away the, the desire to help people, by just being signing up the minister, and

then he's got his board of directors and who and then they started on and on the church, all of them make all of the money off the church, and the guy that introduced it gets a one person. And so it all depends on how they work it out. And that we've designed it for somebody to introduce it and start being a part of it. But if they go so many levels, and then finally sign up a lot of people then, you know, what do you say, really people? I mean, we've tried to help that person and have an interest in getting out into the people. But if you've got so many people that are getting involved, I mean, the minister, he's going to be a beneficiary, he's going to have \$26,000 a month, \$28,000 a month. If he's married, he has a wife, they get together get \$56,000 a month. If that's not enough for a minister, you know, there's a lot of churches who have no ability to give that kind of money, obviously. And so we're coming along, I hope that they don't be really greedy and take it away from the people who are introducing them to us. So that's my, but it's, we have really nothing to do with it. I just watched Alan's video on ECA for florist explaining the bokeh, and the ECA advantages for small businesses. It is mentioned in the video that a director can double A business owners income over a period of time to the tune of 27 cents a minute. However, since the business owner is already an RSS beneficiary, he would already be making a grand total of 70 cents a minute. Would it not be a better incentive for the owner to sign a contract for at least 70 cents a minute, in addition to his doubled income amount, instead of the 27 cents a minute. Ron had mentioned in a previous q&a that we should at least double the RSS income of 70 cents a minute and add a 70 plus cents a minute in a contract so as to keep the owner motivated to stay in business. That's much more motivating than 27 cents a minute we have the money let's keep spreading to the masses. What are your thoughts?

Absolutely correct. You know, here I am thinking well, we've we've got 10 said Some minute, forgive them 25 cents a minute, then they'll really do well, whatever times as much. And Dong, I didn't realize, I know, I know, on one level, I didn't equate the other six trusts and this in the 10 cents per minute per each one of those in terms of what the value of a beneficiary income is going to be. And so I really have had come to Jesus meeting on this one. And I said, if I'm, if I'm working and having a business, I'm going to give a value a beneficiary value of 26,020 \$8,000 a month. And if that's true, then why would I give a Why would I sign a contract with you for 25 cents a minute, when I'm getting 70 over here. So all of a sudden, I said that person that that business owner, you better be given him, I've always said double your income. But let's just be sure that we understand what his income is. Because he may be getting just a little bit of income out of his business, and you're giving him a beneficiary account. But you want him to stay in business. So if you're going to give him 25 cents, he's not going to stay, you know, I'm sorry, I'm not gonna I'm not doing. But if you're giving 70 cents a minute. If if his income is not more than that, if his income has doubled, and you and it's more than the 70 cents, then give him what it is. 70 cents is not a sacred number. For any of you. In my opinion, when you're a master director, excuse me, Managing Director, when you're managing director, and you have from the old ideas is 1.25 quintillion dollars a month, you've got to get rid of that, or put it in that bond account, your first, you know, year or two, you'll be filling up that bond count with a lot of money. And there's no reason to be skimping on things really is no reason it's money that's been put into activity. 1.25712 quintillion needs to be put into active use. And so there's no reason to skimp let's use our mind, let's work it out. If I'm going to go up to the I'm gonna at least double what he's getting now with the beneficiary account. And then he can have all the money he wants and makes and I'm taking away his labor costs, I'm taking away all bunch of things. Let's just be sure that the we understand that we have the money to make it worthwhile for anybody to work, just make it worthwhile. 25 cents isn't gonna cut it. 70 cents may not cut it. We'll see how it goes. Okay,
