Ron Giles 00:00

Hello humanitarians. This is Ron Gile. I'm here with Tracee. We're going to do a q&a and today is the first day of August 2020. So we'll go ahead and start with number one, Tracee.

Okay, if Love won society is planning to appoint continental regional national level ambassadors or representatives or directors to oversee or monitor the work to be carried out by Zim benefactors across the globe, is there any accountability mechanism?

Ron Giles 00:33

Well, we have never said anything that we are going to do like that. The concern that I have with all of this is that loved one society is a structure that people can use to enhance their humanitarian efforts. Other than that loved ones, society is not in some kind of a position to monitor anything, because I have my own stuff that I'm going to do. I'm sharing this with those who want to do it and enhance their humanitarian efforts. But beyond that, there's no reason for me to be involved. So are you or somebody else wants to do something about it? Then they came and asked me, I'd probably say no, I don't think that's appropriate. I don't want people in control of humanitarians period, not one over the other, not husband or wife, whatever. I want each individual to have their own responsibility, their own stewardship responsibility that they are going to be judged for as far as God is concerned. Why would we ever appoint somebody to be a even a leader over that? I'll get if I get confirmation from there, get suggestions from the Alliance to do something like that. That may be what we'll do, but without they're suggesting that to me, and I'm open for them to do that if they want to. But without without there wanting it to happen, then it's not going to happen. So I'm going to be happening for me. Let's just leave it at that. Okay, next question.

Will the new CAC dot solutions database be dovetailed into the RSS dot solutions platform located on the queue QFS, as all systems we know of in 3D land are going away soon?

Ron Giles 02:42

Will the new CAC solutions database, I'm not sure what that means? Are you talking about the one on the maps?

Tracee 02:50

Yeah, that's an Alkalyn.

Ron Giles 02:53

Yeah, there's no plans. Other than just the CAC is here, there's the maps and people are doing what they're gonna do. And then this solar revenue sharing solutions program. Other than that, I'm not. I'm not saying that there will be any dovetailing or anything of this nature will say, I don't know what I that. Tracee, do you know where that that kind of question would come from? Is there something that I'm missing out?

Tracee 03:27

Yes, at the beginning of our call with Ryan and Francis Ryan mentioned that the platform he built is able has the capacity to expand and include whatever we want to have on it insinuating or perhaps helping somebody suppose that the RSS might be integrated or built within that system? So the answer to this question, in my opinion, is we don't know yet. And also, why would you think that all systems are going away? I mean, like, why, why, why would that be? I don't know where that came from. But anyways, yeah, that's my answer.

Ron Giles 04:09

Yes, just just just the overall, we're changing everything, and everything is going to change. And up to that to the you don't know what's going to be changed until it changes. And so when you assume you know what assuming does, about you and me, then you're liable for a lot of real happening and going things that are not perhaps going to happen, so don't assume things. I think that's sufficient for now.

Is there any document that justifies and certifies the origin of my lawful funds here in Colombia, it is needed to support the legality of the money that is going to be used in doe nations and projects.

Ron Giles 05:04

Colombia will have GESARA a complaint country or government. And there's no ability to legality couldn't legally control anything to do with the quantum financial system. They will have no access to it except for their own count account that they set up for themselves. The largest corporation in the world will set up their own account. And mine, my account might be right next to it. I won't know they're there, they won't know that I'm there. It is absolute privacy. I don't even believe law enforcement will have opportunities to go and check out things of other people's privacy. That's cabal orientation, and it's not going to happen. So if there's a problem in Colombia, it's because it is not just our complaint. If it is not just our complaint, there will be no activities from Colombia and the government involved with quantum financial system. I hope that's very clear. Now it looks like we have another one from Colombia, I only can call him.

In Colombia, will it be necessary to create and register a foundation to manage just fine negotiate the money of all the projects? And that is the representative to negotiate before companies entities and people?

Know? That's a question that I've already answered. But I don't believe that's going to happen. That does then there are some problems. Next question.

Today I received a debit card to withdraw fiat money and pay what I owe and is it used for online payments and purchases?

Ron Giles 07:02

Yeah, whatever you've got going on with your bank has nothing to do with us.

Okay, what maximum daily and monthly limit can I use for online or face to face cash payments?

Ron Giles 07:16

Read the documents, please. And then make up your own mind what you'd like to do. I can only say we've got it all covered. And you you're going to you're going to be swimming around in

circles until you read the documentation. If I ask you a question, then that's one out of 100 that you're going to come back and ask again. Because you haven't read the documents. We're going to start getting really serious about this. Don't ask questions. Find out for yourself. Because this is a basic question. It's already been answered. And perhaps not in the way that you think it is. But it is there. And you've got to interoperate interpolate what we say and see how it really does affect you. There's nothing to say about that face to face cash payments. It's all in there if you want cash, you get cash. If you don't want cash, then you don't can you use cash for face to face payment? Yes. You just have to get the cash out. Tim the documentation so continue on and

So we've never have and why would we assume that there is a maximum? This is your money. And the alliance will never put concerns or limits on you like a bank. Don't think that they're like a bank. Get out of that banking thought process where you have well I can only spend so much a day. That's there so limitations. I'm spending 15 quintillion dollars one day who's limited that break? There are no limit. It's your money. Quantum financial system has no limits like that. And I don't think they ever will. Okay, next question.

I feel like all these are from the same person, okay, because of the Columbia. Can I name inherit and allocate the six additional accounts, the trust accounts in case of my death to my loved ones? Yes. How when and where can they use the resources wherever you want? What are the additional accounts that I must and can Oh, If, while they're probably brand new, and I just sent out that job form the other day, so some people perhaps haven't had a minute to, you know, get up to speed. So and I sent it to everyone, so maybe there's a lot of rookie questions on this that people just need to go get the studies. But what are the other additional accounts that I must and can open? Please just follow the form that's on the website under the redemption appointment program. Okay. Although there, although there's a process for requesting and using the med bed, Can I request the three types of medical beds for each Medical Center in each capital city of each department in Colombia? Include them in my support projects for child care foundations, old people and animals?

It's in the literature. And we're putting it out there. So, you know, I apologize for being a little bit abrupt. But these are your spending five or six or seven or eight questions that are already answered, and then I'm not gonna go through them again. Okay, I'm sorry, that's just the way it's gonna be.

Who has ever said that that has authority to say it? I'm not going to say it because I don't believe it's true. There may be something that's being done to us, the Starlink. But it is not part of the quantum financial system, or the quantum pneus of what's going on. Period. These are all a bunch of garbage gurus that think they know something about it. Okay, I'd like to invite you to the qf s on the website. There's two documents on there. And in between those two documents, there's some job forms for questions and for the SKR's. That's all I'm gonna say about that. It's there. And so I'd invite you to get because I can't copy or give you all of the information in those documents. That's why we wrote them. And it's all there. So let's go to the next question.

Tracee 14:59

Is it preferable let people do the trainings and wealth management first before they receive their funds. What about hyperinflation? Wouldn't we be flooding the market,

Ron Giles 15:10

there will be no hyperinflation. If you understand loved one society, we will be entirely in control, there will be no hyperinflation. We will own everything that we can get that we can buy for people who are part of our program, then we buy it and distribute it through the normal channels at the prices that we want to have. Now, where can you? How am I as a dim benefactor with quintillions and whatever your Lillian's of dollars? How am I going to just simply say, Oh, we got to have let hyperinflation go. That's not true. So it won't happen. We are when you talk about flooding the market, what are you talking about? You're not understanding what we're about. So when you do the thoughts, when you do the, read the documents and listen to

the things, loved ones society as a whole program, we go from giving money. And then we have the PAC is a for a community, then we say we put in the IRS, the real estate listing service, and everybody can get their house, and we go into the economic stabilization system. Everybody gets contracts. Then we go to the International, the International commodity clearing houses. It's a step by step process that will take care of all of the things that are going on in the economy. It's not just for the world, it will be going into the galaxies. And maybe, because I'm saying that people are saying, well, this guy's crazy. I don't care if you think I'm crazy. I think God's crazy. He's the one who told me. And what do you say to God when he says something like that? Boy, I don't think that's true. Those who say that the Bible worked out am I talking to? Well, I don't do that kind of questioning. When you told something, that's the way it's gonna be period. So

Yes, it is correct. Every time you sell a 10 year bond contract with a bond. Every year it is renewed, you're gonna put in let's say you're gonna put in 10 trillion \$100 trillion in that bond account. It'll never be touched. So it's just stays there. And it just works out for another 10 years, or for another year. Every year, it is already there for the for the next 10 years. We just renew that for on an annual basis. So the 100 trillion is going to be there for a very long time. Is it bother you? Is it going to be short? Are you short something somewhere else? Are you listening to what we're saying about putting a lot of money away that you will own and if the Alliance wants to use some of it, they will come and ask you. Otherwise, it's for you. 100,000,000,000,200 500 Let's get into the billions in the quintillions and quadrillions and, and write on that. Because it's money that we have. And it's not going to return us on an investment and there will never be a shortage of what we're trying to accomplish. Unless you're listening to the Guru's and get your 12 million or 11 billion for a 100 keynote. And when you do that, then you have the consequences are associated with that. So if you get your higher rates get the highest bonds, you can't get your highest rates out there and put that money in an account savings account. I call it a savings account. And it'll just be sitting there until you need to use it or unless the law He comes along and says, Would you like to be involved in this thing? Okay? Yeah, good luck, dude. Okay, it's gonna cost quite a bit of money and you got plenty of it so it can do it. So those are the kinds of things, you kind of be thinking about these things, because this is what's coming. And putting limits on anything that humanitarian is does is not part of the Alliance. It is only part of the Cabal, and their minions that are out there preaching their version of what's going on. But they don't have a clue because they're not part of the Alliance. I hope that some day, we can get an idea that Ron Giles talks to the alliance proofer that is the loved one society programs. The whole bond of a revenue sharing solutions, loved one society is is the ultimate bond holder on all of that each individual's in benefactor will be the bond holder for all of the activities that that person does. That's why you have a bond account. They're double bonded. Hundreds of 1000s. You've just got to get your mind out of the way and let your heart look at things the way they really are. So if you're talking to me hundreds or 1000s, about billions, or quintillions, or Biogen trillions or quadron, Gen trillions, all the words you want. It goes up to 300 million zeros for a million. I mean, those of you gone be haven't gotten 180 There's there's still something to go for. And if you're not doing that, then why are you telling God? I don't want to do that. I don't feel good about that doing. I wanted to do that God. You don't believe in it. So you don't. Next question.

Tracee 23:11

I love the information provided today. Ron and Tracee, great job. I really enjoy all the updates of the answers. Yes, I assume we take care of the accounting of all these people, is that correct? In our case, we would use Deloitte CPAs to the world to do the accounting and disbursements Is this acceptable?

Ron Giles 23:29

Whatever you want to do for your accounting procedures, Deloitte is good. I think KPMG is international, even down into Africa. And that's one that I feel more comfortable with is one I inquire about, and I got confirmation on it. So that's what I probably use. If there's others that come in, let's just take a look at it see at the time. But until that time, we don't really understand and so we don't really know what we're going to be doing. But we can shoot down ghosts in the future by saying, Well, we're going to have these kinds of problems. So let's prepare for it this way. You've got performance bonds, and so forth. Okay.

Tracee 24:16

County question. Okay. Um, okay. In the event that humanitarians come together as a group to fund a project jointly in a country, for example, are there any suggestions you could give us on how to best approach this, for instance, could one humanitarian set of a bond account others could then commit to funding it on a quarterly basis until the project was completed?

Ron Giles 24:42

You're on your own. As far as Balint is concerned, you're a gym benefactor, the money is yours. You're using it for your projects. Why are you getting other people involved in it? For bonding? You don't do that. That's my opinion. Its opinion But I wouldn't have somebody else coming in and trying to bond my stuff. Why would they want to be bonding my stuff bond in their own?

Tracee 25:10

And besides, if you have a SKR, you have more than enough money that you're going to need to do your own projects, you're not going to need to combine with a group. So, okay, true. This person wants to set up a corporation sole trust, so I'm gonna have to forward you their email, or do you have do you know, somebody who can set that up for somebody?

Ron Giles 25:34

A corporation sole. It's not a trust, it's a corporation sole. Now a trust is something different. A corporation soul is a corporation. I am the sole owner of that corporation. That's why it's called a corporation. So I don't have board of directors. I don't have any of that structure. Tell it's not a trust. And you'd like to do this? Yeah. Oh, yeah. Mine cost me \$4,000 At the appropriate time. But that's all going away. Because all these old systems are old systems that will not survive into the ground into the queue. NESARA GESARA? It's my understanding, I'm just using it because that's what I've got. It just we'll use it until it's not usable anymore. And who cares what's going on from then I'm, I'm in the quantum financial system, and I don't need anything else. Next question.

Tracee 26:40

I understand that every beneficiary can have six trusts or these official trusts with different ein numbers.

Ron Giles 26:49

I would not go to Okay, first of all, the money is not coming until we're away from that system. So there's not going to be employee identification numbers. For trust. Now, trust can be started in with a banking account, and you can put it in that name, and then you would need to have an EIN number. That's the only way to get an account from a bank. But the banks are not going to survive the they'll be turned into financial service centers. Until, because that's going to be in a quantum financial system. So I don't see an EIN required it is now if you do it that way. And in preparation, I, I would wait. Number one, you can't set up your trust and tell beneficiary trust until you have a beneficiary account. Didn't do all the work you want to do beforehand. They set up trusts and do whatever you want to do with them. But I think you're putting the cart

before the horse. And you might have an engine instead of a horse. So you won't need a horse to drive your car. So those are the kinds of things that I'm looking at. So I asked I answered the questions with those kinds of things in mind. Next question,

Okay. Whatever you want to do? Are you in charge to your money? Don't do do things that you'd like to do to help you with what you're trying to accomplish? There's no limit to the accounts. Next guestion.

I'm going to answer this one. May we humanitarians use a sample refer a little letter in sampled trust document on the website as our documents. Yes, that's why it's there. Next question. I know that pretty much all possible questions have been answered. I just haven't gotten to them all. I'm interested in spreading the wealth not only here in the USA, in my community, but also in my other country, Spain, will this be doable? Or easy to accomplish? doable? Yes, it'll

be easy, it's up to what you're saying is easy. It's gonna happen, you know, you're gonna do the things that are necessary to get it done. And you will and don't think that governments are, are not making things hard for us. And so just aren't compliant. Governments will not be in the way of Zim benefactors doing the things that they need to get them. It's in it. Besides, it's an individual thing. The Quantum financial system knows no boundaries. Have you set up a quantum financial system in different countries excuse me, an RSS program in a different country? And then we will have some changes in the downloads. And we'll do that in an appropriate sort of way. But as far as the money going to individuals in the quantum financial system, they had no snow boundaries. It'll just happen there. I don't know, we'll see how that works out. There'll always be little things that need to change. And I don't know if you set it up in one account in one country, and then you go to another and if you set something up in us in Africa, then it's going to be smaller. And if you've moved to Australia, CAC directors has the ability to change those things. So find the CAC director and, and make the changes. And I'm just saying that off the cuff because I don't know what's going to happen. I'd love to be correct in that, but we'll see what happens. Next question. That may be one of the reasons why you want to go from or stay in the country that you're from? I don't know. Next question.

What is an appropriate way to share any of the Benefactor programs, I tried to send a friend to your website? And they said it was a scam? And they weren't interested? Okay, can I answer that? Everybody? I had the same thing happen. I've sent it to so many friends. And only one of them went forward and moved forward. Well, that's got to be true, and are they going to be around? If they're, if they're totally dead, spiritually, they're not going to be around for the golden age of mankind and for the higher dimensions. So everybody's going to be personal. And God knows every one of them and is working out with their soul, the things that are going to happen to those people. So let's not have an opinion about it. We just give them the opportunity. So if your pin is a different color, will you please go in and change it to gray?

So doing one is not is not does not then There's not make a.on the map right now only zoom benefactors in this is where I'm gonna say zoom benefactors in the in the city that they live in, should be putting their map, putting their CAC propositions on the map, it helps us to understand where the Zim benefactors are located. If this is a problem for you, you don't want to do that. That's up to you. But it helps us as planning helps us to know, and how we can make some changes. That's why the SKR program came up because we don't know where these embedded packers are, we just simply know that there's a lot of them around and they don't have Zim been been sim bonds. And so the fkr program was designed to give them Zim bonds so that now they can they can be potential training, or they're in training to become potential Zim benefactors. We just gave them the funds to do it. So if we don't know these kinds of things, I guess we just stay blind about it. But for us, that puts your punk put your number or your is it? What color is it? You donate to loved ones you don't donate to a loved one says hey, here's the philosophy or that are accurate. I have all of these Zim bonds I

have in my heart, an amount and that might be in your heart for the SK ours came or not. They're saying to me have them use the hard sell rates that Peyton have already established for their humanitarian activities. Use that same rate when the SKR's come out with 180 Millions. Now, because it is so big, because it is so large, I have been saying and I will say it until the RV takes place. The person who is going to be at your appointment will be your counselor. talk to that person. This is what I have plans, you have made your presentation. This is what I have planned for my projects. I would like now to discuss with you what we should put in the structured payout.
