We'd like to structure and we'd like to keep it as closely aligned with that as we can from one person to the next. But your hours of working are nothing to do with me. And I have not said anything about that. Because I personally don't feel that you should have somebody dictating to you how to run your business. So don't let other people start running your business for you. Now, that doesn't sound like this person who asked this question is a zim benefactor, maybe they are. Maybe they're thinking that they're going to be a director and want to tell the same benefactor that they'd like to work a full day, I don't know. But you as in benefactor, determine those things for yourself. Work it out with your people. It's not an being a director is not in a nine to five or a two, whatever that person has. It's more like a salesperson, because they're going to have cones, they're going to be talking to business owners. Sometimes a business owners don't want to be talking during the day. So you're going to have times when you're going to have appointments in the evenings. It's, you're getting paid 24 hours a day. So it's not an eight to five job. And your work is not going to finish at five o'clock. The CAC program or the CAC office should be open till nine o'clock when people could come in and do their business with you. All of those are the kinds of things that you will take care of yourself. But don't let anybody tell you what to do. Oh, that's that's my bottom line. Next question.

Well, I feel for you and in, you know, I don't want your heart to sink, I want you to know that the people who are the counselors, are there as a loving gift from our Father in heaven for you. And well, I'm saying is why would you feel like you have to have only one source of income so that you can all work together, the SKR program. She's going to miss out on all of that for the next 100 years. Why would you want to do that? You're corralling everything. And that's okay. You're talking about a foundation? That's okay. But what's wrong with each one of you going in and having your own appointment? When you are contacted? Make an appointment? Why don't you discuss that with the person on the other side of the phone, or whatever it is. And ask if the three of you can come together. And I do suggest that you go ahead and do the SKR for each of you. Because you'd have a lot more that way. And you'll each have your own money. And you have no client relationship. By means you might still have a relationship with those people. But that's not the way it's set up. Where do we get the contracts? Do you want the contracts now? We're trying to to get somebody to do that for us. It takes money when you're talking about contracts. It takes a lot of time and effort on my part to determine all of the things that would be in a contract. I just really don't like what if but contracts are built by what if sets of circumstances and how Having to go into that is a real problem for me, I don't like to do that. However, those are the things that I have to, to work it out so that we can have a good zim benefactor contract. And we can have a good business owner contract account, we got to have that all put together, I feel as much as we possibly can. So that when the money comes, we are prepared and can start right off. And there's no delay as far as love won society is concerned of things that we need to get done. So I'm looking at that it takes money to do that. And we don't have sufficient funds for that. Presently, we have some funds, but I don't know how much it's gonna cost. And right now, I'm trying to set up a set of peoples who can be the basis of our contractual obligations for the entirety of what love won society does. That means we have a legal team in each of the different countries where they have different, possibly different laws, conducting the way that their country does their thing, especially with in relationship to transfer type of properties. So there's going to be a lot of things that have to be considered. And we're finding the right people, we'll get the right people. Well, who's paying? What is the commission? Where are you gonna go to get the refinance taking care? Are you going to go to a bank? Or are you going to a financial service center? Financial Service Center doesn't charge for that kind of thing. So you're asking some questions, and you're not really sure what's coming. So the questions are there, but I understand why you're asking those questions. But let's go on to the next question.

The NRELS documentation incidents a 5% deposit required on all home purchases, most without housing would not have funds for deposit. How is this to be handled?

R Ron Giles 28:19

Well, they have to be part of the quantity or the beneficiary account, they have to have a beneficiary account. And if they can get up to \$28,000 a week, don't you think they can come up with a 5% down payment? Think it through? Come on, think it through this place? Next question. Okay. The

documentation states that a 2% Interest is charged on the loan and appears this money is calculated upfront and held in escrow to cover the new owners property taxes and ongoing improvements. So they are not really being charged interest. Is that correct?

That is correct. However, I don't think that there's going to be property tax in the future property tax is a tax and only sales tax will be involved in the future. God look forward. Next question.

From what I can gather, the broker actually makes two Commission's under the NRELS program. The first commission is when they bring a property into the NRELS which constitutes a sale as it is being purchased by the program slash benefactor and the second one it is sold again to the beneficiary in the RSS program is this correct?

Yes at the president way we have it structured Yes, that's true.

Okay, and is the dollar value shown in the RSS system able to handle these huge amounts for example, the my lilyan with 3 million zeros once converted to 500k or a million How can the RSS program handle those numbers,

what? What kind of questions? You got enough money? What'd he say? Well, how's it going to handle all those problems? It handles all those problems and worse the question, and I'm not sure that's what you're asking. I'm just trying to clarify that. And it's not just 1 million. It's 180. So you're gonna have to study the structure of what we're trying to accomplish. This is obviously a person who's new. And that's okay. Get into it, find out what's going on. Read the documentation, especially was about the SKRs, you'll understand a little bit better, why we did the program. And how the alliance as a different idea about what they can do with the SKR. And we implemented that at the same time, though we solved the problems we're having, but we're also solved what the alliance is having and as to activate the digital gold certificates in the quantum financial system. I'm having people who resist that idea. And I'm saying what is your relationship with God? When he's given you an opportunity to help him, help them down wherever, in something that is third dimension, and we have to be the ones in charge of it. He can't come in to do it. We're asking you now to put it a CAC in your own home, we're going to do a CAC put it in where you're located, why? Brand new for you? How many CAC's experience wise have you set up before you know all of the problems that are going to be associated with it. All of those kinds of things multiply when you're going into other locations to set up CAC's. And you find all of those same problems that you could have found with one CAC solved it at that level, instead of going to different countries, different locations, and trying to get everything set back to where it should have been. Had you had the experience for the CAC. So do you want me to make rules about that? Rules come from problems that have been had that you've had in the past. So we got to somebody hurt themselves and fell down hurt themselves? Well, that would have everybody have helmets when they ride a motorcycle. Those are the kinds of things that I want to avoid. I'm just saying, let's be sensible about this. Everybody, I get this grandiose idea. I've got all this money, I'm going to save the world. I'm going to have a CAC in every country in the world. I'm going and they're going on about all of this stuff. And I say, Do you have a clue what it takes to put one together? And I say, show me show me that one? How's it working for you? So I'm just simply saying let's do one first. grandiose ideas can come about if you get the proper experience and do things appropriately so that it works for everybody. And I think you have to try it out first boasts a home where you can take your director to lunch and talk about problems that are hard to fly over to Paris to talk about problems that you're having over there when you haven't solved them here. That's just my idea. I'm not going to set up rules and regulations, if that's what you're asking, but I'm not going to do that. are grownups we don't need laws. We don't need all of that we got a structure let's stay with the structure and and it gives us opportunities to perform in the way that is uniquely us. And under the structure and uniquely us is the greatest way that humanitarians can accomplish what they're trying to do. That's the basic premise of loved one society and the CAC and the RSS programs. The NRELS is a little bit different has different things to it. The economic stabilization system has a unique opportunities sometimes they can blow over and where there's one that you don't have a direct line of demarcation. This is this and this is that some of them just work together. The CAC out in the rural area is really good for farmers. The people that are going to sign the contract are over and another state signing contracts. Are you going to have somebody close by that you can help with? Yeah, well, that's what the CAC is about. it's a good question. And it needs to be answered in a proper way. If you if you're going from one country to the other, and there's a difference in the download, the download will be the difference that you're dealing with, with one country to another, the actual program itself is going to be the same, the platform will be the same. It's just that you have to sign up for a local area, or a local country for the kind of the currency that you're going to get. And how are you going to spend it in your country. So we're trying to be sensitive to what needs to take place. And with the, the magnitude of what we're trying to accomplish, we're going to have to do things that, let's try this and see if it works best. And if it doesn't, then we'll try something else that will work better. We've got to be sure that when we have the RSS program from one country to the next, that it's not destroying one country. And if you give, if you go to Africa, and a person is used to making \$20 a week, and you start giving him \$100.01, that's going to give him \$100 A week. Now, their structure is worked out on the \$20. And they're working hard to get that and we want them to be sure that they get more than what they've got now. And that's the exciting thing about it, they can get more than they have now. Because if they can't get too much, then you have the problem of the 3% the lotto people spreading out over the smaller countries, these, these less third world countries, I guess that's the way that everybody looks at it. We don't want to hurt them, we want to help them. Eventually, they'll come up to the standards, and we'll raise the art of the downloads and and we'll be cognizant of the sitz the situation and the changes that are taking place. Now, if a country is there, people are not getting as much money as other places. Well, those are the places that what you bet that the Zim benefactors can go in and start using grants, and start using things, money to build roads, and to build good roads instead of the ones with check holes. And ones that you have to have a problem when it rains. Those are the kinds of things that we can help out with. I'm looking at 1000 at 10,000 wells in, in Africa, all over the continent of Africa. There's a huge aquifer underneath most of the country of Africa, countries of Africa. And it's there, but it takes money to do it. And it's still expensive for farmers to be able to accomplish that. So we go in and we drill the wells, we do the engineering to get the water to the to where the farmer can use it. And then the farmer starts making money and, and growing crops and doing things that are really beneficial for him, her it that area, that country, that city, whatever it is. That's how we get involved in the smaller countries, while still having a smaller amount of money that's not going to destroy it. So we're true doing things in a very wise way so that we can accomplish what is the greatest that can be accomplished? Africa could see the whole world they have such a long growing season, they just need the money or excuse me, they just need the water. And most people with money come in and rape and pillage everything. They steal their their gold or silver their China comes on mines and they mines gold. And they destroyed a whole river system. Because of the way that they were mining it. This is what Africans are used to. They destroyed that whole river system. It's not it's not water that you can drink anymore. Because of the way the Chinese went in and they rate the the, and pillage the ground and the people discussed disgusting. Yeah, if you have money and you do things appropriately, then we make changes that will be beneficial for who the people and we don't get to we don't get a dime out of it. Isn't that great, we don't have to have a return or arabesque, we've got to give away 1.25 quintillion dollars every quarter, we've got to get rid of that put it into society. And now that we're going from the 100 note up to the 100 quintillion, then it's that much bigger. So we don't have to scrimp and save and worry about if we're going to run out of money in 100 years. Not gonna happen. Okay, I'll get off my little. But that's what a love won society is about. That's what humanitarians are about. That's how they go in with their money and make changes that are beneficial for the people. And we don't have to be given a return on our investment for the people. Let's go to the next question.

Well, you might have to have two or three or five or 10 of those counselors, just to rescue you from your lack of knowledge. What can I say? You think that the alliance is going to say we'll have a heart of gold, and that's going to be really good. But if we give them money, they don't know what they're doing. They may not be the humanitarians we're looking for. We've given them all of the all of the opportunities to train themselves. They haven't taken advantage of it. There's a certain amount of the training that can come from that counselor, but if you haven't done your job, why do you think they should spend much time with you? When you have all the time in your life, that you can prepare for the greatest job you'll ever have, with all of the money that you could ever hope for, and do some of the greatest humanitarian activities, but you won't learn about it. Why would they give you the money and trust you, when they've given you the opportunity and you don't learn about it. We spent hundreds and hundreds and hundreds of hours. I've spent six, seven years on love won society. I've written documents. Some of them aren't accurate now, but they're still there. That was the basis of what we're trying to accomplish. And if you want to go through a learning curve, try a six year seven year learning curve. When you miss, calculate things and you don't do things appropriately. And then six or seven years later, you become a good humanitarian. You know, if I get a chance, if I get these kinds of questions, I feel like I really need to pound on it a little bit anyway. So that we can stop getting these kinds of questions, and you go into the documentation, send the videos and do your own searching of your own answers. Because they're there. So let's go ahead and end for today. Tracee, it looks like it's our hours. So yep. Thank Thank you, as always, for your contributions and perspective of way things should be and and thank you for putting the reins on the old guy. Good. I appreciate it. I really do. And so with that, let's say thank you to Tracee, for all that she does. And thank you for the questions and answers. We're thankful that you're here.
