We'll be working towards everybody getting their contract signed, and trained and so forth. So, but no, it's going to it's going to be, there's going to be some time delay in there as we transition into having a website for the RSS program. Next question.

Let's say I buy Ford Motor Company, after I sell a car, where does the money go? Do I set up some kind of fund for the sales I made, we really don't need the money. So can we use it for another project?

Ron Giles 01:17

What you're doing when you buy some of these larger corporations, and start selling, in this case, Ford Motor Company start selling cars, you put the cars through the normal distribution system, the only thing really, that we control is the the price that we are charging dealers and

distributors for their, for the cars, we don't make money, and we can lose money. But the money will come back to the benefactor. So that yes, they can go ahead and use it for another project. But what we're trying to do is be sure that we don't mess up the economy. And so we're gonna, and that's why we want to go through love won society, so that we have a degree of control with those who we bring on to give us advice to be advisors in the industry, in the specific industry that those people will work in. There's a lot of manufacturing, you know, appliances, and heavy heavy duty equipment and trucks and all that sort of stuff. So it's not just cars, but it will go through the normal distribution system that's already been set has already been set up. And as the cars move that system, we we get to charge what we want. As long as I think we want to be intelligent, we want to use wisdom and what we're doing, because it's a powerful position that we hold. And we have advisors, we have counselors from the heavens, that will help us as we move forward with this program. So basically, the money goes back to the benefactor. And as it's moved through the whole system, that's where the money goes back to.

So I have a question. Why wouldn't the money from the car sale go back to the company to purchase the materials needed to make more cars?

Ron Giles 03:30

Oh, yeah. Okay. When we buy the wholesale price, that means that the company is, is making all of their money getting all of their money back, we pay the wholesale price, less the cost of labor. So they're all putting they pay for all of their stuff and putting it all into the cars and so forth. And then they get a profit for the company. And that's all they need to be able to pay for all of the things that they put in the and then we start going down into their suppliers. And we do contracts with them. And we can contract all the way down the suppliers to the miners who are mining the the iron ore to get it out of the ground. We we have the ability to get involved at every single level. And my wisdom tells me that we don't start at the top. But we go into the suppliers and then have that move forward or go into the dealers and have that move forward. So that we are establishing our credibility in the chain of suppliers. And then they can go to the upper ones so or go into the manufacturer and get from there. So we're going to pay the full price or the full. We're going to pay the price of the that they charge for the wholesale order car, and they charge us a price that will take care of all of their profit and cost of goods sold. And so it works out really good. We also will bond them. And if they and that money will be put in into an escrow account, they can draw from that to for expansion loans and things of this nature. And we'll work that out with them, too. And that will be part of the escrow instructions, but we always are in control of where the money is. So there's a lot to it, it's complex. And that's why we need to go through love won society that will establish the way to do things and take control of what is happening so that we can be wise in the stewardship that we have. Oh, I see what you're saying, Okay, let's buy Ford Motor, you have a clue, anybody have a clue what it takes to buy one of these large things, who have outstanding stock, you got to buy up all the stock don't own Ford Motor Company, that's going to take you years to do. So we're not interested in buying Ford Motor Company, we're interested in buying all that they produce all of the cars that they produce the say there's 800,000, wherever their model is. And they normally only sell 700,000, that's, that's 100,000 Extra cars that we have to, and we're not the price being of the market. But as as our price comes down. And our idea is to get the cars five years and older, if they're older than five years, let's get them off off the streets. They're not as safe and they're not as so we offer a real high trading value to junk, if you want to call it that, and then we restart recycling it through the systems that are going to come and there's new technologies for that as well. So we're working on a five year program to have the cars and then they they trade them in for new cars all the time. And that's the way that this will work. For the foreseeable future, we don't know, it may be that with a new technology and new things that are coming out, it's not going to be very good to have a car that runs on gas. When you get free energy, and you use those sources to put your car down the road, there's no reason for gas, it's going to be interesting to see how this takes place. And how we're moving forward in society. And the end of motor company Ford Motor is not the only it's not the only segment of the of the economy that is going to be affected by what we do. Virtually all sectors of the of the economy will will be affected. And that's a great thing because the old one was bad.

You've got two sets, two sets of commissions. One is when the broker goes out, the agents go out, and we are there, they, we are their agent and they go or excuse me there, we have they work for us. And they get the Commission's that get the selling commissions from properties that are listed. Okay, that's, that's actual cash that comes from the multiple listing service through the purchase of a home, we bring the property into our national real estate listing service, and we sell it for the price that we determine that it's worth, because that includes the remodeling and the other things of that nature. And then it's 20% off of that, and that's what we that's the the 20% off, it's a 5% down, and all that sort of thing. So we're working through that, so that we can be sure that we're but there's two, two commission structures, real estate agents are gonna make a lot of money. When they, when we view sell through our listing service, the national real estate listing service, then they get a commission. And that commission is what's been published, five cents for every 50 forgotten one of those, I better be quiet. Sometimes my mind doesn't serve me as good as other. And anyway, at any rate, there's two commission structures, one coming into the NRELS, yes, and the other is going out and selling it. So we need, we need to have their expertise at both areas. So that's the way we've got it set up. The Commission structures are five or 6%. We're not involved in that as far as what they do in the multiple listing services. We're not interested in that at all, what we do is we pay a commission when they get sold through our program. And I'm sure that those people, the real estate, agents will be very wealthy over a period of time, because of the structure that we're planning on giving to them. And I don't have a problem with that at all. Make two or three millionaire it's not a problem for me. It shouldn't be for anybody else. The service to society. We get people in homes of their own, and then we help them pay for it. Next question.

If you can't afford it, you can't you're going to create a liability, you have no idea how much you're going to have to pay out. And so if you're not well positioned, you can have some struggles in doing the RSS program, the beneficiary program, and doing other things that you might want to do on your own. So I can if I'm gonna say this again, if you send me an email, I'll send you a link where you can Get 10 100 T notes for \$15 here in the United States comes out of California. So, if this can help, then I suggest you do that instead of worrying about all of this other stuff, the 2008 A or a B, don't worry about that. The gurus are making a big deal about it used to say that you could only do 100 T notes instead of 50s, and 20s. And Dan's, well, that was just a bunch of their own crap, I'll call it crap, because they make it up. The Alliance will redeem any of the bonds from Zimbabwe, regardless of whether they're trillions or non trillions, or if they're your Lillian's, which is the highest that I have seen that they have created. It might be that you asked for proof of funds letter and they say and the the Alliance person says what do you need that for? Well for purchase, well then come and ask us. It's not a one time shot. Who do you think's going to sign a proof of funds letter? Are you not going to be in contact with them on a daily basis, I will help be in contact. I'm not going to put them on the shelf and normally talk to him when I have a problem. We want to get some guidance. We want to get some instructions. And not only instructions but we want to get their input in the decisions that we're making. So a proof of funds letter, don't worry about it. If if you don't understand it, take it out of your presentation. It was just for me to be able to do some things that I'm going to do. How do I know what they've got in mind? But I don't know. How are they going to do that? I don't know. What it's going to look like, I don't know. When they see a proof of funds on the top of the letter, then they'll say, oh, here it is.
