Ron Giles 00:24

No, a person cannot pay more than \$10 to become a beneficiary. And yes, beneficiaries can send up new beneficiaries just using your user ID. Next question.

Tracee 00:36

Well, the contracts we make with someone be entered into the quantum computer who handles these contracts to make sure they're adhered to?

Ron Giles 00:47

That's an interesting question. A contract is between two people who, who looks out for those and make sure that they happen properly between the two people. The computer doesn't get involved in it. So you're kind of going your minds going a little bit out of bounds on them. So next question.

Tracee 01:11

As a beneficiary, is it considered appropriate when meeting someone to sign up a new RSS account using one of your directors or beneficiaries name and account number? As I understand things benefactors have no need for their own beneficiary account?

R Ron Giles 01:28

That's correct. Yes, to sign it to somebody that you, your family member, somebody like that. It's up to you.

Tracee 01:37

I am looking for a reliable source to buy 100 T. Zim notes you mentioned you would supply a link I missed that I see eBay at the moment goes for about 153 U.S, Is that about right? I am in South Africa.

Ron Giles 01:52

No, there can be a problem in South Africa. Because eBay, some eBay, people won't ship there. I can give you the eBay thing. And I have put that out. But you have to call in or email me and ask for the for the link. And you can try it with them. And if you have some success, good. If not, then there may be some others links that we can do that, you'll have to contact me through email on them.

Tracee 02:21

I'll forward I'll find the email and forward it to you. Thanks. I'm wondering if I should or can make myself a share account for my personal needs and household etc. I know the funds come out of my master account. But it seems like it would give me a budget instead of feeling like I'm dipping out of the ocean, I would also get the experience of the system that would help me relate to the people I'm setting up with an RSS account.

Ron Giles 02:46

I think that's an excellent idea. I plan on putting myself on what I would call a budget. Just give myself an account, benefactor account or master RSS managing director account. And whatever we call it, and, and then just take, make my personal funds or take my personal funds from there. That way I, I have my own little bundle that is mine. I can do what I want with it, and so on. And so I think it's a good idea. I think it's a good idea for all of us to have a little bit of a budget. And so that we don't think that, you know, if you have purchases and you can go outside your budget, but it's good to just have something there that you know, you can it gives you a barometer for what you've been spending. Tracee 03:41

In the 923 q&a, there was some discussion about the quantum internet and the ability to use existing home computers out of ignorance. I'm concerned about the internet service providers and their existing business practices. Today. ISPs control available bandwidth bits per second natural places we are now allowed to connect to on the planet. If we have problems with ISPs, it will be momentary. They're not going to have the ability to cause problems for us one way or the other. And I don't know what the other would be, but if they won't let us do our stuff, and then they're in trouble. They will be unplugged. And there'll be other providers because they're, they're using the quantum internet in the transition. So once the quantum internet is turned on, if you have a problem with somebody, just report it, and they will be dealt with because they're at our pleasure not there. If they don't want to be a part of it and cause problems, and they'll, they'll be cut out. So I wouldn't be too concerned about those sorts of things. It is my intention is to, uh, for for Zim benefactors to receive reports that would be helpful for them to do their managing of their their funds just to give feedback, if nothing other than that. So how many people are in your chain of beneficiaries? Things like that might be there? where they're located? I don't know that that would be important. It would it would not be by city or

it'd be by nation or something of that nature. But yes, we're exploring that. And we'll get some, you know, I'm gonna have an angel too. So I'll explore that with them as we prepare this thing too. As we prepare the platform.

#### Tracee 06:29

In regards to the NRELS the purchaser receives the increase in download for the payments, seems everyone will want the most expensive house with the highest download as long as they have the 5% down payment. How is discriminating avoided when one person opts for a million dollar home and outside of town on five acres, and another person is given the choice of far less condo in the city limits?

#### Ron Giles 06:54

There's there's marketing, there's a market, the market will drive what people can get. If you want a million dollar house, and you position yourself to find one, then it's the end you line up for it, then you do? Are we going to try and control that? No. If I see there's a problem as we get as we start implementing it and start getting feedback about what could happen, we'll take a look at those problems. But right now, they're just only projections of problems. And how do you deal with projections of problems? They're like ghosts, you try and shoot down as many as you can, but the devils in the details and that's where we go and we find the details, we kick them out. So there could be some problems, we'll find out what it is, and we'll, we'll deal with that. But I have no problems with people buying the kind of home that they'd like to live in. I hope nobody else does, too. Next question.

Is this training in line with the Alliance? Yes. Here's a question regarding the CAC's work with local businesses. I am aware that in the US and Europe, many rather small businesses were incorporated as C or S corpse and more recently as LLCs. Do you see an enormous number of sole proprietorships or sole proprietor registrations following GESARA?

There's gonna be a some directors of central NESARA and GESARA what survives, we are not going to have corporations survive, okay? Corporations are artificial people. And we're dealing with real people not artificial. That's a subtle change, isn't it? Trust might be a little bit more of a appropriate way to put things but LLC says sorts of any corporation is not going to survive. Even the love won society as a sole proprietor or a corporation. So excuse me, that structure will not survive. But that's that's our the one that we're using now. We'll change it to trust at the appropriate time. Next question.

I'm not sure if I'm properly signed up to be a benefactor there is repeated mention of a \$10

signup charge and a form to illi out but I can't lind these anywhere on the love won society website. Can you send me your email or the signup form? I bought my Zim note and I'm waiting a call from the Alliance angel. I want to be sure, however, that I'm properly signed up. I hear reports of the various currencies being converted now. Do the benefactors come later.

### Ron Giles 09:49

Oh, you're hearing stuff that is? Well, number number one. The \$10 is not for a better factor. That's why you cannot find any place on there for the \$10. The \$10 is comes when the RSS program is up and running. And people who want to be a beneficiary, a beneficiary receives money, they pay the \$10, they have an account and start receiving money. That's where the beneficiary account is, as a benefactor one who has the money and is giving that you do not have the \$10 fee. So I refer you to start reading a little bit better the documentation and listen to the things that we have. Because this \$10 fee comes up all the time. And I am really kind of getting irritated because and I'll say this out loud. Most people that are interested in paying the \$10 want their money now. They're only in it for the money. That's what they're talking about. We're humanitarians, we're going to get our money when the time comes. There's no registration fees, there's nothing with you getting the emails, you are registered, and are being in a position to be trained to become as in benefactor. At the appropriate time, those who have gone through the training, will and they've gone through and got the high rates and get a referral from the angel that you have sufficient funds to to the RSS pro program, then you'll have a contract offered. So that's the way it's gonna work out. So so please, there's no registration for benefactors, there's no place to register. As long as you're getting the emails and you're in the program, you're in the you're in line to get your benefactor contract, and so forth. If you perform, and if you gain the understanding that you need to gain by self educating yourself, we've given you everything you need to know exactly what's required of you, in the love won just Society Program. So it's all in there, it's just up to you to find it. So I apologize for being a little bit upset with this \$10 garbage. But we get that all the time, I'll say 20% of my emails that come through, are asking questions about \$10. And where to pay it. On the internet, it's not on the website. So don't even look at question.

What training do I need? And when can I start? Where will I do my training?

## Ron Giles 12:48

Okay, we've send out an array video that talks about the website. We went through it thoroughly, you can see where the drop down menus are and the different documents that are there. And we suggest that you begin reading, then reading all the documents, the first two menus are the documents. And then you'll you'll get into some questions and answers. And then there's the training videos. The training videos are there to train you. If you're already in that program, then you are being trained. If you're on the email list, you're getting everything you need to do the training. So when you say, When is the training starting? Now it's already started for you if you want to do it. But it's something that you have to do the training is there. Next question.

When a new person signs up for a beneficiary of the RSS besides the credit, debit card information, name, address, email, phone number, etc? Do they need to enter any government issued ID number or any other personal information?

Ron Giles 14:05

Absolutely not that and, you know, Name Address. We're not asking for addresses. There's an email. And we don't ask for a phone number. All of that sort of thing changes. There's no place for it on our website. So very minimum amount of, of information, private information. I think we're going to do country in there because there's gonna be some changes in the download for different countries. We'll just take a look at it and see how things are going but that's our intentions at the present time. Next question.

How will a beneficiary receive the downloads with a new QFS account be automatically created for that person? Would it be simple for them to transfer the funds to their bank accounts?

- R Ron Giles 14:56 Yes, all of the above.

How can orphanage have hundreds of children create trust for all the children.

- R Ron Giles 15:05 They can't.
- Tracee 15:08

What if something in us made us purchase a Zim? No, I have humanitarian ideas. But I have young children, I do not think I will have the time or energy to put into what needs to be done. Can I still be a benefactor? But have people helped me with my visions?

Ron Giles 15:25

Yes, you can certainly do that. Not a problem. As a as a humanitarian, you're going to get the funds. And what greater opportunity than have other people assist you in your humanitarian work? It's a good thing. And you'll find a way to take care of your children to do that as well.

That's just who we are as humanitarians. It's not that hard. It'll be a pleasure, it'll be a joy. And when your children get older, then they too can become involved. Next guestion.

You mentioned your articles that one must be an RSS member to get the higher Zim rates. Please tell me why this is so?

### Ron Giles 16:09

I have not said that it takes the RSS a member to be an RSS member to get the higher Zim rates. I'm trying to say this properly. And I did so and made it as common in the telegram. The fact that the RSS people that people who want to become Zim benefactors, they're going to get what they asked for, if they're humanitarians. And if humanitarians can go in there and get what they asked for, all I'm saying is those who are not involved with love won society have no idea how much money is available as a rate for their redemption appointment. They have no idea that \$500,000 They have no idea that it's available. So they're on a different telephone line. No less are people no less humanitarians in their heart. But unless they tune into what we're doing, they're not going to ask for the higher rate has nothing to do with who they are, it has to do with the rates that they ask. And if you don't know, and I'm going to say this to your mind is controlling your heart in many settings, set some circumstances. If your mind has not stretched out, let's say \$200,000. Because the gurus are saying that you normally get this system that's and and if you're listening to that, it's preconceived in your mind that that the higher amounts of money are not available to you. And I come along, say the minimum is \$500,000. Talk about a stretch of the imagination and stretch of the of the pea brain mind. If you don't have somebody stretching them, they'll ask for \$1 or two on the redemption and and a trillion dollar note. And getting trillion trillion dollars is a lot of money. But it isn't when we have the work to do that we're going to do. And therein lies the difference. We're no different than other people except we, our minds have been been stretched and stretched and really stretched. To accommodate the idea that we can get that then your heart kicks in because your mind is not overriding that new Ask your heart what rate should I get? And if you don't have any preconceived ideas or limitations in your thinking, your heart can have Sway on that. And you'll ask, you'll ask, you'll get and you will ask for the higher rates. So I hope there's you can see that there is a difference with that. We're no better than other people, we just have a different. We're on a different telephone line, radio station, whatever you want to call it. And if you're not there, you're not going to get your mind stretch to work and really apply for you. So I'm grateful to the alliance, that they help us to understand that we have unlimited funds available to us. And if we don't ask for them, we won't get them. But if we do, then we'd get ourselves set up for our humanitarian work. Next question.

I, there's, there's nobody going to say you can't spend your money on that. No, we're going to get all kinds of projects and technologies to fund. And so you don't have to ask permission about that. If you want to do that, then you do it. And if you want to do it big, then do it big. You'll, if there's a technology that is competing with that, then you have to deal with the competition of technologies. But the bottom line is, is that humanity gets served a very highly evolved set of circumstances for us to begin living under instead of all of the garbage that we've had to have. So as technology comes out, there be competing technologies, there's are already competing bit med bed technologies. So if I inquire about that person, there's there's a use for money in the future. It'll be wise. Ron Giles 24:44

You know, I've I've put a lot of effort and thought in doing exactly what you're talking about. And then I find out that the alliance is already setting things up. With the banking system. They've lopped off The bad people, the bad heads to the banks. And they're penetrating down into the middle, upper middle and middle management to find people who they can trust and be the people that are involved in managing and doing the financial service centers. They're already doing that. I have the feeling that all we do will just be to come in and say, Well, I'd like to do Bank of America, I'd like to do Chase Bank, right, I'd like to do this and that and the other. And how many of us are going to be involved in that? I don't know. We're gonna it'll be by invitation, though. If you don't have the larger sums of money, you're not going to be part participating. So there's a lot to a lot to that. But there's a lot that we don't know. So I was surprised. And because I was thinking, we'd have to sit back, wait until it all collapse, and then pick up what's left of it and try and make a financial service center our industry. But apparently, it's a good idea. And the alliance is already doing it. So we'll wait for, and I think that Chase financial service centers, or whatever you want to call them, or Bank of America financial service centers, it'll, it'll just be the next step forward to call him whenever we want to. I would like to hear more of the six trusts to get clarification on why we would need or use them. And are they necessary?

Ron Giles 26:43

Well, if you don't see it yet, then just let that go by and don't do them. If you don't see the need for them. They're they're available. You don't have to use them. And I suggest that you either kind of get an idea what's going on with those use of those trusts? Or just forget about it. Nobody's forcing you. Next question.

Tracee 27:09

So let's say six trust, how are funds added to each trust or when your main account adds a penny, so does do the other six or do the trust continue at only 10 cents a minute.

Ron Giles 27:25

I trust will only be at 10 cents a minute, there will be no additions to it. It's not part of the bonus program, as is mentioned in the literature. You establish a trust, it has its own account that you can draw down into. And as the trustee, you are the one in charge of that trust. Now, in the corpus or the body of the documents that require that are required to establish the trust, there are certain things that the trustee has to do for the beneficiary. Be sure that you do this properly and keep track of what you do. And be sure that what you're doing is allowed by the trust's because you set up the trust. So be wise with what you do. And, and you'll be fine. But don't worry about the trust so much. And they're only 10 their 10 cents a minute. Download for each trust. Period, there will be no more or a trust. Next question.

Tracee 28:39 already plenty. Okay, what happens if redemption happens and I'm still waiting to receive some

of my Zim?

Talk to the people talk to somebody who contacts you asked him what you should do. Next question.

Tracee 28:58

A question about the love won society cards. Why do you say nine billionaires to share their wealth? Does the number nine mean something special for our humanitarian projects? A statement seems enticing to people to ask why only nine billionaires or who the nine billionaires are.

Ron Giles 29:19

It's a marketing idea. Keep in mind that you're going to be giving away trillions and whatever funds. People are wanting to know where that I'm just saying there's nine billionaires that want to share their funds. Who are the nine billionaires? Number one, it would be none of your damn business. Don't look a gift horse in a mouse. Just take the money and add see people are thinking in their mind. I'm going to sign up for this. It's not going to last because billionaires are do the math. billionaires don't have the money for this. Somebody does the math and they understand that there's something else behind it than billionaires. It's a marketing ploy to tell

people that there's people who are giving money away. So you need to put the find the context to put this in. I had nine people that are love won part a love won society. And I just identified them as billionaires. I could have said, trillionaires nobody's gonna know who they are. Nobody's gonna know anything about who's putting up the money. Unless those who put up the money start. Do you ever jabbering and telling everybody about it? Otherwise, it's it's private information that will not be put out? And there's no way for them to find out who's doing it. The card is only for a promotion. If you want to scrutinize promotion information, then do so but you know, we're innocent. I had the nine people that identify as billionaires and could put up money for the RSS program. Thanks. question.

Tracee 31:18

A question about ECS. Can RSS platform track the time or term of the easiest contract and make the quarterly rise of one cent per minute automatically?

Ron Giles 31:29 Yes.

Tracee 31:32

Who are the Chinese elders? Are they part of the alliance and QFS as well? Yes. I can imagine some more down the road, there's going to be some changes, hopefully, with a little input from the Alliance, it's pretty obvious all this is going to take some time to implement once the redemption process starts. Even once you get your money, it's going to take time for you to put in place your programs, I'm hoping you'll be one of the first so you can get things started on your end. But I'm sure it's going to take a few months at least to get implemented. Now in the interim, between the time the world gets on the QFS and all businesses and vendors gear up for it, we're going to have to work within the current banking system during the transition, is there going to be a way to transfer money to an actual bank account during the transition?

Ron Giles 32:23

Yes, there will be there'll be good banks, and and safe for your money. There's there's this set of circumstances that banks will have already been cleaned out plans of the bad people. And they're already in the transition. So there, if I were to transfer money into a bank, if let's say I had a trillion dollars, we have this, if I wanted to put a trillion dollars in a bank, which is probably a really stupid thing to do, because you don't like that much money in involved in a bank. But I put money into the bank and can transfer it there. And if somebody tries to steal it, what greater opportunity then to have them arrested than them trying to steal money from us, it's not going to happen. We're going to be so much money that there will be no reason to be stealing money from other people. I mean, if \$28,000 a month isn't enough for you, and you need to go out steal money from somebody else. Keep in mind that you're going to lose everything that you have. RSS program will just

fold up and you won't be a part of it anymore. This is only for those who are here for society in doing the good for the for the whole of society rather than just selfishness. Those kinds of people will be gone. Next question.

#### Tracee 34:07

I know people who have submitted projects to Simon parks, and here in this group who have a burning desire to get their projects up and running, but maybe not with Simon, because apparently he says Not all will be passed. What would you say to these people? Or how would you advise Ron?

### Ron Giles 34:25

Well, I'm not going to say anything to disparage those who believe in Simon parks and what he's doing. If you look at what we're doing, where we're hopefully headed in the same direction, but this way, I'm hoping that Simon is headed in the same direction we are. We have the Alliance. I talk to the alliance. I've set up this whole program under the alliance and they're the ones Who are going to give us the money. So if you are not talking to the alliance and doing things that are outside of their channel of the way that they're going to do the redemptions. And for the humanitarian stuff, if you're outside of that, there's a good chance you won't get the money. So when he says that there's some that might not pass. Well, that's true. And if you're only humanitarians who agree to get redemption money from the Alliance, period, exclamation point, end of discussion, if you're not a humanitarian, from the alliances perspective, not from our demanded, think we're really great, all that sort of stuff. They are the ones who will determine whether you're humanitarian. And if you're not humanitarian, you won't be participating in the redemption of Zim period, exclamation, I have no obligation. Zim is a dead debt instrument, it is gone, it is of no value. And if you don't believe me just go to eBay and see what they say on there and advertise, that's a dead currency. It's only for wallpaper, whatever you want to call it. So if it's not for the Alliance, Zim is dead in the water. And in the other bond is dead in the water. Because even if you have some of these ancient bonds, and you have hundreds of 1000s of them, and there are those who do have that. If they're not humanitarians, the Alliance won't redeem their bonds, period. They have no obligation to. But if you're humanitarian, they just love you. And they are redeem your bonds at a very high rate that you would not believe. Because those who are going to do coming from their heart and doing humanitarian things, for good people, then they want that the funds the surrounding the terian funds in the hands of those people. If you can't see the value, then don't use it, period. If using the RSS program to pay people in your way of doing things, like the end of the month, we're gonna have to sign all your checks and all that sort of stuff. If that's a problem for you Do it your way, the RSS program will automatically pay your people if you set it up for them. If that's not a good thing, if you'd rather do it yourself, then don't use the RSS program. It's all voluntary. There's no reason for you to do it unless you find a reason in your humanitarian activities to use the RSS program. It's free. Just another way to deal with your financial situations.

Tracee 39:01

I am in the USA now but I'm planning to go to Spain very soon. Well, I have the opportunity to meet someone from the Alliance there for the appointment.

Ron Giles 39:12

Okay, I'd like you to read our literature. I have stated specifically. The Alliance knows who you are. There is not one humanitarian that should be getting these funds that will not be contacted by the Alliance. It doesn't matter where you are. They will find you. I can't put it any more strongly than that. It doesn't matter where you are. It doesn't matter whether you're in traveling or something of this nature. Or if you're in Timbuktu. There's no way to get to you except by Campbell's caravans. They're going to find you And they're going to redeem your gym. And you're going to have the opportunity to come from your heart as a humanitarian. Please read the literature, please read read the literature. This question is basic. And I have pounded this in. I don't know how many times your alliance will find you, regardless of where you are, unless you're not a humanitarian. And just thank you our next question.

When will the map of Zim holders who submitted their location information be available for all

### Ron Giles 41:25

That's an interesting question. First of all, the map is just an idea to help those who don't want to set up a CAC program where somebody else is located. If you have four or five people that want to be in a resort town or something like that, and set up their CAC is there, then you get an idea how many people are there? That's all this is for? And it's all voluntary. So it's not really we don't we can't guarantee it accurate. The accuracy of the map is just there for you to help to make a decision on where you want to set up. And I hope that you'll use it and volunteer for I think it's a good thing has no names. Just has the CAC program so when you say benefactor, it has a CAC program in that area that has been reported by the Benefactor who's going to move into that area or has already set up the CAC program. So instead of active Zim benefactors is an area in an area. It's a CAC program that's been sent, and that's one that's been identified. So you might have Zim benefactors aren't doing or they're in a city doing their own thing. And having done the CAC program, we don't know those kinds of things. It's all voluntary, and they are CAC programs in an area and that they'll be on that map. Next question.

How would it work to provide the infrastructure of paved roads, electricity, water, and sewage, to lots that have homes or structures that were once homes, it would seem that everything ties to a central Financial Center, I'd better lose the humility as this is going to take extreme expense.

### R Ron Giles 43:24

That's true. And don't put your name on it, but somebody else's name on it, let somebody else do the work. You hire them to do the work, then you don't get involved. If you're if you're spending all of your time in one area, trying to get something going. What about the other areas? If you are the one that has to be in the in a ditch digging the ditch, then you're only going to get one ditch dug that you can do. But if you get a lot of people digging in different ditches, wherever they need to be, then you have really maximize your use of your phones. So I'm looking at this, I'm saying, humility problem. Don't worry about that kind of things. Just enjoy the reality that you were able to punch some things. And let that be your view, morality or fact or whatever you want to call it. Get other people to do your work for you. Central financial centers? I'm not I'm not sure I understand what you're talking about. A financial central financial center. Sounds like you won't set up a bank or financial service centers or something like that. And you know, you already discuss that in this q&a. Next question.

## Tracee 44:50

After the six trusts have been established for the beneficiary, can they assign any of their Penny increases from sharing the RSS program to increase one of the First instead of the regular RSS beneficiary account?

#### Ron Giles 45:04

Absolutely not. Trust has 10 cents period doesn't add to or take from. It's not on the bonus system. Okay, now, if you're a benefactor, let's talk about benefactors. It's not the place for a benefactor to get involved in those six trusts that are for a beneficiary to establish. It's the beneficiaries responsibility, and you have nothing to do with it. It's part of the RSS program, the beneficiary program. If you want to suddenly go pennies, and so forth, and don't put them off, that's not a beneficiary trust, if you do that. It's a manager's trust, RSS managing director trust, whatever we finish, actually call it when we do anyways, that you have all the flexibility you want with that the RSS platform will do will perform just perfectly and benefactor can do whatever they want to do. And we have the vehicles for them to do that. So they can get money into the hands of people or organizations or whatever, if they so desire to do that, to setting up their managing management account for that managing director account. And you can do everything you want to do, but you're not going to mess with the RSS platform. There's certain things that are invaluable. And that's one of them. The platform is there. And we're going to be very strict with that. And when I say strict, we have plans to accommodate the different economic factors in countries so that we can be sure that we're not giving 10 cents a minute to a tribe in Africa, or somebody that that is not sophisticated and is used to making working with hybrid 10 or \$20 a week, and you start giving them \$1,000 A week, you're gonna blow the economy apart. We're not going to do that, though we're going to be wise with what we do. But only at that point in that direction, we will make the decisions of how much download for that country, and then there's 10 Stone, you don't have you can't play with it. That's an that's an RSS management decision. Don't use as in Ben factor, have all of the movement you need, and all of the things you can do. So I guess we'll probably be talking about that for a long time until everybody gets the memo. Next question.

### Tracee 48:03

Who's going to be a benefactor? I have a beautiful plan for helping people in every world bring food to everyone in Mexico, it's the best a big deal for making the food free to the rest of the world.

## Ron Giles 48:20

I want to have everybody look at the word free, you're going to get this for free, you're going to get that for free. I got all this money, I got to get it out. Yeah, you're gonna you're gonna get everything for free. What kind of a society you creating, you're taking away the dignity of people that really enjoy working and then enjoying the fruits of their labors. To somebody else does the work you buy that or buy the food you you get you buy the food from the people who grow it. And then you give it away to people. They say, Come on, get in line with a proper way of thinking about humanitarian activities. You don't give things away for free. They don't appreciate it. They have no value on it, because you didn't value it and gave it to them for free. You're coming from your heart. They're just they just think they're just getting something for free. And you're creating a whole different society, then what we have in the wrong direction. You want people that are accountable. You want people to work and enjoy the work ethic and enjoy getting things and buying them because of their own labor. Why would you ever take that away from people? Why would you ever take that away from society? Nobody's going to work. You're going to buy food from the farmer and the farmer is going to get all this money. I don't

have to work. How long are you going to sustain yourself with that kind of behavior? You You got to think this thing through. And one of the biggest problems I have with humanitarians with all of this money, they think it's wise, and has great wisdom to give everything away for free. There are certain things that will be free. But if you start coming from free stuff, you'll have people lined up at your door, wanting free stuff, because they don't have to work for it. You robbed them of a life of productivity. There's going to be more about this. Go to the appointment, and you say, Well, I'm going to plan on doing this, I'm going to do this, and I'm going to do this and it's all going to be free. They might not hit their head, hand on their forehead and roll her eyes. But that's what they're thinking. Because it's not in line with not the right way to do things. And you'll find that out. If you start putting yourself in IV, we're going to we're going to build homes for every homeless person to look to, we're going to get everybody off the street. And and I say, Yeah, okay, good, you're going to be fighting over the, the homeless to get houses for the fighting, you're going to build the houses for all of these homeless people, and they don't have anybody to move into. That's not the point. The point is, you have to use wisdom in what you're doing. So that you can manage things properly. And in an effective way. The problem is not homelessness, the problem is society and the economic system that the cabal has made. Once you get that in your mind, then you'll know where the money needs to go and how we can change the economy so that we don't create homeless people. You're you're looking at a tree and you're whacking away at the the bad limbs that are producing the dead leaves. When the reality is you have to attack things from the root. And if you look at all of the programs of love won society, you'll see how if we use that properly, we will change, we will do an entire change for the economic system. And not one person will be left behind. You take a look at the system and look at it from that standpoint, ESS program especially just a different way of thinking. Next question.

I don't have an educated guess. Because it would still be a guess. I've guessed it's going to be 234 years ago. Nobody knows. So we just continued to prepare what came two years ago and you weren't involved with love won society. We were up going to go doing our own things and you wouldn't have a clue about it. You wouldn't even know where to get Jim Whenever things happen the way that they should. And in cutting corners, you're thinking that the alliance doesn't want this to happen, have already happened. That is absolutely incorrect. Their circumstances. Number one, you have to be safe as the one receiving the money. Number two, the money has to be saved, so it cannot be stolen from you. And then we have to be free from the government institutions. So it would corral us into doing things their way. All of these things have to change, before we get our money, so that when we do get our money, we can have the freedom to go about doing the things we want. That's where the Alliance steps in and says we're doing it our way because we know what we're doing. And if you don't want to have faith and trust in the Alliance to do it exactly perfect. That's up to you. But it's going to be really frustrating. If you don't exercise faith in the reality that there is a plan. If a beneficiary refers the RSS to someone new, whether the new beneficiary signs of immediately or is left some cards with referral information and signs up later, how do they establish the six trusts or even know that they are available?

## Ron Giles 57:11

I'm getting the feeling that the six trusts are the most important thing that you're thinking about. There's an educational system. If they want to find out about the trust, if they want to read the information and and establish the trust, then they can do it will be available for them. But nobody's going to teach them. They're going to have the information on the website so that they can establish their own trust, it's just that simple. We're not going to force it on them, it's just the opportunity for them to say, Oh, look, I can get these six trusts. Seven times the amount of money that I'm getting, wow, let's do this. Let them explore and find out for themselves. That way we'll get into the literature and become knowledgeable about what this whole program is about. So I wish people would not talk about the six trust because it's a it's a sore point for me because most people are only looking for money. And this trust are there for certain purposes. And to be honest with you, I I didn't feel that six trust was I think that's too many. But I was told that it's six trust. That's the way we set it up. Okay. We'll go with what you say. And so there is wisdom with the six trust. And let's find out what that wisdom is as we move forward. Thank you, Tracee for your help. That's our last question for today.
