Hello precious humanitarians. This is Ron Giles. I'm here with Tracee and we're going to do another question and answer session. We'll be about an hour. So with that introduction, let's go ahead and ask the first question. Tracee.

How can we make sure our Zim is legitimate? You mentioned two websites on eBay, which is where our bonds are purchased. But we are still not sure we have the correct Zim. Please help direct us?

**R** Ron Giles 00:28

It's an interesting question. And let's just go back to the idea that anything you buy on eBay is just it's not currency. There's no value for Zim bonds in Zimbabwe, you can't buy anything with it. It's a useless defunct currency. Any facsimile of the defunct is neither currency, or is it of any value except for what people will pay for them to buy them. However, that being said, the alliance has no concern about the actual bonds themselves. It's only a vehicle to get you the money that you need to do your humanitarian work. Now, it's not as if you just write a fax or write out a thing on a piece of paper say, this is Zim bond, you've got to make the effort to go ahead and get the Zim because that's your responsibility. But when you get it, it doesn't matter to the alliance. If it's a facsimile, or if it's in counterfeit or anything else, their interest is in using that to get you your money. And if you bought those things for the purposes of redeeming for your humanitarian work, they will honor that. So don't and I get a lot of people as I've been referring them to the eBay site to get them was only this these don't even have serial numbers on. They don't. That's because they're not real. But the alliance will redeem them. So they are real for you. And for humanitarian. Next question.

I am a humanitarian with the Zim Is it mandatory to pre register in the RSS program in order to get a redemption appointment with the Alliance? Or is the only appointment requirement that I have Zim into humanitarian projects,

**R** Ron Giles 02:28

the RSS program has nothing to do with the Alliance in terms of you getting to use it or qualifying. So it doesn't matter whether you're going to be an RSS benefactor, or not, if you're a humanitarian, you're entitled to go in and redeem your bonds has nothing to do with us. At the appointment, you're going to say we'd like to do love won society and be able to Zim benefactor, well, that gives them all that they need to be able to understand where you're coming from. And then the questions might be to check, you're in the intent of your heart to do this kind of work. They'll know everything about you. So it's just a formality that you have to go through. But you do have to go through it. You don't get around it, you got to go through it. You have to have a face to face appointment with somebody that's representing the Alliance. In order for you to get your pot your money, you can't have anybody else do it, you have to have a face to face. And why would you give that up? If the person that's doing the appointment, or the the interviewer is an alliance agent who is representing the alliance as well as the angelic realms, or the higher realms as well, so why would you want to miss out on that opportunity? So those who turn their bonds in for somebody else to to, I would get them back as quickly as I can? Because you're gonna miss out. Next question.

No, the only thing that I have is proposals. Now this proposal, but an example of what I'm doing that so on the planning part, appointment planning, or preparations. So on the website, those particular ones are on the first menu. I believe it could be wrong, but it could be the second but I've forgotten. But that's all I've got. Next question.

It's a very good question. Question. And I would say with 10 billion, you're not going to have enough. Unless you ask for a very high rate. They're there to counsel with you and to advise

enough. Unless you ask for a very high rate. They're there to counsel with you, and to advise you, to help you to assist you. Talk to them about if you might have my Zimmer in the mail, and they're coming, I have proof of the purchase here. And because they send that to you, so you'll get what you need and just talk with them. We're presuming at this point that you are a humanitarian, and that you're there to get your funds to do your humanitarian work. There are those who will go and they're not humanitarians. And they won't be getting anything, that's just the way it is. So counsel with a person there, that's your friend, that's your, your mentor, that's the person who's going to help you to become a Heidi. I'll say high functioning humanitarian. And that's what their job is to get you to that point where you're really doing a good job with your humanitarian money. So it's all in place for you to do so. But if there's a problem, just talk to them. They're very, they'll be very easy with you, and not cause you any problems. They're there to help you. Thanks. Question.

I need to do my own projects with orphans throughout South Africa and parts of India as well. How does your program affect the cash flow? In our projects, we have our own foundation, NGO, who was in control of our money, we have 320 T. Zim. And I guess I need to ask for 500k at redemption.

**R** Ron Giles 07:11

Okay, your bottom sentence is correct. You are always the next one up is who is in control of our money. You are, you're the one that is the humanitarian, the money is coming to you specifically now you're you're talking about other people involved with you, I would recommend that you be the one in charge, they're yours, him, you take your Zim and get your funds, and then you are the one who's in charge of the funds. And you can do whatever you need to do. Love won society of the RSS program is a platform on the internet. If the person can access the internet, they can become a beneficiary and yet their own beneficiary account and start accumulating their own funds. So I'm not sure beyond that, what you need to how does your program affect the cash flow, it's downloaded into their beneficiary account, if they have signed up for one. Right now without changing it, it's \$10 Different countries will have perhaps different levels of fees that they pay to get in. And so I won't go into the reason for the \$10 or reason for any fee for that matter. But we've already discussed that in other times, so there is your cash flow. It's from the internet, draw it down whenever you want. Next question.

Well, those are good questions. You have the money if it's for sale, and you say oh, we could use Yes, go ahead and buy it. I wouldn't I wouldn't stumble or have a problem if they want to lease it to you. I'm looking at their circumstances in the area, you're in a camp in your large metropolitan community. Do you have facilities for having large gatherings large meaning, you know, maybe 1000 or 2000 or 3000 square foot or something like I don't know the size of a little assembly hall sort of thing where you can put up tables and have computers that people could come in and sign up for it and also have other areas that you have her office space so your small business owners can come in and get their contracts. You're going to be helping people in other areas. How many assistance do you want to have, I suppose in a large metropolitan area, and you'd want quite a few, however, a large metropolitan area is not just a simple community. So I look at a community as a geographical area within a metropolitan area. So how many directors do you anticipate having there? Do you want to have one large building that can accommodate all of the directors in that metropolitan area and all of the activities they want to do? It's, those are really good questions. And yet, I have no answer to them. I know that when I get there, there are certain things that I look for when I'm looking for a building, or certain things allow look for here where I live, they do have libraries that have places where you can have meetings, and that can be set up for our use as well. So for some, it might not be necessary to have a meeting room, or a board room or whatever you want to do it but call it because we have the facilities there. It's just depends on what you want, how you want to do it, and it's yours. So make it home, make it your home, I get your director so that your director make it hits home, her home and have some fun with it. And I would I would suggest you don't skimp on it. Get find furniture, find things that you put in their break room, microwave oven or whatever you want. All of that sort of thing is important. So make it a home. Spending a lot of time there. It will only be my opinion I've inquired about cryptocurrency. But cryptocurrency is not going to be part of the quantum financial system. It's not we have our own money, we have our own currencies. Now, when I have inquired about that, they say yes, you can. You can take cryptocurrencies in and exchange them for real money in the quantum financial system. The Benefactor is a person who has signed a contract with love won society to be a part of the RSS program as in benefactor. Now, if you don't have sufficient funds to do it, when I say sufficient funds, when you go into your appointment, you ask the person there to give your referral. Not a letter indicating that you've got a lot of money. Just ask for a referral and they'll know exactly what you're talking about. The referral is we refer this person to be a Zim benefactor, having sufficient funds that they've gone through their appointment getting so that would be the best way to do it. So you're not going to get you're not going to become a Zim benefactor. If you don't go through the redemption appointment with the Zim, and ask for the higher rates, you don't have enough money, you're creating a liability that you can't sustain. It's hard enough to know how many millions are going to be in your chain of Zim benefactors, are beneficiaries without having to try and go in there with without this sufficient amounts of money that we know are not going to be sufficient. In the very beginning, we won't sign a contract with people unless we were working it out. So that that the alliance is going to give you that letter referring you to become a gym benefactor. So we won't let you become a gym benefactor without them, because we just have to take your word for it. And there's nothing that we can, we're not going to take on a liability of somebody else's activities. So that's why we're doing it this way. benefactors have a contract? I hope that's an answer to this person's questions will if it's not been asked again, using different words. Next question.

I'm not sure if I've ever said that it'd be better to buy or pay off a property using a down payment and paying it off, you've got the money to pay for it, then there's no headaches. The only thing that I'm talking about there is when somebody is buying a home through the national real estate listing service. They're buying a house and most people don't have money for a down payment on him or her to pay off a house. And so they are going to have to borrow money, and we're just playing that little game with them psychologically. But when you do all the numbers, we're paying for the home for you, you get it free, it's just going to take 15 years to release the lien, or the lien has to be paid off together. Somehow, because you're going to be getting the money for it. We say don't don't pay off the lien unless you want to buy another home. But because you're still gonna be getting the money for it. It's complicated, yes, but think it out. Do your best that you can. But we are not interested. I'm not interested in paying off a place that I have the money to buy. It's just a headache. Go to down closing, or closing and pay your money. Put it in escrow and pay for the could be a \$2 billion apartment building who knows? In the middle of Manhattan? If it's for sale by? If that's what you want. If you have a reason to mine, don't just go buying things without a reason. I hope that's helpful. Next question.

It's your stewardship responsibility. If you've taken it upon yourself to do humanitarian work and advertise yourself as a humanitarian, wanting to become a benefactor, you set up the program the way that you want. If you want to give people money, which I question in my mind, I would, I would put them as a on the best beneficiary program, how much money you're going to give him. I don't think it's appropriate for us to be giving money out handing out money to friends and people that we have just an acquaintance with. I think free money destroys people's lives. I would do it. I wouldn't do it myself. Certainly not recommend it for other people. If you want to give somebody some money and like in your field, employ them, give them a contract. Give them a manager's account that you're giving them so much my Grandma's not going to go out and do a lot of work unless she gets him the med bed. And then you just adjust it be wise And don't try and solve all the problems now. Because things are going to be changing. Let's allow ourselves the ability to change with it, especially our thinking. Next question.

I love the clarification training you provided on dominion, I know this is something I must work on myself, granting others absolute dominion, that I'm not clear how this works when funding a grant or trust, I believe inherent in either of those, there are generally stipulations or terms such as what the money may or may not be used for, who has to manage it, etc. Even asking for or adjusting a business plan prior to funding the grant or trust to determine whether or not to do it, or how much it should be funded. I'm unclear how these things can still be done while granting dominion, would you please provide your thoughts on this?

**R** Ron Giles 20:53

I'm not sure. If I understand your word, your use of the word dominion, granting dominion. If you have a grant, if you've got somebody approaches you, and they would would like you to give them a grant for a specific purpose, it makes sense to give them money to do that. A grant is money you give to somebody without them having to pay it back. But you also don't just give them right amount of check and expect them to go and follow through. There's ways to do things that are appropriate. Talk to those who are in the business. Business people, how do you how do you manage a grant so that the money is is going to be used for the purposes for which it was intended, you're going to build a recreation center, you've got to have a contract, you've got to have somebody that's managing that. And then so on and so forth. There are those who you can assign to do that for you, you don't have to do it yourself, you can assign it to somebody else, and pay them to do it. Give them the responsibility and the accountability back to you that they have done things done, they have done things properly, as you've asked them. If I want to build a road, I'll use a state and their Department of Transportation to manage the account manage the the contract, it's a simple thing to do. And they'll be happy to do that. However, we're trying to get away from using the government for those sorts of things. But the government is made up by people who do that those people may be out of work. So let's put them together, put them to, to work doing some things that we're going to be doing, there's a transition. And let's help them to transfer the responsibility that this state or the city or the county feels that they got to be building roads and taxing people to do that. We'll do that for them. But we need help in managing it and managing the contracts and so forth. So there's good people out there, we just have to find them for what we want to do. Get in mind with the circumstances that you want to create in the best way that you can. Now, as always is the case, you have the person who is going to be your counselor, talk to them, see what they think. counsel with them, they're going to assist you not do it for you. But if you don't use them, then it's of no value, they're of no value. So become a friend. Work out your communications, whether it's weekly, monthly, or or every day check in everyone, you're going to need a lot of help in the very beginning. When you get up and flying really well by yourself and you won't have so much day to day decision making that they would need to give input to so but they're your resource, golden resource use it often. There will be no social security numbers that's not available anymore to be used for our purposes, or the quantum financial purposes, you'll you'll set up your account at the appointment, that person who's helps you with that will teach you how to set up more accounts as you need them. There's your golden ticket right there. That's the person who you want to talk to? How do I do this? Well, let me show you. It's a simple effort. It doesn't take long. And it it just takes a connection into the quantum financial system. And from my understanding, at this point, it may be that new Q phone, it may be a computer that's designated for that purpose or something like that, I don't know what it's going to be. My opinion is if the there are going to be a real nice even transition there, they will allow the present computer systems that we have to have their way into a portal through which you can go into your account in the quantum financial system. Ron Giles 27:16

Okay, I covered this many times, I'll do it again. The Alliance will contact you. I don't know how they have not told me could be a phone and my caller ID might say Alliance on here, oh, but they will contact you. It doesn't matter where you are. It doesn't matter who you are. If you are a humanitarian, they will contact you. And I keep saying if you're a humanitarian, you have Zim they're not going to get a camel, camel train to get out to you go through the desert to find you. They've got their ways to do that. I don't know how it's going to happen. And if it's out in a



remote area, they may be doing the appointment right there in your living room. at your kitchen table. They will contact you ask questions when you get contact. And there you go. I'm just telling you, they will contact you. How it happens is going to be your job. Your your you're at your pleasure. Do it that way. Let's put it that way. Next question.

I have been limited financially and could only purchase 10 trillion plus 50 billion Zim. Can I ask for a rate of two or 3 million? I think that's a pound? I'm not sure. This would increase the amount available to me for humanitarian work. I'm just gonna peace out. Yes.

Okay. Okay. I'll just simply say, you ask for what you feel you need. I feel like you need to get up into the quintillions. If you're going to be a Zim holder. So figure out how much money you have. Figure out the Zim that you have and times a rate or divided by the Quintilian rates that you want, and then that's your rate. So you're asking a question, can I? Yes, you can ask for whatever you want. And tell him that you want to be as in benefactor, then they'll say well, you need to ask for this. You know, you don't need to, they will counsel with you. Maybe ask them what is your suggestion on a rate so that I can qualify to be a Zim benefactor. 500,000 may not be enough. Two or 3 million pounds as you put it would be fine. Come from your heart. Don't make don't don't think this through and get blocked with your analysis, paralysis of analysis with your brain. Put your brain aside and get into the heart And that's where they're looking for you to come from. And that's where they will prompt you. Okay, next question.

**R** Ron Giles 30:25

There are those I've heard of a number of them just not so much public? have asked people put their gym serial numbers on a piece of paper thinking that the serial numbers have some kind of a magic and can't be duplicated. And if you try and withdraw from us, you're being put on a blacklist activists are just trying to stop you from doing the acute your redemption appointment on your own. Because they know that if you do so, then you'll get money because you're the humanitarian. And they have lost their ability to control a situation the narrative. So those kinds of people just let them go. If you still have the Zim there's nothing that they can do to stop you from getting your redemption money if you're a humanitarian. So if you've got your Zim wouldn't even concern it. Don't send in a letter cease and desist and all that sort of stuff. The Alliance has. They say you've made your appointment with that, and that's what you're gonna get. Those people are frauds and fraud vitiates your contract so you don't have a contract with them anyway? Because they were lying to you. So don't let that get in the way of things. If you got the zim, then you're good to go. Next question.

I noticed the mention of the word mortgage and the NRELS paper mortgages, the death pledge used against the people created by fraud of the bankers, solicitors and registry office. Does NRELS mean loan, not mortgage?

R

Ron Giles 32:06

Well, let me ask you this question, you're moving into some really gray areas, bringing in the concept of mortgage, if I had that in there, I don't remember putting a mortgage in there unless it was four or five years ago, when I was told that's not the right way to do things. So I've changed. If you look at the present documents the way they are in the NRELS, you will find that if there is a lien on the property, that's, that's a lien for the amount of the remaining loan on the property. That's the link, there's no mortgage involved. Mortgage is the illegal use of funds. And your reality is, is that you sign a promissory note and they take that in and they finance or monetize that note by the house and then you have to pay them back. It's your money that was used by the house. That's what makes it fraudulent. And that's why those who say that mortgages are not going to be paid off are not going to be forgiven, do not have a clue what the NESARA means. Because a mortgage is a debt instrument from a fraudulent transaction that you did not know was existing and that was the only way that you could do it to get in the house. The money to buy the house is yours was yours the house is already paid for you've already paid for it. So anybody that tells you that the mortgages and then as far are not going to be forgiven, then they don't know what they're talking about. And I know some high profile people that have said this and I argue with them till I'm blue in the face because the Saara will not allow a transaction that has been illegal from the very beginning a fraudulent activity from the very beginning to get in the way of that been released. Because they use your money to buy the house so it is your money anyway. Or your house anyway. You've already paid for it. Ron Giles 34:48

No, it's not correct. It all depends on what your your projects are dinar Don't forget about that as far as humanitarian work is concerned. Unless that's the only thing you have If you're looking around the neighborhood and said this, there's there's some people here who needs a wheelchair ramp. Well, the Dong and dinar might be sufficient income for you to have some money left over to do some things like that around the neighborhood. If that's all you're interested in doing, then that's fine. And those wheelchair ramps need to be built. The CAC program will get involved in that sort of thing anyway. However, if you're a Zim holder, then you've got other things that you're looking at. Now, there are those of us who are a little bit

older who have some ailments consistent with the age, we're going to have the med beds available for us. And we'll be able to heal our bodies and our afflictions to be able to function properly. And to be able to function as a humanitarian. For as long as we want, I don't know when you're going to stop, or when you want to start to get tired and say I am through and father to bring me back, I'm finished with this stuff, then that's up to you, that's your choice, your sole choice, whatever it is. But there's ways for it to solve the problems that you're talking about. Because they're saying it like it takes 18 months for even a medical person to transition into the use of the med beds. The military is already working on it. They're already training people. How long have they been working on? I don't know. But from my understanding of the way heavens do things they started a long time ago, and all of a sudden, here it is. And they've already gone through the necessary stages to get the med beds to us in a way that will be the best for mankind.
