So if there's 100 million trillions or whatever in the in the ground, then the bond basically says you have to go dig it up to cash in your bond. That's why it became obsolete, defunct, and declared such. They went in there and they they created bonds that were such a high value, not real value, but high numbers, that they went off the chart. So along comes and then that's good. You know, it's wallpaper from then on. But the Alliance says we have these large bonds, we want to get the money into the hands of people will take those large bonds, tell them that they can go out and buy these in bonds and will real redeem them for the price at a rate that they ask for, so that we can get the money into the hands of the people. Ron Giles 32:51

Well, the only relevant gold is the gold that's used to back the currencies. If a country has a lot of extra gold, Does that, does that affect their their currency? The old system would say yeah, does I say well, how can how can the gold in Fort Knox create value in our currency? When Nixon can come along and put us take us off the gold standard and start the whole series of circumstances where they create money out of thin air? That's what you call the gold standard. That's why I preach against it. Now frozen in time, what does that mean? Right now there got price of gold fluctuates. Let's take a kilo of gold. How many gold certificates are there in that kilo of gold? Well, there are enough to pay for that kilo of gold at the present value per weight. So a kilo, I don't know, let's say is worth \$1,000. To buy one of those. Well, then it's going to support the value of \$1,000. So when the quantum financial system is set in place, the price of gold is then held in time froat, frozen in time. And from then on the number of gold certificates to ascribe to a particular kilo of gold will always be the same. The price of gold goes up who cares? price of gold goes down who cares? The same gold is doing the same thing for every other country's currency. That's what we call a golden the Global Currency Reset reset to the thing value The dollar to the, to the dinar, the the pound to the South African rand, whatever it is, it's going to be the same. Why? Because when you transfer money from one country to another, the the difference in value right now has to be taken into consideration from one country to the next.
