Each benefactor set some up for themselves, the cards will, but they may have cards at the redemption appointment, I don't know it's coming was a hold up. If it's if it doesn't, if it's not released at the time, I don't know, they've got plenty of time they plan they do things before, before we know about it being done. So at the appointment, you may get your your cards to access the quantum financial system and be able to pay for things, there will be a rush by merchants to become part of the setting up their account in the quantum financial system. So you want to do business with them. You go in and you show them your card. And it's just an account to account transfer of funds doesn't go through any third party or anything like that. And they don't pay the fees that Visa and MasterCard pay. So why would you want to be associated with them? If you are a merchant? It's a transition. And it's going to always work out for our best interest. Let's just see how they think is our best interest. I am looking forward to this. Next question.

Ron Giles 19:25

Well, why can't people be taught that maybe that's not what's true. Maybe it's not their money. You have been given a stewardship, the money is yours. If you want to give it away, then you give it away. I'm not sure how the best way to look at this is. There's one way to look at it from a Zim benefactor point of view which means that you have a stewardship and the money is yours. You get to spend it as you want for the purposes of humanitarian work because you're humanitarian, and that's why you got the funds. Only humanitarians, you're going to get the funds, but they will use it. With the different programs. If you're Zim benefactor, you can use the love won society programs to do your humanitarian work. Not all humanitarians are going to be Zim benefactors. But all Zim Ben factors are humanitarians. It all depends on where you want to look at it. Not sure that I would be looking at it the way you're doing and say it's their money. That's entitlement. And recompense is a good idea. But that whole idea can go so far to the point where people will just sit down and say, You owe me a living cabal, or world, whatever, and then not participate in it. Because of their entitlement mentality. I wouldn't go there. This is a gift from your father in heaven. **R** Ron Giles 22:27

Well, it's a, it's a difficult question, the way that you're understanding it for me to answer the RSS program is, if a person signed up for the RSS, and later, in time, a person wants to have the opportunity to be in the ESS program. They're not mutually exclusive. What does that mean? It's not one or the other. It's both. You can be you can be a beneficiary, in the beneficiary program where you get bonuses and things like this for the work that you do. But that's coming to you. And then you can have an employment contract, regardless of whether you're calling up the ESS, or just simply the CAC program where owners of businesses can get a contract to stay in business for an extended period of time. And there's a whole parameters involved in that. And I won't go into it here, but that's part of the CAC program. So if the question is, can I have both? Yes, absolutely. Next question.

Once we activate our QFS accounts will be possible to actually send certified checks to charities, ministries and family members who are reluctant to activate their own accounts until they can see for themselves that this money is real and not part of a larger scam.

The it's an interesting question, if it's if the rollout is not done properly, then you're going to have doubts and fears about it, and possibly have doubts and fears about it anyway. But the we're looking at the general, if you want to go to the specifics, and somebody says I don't want to do that, because well don't they don't have to do it. They don't have to participate. If they when you're talking about certified checks, and all that sort of stuff, we're not going to have certified checks, we're not going to have checks. Because I see because it's all going to be digital, unless you have want to pay cash for a used car from some private citizen, and you go to your financial service centers get some cash. And the way that the cash happens is that the gold certificates that are the digital gold certificates are then transferred to the serial number on the on the font funds that are on the Note that you come back It comes out of the bank, you just take the cash and do your transaction. And then when they want to put it in their account, they go ahead and put it back in and it's the whole process was reversed, the serial numbers are reverted back to the digital gold certificate. And that's the way that the cash can go. And it's not going to be a cashless society. It's just a lot of hard, not hard work, but effort to get cash to do that. But it's, it's going to be part of it, especially in the transition until everybody

has their own accounts. Why would you never, why would you want to not get an account? Why would you not want to get an account? What perceived idea? Evil is there and having an account within the quantum financial system, the system is given by God. Now, if they don't know that, let's tell them faster we tell them, the easier it'll be. It's always a step ahead. It's always moving forward. When they roll things out, it's this is exciting. This is fun. Let's do this. There's other ways if you're trying to if somebody's starting a business, I mean \$28,000 A month that they can get from the from the beneficiary program actually start a lot of businesses. And I think it's going to be fun to see how, from a centralized commercial system to a personal, where we all can have our own businesses. And it doesn't have to be that we make a lot of big money like the big corporations, I have no interest in keeping McDonald's or any of those large corporations who business because of the way that they have treated us and built their whole system on the back of paying \$10 for people to flip hamburgers for them. And then they run around in their jets in their big cars and expensive cars and living in big houses and so forth. on the backs of the people that's gonna change, it's not gonna be that way anymore. So if somebody wants to start a business, you don't give them a contract to start their business, you give them a grant, that they need some more money, then you give them some more. It all depends on how you want to work with that particular person. And I can't tell you every shirt a set of circumstances, you're going to have a counselor as best way to work with this person. And you discuss that with your counselor. And you'll come up with some really good ideas. Perhaps some that are not presently available for us to think about. However, next question.

And those are the ones that you're responsible to pay their, your their activity that is in your ID number. But see, they won't have an idea at all. All you got to do is just do one person

with your your referral. And from then on, it's a brand new referral ID number for the whole rest of the chain. I mean, you can give as many beneficiaries as you want as a sim benefactor. But once it started, it's it goes on its own. The RSS program is designed to just simply explode like wildfire to to everybody in the world. I hope that helps. Next question.

Are there any differences in the registration process for a farm? If they are a co-op, they grow alfalfa and want this to be my first project to save the farm from being sold? Because it's currently for sale?

Sounds like it's a specific thing. And you have to know the specifics to solve the problem. And I don't know the specifics. So I'm not sure how to help you with that. Get in there, find out where, how to help them. You got the money to help them. Don't worry about them planting alfalfa or any other things save their farm. mean once you plant a plant, Alfalfa is an annual crop so it's there and you just let it grow and harvest it for hay and so forth. So it's not as if it's brand new There's a lot of things involved in that in the agricultural industry. And that's why, to some degree, it's a selective part that's part of the economic stabilization system, ESS program. And that's going to be administered by love won industries. Because it's a sophisticated concepts that has to be coordinated at some higher level than each is in benefactor. And that's the way it's set up. So you can participate, but it's by contract. Next question.

Question about NRELS in Ireland, is the five year rule applied to people like military and police and naval and air force who are continually being transferred to new locations? I would assume not unless they decided to keep the same.

I think whether it's saying is if they buy a home to the NRELS, and then they get transferred. How do they go about getting a home in a new location. Zim benefactors, have the hearts that are necessary to do and to resolve problems that might come up like this. And you have been given the ability to make adjustments to your programs. There's nobody that's going to, I would never fault you by saying, just simply forgiving the loan, they move out of the house, just get a new person to to buy the home. And then they can buy another home, where they're, where they're at, if they get changed every four years. And we have that five year. thing on that. Just adjust your thinking adjust their people we're hiring, we're helping people. We're not setting up a program. To that other people have to follow, we're setting up a program for the people. And so let's not lose fact that our responsibility, if you want to call it that is to the people, not to the program. We use the program because it's its order. And we do need order amongst those who are participating. So that you as as in benefactor in your location, and the Zim benefactor and another location are part of the NRELS can work the system the same way. But on an individual basis, if you need to change things around for an individual, a family, a military or whatever,

then that's fine. Do so be kind, be gentle, be loving, and show them a new way of doing business in life. And we're changing. And the change is being brought about by the way we handle ourselves as humanitarians. Well, let's just be sure we're doing the right thing for the people. Next question.

I live close to the border in Arizona and 1000s are coming over the border. I remember Ron saying the individual should return to their origin nation and register for the RSS program. This situation is sure to come up and I want my team prepared. I too want everyone to receive their share. But how would Ron handle this situation?

**R** Ron Giles 38:49

Well, how would Ron handle it? I guess I gotta give you my opinion of how I would I do that? When I say I believe it's it's the important thing for people to go back to their homes. home countries. I have reasons for saying that. Number one, that's their culture. Their family is there. They have problems that need to be solved in their own locations. Everybody's bailing out who's going to be there to help. If you were to have come across the border illegally, and want to be a part of love won society, or the revenue sharing solutions program, understand you're going to have to have an account. Will the account be available to you if you're not in that country? I don't know. The Alliance has talked to me about that and I'm not sure how that's going to be enforced. Or even if that's desirable to be enforced. I think it's a, it's an idea that needs to be explored by each individual who lives in a country that's foreign to them. What of all of the really highly educated blacks from Africa who have gone into Europe and other countries? What if we were to give them a very high stipend grant, I pay low or download account in the RSS program, to go back home and use their talents and their, the ways of their education in helping the people where they used to live. If it's if it's poverty stricken, then make those kinds of people, your CAC directors in their home locations, and see what magic can be done when there's plenty of funds. And nobody's trying to restrict them. Imagine us going into a farmer in let's say, a farmer in Uganda. We put them on this program, and we on our ESS program and do a farming thing. But in addition to that, we pay for wells to be drilled down into the aquifer that underneath all of Africa, shall we drill down and they get the water that they need to, to run their farms. The farms have their soil is rich in nutrients has been deprived, the waters the thing that may be holding them up? But what about equipment, and seeds and the things that are necessary to run a farm? What if we just increase that, and those farmers get the food and they have the land and everything to take care of it. And that may be co ops with the use of common use of certain equipment, harvesters and things of that nature. It's all available for us to do things the right way. And the right way means that we put out money that we don't have to have funds come back from. So we can drill 10,000 wells in Africa, and not worry about it. And we can pay for the engineering to get them in the ground up to the surface, and then use the engineers to get it to where it's supposed to go. Who's going to pay for that we're going to pay for farmers can't do it. They've been deprived all these years. So let's just do use our money to create the powerful changes that need to take place in the earth. And that's where the humanitarian heart will come in. Because why I've got this money that I've got to get out into society, because next quarter, I'm getting a whole chunk more of it. There's no reason for me to skimp there's no reason for me to wonder if I'm doing the right thing. If you're not doing the right thing, it'll come back to you. But you do have a counselor that will help you

with these kinds of decisions. And that counselors from the angelic realms use them. As you go into a newer area that you're not familiar with you use their expertise, yet their information for your what you want to do. Is this feasible? Can we work out a way to do this? Usually the answer will be yes. So we get a chance to to come from a different point of view. Now as we're doing this as humanitarians as Zim benefactors. If I've got the money that I can do all that? Do I have the abundance mentality? Or do I look for restrictions on what we can't do? Money can change things so quickly. The lack of money has caused the problems, then a lot of money can solve a lot of the problems, obviously, if they're social and things of that nature that are causing problems, and money's not going to perhaps solve that as easily. But resources for making changes is thing that we're involved in. And as we get involved in it from our hearts, we're gonna find the solutions to the problems. And we have the counselor with us. And together with our hearts and the money, we get to do the magic that this world needs together shells out from underneath the attraction that has been caused by the Cabal. It may take us a few years to do it, but we're going to do it because that's what we're here for. That's our calling humanitarians and that's what we do. We have a whole new vision to obtain. And without the vision, the people perish. That's what the gospel or the Bible says, without a vision people perish. Well, let's get the vision, then we don't want people perishing. And we certainly don't want to be lacking the vision that will help us to do what we're trying to do. So we're going to create our own visions of what we want our own goals, if you want to call it that, but we're going to do the things that are that we came here to do as humanitarians. As before they come up, every problem comes with a solution, those solutions are oftentimes in place before the problem is becomes relevant. I'm so strong in that feeling. And in that belief, and in my faith in that. That's what gives me the power in my own personal thoughts and ideas to be able to accomplish what we're going to do. Oh, please don't be offended. Please understand that there's, if we're off course, then we need to correct the course. And that's the only thing I'm trying to do. Then my blessings in love to all of the humanitarians because we have a lot of work to do. But show up with our shoes shined in, or checkbooks in hand or our cash in their hand wherever and solve the problems and go about doing the things that we came here to do.
