Well, I'd like to do some training, the NRELS is wonderful as it is, is not the major thing that you

need to train for it the present time, a lot of people will not do the real estate listing service, a lot of people will, most everybody will do the RSS, obviously, and then the CAC program, so we won't put as much emphasis on that. But we need to do some training on that. And we're going to get a number of people who are real estate licensed real estate people with a lot of years of experience in create a council so that we can hash through all of the details, and be sure that all the possibilities are on the table so that we can see the best way to do things. And from that level, then we'll go ahead and do training and, and bringing that information to the gym benefactors for their consideration. Does that sound good? Especially because that's a good idea. But there'll be there'll be training? Well, I just don't know yet. Well, it's all going to be, we think through the details as best you can. it is not the same thing. it is not the same thing. if you read the words that i've used in there, the letter of reference referral letter is the one is the way that like they're referring you, as the person who's sending in prone, they are coming in into the, to the appointment. They're assessing you as a humanitarian. And the letter will certify to me that you are a humanitarian number one. Number two, that you have obtained sufficient funds to do the RSS, the RSS program, and the other things that you have, as far as projects are concerned. That's all it is. You take that letter, you hold it until we come up with the Zim benefactor application. And you submit the application and that letter, that letter, that ticket is your ticket to becoming a gym benefactor. Without that, that's critical information that I don't know about. And if you haven't gone to the project, or the prove the process of what the alliance is called the way to redeem your Sim, and tried to go a different way, and you don't get that referral letter. You can't be as in benefactor, that's how strong it is. I cannot just simply let people become Zim benefactors, unless I know for sure that they have the funds and that they're humanitarian. And that comes from being certified by the alliance that you are in deed a humanitarian only have the funds. That's what that letter is for proof of funds, letters are proof of funds, if you're going to go buy something not to become Zim benefactor, so don't because it's the ideas that I get outside the information. employment contracts for business owners, where we call it BOCA is business owner contracts, you'll see whenever I count one person who's in business and get something like this, we'll be talking to every person that they know. And the information will spread like fire wildfire in that area. Whether they see this is that the director might be knocking on a few doors. But the reality is, is that you will put the information out there for people to come to a meeting, maybe at the library or something to use in your facility that you've set up. And you might have 30 or 40 or 100 business owners, they're the one to do the contracts. And so your your need is going to be to facilitate all of them. And work out the documentation so that they the applications or whatever you want to call it for the employment contract. There's a process there that we'll we'll try and identify in a more accurate sort of way. But keep in mind that it is from our own ideas. And yeah, they're my ideas. And yet the CAC program is, you know, it was what we've done. And we're just a little bit further down the road as far as creating that. Because we've we thought it through and they're sharing with other people. But you're you're going to have to have the same intense information and concepts of what you want to do that are uniquely yours, and be able to apply those things that uniqueness as you start the CAC program. So it's going to be interesting to see how this really works out. I don't think you're going to have to advertise or anything of that sort. It will spread like wildfire, and your biggest problem is going to be to facilitate that. So your director needs a lot of assistant directors, your staff at the CAC centers, the Community Assistance Center, that you have established in a location it's going to be it needs to be big, as big as you can get it and think big because you can have if a library or something like that doesn't have room for you might be getting a gymnasium or something like that, and a school or something to be to facilitate what you need to do to get the greater number of people under business owners under contract and their people. So it's going to be a big job, but I don't think recruiting people is going to be one of them. They will volunteer to be business owner contracts. It's such a good thing. So when you got a good thing, you don't have to promote it. Have people saying well, we we want to promote the RSS program? Well, okay, you start a little fire there and the wind starts blowing and that's going to go like wildfire, and consume everything in its path. Because everybody wants we're talking about money. responsibility and and require accountability. And the way that you do that is through reports. You're going to look at, there's 10, directors out there doing stuff. And once bringing in five, or six, or 10, or 15, or 20 contracts a week, and another was only doing four or five, then that director, maybe need some help to see what's available, see how so you go in and you bring him in, and you say let's do this, and let's do that. But I believe that the accounting process that you set up, is vitally important for you as a manager, as the manager of those people. It's a management tool. So I kind of sense that you feel that you don't need an accountant, that I believe in my mind that each individual who you give money to needs to have an account that is not controlled, that is reported from through the management of a bookkeeping company or an accounting firm, I plan on doing that, and I don't have enough people, but I'm getting big like in the world, I want to I I'm looking for internet and international accounting firm. So I can just tap into it to wherever I am. And I don't have to retrain everybody. But those are my plans, those are my ideas. So accounting firm, that's good thing. And you don't need to look for the businesses that need help all businesses needed help. And all businesses want to get those kinds of contracts. So need is not an important thing. What we're doing is changing the way that society does business. And we're using our money as a powerful tool for the expansion of the concepts of abundance throughout the world, and throughout the communities and throughout the cities, and that comprise the, the, the community, so I don't think we're gonna have to promote much at all. I have some questions about training where we have little information about the trust. So I would like to obtain more info about trust, and an answer about why actually operating an LLC cannot be used. Instead of a trust in the new system. What will happen to the old LLCs?

R

Ron Giles 43:53

Well, the word here is corporations. A corporation is a legal entity that acts like an individual. It's artificial. Now we're going to need things artificial in the new way of doing things. The the Vatican has owned every single corporation in the world. Every single one of them. It's by their decree. And all of that is going away. So when you say we're what can I use the LLC? Well, you can through the transition. I believe that trusts are the only thing that's going to be that will survive the GESARA compliance. Because I think it's organizations not corporations that are going to exist and how we move into that and how it's structured. I don't know yet. But I know that corporations are not part of what we're going to do in the future. Yet there's a vehicle there that can be used if Gods set up then go for it. I have love won society set up a corporation. So will I need to have a corporation sole in the future? I don't think so. I'm going to set up a trust for all the things that I do. So everybody's entitled to ask that question to their counselor, and get the right answer that's appropriate for you to have. So be flexible. Don't

question too much. Don't hold on to things of the past. Let it go and use it for the transition, and then love it and leave it. It's where they're like. That's, that's why I'm, I'm going to do it. if the RSS will take a block of time to get up and running, that's a block of time we've had access to funds and could be getting them out to people who need them. When we receive funds, the quantum system will be up and running. And theoretically, we should be able to start setting up accounts for recipients. If someone follows the plan for 10 cents a minute, roughly 52,000 a year, why not deposit 26,000 with instructions to return in six months to receive another payment? Or if available be registered on the RSS program? Does this sound feasible?

No, well, let's put it this way, you can do what you want with your money. But I won't, I wouldn't feel like a time crunch. Because once we set our wings and re establish the RSS program, it will fly on its own. And, and we don't have to worry about these kinds of things, in my opinion. We get our money, set it up, set up the RSS program. So set up the CAC programs, you're asking your what you're doing is you're asking if you can fine tune things, micromanage things, to get it done faster, and I'm saying it's gonna be overwhelming you, you won't be able to keep ahead of it. Six months and you give them \$26,000 or 28, whatever it is, that's not going to, you're going to have to manage that. You're going to have to remember and go back and do something about it. Why not just let the system take care of itself. Those are the kinds of thinking that I have, why why create more administrative stuff that you need personally you need to do, just let the system take care of itself. And it will just it will go along and do much better than we possibly can. If we try and find to micromanage our projects and our things that we're going to do delegate responsibility, get other people involved. That's where our magic comes. That's where the the use of the money is going to be well spent on people who are getting it out there. We might be the first ones to get the money. But it's the humanitarians that come after us, that will take our opportunities with the money and, and do the work of humanitarianism for the whole world. Because we can't do it all ourselves. So we're going to rely on those humanitarians that did not get the money in the beginning, knowing that we're this point of the spear and we did get our money and the rest of the spear that creates the energy to penetrate into the darkness with a point. All of that has is part of the spirit of those people who come after us are the ones who will do the work. Now, the QFS, there's going to be ways to do this, maybe they're giving free Q phones away, that you'll get into the RSS program. And and the quantum financial system, I think that everybody's going to have some wonderful opportunities, even though we don't know how that's going to happen. So a computer is not the only thing. A cue phone might be the smartphone, this designed to get you into the quantum financial system.
