Hello humanitarians. This is Ron Giles. I'm here with Tracee and we're going to do a q&a. This is February, the 21st. Prime Day, and we'll see how much fun we can have with that. 2022. So, February 21 2022. So with that, let's go ahead and start, Tracee. First question, please.

Okay, does it make a difference whether I'm a benefactor or not? What does that do? For whatever place that puts me with the Alliance or love won society?

R Ron Giles 00:38

Well, it sounds like you're new with that question. The Zim benefactor gives you opportunities to use our programs for your own humanitarian work, using your own redemption funds. Were putting on the trainees so that you'll prepare and go ahead and get your funds. And at the redemption appointment, if you're a vetted humanitarian, and, and have funds, they will give your referral if you ask they'll give you a referral letter, referring you to a love won society to become a zim benefactor? This is a good question. And I think it's important for you to really get into the program and start learning about these things. So that that's an answer to that question will just come to you. Oh, next question, please.

T Tracee 01:38

When we have established a CAC center with directors would a director who is helping a beneficiary from another state or country using another benefactors beneficiary ID number. Do they meaning the director have the approval to help with other programs like NRELS and ESS to that beneficiary? Will they be able to download extra funds per minute, even though the

approval was not from my master account? What if that benefactor has not accepted the programs with the love won society? That's a unique question. We've never had that one before.

Ron Giles 02:18

Yeah, it's a dilemma. Because a Zim benefactor, that's up an account for a Zim beneficiary beneficiary account, as far as paying the 10 cents per minute plus the six trusts that they establish them. And then that beneficiary wants to get a job. And this beneficiary could be somewhere quite distant from the benefactor. And so the new employment contract that they're going to get, somebody has to be able to go in and create an account or employment contract, account with them 25 cents or whatever they will, their their money is supposed to be or whatever the wages are supposed to be. But the, the old benefactor will have to be paying for it. And some people perceive that as a problem, but we're all doing it together. So I don't think it's a problem unless a benefactor gets all uppity about it, and paying for her employment contract for some, you are paying for a contract, an employment contract. Is there a problem with that, even though the beneficiary was not yours, or the beneficiary is yours, and, and the employment contract is from another location, but you have to be directors have to have access to it or we have to have do dual beneficiary accounts. And that's that's not going to happen. So the point is, is that the original user ID benefactor that set up the account for the beneficiary will still pay that beneficiaries employment contract amount to their master ID or master account and RSS program. So that unless there's some changes to be made, that's the way it's going to be. Next question.

No. you appreciate it and you will get redeem it will you be alliance will redeem it for you. Ownership is his hat has very little almost none existant value to the alliance, as long as you're showing up and you're humanitarian. They know all that stuff. So it's not it's a non factor. Let's put it that way. So don't worry about it at all, your humanitarian you reading? Next question.

If we are contacted those beings who contact us come to support us with the projects individually? Is it the unified field technology that will help us to transform ourselves to help transform the planet?

Well, you've got to, and unified field technology, I'm not really sure what those words mean, if you're talking about the quantum field of understanding, or whatever you want to call it, it does

you're talking about the quantum field of understanding, or whatever you want to call it, it does tap tap into that the individual who you'll be your, your counselor, your friend, is there to help you to become a humanitarian. They won't help you with your projects. As in, they came here to help you with projects. No, they came to help you as a humanitarian, you will establish your relationship or working relationship with that entity. And they will be there as a resource for you to ask questions in software. They're not there to do things for you. And they won't. They'll encourage you, perhaps to do certain things. But you're the boss. And they will just give you some counsel, but you the decisions always are made by you and will not be made by them. So you'll work out your and it's it's the best way that you can have far as resources concern, but they're not going to do it for you, you have to do it yourself. So ask them the questions. That's what they're there for. Hope that helps. Next question.

On q&a 11/29 at minute 13 You are saying that Loveland society can do the accounting for the benefactors working with LWS programs. Many times over, I heard you say that no one but the Benefactor himself knows what she or he has in their master account. Can you explain to me how the benefactor and love won society will be intermingling together, I would like to understand the intricacies of this cooperation between the parties so that my planning can consider all aspects of this agreement.

R Ron Giles 07:54

There's an assumption that somebody in love won society will know all about your benefactor processes in their back office. I suppose if there was any need to do something of that nature, it could happen. The information is there. And the reports are going to be available for you as a sim benefactor. But you're using the program. I'm using the program, every benefactor will be using the program for themselves. It Right now we have 11,000 people that are being trained for to become a gym benefactor. Love won society has no interest in keeping track of that. It's an accounting, the RSS program is in the accounting process. So that you get paid for what you need, and the people are as a beneficiary. And as the benefactor, you will find out, you know, the funds that are necessary, but I'm not sure if I'm understanding really what you're talking about or what the question is, it sounds like that you have a problem with love won society, knowing what's going on. And in your back office, and I'm just saying to you, we have absolutely no interest at all, as long as your master account is funded. And people are not having problems getting paid through your master account. Or if you've derelict in putting money in there, where's the funds coming from? Well, love won society is the one that will be responsible, but your master account, and the way it's going to be set up is that you bond that account with the money that you put in your bond account, and the contract will read the account agreement will be that if there's insufficient funds in your master account, the computer will go over to your bond account and draw from that. That's what the bond is supposed to do. So that there's no problem with payments being made to beneficiaries. So those are the things that we are working out. And that will have to be of necessity in the benefit zim benefactor account, or in the same benefactor contract, we're not going to just simply willy nilly create liability for love won society in the RSS program, without having somebody that is responsible for it. That's why it's an it's a contract that you make. And if you are derelict in that contract, then there's remedies that are going to be available to love won society. And that's just good business. So although this is all humanitarian stuff, it has to be aboveboard. And it has to be in a position where there are things if you screw up, then there's ways that things can

take care of it. Perhaps even just automatically, if there's a problem, you will be notified. And because that's it'll generate the report, so and you will be appraised of that going into the bond account to to pay the things that are below the amount of money that you put in. I hope that helps. We're going to run this as a business. But it's all humanitarian work. Next question.

No, that's their business, not ours?

No, no. The referral letter, I don't even know the verbiage on it. So I can't I can't do that. If you're asking me to do that. I suppose I could. But why would I want to do that? The person who is there that's doing the interview, your redemption appointment? They've been assigned to you and have been working with you observing you. And it could be for all of your life? I don't know. I really don't. And so what we're talking about is a person who knows you intimately. And it's not just brand new stuff. And if they know already know that you're a Zim benefactor, or excuse me, a certified humanitarian, that letter will already have been produced by them. So we there's no reason for us to get involved in that. And then at all, okay, something that they will take care of. So

Well, the important thing is that is that if you're this level, there's a very strong chance that you are a it can be a vetted humanitarian. And don't worry about it. That's what I say. If you're humanitarian in your heart, you know that. And if you're not, you know that as well. If you pretend to be something that you're not, you're going to be very disappointed as you walk out of that redemption appointment, because you may not have any funds at all. That's the scary thing is if you're not being honest with your show, you continue to tell yourself lies, and try and live a different type of life than what you really are. That will show there's no way for you to lie to these people. They see it in your RSS, they see it in your accountant, they see everything.

And so you're an open book, and you'll be judged as a humanitarian. You know, if you've had some things in the past that have been that you feel might won't qualify you to be a certified humanitarian. You'll leave that up to those who know your heart. And if you've if you've done something wrong in the past and go through the process of repentance and and deal with it, don't just sweep it under the carpet because it's it's still there. So deal with it and set yourself right. You're gonna sail right in there and your ship isn't listening to the left or the right or drawing water and just barely afloat. You know what's going on and they know what's going on. So you'll, you'll have a meeting of the minds, don't go in there afraid, just don't do that. Go in there with all of the confidence that you are acceptable as a person who's going to do humanitarian work and will get the funds to do it. So I don't want to create a a confusion here. And yet, I have to emphasize those points that only humanitarians are getting the funds. Because that is true, so don't worry about it. If you have it in your heart, it'll be there. Next question.

Ron Giles 16:09

It's a, it's a problem that you've created in your mind, somebody told you that the point the point is, is that our bodies are going to be changed. Now, I'd like to make a statement about med beds. I had a person on the on the thing kind of chew me out because I was talking about bed beds, and she says you shouldn't comment on things you don't know anything about. And I respect what she has to say. And that's true, I shouldn't comment on any on things that I don't really think about. But as I inquire about this, there is something different a foot than med beds. What that means, I cannot tell you, I'm just quoting you the words that I heard, there are changes afoot. Now, that means that there's something better than the concepts of the med beds, that may happen to us. And if these kinds of negative feelings, you call him a virus, there's no viruses, really, this is a mental state here, and it's not even mental states have jozin Safe at any rate, but what I'm trying to say is, don't make something out of nothing. You hear somebody say something like this, and now you've created a whole problem surrounding that on something that may or may not be true. No. But we know, we should know that as a valid humanitarian, we're not going to have to deal with those kinds of things. Now, there will be other people who will have some of these kinds of problems, perhaps. We're here to help as many as we can. But each individual is a free agent, and has their own choice. And we're not here to take that choice away. That's called cross dominion. We just start in on that sort of stuff, then we're creating karma in a very negative sort of way. There isn't one person from the higher realms would ever do something that is crossing Dominion wouldn't do it. That's the main reason why I say to you, that your counselor will not tell you what to do. It's not his dominion, is coming into your store. And you can ask him questions. But he's not going to tell you how to how to run your business. He's going to sit, he's not going to sit at the cash register and be sure that everything's correct. That's not what they do. So those of the higher realms will honor that dominion and not cross it. And one of our biggest processes or projects, or problems that we could face, is we get into we want to help everything and do and give it away for free and all this sort of stuff in crossing over Dominions because we can't we think that they

should do everything that we think is right. They have free agency, they have choice. You take away that choice by only making stuff available that they like, then what good have you been to them? If they want to have some modalities, go to a health clinic or something to get better than they can if they don't want to, and you put all this money up and create this thing and think it's a vacuum that these people are going to come and fill up. It may happen, but it may not be wise in the things that you do. We're giving people in the RSS program, it's giving people at least \$1,000 a week and probably closer to 7000 a week. And then that doesn't include bonuses and other things that they can get. By going out and spreading this around. We're giving them \$28,000, potentially \$28,000 per month. And our humanitarian people are going to give things away. When these people will have the funds to take care of it, that that will with use of those funds there. That's their energy, that's their own stuff. If you take away the ability that they have to use that and everything's for free, you have destroyed the whole process. If somebody has the money, let them pay for it. It creates dignity. If they need a leg up, then you'd give a leg up. If they can pay for things, then let them pay for it. If they can't, then you adjust things accordingly. But just don't give things away. No skin in the game, no interest in the game. So be wise in what you do. We're giving the money to do things. Don't take away their personal dignity by giving things away. It doesn't work. Okay, next question.

How can future benefactors recognize any contact from those conducting redemption is genuine or recognizing any of the team bad guys trying to interfere with humanitarian projects by impersonating the true or impersonating? Sorry, the true redemption contacts?

R Ron Giles 22:06

This kind of question means that we haven't, that the alliance hasn't take taking care of things. This could be a problem if the Alliance hasn't taken care of things. But from my perspective, they will take care of these things before we have the money. If you try and go in and impersonating mentioned this brought this up earlier in this question and answer. They know who you are. You can't you can't get around this. You can't hoodwink, you can't be dishonest, the only thing you can be dishonest with yourself. And as a result of that, you may not be getting the funds. So I would like you to just simply throw out this kind of thought processes, because it has no bearing on where we're going. Things are going to be cleaned up before we get our money, not afterwards, that we have to concern ourselves with. So just let this kind of thoughts, let them go away. They're not they're unproductive, they bring down your energy, they bring down your vibrations. It's worry, it's concerned. It's doubting the system. And when you start coming from that position, you're lowering your vibrations. Just the thought of doing this lowers the vibration, so don't go there. It's unproductive and will not be of benefit to you. So let's go ahead with the next question.

Is the counselor someone we can see and talk to on a weekly or monthly basis for advice on how to be a good steward or benefactor of the Zim we received to help humanity?

Ron Giles 24:04

My assumption is that you will create the kind of relationship you want with his counselor. They're not there with a precondition, though I can only do this around not gonna do that I can only see it two or three times a week or so. When you need help, that help will be available. That's the way that I see things. Now, if you're barely independent person and you don't need a lot of help from them, then you you won't talk to them very often. But I believe this is your best friend, best friend. You know, he's from the other side of the veil because they're interested in you, specifically you and a personal basis. And their job is to make you a good humanitarian help you to become a good humanitarian. And I think you'll really enjoy this experience. And again, you are the One who will create the relationship that you want with that person, they are available for whatever level you want them to be with you. And then again, we'll find out. I might be wrong, I might be just painting this with a big wide brush, this just beautiful stuff. But that's the way I believe it's always going to be for our best. Oh, when you say, My people on the ground, love won industries is going to be huge. For that to be effective, it has to be under one control. Now, we're not looking for power. And we're not looking for a legacy and all that sort of stuff. We're just saying, if we're going to accomplish what the ESS program is doing, that means we buy everything in the world. And we sell it, resell it through and distribute it through its normal distribution channels. But we are in charge of the funds, how much we we charge for things. And we will be very responsible. But you can probably see prices of things coming down. Prices or things coming down on one end of the spectrum, people getting more money on the other end of the spectrum, all of this thing on both sides, I'm trying to think of a better word in nerd to the benefit of the of the people, each individual is going to benefit them. So we have to be have a central control of this. Otherwise, it is chaos. And I'm not going to participate in in chaos. So those who want to get involved in the US and the ICCH, that will that will be by contract specifically laid out. Now, I haven't given the the intense energy into that to figure it all out yet. But that will be coming. There are those who are already assigned. And I'm aware of who's some of the angel ik realms that will be involved with those individuals. It's huge. It's major and requires some really high vibrational energies from the counselor. So it's an it's an archangel. So and I know that there's a number of people who have Archangels as their will have Archangels as their counselors. So they love us they want to do really good. That means they don't have to come back to you every time they want to get paid. They can go into their own account. Now it's like a bank account, this keeps getting all their money, are they getting their money through the bank account. If you can find a better way to do it, then go ahead and do it. I don't see a different way. I don't see a better way than that. So, but it's up to you. You are the one that's in charge your money, your Stewardship Council with your people with your counselor to see what's best and each individual family member has perhaps different needs. respond to those and and it'll be good. But it's none of our business loved ones listening to my business how you do it. It's your except for the contracts and things that you sign. Otherwise you're in charge you your money, you get to do what you want, set it up the way that you want to do it. With that, let's go to the next question.

Ron Giles 30:16

Well, it's you've made some interesting statements. Number one, we don't monitor anything. You have absolutely no ability, once you start the RSS program, and Jim benefactors, excuse me, beneficiaries are being signed up all over the world, and you may be started in Philadelphia, and you end up with some people in Puerto Rico or South America or any other place, you have no way of monitoring it. It'll grow as it grows. Absolutely no greedy Millionaire is going to be involved. Because those are the kinds of people that we don't want in our society. Show if they're greedy millionaires anticipate that they'll be gone. And that they are not gone. And they're not going to be greedy millionaires anymore, they'll just be people who are trying to have a life. But if there's greedy people around, they will be dealt with, according to me by the Alliance, not by us, we don't have any care and concern. I don't care if a greedy millionaire wants to be a part of the RFS program. His account could be frozen, and all kinds of things like that, that the alliance has in place at millionaire has to go through the quantum financial system. If he's screwing up and doing things mean, he's going to have his account blocked. So there's some teeth in this, it's very benevolent, because but we're a society that's moving into the golden age of mankind, we don't have to carry trash with us. White Trash any other trash. Well, the the HOA has some teeth in it. And it's, it's had to be that way. And I understand the the nature of it, and those who get involved with it potentially can become dictators, tie radical control over other people. I'll say it this way, there's problems with that whole structure, yes. But those kinds of people will not be associated with us. Because people who want to have control over other people and try dictating into their lives, that is a sin, that is a trespass. That is not tolerated in the new economic system that we're creating, we're going to be living by higher principles. So those kinds of people, they start doing that. Or if they continue to do that, they will be up for reassignment at another location. And it's probably not going to be Earth.

However, Our people will they don't have to go to work for money, they'll be getting 28,000 per person, as adults per month there's gonna have, they're gonna have a lot of money, you could buy the HOA and the whole system, you'll have eventually have enough money to take care of that sort of problem when it arises. So yes, governments, we're supposed to be our friends, Hoa says we're supposed to be our friends. If we as a community, create a Thai radical way of dealing with us. Who does that reflect on that reflects on the people themselves that do the electing of these HOA people? If you're not if you want to participate in that kind of garbage, then vote for people who are greedy, anti radical in nature. That's what people have done in government. Of course, we've had the voting systems all been rigged for centuries, to get in the right people, as if they could, if they could mess it up, then they will just so that they can get the right people in. However, that's all going away. So things are gonna change. I would allow this to change to if I was in charge of it, and keep a very close eye on it. Why don't you look at that say, these people that have had the stem sees in the past, things are going to be really good now for them. And they're not going to have that same kind of propensity to be mean. There's no way that we can control it, we can only respond to things as we move along in society by solving problems. Most of the problems in the past are because of money or lack of money, there's going to be a whole change in society, when lack mentality is no longer the prevailing way of thinking. They're going to, they're going to be abundant thinking. So my, my suggestion for as an answer to this question is, don't go there. Don't believe in that.
