So I'm not in harmony all the time with Simon Simon, but respect the fact that he gets his information and has his followers in there, he's doing a good job for them. You're, you're the one that's in charge of your humanitarian work. Love won society is just a structure that you can use, that we're letting everybody use. So if it's if there's something else that you want to do, then you have no problems from us doing whatever you feel is appropriate. My only concern not concern even but I would say be sure that you work through your with your counselor, and and then go from your heart. We're not here to control you. You think as far as I'm concerned, you're in control. There's no reason for me to even try. You'll you'll get to do what you want to do as far as humanitarian work is concerned, because that's why they gave you the money. You don't have to ask questions or permission from anybody for what you want to do. Next question.

Have a question about the referral letter? Is it the alliance that provides the referral letter for us to give to LWS? or is it LWS that provides the referral to give to the Alliance at the redemption meeting? Sorry for my confusion on this topic.

Ron Giles 04:33

You're not alone. There's been maybe 15 or 20 people who have asked for a letter from me. I perhaps didn't write it down clear enough. But you're going to go to your redemption here. Here's the dilemma that love won society is in. I'm going to have you sign have a contract that you will pay for the liabilities that you create in your love won society activities without the RSS program, I have no way of knowing if you're dishonest with me if you have the funds to do that. So therein lies the dilemma. And although I'm sure that most people wouldn't, wouldn't lie to me, but what I'm asking from the Alliance, and they have given permission, now, listen to what I'm saying. I have checked with the Alliance and to solve this problem they have offered to give a referral letter from the appointment that states that you do have the funds that are necessary to take care of your responsibilities with the RSS program, that you are a humanitarian. And that they are referring you as a humanitarian as a vetted humanitarian. To your they're referring you to me to have you become a Zim benefactor. Now, is that important? Yes, it is. Without that letter, there will be no contract offer to you for redemption for to become a Zim benefactor. And that's the way it has to be. And that's what they've said they would do. And so that's, so that is what I'm asking you to request from them. When I say you have to ask, you have to ask for the referral letter. If indeed they feel that you're that you're refer in referring to the competent and referring you to love won society, to become a Zim benefactor. So that's, that's the process. When you're there, you asked for the letter. And of course, in that

conversation that you have at your redemption appointment, you will know if you have sufficient funds, you will know if you're humanitarian, because you'll be offered funds. So I feel like that's good communications that this has been one of the I'm scratching my head trying to figure out, why would I give you a referral to them? I don't even know who you are. So, keep those kinds of things in mind. Make it make it sound reasonable. Oh, okay. Next question.

Okay, so, with that said, Maybe we should provide an example of a referral letter so people can see what you're envisioning.

R Ron Giles 07:50

Oh, that's an idea. Good job. And we can do that just posted on Telegram, send it out as an email.

And you know, the document that is like the cover sheet for the Zim redemption appointment that has like, what you're requesting, like the accounts, the trust names and all that. I don't believe it says, to have a referral letter for LWS, so maybe we should update that.

R Ron Giles 08:17

Oh, yeah, that's what. Okay, I was told to do that and haven't done it yet. Okay, so I'll, I'll update that. Yeah. Good. Good thought.

Write it down. Boss, man.

R Ron Giles 08:30

Way to go. 99.

T Tracee 08:36

All right. Next, I'm a French Canadian from Quebec. And it seems the French telegrams link don't work anymore. Is there a new channel for French people? So I read this question while you are answering another and I just took the French telegram link. And I posted it in the chat and I will check the the master links thing and make sure it's the right one. Okay. Okay, sounds really good. didn't change anything. So,

yeah, the problem that we have is that the links, if the links go bad, it's not because of something that's changed from us. Sometimes it's, I don't think that telegram change the links either. So I would look more towards your own system and how it may be screwed up on that part. Because all we can do is give out the links. There's nothing that we can do besides that. So if there's if there's a problem, we can send you a link, and if that doesn't work, and I'm not sure what to do.

That is so so very important, though, the idea of just giving things away is not the right way to approach your humanitarian activities. People have dignity and and they want to be able to pay their way. They just need a leg up. They don't need a government door all the time. So let's be sure that we're doing things in a way that is effective. And, and if you pattern your activities, with love won society, programs, then you you should be in pretty good shape, because that came from the heavens. And we know that that's the way that is meant to maintain dignity and so forth. Okay. Next question.

Pertaining to the trust under the RSS beneficiary accounts. I'm assuming that's the six trust. Okay, can funds be transferred to those trusts from the beneficiaries account, or other outside accounts of the beneficiary? I understand that funds from the trust would be able to be drawn upon and transferred out for purchases and usage. But just inquiring if those trust accounts can have funds also added to outside of the RSS. Okay, I get it. So what they're saying is, say for instance, I set up a trust for one of my underage children. Okay. Yeah, they are asking if say grandma wanted to donate 100 bucks to that trust. You know, can anybody add money to that trust account for that child?

Not in the RSS program, you can do what you want outside of it.

They said, outside RSS program. Yeah.

Ron Giles 13:10

Putting money into the trust, that trust is set up in a way that it is. We're using it for our RSS purposes. But it is a legal entity, if it has a bank account you just transferred into the bank account has nothing to do with us. So if grandma wanted to give a grandchild, some money in their trust, then go to the trust account, put the money in there. And that's in the quantum financial system or bank in the transition. So grandma's Welcome to give a child money. They just don't go through RSS. You. You put that money in the trust account within the banking system or the quantum financial system. It doesn't have anything to do with us. We're giving that that account money and so his grandma and it, they're they're not. They're not joined together, except when the money gets into the right hands. Next question.

I want to be as in benefactor, but since I woke up after learning about the children and all the lies we live in, I have been angry. I do my best trying to manage it, but I'm so frustrated. I am hoping after the RV takes place in the world begins to write itself that my emotions will have more joy. But I'm concerned that the alliance might not feel I am suitable. Any thoughts?

Ron Giles 14:40

Yeah, I have some real good thoughts on that. Don't judge yourself. Period. Don't judge yourself by your emotions. You are who you are and that's who they know you to be. Now you might have some emotions that are your You're angry and that sort of thing. That's okay. That's not who you are. Those things can change but who you are can't change, you understand their humanitarian, you can get angry. And you can get very frustrated and upset, you might even swear a little bit. That's not a judgment thing that the alliance takes into consideration. They're looking at your heart, not your mind, not your emotions, you know, some of those things are contributing. But the fact is, is that they're looking to you as humanitarian, they're looking into your heart. And it's from the heart that they determine you to be humanitarian, your past history, and what you've done in the past, and things that you've done wrong. Don't bring them forward, because the Alliance doesn't, don't bring them forward and say, this is this identifies me, this is who I am, because I did stuff in the past. Now, if you're the humanitarian, that's what they're looking for. So don't judge yourself. Don't be harsh on yourself. Let your heart come out, coming from your heart, and get out of your mind. You've got some judgment against people that have been doing some horrific things to our children, you're going to have

to forgive them. Now, am I saying that they're going to get away with that? No, let justice take its course. But you're not involved in the justice. So don't judge them. Your job is to forgive and forget and move on. Why? Because if you don't, who does it hurt? It only hurts you, if you're carrying are hurt, that has absolutely nothing to do with what happened with the children. That's the cause. That's the reason why you have those feelings. But you're having negative thoughts and feelings about somebody else that is hurting you, not them. They go on with their lives and doing what they're doing, and has, and they don't even know who you are. And yet you're the one that's causing your problems for yourself. So be sure that we understand things the Alliance certainly does. And they are not going to judge you. They know you by your heart. Next question.

You have your referral number and you give it to somebody else. And that's the way that they sign up, that's when it comes time to register, you'll they'll register using your referral number and then you get credit for that. Other than that, I'm not sure what you mean, referral ID, you got to have a referral ID number to sign up. And that number is the person who referred you. And so when you refer somebody else you will be using, they will sign up using your ID number so that they get credit for that. For the bonus program. Hope I made that clear. Next question.

Ron Giles 19:03

Yeah, clearly, you know, here's my suggestion. The website has all of the answers to any questions that you can find or that you can come up with. That's my opinion. And that's been my experience. First of all, when you get involved with us, or want to get involved with us and see this might be something want to do, you go into the website. At the top there are menu items. It's black with white letters, some people have not been able to find that. That is where the menus are. Click on that. And you add then there's articles that you can read. My

suggestion, first off is you go to the first menu and click on that and start reading those documents. They're kind of in a chronological way so that you can get familiar with things as you move through it. And then You'd go to the next menu item. And then there's questions there. And then you can go to the, to the videos, the training videos, the training videos will make a heck of a lot more sense if you've got the background having read everything. So my suggestion is you read things first, then get into the videos. The program videos are really good. And then the question answers are following up on that. So there's three prongs, that you, you have here, reading, and then the two different types of videos, you're not going to get away without doing that. You've got to become an educated person on all of the programs and everything that we want that we're trying to do. Now, if you skipped something, well, I'll say it a little differently. It's your job to become familiar with the things that you want to do. And there's no getting around it. This is not a school, or anything like that, that you can just get a passing grade and then move on and forget the information. This is information that you're going to be using as humanitarian. So you're going to have to not, and we want to take the easiest way to learn that's possible for us as just our human nature. But you're going to have to put in the work, you're going to have to put in the effort. And the mental capacities show up when you're doing your education. And remember things, learn the words, learn the vocabulary, we've got a glossary at the beginning of that first menu item. Read through that. And and then I understand that you can go back there and get a definition on a word that you don't have, or that you don't remember. This is a self learning program. And it's important that you show up to do your own work. Now, we can only give you the things. There's over 10,000 people that are being trained right now. There's no way that we can do everybody on an individual basis is designed for the greater number of people. And those who will show up and do the work are the ones that will get the money from the redemption appointment. And get the referral from your redemption appointment to become a gym benefactor. Those big rope for the big ships their mooring ropes, has nothing to do with them nationality. I've had one other person has thought that too and said why do you use that word I have explained to him has nothing to do with nationality. Now, if you've if you've straightened thing down as far as Mr. D long, then that's fine. I have no problems with with what you're doing. However, I can see where you got the idea because I said that the alliance is watching that. The telegram as that when I say the Alliance, specifically you will have somebody who's assigned to you as your counselor. That person is following your your mood right now. They're observing your activities. And they're determining how best to to counsel with you and help you it's nothing it's not a

negative thing. It's not a judgment. They're there to help you. So when you talk about the Alliance, in this particular case, talk about your counselor, the one that's been assigned to you, because that's who's looking at the telegram and seeing how you interact with other people and how best to help you in their responsibility to help you. Come as a humanitarian, so kind of take a look at things a little different way. I know that it sounds like you're being pressed upon, but that's not our intent. We want you to be the highest and best functioning humanitarian that you can be so that so that you can accomplish the work that you've set out to do and fulfill the full measure of your creation as far as the humanitarian is concerned. So the Alliance knows who you are the Alliance, okay? Meaning each of you have a counselor that knows who you are. And they're, they're going to take care of you. They're going to call you at the right time, or communicate with you at the right time so that you will have your opportunity to become a good benefactor. If that's your intent, and if that's not your intent, then to become a good humanitarian. Not all people are going to be all humanitarians, you're going to be part of love one. But all those who are part of love won society will be humanitarians. How's that sound, so the alliance will contact you, you will be contacted. And don't judge yourself and cause a bunch of heartaches and concern. Just let everything go and be sure that you're doing what you can to be appropriate. And there's no judgment here. Really, there is no judgment, unless we feel that your intent and being in the chat room is a problem? Or that you're not there with the same intent that the rest of us are. Don't that stand out, then we would not want you to be a part of our program. So that's all that that was about. So next question.

With med beds? We'll see and benefactors be given priority to the private use of med beds? No. No, you just because you're humanitarian doesn't mean you buddy in line for somebody who's dying. Be reasonable about that. There's a nod towards humanitarian. But it's not in a priority basis. Because everybody gets a chance to have their opportunity for a med bed. Okay, do med beds heal vaccine damage depends on the med bed that you use. There are some that will there are some med beds that you go in and give your sample of your DNA to and then they they take it and determine how and they wash the DNA and figure out how to do it and then they put that DNA back into the machine. And that's what you get. That will not heal the vaccine because you're giving it damaged DNA to start from. And so you're going to have some problems with that. So stay away from any med bed in my opinion, this is just my opinion. Stay away from any med bed that you have to give your your DNA to before you go into the med bed experience. Okay, do they heal severe emotional trauma? Yes, yes, they do. The children coming out of the dams are or the caves or tunnels whatever. They have a special priority as far as because the med beds are not available to all of us but they're available to those in a in a different sense. Those children have been taken and put into locations where they can be taken care of. They'll go through a med bed experience and all the trauma be raised so that they can have a life after that. The the military the men that go in there and have children of their own

and see what's going on. It is extremely traumatizing. And to the point that they can't function they would not be able to function where they do not have the med bed experience. And we want all of that erased so that they can come back home to their families can be the dads that they they wanted me. So there's a lot of stuff going on now. When will they be available? You're getting as good as mine, if you're listening to all of this stuff, I have no inside information. I have my own opinions, but they are my opinions and I won't share them are at this particular point in time. I don't believe that med beds are the cure all. I don't believe I believe the technology is there. But there are other things that can and would happen possibly happen, that would heal us to the extent that we can live up until we get into the med beds. And those are things that that may be coming, I've heard that they're coming, like the blasts of light from the Central Sun and that sort of stuff. It's a very healing process. But keep that in mind that if you're lacking behind as far as your humanitarian heart is concerned, or even you're being civil to one another. If you're not in the higher vibration, that that, that that beam of light might kill you, and be very uncomfortable, or it might kill you. So you have to determine you, on a personal basis. Prepare for it, quit judging other people, quit talking evil about people, quit doing the stuff that you know is not right, cleanse your body, cleanse your mind. Get rid of the judgment process that is so emotional, that it overtakes you, and makes you so that you're incapable of raising your vibrations. Yet out of fear, do not fear. Turn not doubt not, but be believing in all things to work out for your best good. Is that not the promise that we're giving? Yes, it is. So if you cleanse yourself of your thoughts and your ideas, and focus on things that are our true and focus on things that are loving instead of the bad stuff, then it's a good way for you to work through all that to the point where you're ready for whatever is to come. And you know, it's all benevolent. And we need to, we need to understand that there's no punishment, that's coming except for justice. And that's not our job. So we stay out of judgment, let those who do the judging the military and the tribunals and so forth, take care of everything. And in God's mercy, everything will be done appropriately, justice will be served. And we don't have to worry about it. So don't judge it. No, that's the only way that I can go through this without I have children of my own have grandchildren male. So I have I can I can fall prey to that, especially if something were to happen to one of them. But I'm just staying away from the fear because the fear that that was we focus on is that which we bring into our life. So I'm not going to focus on there. I don't want it I know, from my own kids for my own sake, I'm not going to focus on that I don't want it in my life, so and then the life of my children. So just stay away from judgment and focus on fear and and be sure that we're walking a good path. And we have control over that. But we don't have control over other things. That things be as they should, as they are God take care of next question.

I haven't really put anything on the forum. I don't think you ever But there's no training materials on telegram that I'm aware of.

R Ron Giles 35:07

Yeah, it was a confusing question for me. And I thought, well, I better check with Tracy. So I'm not running amok on things. But I believe that, when you ask this question, here's my thought, to trying to get things done in your way, the best way that you think we should be training you. But keep in mind that there's 10,000 people, and we can't direct our training for each individual, we have to do it on an overall basis. And then you as the individual, here's the information learning, just like I said earlier in our conversation here today. There's no shortcuts, the only problem that I see is in people having a hard time with language differences, and understanding what the literature is. But we've we've done all of that, so that you can get on to YouTube and get the videos and so forth in your own language or the subtitles subtitles. So we're doing the best we can. We don't have a lot of money to be doing a lot of things. And I'm not sure that those if we had a lot of money, if all those other things would be that much more helpful. Because if you're having problems, everything that you need to do, as far as the language is concerned, from my perspective, there is available for you to do, there's no blocks that we've put on it. So you've just got to do the work. And hopefully that'll be okay. Next question.

Ron Giles 37:16

Yeah. It's a it's an interesting question. And mortgages, you know, you're using definition and terms that are not relevant. It's not a mortgage, it's a home with a lien on it. As far as the volume is concerned. It's not a mortgage, there's a lot of benefits to issue to the people. But I'm not sure exactly where you're coming from. The beneficiary account has the the money that comes in at 10 cents a minute. And then you have the seven, six trust that you can do. Then, from the different side of the RSS program, you have the contracts, employment contracts, which adds to your download in in your account your basic account in the RSS program. So there are different places where you're going to get money from potentially, I'd like to see every person in the world on an employment contract of some sort. Is it because I want them working? No. Well, I do want them working and being productive. But every person is entitled to that if that's what they'd like to do. Even if it's to start a business of some sort. Being do that within individuals, director in the CAC program, you can talk them into it, and you might get a grant to start a business or something of this nature. You might come to somebody with a project, you might come with a an invention that you've done and wanted to financed. And those are all the things that we're going to be involved with. But there's many, many different things and benefits for the people. So get into the programs, understand them, and you'll see what I'm talking about. Next question.

No. And the reason I say that beneficiary account is very descriptive of what it is an RSS account does is not as specific. An RSS account, I don't think covers everything. So, but we've chosen the beneficiary account. And that's, you know, what's wrong with that? It's exactly what it is. beneficiary is the person who receives the funds and that their accounts. So there's been a lot of thought behind it. And we're not going to change because changing requires us to go back through all the documentation and change this and change that. And how many times have I done that it's cumbersome and is very disruptive of things that we're trying to accomplish. So beneficiary account is what it is, if you want to call it an RSS accountant, and want other people to understand you, then that's your your business. But we call it a beneficiary account. So next question,

wouldn't the ESS plan be a distraction to benefactors, whom I believe would rather focus on sharing wealth rather than getting involved in this complex process of managing production value chains, thereby tinkering with delicate interacting market forces of demand supply and price?

R

Ron Giles 40:56

Yeah, if you're not, if you're not into that, then don't get involved in the program, until it's all voluntary. And if that's not, the fat doesn't suit, you, then don't do it. The S S and the International commodity clearing houses are our major projects. That's why they're not under love won society, their love won industries. And they will be taken care of in that venue. And not everybody's going to want to do that. But it is by contract that you will be involved with things. Because if that, at that level, we have to have control from one source, so that it is effective. And everybody can be involved that wants to be involved, but it will be by contract. And, and then there'll be some teachings and understanding. This is very intense, as far as the legalities are concerned, and, and the bonding and all those sorts of things that need to take place to create credibility into the program. So it's not easy. And I'm gonna say it this way, most human benefactors won't be involved in it. There are things in there that are really not fun. But yet there are fun for those who really like to get involved with the numbers and everything like that. So find your own level of humanitarian activity that you want, and to do, and then stay in that lane. If you want to venture out into something in a couple of two or three years. And you can look at it and see if it's has any draw for you as far as your hardest concern. So I understand what you're saying. And it can't be a distraction. If benefactors aren't interested in doing it. The you don't have to. And that's the important thing. You're the benefit. You're the humanitarian. If you don't want to do something you don't. Next question.

Would it this help us achieve the same objectives without getting too involved with complex economic forces?

It sounds like this is the same person that's asking this question. We will continue to use the distribution system. We just own everything. And we we charge our prices for things with a charge that we can't make money, we can lose money. So if we buy a car for, say, \$45,000 we can sell it for \$40,000. Now the normal thought process will if we can charge 45 we can charge 50 and start making some money on no we're not going to do that. People say well, isn't that going to cause? You know, isn't your program going to cause things to to inflate in their prices? No, we can control the prices. With us the price goes down to consumers. And everybody along the the distribution system is under contract and employment contract. So everybody makes money. However, it's not meant for everybody. There is a disconnect here from the reality. This program came from the heavens. This program came from the Alliance. You can find fault with it all you want. But are you in a position to find fault with it when you can't see down the road to see what's going to happen? You're taking our your situation now and projecting it into the future down the road of that you can't see. And you're projecting it down there and then wondering how we're going to get by with this and that and the other, leave that to those who can see the future. And that's not me, I can't see the future. I'm just doing what I'm asked to do. But I get a lot of people wanting to change things wanting to do this, that and the other. I'm saying, Well, if you can see better than the Alliance, then you can have an opinion. But I'm going with what the Alliance says, I'm not going to be stubborn that way. If there's something that that I can see might be beneficial, and I'll all approach it, and we'll discuss it with the Alliance on things. But I'm not going to go back to every for every person that wants thinks we

should do it a different way that has no, you know, I could do a little test on this person and find out if you really understand what the programs are about. And I'm not trying to pick at you, I'm just trying to say there are those who have studied this thing out to the point that that solves problems instead of creating them. And when you get to the point where you understand the programs, you can see what I'm talking about. I find most times when people have some ideas, is because they don't really understand what the the intent and the process is, is what we're trying to accomplish. So you can have your opinions and you can write the questions and so forth. And I'll try and do the best I can to accommodate the answers. But when we want to change the programs, start changing this that the other, I just say why do you why do you feel the necessity to do that? Okay, now for that next question.

And people can get together and become all beneficiaries and get a whole bunch of money and start doing things and so forth and so on. If they're acting contrary to the to the way that Earth is moving towards, they won't be a part of us. They're limited ideas and and a greediness and manipulating. We don't want that in the third dimension in the higher dimension. We don't want that in the golden age. When I say we, I don't want their do I am I different than other people. might be the last one is the broker. If the broker is to receive their broker commissions from sales through NRELS, how? through RSS platform as an ongoing income, like the sales agent or a one time commission, are these Commission's given when the sale is completed through and NRELS?

To receive the broker commission from sale through an NRELS? Yeah, yes. That commission is given at the time of the closing. And it's from the Commission's paid into in the NRELS, is through a download increase. That how. Let's see, I'm just quickly, okay, there's two aspects of the Commission's for real estate people. A real estate person goes out and sees a home that's for sale on the market, then you can approach the person and they negotiate a price, which is the market value through appraisals. And they pay the market value for the home. The real estate agent that is the selling person will get us a cash. At the time of closing, when that home is sold and brought into the NRELS. There's there's commission number one for the seller for the as the buying agent for the property. Assuming that it is it does have a commission structure and center, the multiple listing service or whatever service it is. And please understand that I'm coming from the American way of looking at this because I don't know other other countries, they'll have to, we'll have to get in there and make adjustments as we need to for the specific countries that we need to want to do this in. But okay, so that's the first commission structure, once a home has been, is now in the net real estate listing service, and has gone through the remodeling and everything to bring it up to a speed, then that same broker that brought it into NRELS will be the listing agent for the sale of that home to anybody that wants to buy it through the listing service. That's the second commission that is also done at the closing. So we'll have our representatives usually it'll be a director of some sort, system director, maybe whatever it is, and and that will be the adjustment for the RSS program and get the downloads in the appropriate place for the Commission's and so on

directors can give the brokers \$10,000 to sign up with NRELS, I've never said that. I've never said that. There's there's no reason to pay a broker to become part of our program. There is a reason for one broker to a person who is the broker or any other person to bring in no broker into the program by introducing it and going through all the education stuff to bring them up to speed to where they can go and will give a certain amount of increase, maybe three, three cent increase on that project. broker for somebody, and we give a broker to sign up another broker, we don't give the broker to sign up with us. There's no reason to do that, that they can't see

that they're gonna make millions and billions of dollars, whatever you call it. If they can't see that, then they miss out on the on the whole program. So we don't pay for the brokers to sign up. I'm not going to, if you want to you can. I'm not going to. So you got a premise there. That's inaccurate, false false process policy process? Do I create an account on my end or a trust for all brokers to purchase property? And renovations for and our Yes, that sounds like can be a good idea. Otherwise, you're going to be running around trying to take care of all your brokers set up an account that trust account and then authorize it to be drawn from for under certain circumstances. No. How you do that is your business. If you want to get involved in the NRELS and work it out how you do it. I'm in California, so this will be billions? Well, if it was continuance, would you be upset? You're going to get you know, if you're if you understand a person with one 100 T note and asking \$500,000 You're going to get 1.25 quintillion every quarter. Are you worried about money? Your biggest worry as far as I can, I'm concerned as to how to use that money get it out into effectively give it out into the economy is this not a good way to do it. So you're flip flopping, you need to flip flop your ideas on this, we're not doing we're not trying to stop people from making money. We're encouraging them to make money. We don't make money. But we're encouraging other people, if somebody comes to me with a project, or with a technology that they want to fund, I'll send it for them. But I don't make money that they make, and they'll make it all. Usually the person with the money makes 50% We don't make money on our money. So there they get to keep it all. So there's a different way of looking at things and I think I'd invite you to have a different thought process so that you're more in harmony with with what we're trying to do with the NRELS program.
