Hello humanitarians. This is Ron Giles. I'm here with Tracee and we plan on doing a question and answer period this morning. It may be a little shorter than Newt usual, but we'll see what happens. So, Tracee, let's go ahead and start the first question.

Okay, in the q&a recordings, Ron has stated that is inappropriate for a benefactor to open a beneficiary account in his own name under the Benefactor account. I just agree because my heart are conscious won't allow me to withdraw God's money for my own Corporal desires, whoops. Instead, it would prefer to open a beneficiary account under my name, where I could receive the same blessings that the RSS is giving to everyone else. God's money is for humanitarian work, not for my personal petty cash, as it is, I will have to be judge and jury over other people's needs or desires, funding what I think are good uses of God's money and bypassing what I think is selfish or unnecessary. I don't want to feel guilty about giving myself money. Any comments?

R Ron Giles 01:09

Yes, I have some comments. I appreciate where you're coming from. And I understand that and I really do. This is God's money has given to us as a gift. However, there are things that happen with money, that if you don't allow that money to be yours, and use it for whatever you want to do, then you're missing out on the opportunities to have your own abundance mentality. Now the abundance mentality, what good is that it is essential for you to have abundance in your life, in order for you to feel comfortable about going into the fifth dimension into the ascension process. There is no limitations. You know, I don't want to be critical about your feelings. But I want you to be aware of the fact that there is a reverse pride that I believe is at play here. When I say pride, you want to do what's right. But you're thinking about that is a little bit flawed, in that the alliance has given you this for your purposes, you are not to sacrifice yourself on an altar of humanitarianism, you are entitled to what you want and need in this life.

And that is part and parcel to what the gift has been given to you. The money is yours, use it for your needs, buy the house on the hill, buy the car that you want, it is essential for you to have the abundance mentality. And that's why you've been given this money. So don't think you have to sacrifice that false pride. And if you really got into it, you would understand exactly what I'm saying. You're putting on a pretext, as in, I need to do this in order to be acceptable. And I'm telling you that the rules of the game are not what you call acceptable if you are not taking care of yourself. First period. If you're not taking care of yourself, then you're going to have a problem. When your cup is not full, how can you share with other people. And so the reason I really kind of plain on this is because it is absolutely essential that you understand the stewardship responsibility. There is not one dime that you spend on yourself that is taken from somebody else. Your sacrifice of not getting to do what you need to do and want to do with money or with your own stuff is is not appropriate. You can you're doing that and it's not part of the game. You're assuming it is and I understand where you're coming from and I'm not trying to be picky or to tear you down. We all have that kind of self pride, that we've done a good job and when the sacrifice is acceptable and all that sort of stuff. You as a sim benefactor can Create a benefactor account, and it can go through the RS program. And then you will be getting your download from there and you can just pull the money out that you need and do whatever you need want to do with it. I don't recommend you do a beneficiary account, I recommend that you do a benefactor account. And I recommend you do do, I'm going to do that for myself. For my daily, weekly, monthly, whatever expenses. However, if there's something that I want to buy, I will, I will go to the main my account, my big account. And I will draw the money out of that for the things that I want to buy, like a house or a car, whatever. Not only, I plan on buying a lot of ranches, because I have a heart there and will do really good things. animals need to be treated with love and respect and kindness. And that's what I plan on doing with the ranches. So brand new thing. So I'm going to be doing that. And I invite you to do that as well. Create Your Account Your benefactor account, put money into or get your figure out what you wanted, budget out for yourself on a monthly basis, I'm going to keep track of that. I mean, keeping within my budget, then I have my that's my personal account. And I have the business love won society, for expenses in traveling, putting on meetings, and so on and so forth, that I plan to do worldwide. So the money is yours, please, please, dear heart, understand that this money is yours. And that God would be very pleased if you accept the gift as it was given for you as an individual to maintain or to build the abundance mentality so that your mind is free of all of the trappings of this world, and can move on into the ascension process. This is a way that I've looked at it, this is consistent with the way the Alliance wants us as humanitarians to be. And if you'll read all of my literature, you'll understand that I've been very consistent in this concept and this understanding. My heart goes out to you just adjust things a little bit. They're the ones with the money and they'll be doing it according to their plan. So wherever you got this from is absolutely incorrect. Now, having said that, it may happen during the eighth and 10th. But it's not a date that the alliance has given. So I don't know when it's going to happen. I'll know when I get my call from the alliance and I get to set up my appointment. Then there we go. Then it's then it's in play. And there we go. And we get our money and move on down the road. Don't believe any date? Don't believe any date the Alliance does not give out dates. Okay, having said that, yes, they do. It is for a military deception. But they're doing things to irritate the people so that the people will wake up and say I've had enough of this. Once GESARA starts for every other country, then we'll get the RV. So what you're asking is, no, it's not going to happen before the RV, so you're not going to get the money. But when Australia becomes GESARA compliant, then all of the other countries are going to be just are compliant, we'll get our RV, go through the redemption process. So which comes first? Well, I've been told that the Nosara and all that's part of the leveling of the playing field to make it safe for us to do our jobs. And they won't just so you're not going to start

someplace out starter home. And your country's Australia's couldn't be just our compliance is when everybody else is and that's the trigger that needs to be pulled with the Alliance so that we get our redemption funds. We all go or none Go. Next question.

Ron is suggesting that at the redemption appointment, a referral letters requested which will guarantee sufficient funds are available to become as an benefactor under the LWS programs. My question is, how will the Alliance be able to guarantee that sufficient funds will be available for the duration of the world of the requested period of the project's example 100 years when the nature and scale of any future projects to be undertaken will be unknown will be an unknown factor at the time of the appointment.

I would suggest that you go find and go through the structured payout program. When you set it up properly, and you will that's what's part of the appointment. The money to to give you for the next 100 years is put into your structured payout account in the quantum financial system that is administered by the Alliance. Now we use the idea of the 100 keynote asking \$500,000 you work out the structured payout and it's five quintillion per year. And it's paid quarterly or wherever you want. And that's 1.25 quintillion. Okay, let's go back to the yearly which is five quintillion? How much money are you going to need for the 100 years? Well, that would be 500 quintillion, is that correct? That is the amount of money that's put aside into your structured payout account as you leave the appointment, and as you lead the appointment, the redemption appointment. You will already have your first tranche your first 1.25 quintillion. Now obviously if you have more than that, then that's up to you and your angel, whatever we're gonna call With the counselor I like to or Alliance agent, it's a situation where you have the chance to talk and, and work out all of the details that you need to do. So you're not understanding what the when you say this, you're not understanding what the stress structured payout program is. So I would suggest you go back and read them. Is there on the first menu, I believe, first or second menu item, and there's a menus, and it's either the first one or the second one, but I forgot. Okay, next question.

The only time a benefactor increases Penny amounts in the RSS is when they are increasing the director's salary. And when directors increase Penny amounts is on the behalf of businesses, business owners who want to increase the salaries of their employees, is this correct? Are there other times the directors input Penny values into the RSS, otherwise, the quantum consciousness computer will manage all of the trillions of beneficiary computations, manage everything a second, and benefactors? And directors a lot have to worry about them? Is this correct?

That's correct. On both parts, there's some words in there that I'm not feeling comfortable with. I like this is the only way and the directors have. So on and so far, the the Zim benefactor will

Like this is the only way and the directors have to go on and so far, the the ZIM benefactor will delegate to their directors, the ability to set up contracts. And in those contracts, that's where you talk with a business owner. And you, you know, we're suggesting doubling his income, keep him in business, and in paying for his wage the wages for his employees. And that means that the director has to have the ability to go in and establish those contracts, and the RSS program. So that'll be by code or something that will have to figure all that out. Every benefactor will have their own personal ID. And each director will be associated with a particular benefactors ID number, and we'll figure all that out. So that it's, it'll flow nicely. But yes, that's, that's the way it's gonna work. So technically speaking, you are correct. Absolutely. Yeah. Directors are the ones that control the RSS program, and adjust from the side of the accounting. For contracts, the RSF program for beneficiaries is 10 cents a minute period. And they put put in more their six trust, then they get 10 cents for each one of the trust as well. Next question.

Ron Giles 18:28

it's not redundant. And it's a sort of thing that you need to think through how best do you want to maintain your anonymity, and accountant doesn't need to have more information than you want to give them. When I say that, obviously, there's, there's certain things that they'll need. And that's what you need to give them. But there are certain things that they have no business knowing, and total amounts of money and so forth, that you have, should always be kept within your close knit upper echelons of of your humanitarian activities. Nobody's going to need to know for from my perspective about how much money I'll have. And by the way, if you give me the higher face value zams Much of that will not be on the the structured payout. It's, it's can be just too high. So you'll you'll have the structured payout for a certain amount. And that will be your budgets as far as your activities are concerned. But there's larger amounts that will be put into accounts that you will wait until there's some kind of reason to draw it out. And then that'll be that'll be appropriate. So I did ask the question are those that higher money put along the structure? patent in and I was told no, no. But there's a certain amount that you want to have on that. And most often it's the it's, it's the people who have the quads, two, or three or four or five quads, whatever, there's a certain amount of that that will be unstructured payout and then certain amount that won't, they'll just be left in the, in an account somewhere, to be used for cash, whatever. Yeah, I'm putting myself up for a lot of questions by saying that, but I think it's something because we're having quite a few people are getting the larger bonds. And and they're asking for very large rates. So the people who are setting themselves up and positioning themselves to do some major humanitarian work, it's, it's, it's going to accommodate it all. But that's how it's going to be for the structure panel. Next question.

I been old school just can't seem to get my head around how to get cash without a checking account. I want to give some nonprofits, one time lump money, only way I see is just send them

a check. Can you enlighten me?

R

Ron Giles 21:17

Yes, I can enlighten you, the quantum financial system is not a checking account. I am not sure if you do online banking. It's very similar to that. If I want to go into my account, and transfer money to another QFS account, all I need to know is what account number is that it is that I'm trying to send money to. Now does that matter to the person who I'm trying to send money to that I know his account number, now, obvious only that person will have access to his account. And people can't take it out. So it doesn't matter if their account numbers known anybody in the world, who cares? The Quantum financial system and the quantum consciousness will not allow the funds to be used or to touch that account to be touched by anybody unless there's a reason for it. So your charities, whatever you want to call them, nonprofits, you want to send money to them, then you just do get their account number and you do an account transfer out to account transfer within the quantum financial system. There's no checks involved. It's immediate. And you will have access to the quantum financial system just like to do with your own bank account, or online banking. And you go in there and men transfer, whatever you'd like to do that's supporting your humanitarian activities. Just a word of caution. When you're talking about charities, and nonprofits, be sure that you've vetted them out so that you know that they're not just money laundering, I call them NGOs, non government organizations that are used for laundering money and that sort of thing, you want to be sure that the money is going to go to the right people, or for the right things. So I'm I really not going to be dealing much with NGOs, and those who think that they're doing nonprofit stuff. Nonprofits is, is one of the biggest manipulations for money control that you can imagine. If you want to launder money, you set one of those up. And, and you can launder money through that that you want. Because it's all donated, see, where you use the money for it to bins on what you want to do, then the NGO wants to do, the nonprofit wants to do, they can give it to anybody they want. And there's no accounting that's required. To Be careful about where your money's going, in my opinion, always have somebody that's responsible to you for the use of the money that you give them. And if you can't have that, then don't do it. That's my way of thinking. That's my way working with it. And then, after saying that, then you have to come from your heart to be sure that you're doing the right thing and that your heart will protect you as well as the quantum financial system and the quantum consciousness. So we're in good shape. We just follow our hearts. Next question.

If you need to use it for something then do so having said that copy it and put it in your files, whatever. I would prefer our documentation not be posted on other in other locations, because they can change things and we don't even know. And they're people thinking they're talking about love won society stuff. And there's there. We've had some people plagiarize our project, and then change it, and, and then call it the quantum financial system, when in fact, and indeed, it's their whole premise upon which they stole that was inaccurate in the beginning. So I don't, I really don't have a problem. The information that I do in articles and so far is my own

opinion. But it's always sanctioned by the, I always get approval of it from the Alliance. So it's very factual. And if it's not this, if it's trying to get around 95 to 100%. And if I don't get it that high, then I go back and edit it until I do. So 95%, just explanation, communications, I can say something with words. And you're on the other side. So if communications takes place, and we can use common words that give us an understanding, and if I might information is not is not meant for you, then yours. There's confusion, there's not a good communications. And so, communications 100% is where the people that are going to watch or read your stuff, can understand it 100%. And so becoming 100% In any communications is extremely difficult, because we come from different levels of understanding education, words mean differently. And we have the real problem with translating into foreign languages. So the, the, the process of communications, if you can get it as high as you can, and that's good. And I always get it above that. 95% at least. Or there's other times when I'm told that the information has to not be so clear, because there are people who will take the clearness of it and distort it. So there's times when it's 87%. And that's because there's some restrictions on the information I'm giving. Okay, I didn't mean to go into a lot of that. But let's go to the next question. Okay,

That's a really good question. And maybe this I can introduce this now. It is our intention to create an academy for directors. And that means that the, the directors can go to certain places, and in the world, in their language, and so on and so forth. And be trained because that's a major thing. Directors are the foundation upon which our whole CAC program works. So we want to do that we want to educate them. And we're setting up a whole seminar excuse me with all the things that are necessary that we feel a curriculum of some sort that can be duplicated. So that people can go to a location and have a nice, some resort or something like that. And go through the classes and and have an enjoyable week away. And I plan on doing it for about a week or so. So that's our intention. So it's a really good idea. We'll we'll we want our directors to really be up to snuff and doing a real good job. So we feel like this might be a way for us as love won society to be able to be sure that you're getting all the help you need for your CAC programs. Next question.

Ron Giles 30:17

the beneficiary committing a crime we have nothing to do with that. If a person has a contract

the beneficiary committing a crime, we have nothing to do with that. If a person has a contract, and breaks their contract for no legitimate reason, that and that that contract is to work for an employer, and so on and so forth. And if they don't show up for work, and they do things that on the job that get them fired, then that's breaking their contract. And they can do that on purpose to break the contract. And that is the sort of thing that we're trying to say. So when I talk about, it's not a beneficiary, it's a, they are beneficiaries, but they're also employment contracts that they're working under. If they break the terms of that, then they're a little larger companies will have a human resource department, and there will be punitive actions taken, it's always going to be by arbitration. And the arbitrators have the ability to do go into a beneficiary, or a con a person who contracted and take away their benefits, if indeed, there needs to be some kind of punishment for them, breaking their contracts. Now, I'm saying breaking a contract, what kind of a person goes into a contract and then breaks it? That's talking about integrity. And so if you don't have enough integrity, then we have to put some, some teeth in this. So that you will perform according to your agreement that we set you all up in this company for or contract for. Sell the flaky people, if they if they get involved with us, and we don't really have much control over that larger corporation. So we're going to be doing and the ESS program. If they're flaky employees and their human resources department decides that they need to be punitive actions, then they go into arbitration, and we will honor that arbitration decisions. And they can go down into and include the trust associated with a beneficiary account. However, what I've said before, we're not taking away everything, they will still have their beneficiary count that will be giving them 10 cents a minute, or the equivalent in other different countries, and so on and so forth. So we're going to work this thing through, but we have to have teeth in a contract. Contract is the word. And if you're not going to follow the contract, then don't get involved with it. Because you could lose almost everything you have with us. It has to have teeth in it in order for the contract. But if you follow the contract and do your work, for seven years, whatever, then you can continue on if you want to still work and still get the increases every quarter. And that sort of thing. And if you follow the seven year, if he could do that for seven years, then the benefits are yours for the rest of your life. So why would you want to break the contract? I don't know. It would be a person who doesn't really understand. And, and yet, we have to allow the human resources departments to be able to go through arbitration with them. And if necessary, they take away everything except for the beneficiary account. Next question.

If the beneficiary doesn't have any children or family members, can they donate their RSS account to their favorite charity? In the future? Presumably like if they pass?

R

Ron Giles 34:25

I'm gonna say no, there's a charity been vetted as a humanitarian who's in charge of it. You're giving away a stewardship responsibility. Now, I understand that there are those who don't believe in the med beds and that we can live for a very long period of time. And that's okay. And if you want to set up some way of having a person take over for you, then talk to your counselor figure out what you want to do. And that's your best resource, and then find somebody it'll take over. But I would never donate all of my money to a charity, no way in hell. And here's the way we don't know who they are. The Alliance doesn't may or may not agree with that. So we get the input from the Alliance agent who's our counselor. So it'll all work out that way if we use the program appropriately. So after reviewing the ESS and ICCH videos, how do they support each other in theory as the safety director acts as a liaison between farmers and companies larger than 20 employees, the directors will identify and through a referral process introduce the pharma company CEO to LWI representative who will in turn explain and incorporate them into the ICCH process. An example the CAC director places the farmer or corporation under an employment contract for seven years and purchases their entire annual product, then the annual product surplus after the township consumption is then placed into the ICCH for international distribution does that sound right?

R

Ron Giles 36:26

It does. Yeah. The love won industries will be the overseer, if you want to call it that of the ESS and the ICCH. And those programs are pretty sophisticated. And getting into where you need to, to use bonds and so forth performance bonds, surety bonds, whatever you want to call that, to ensure that we will perform on our part of it by giving them them the money every year. So there's ways that we set that up so that the person or the company can have faith in the fact that we will be able to give them the money on an annual basis that we have contracted for. And we've also gone into the bonding for 10 years. So in in one form or another, it's like an escrow account that we'll have 10 years of billions of dollars that we're going to pay for those companies to stay in business. So it's a little bit more sophisticated. When we get into it, then it'll be easier for us to understand. Because we get the attorneys involved in and how they want to write up the contracts, and so on and so forth. So it's going to be interesting to see how that all works out. But it'll work out just perfectly. Not every humanitarian in our programs, not every benefactor will want to do all of those programs. But there are plenty that do and Penny plenty now that are visiting them positioning themselves financially to be able to do that. Next question.

If I add employment contracts to my CAC of a former volunteer have a nonprofit because it won't allow the contract and find later they quit moved or doing other work, Should I terminate the contract? Are there any limits to any employee contract adding to executive levels, presidents of large companies excetera, after adding them into the RSS plan?

R

Ron Giles 38:42

Well, those are decisions that you need to make as a benefactor. In setting up your programs will have guidelines and ideas that we can use. There'll be contracts that will be plug and play sort of thing. Little little, almost paragraphs over include that paragraph will include that one, and so on and so forth. So that's how we're going to construct those. Those larger contracts, because we don't have to go back to the attorneys and have them do every single one. And yet, that might be what we'll have to do anyway. So we'll see how that works. I think it's appropriate. They sign a contract, and then they don't want to do it anymore, then you you terminate the contract. I have a hard time with people that think they can just go and break

contracts without breaking their word. That's a real problem for me. The way that it can happen and the way to do that is just terminate the contract. It looks like in the executive levels, I would, I would stay away from that as their business, and we're going to ensure that their business takes is profitable year after year. They've got their structure for their upper management and bonuses and all that sort stuff. We don't need to get into that. We're working with the people from middle management on down. That's the process that I, I look at. If you want to give a CEO a contract, besides his bonuses, if 10 million a years, then I suppose that's up to you. I wouldn't do it that way. Next question.

My Zimbabwe notes that I got an eBay do not have a serial number. I'll have the same number silver 9999. Is this okay?

Yes. When the bond does not have a serial number, then it's not legitimate. Okay, what does it say it e-bay these are? These are not currencies. They're not this that the other and it's absolutely correct. They're effect similes of things that have already been done by the by Zimbabwe, the Reserve Bank of Zimbabwe. If you have one of theirs, then they have serial numbers. If you have one settler just facsimiles, then you won't have a serial number on them. And so they promote them by saying these are not currencies, and they're just fancy stuff. And you can use them for whatever you want to do. But they're not currency. That's the way they have to say it. Now, from our perspective, as humanitarians that are going to be getting funds, the alliance has given us the ability to use those and, and redeem them as if they were real. But it's only for humanitarians. And in reality, only humanitarians will get the funds from the redemption process, period, exclamation point, there's no deviation. That's the way that the alliance is doing it. That's their plan. And their plan is to put the money into the hands of people who will do humanitarian work with it, instead of creating a family legacy of billions and quintillions of dollars. And they can sit on the top of the hill and look down on others, that's not going to happen. So those kinds of ideas of giving these big people monies and so forth is is invalid. However, getting back to the question, they are valuable, they will be redeemed by humanitarians to get humanitarian funds for their work. Next question.

I think the best way to do it would be the way that will work out for them. I think that putting giving them a benefactor account, meaning that you know how much money they're going to get and so forth is probably the best way to go for. For those companies. Be sure that you've

get, and so forth, is probably the best way to go for those companies. Be sure that you've met them and be sure that the money is going to be used for the appropriate things. There are those out there who have the heart and just need the money. And those are the people we want to find. And we don't want to leave them behind just simply because they're not sticking out as a as a major charity or whatever non profit. We're looking for the people not the organization's if there's good people in the organizations and we're running it properly, then we're interested in doing things for the people. I would like to give a person who wants to take care of animals. I'd like to give that person the money and know that they'll do a good job with it. Because their hearts are already there and are tested and all that sort of thing. But there are a lot of animal rescue places that just use that as their way to get money donations and so forth from people just so that they can have an alternative have income that taken out from what they're supposed to be doing using the money for. By the same token, those people need to have funds as well. So you work it out. Those who have the heart opens up the gates the floodgates for those people. My opinion. Next question?
