Hello humanitarians. This is Ron Giles. I'm here with Tracee and we're going to do a question and answer period. It is now January the 10th 2022. So with that, let's go ahead and begin our with the first question.

What will be the difference between a QFS account that every person will have after the RV is set up in a QFs account within the LWS RSS platform, apart from the humanitarian projects that are carried out through the RSS provided? Isn't the entire QFS system USN and all new QFS currencies from God, Angel source universe secured against corrupt inappropriate interactions by governments or DS puppets? That's what I'm thinking,

Oh, that's true. The QFS is, is our gift from God, for our financial system to use during the Golden Age of mankind, totally secure, and will totally support us as humanitarians in what we're trying to accomplish. Nobody is going to cause problems for us with transferring funds and so forth. We just get to do it. So no deep state, no government, no IRS, no taxing agency looking to find how much money we have, so that they can tax us all those kinds of taxes will be gone anyway. So yes, it's totally secure. We're in for a good time. Next question.

Well, just let me clarify this. So but there is no QFS account. In the RSS platform, it's the same QFS account that you're setting up that the RSS platform utilizes, as a ledger system to transfer funds. Right?

Ron Giles 01:55

Yeah. And maybe I can clarify that, at least in my mind. The Quantum, the RSS platform, is a website. And each person who has a fiduciary account will have their own personal back office or personal office, whatever you won't call it, they go into user ID number and their pin, and then they go into their account, it's a ledger, it keeps track of all the information you need to know that you're getting credit for the things that you're doing, shows you your activities, and so on. So you will as a beneficiary, you will establish an account in the quantum financial system that is tied to your account in the RSS program. When you want your funds drawn down into your account, you will go to your back office, your personal office, and request a certain amount of money, either all that's available or right in the amount that you want transferred. And then you push the send button, and it will transfer the money to your quantum financial system account. Now, where does the money come from, doesn't come from the IRS, RSS. Your account in the RSS, it's only a ledger. So there's no money in there. But the money that you'd get to that's drawn down to your account as a beneficiary comes from the benefactor, who is the head of the chain of beneficiaries that you're under. So the benefactor is responsible to have what we call a master account. And their job is to keep the master account full of money so that they can, when people want their money that they draw out of that account, how do they draw it out of the account, they go to their back office, say I'd like this money, and it's drawn down from the master account and put into your which would be in the QFS as well. And it will be just a transfer an account to account transfer within the quantum financial system. And that's how it's gonna it's so easy and so Elementary in its approach, very simple once you get it, just like learning how to spend money, it's not going to be a problem at all. please clarify how managing directors should present LWS programs to CAC directors, if I understand correctly, Ron doesn't want mentioning of LWS, should I just say that I am implementing programs given to me by my superiors? What would be an appropriate way to explain the origin of the programs?

Ron Giles 05:51

are you presenting it to your directors or just to the public director, you can give a little bit more information, if indeed, it's necessary, you feel it's necessary. Somebody has to be in charge and the Zim benefactor is the one in charge how they hide behind different structures is up to them. And it's their job to maintain that anonymity. Because once it's breached, then, you know, you're going to have to reestablish it somehow. And I'm not sure how to do that. There, right. And that's why we have to learn through the NDA how to conduct our lives. So you're going to have directors that you need to have CAC directors that you're going to need to have, you're the boss, you have to tell them what you want them to do. So we have the structure, the CAC structure and how to administer that is what each individual gets to use their unique skills and so forth to do and, and then you have the whole structure to figure out how it's going to happen. And we've gotten a lot of information about that. So read what's available, as far as the CAC is concerned, love won society, I don't really want love won society associated with money, it's going to be in some respects to some people anyway. But I don't want to emphasize that by everybody using the name love won society. So if you're setting up a CAC program, the community that you're setting it up in, would have geographically have a name of some sort. And my suggestion is using that name for the CAC center like, and I use the word Glendale, because we have a small suburban geographical area called Glendale. So it'd be the Glendale Community, the assistance centers, or the Kerns Community Assistance Centers, whatever name you want to call it. And the CAC director is the one in charge of that section of the CAC program or that community. So that's the way the best way to do it now, that is your public persona to other people, the CAC to Community Assistance Centers, but it needs not be anything other than that. And how you structure those, if you want to put it in a trust or something that each one in a trust, then it's up to you. Each one should have its own accounting, so that you can get reports for the activities that your directors and assistant directors are doing. That makes you an effective manager of your funds, your your money, your stewardship responsibility. So you have your responsibility, you can delegate certain things to other people, then you require them to report back to you through the reports that you have established with an accounting firm. And you can see how they're doing. And if this one over here is getting 15 or 20, Business Owner accounts or contract accounts, and somebody else is only getting five or six a week, then you get a chance to do some training or broadening a person's perspective on what they need to have done. And of course, every area is going to be a little bit different than another. You have more urban areas. And the CAC are just going to be a little bit bigger. They're the geographical area. And they're the uniqueness of what's going on in that that vicinity is going to be if you're working with farmers, it's a lot different than working with a business. So you have to be adaptable and allow things to be as they should be in a particular area for that particular community. And not all communities are the same so they have different needs. Some have already got sports complexes and that sort of thing. So you don't need to, to redo recreation centers and so on. Another stone recreation is going to be a major thing. And getting out and moving and having exercise, all of those kinds of things are open for us to use our money to develop. And so that's on a community basis. And the community leaders, oftentimes a mayor and that sort of thing, maybe governmental, but there's leaders in the community and just work with them to solve problems. And that's your job as a Community Assistance Center as, as a director in the committee assists centers. And you establish that relationship as you work with them. Trying to go back to the original question, clarify the managing directors should should present elder service programs to see as the directors, yeah, don't use the word I Ws. They don't know what it is, they have no requirement to know what it is. It's just a beneficial organization that has, it's not for profit, and

how people who donate and all that source Eden's set up whatever way you want to just pacify people's curiosity. Because it's not a cure, it's only curiosity. They just don't understand how the structure is going to be and how much money there is. And so we they don't need to know this, let it be a question to them. It doesn't have to have an answer. So you just work for the director, work for the the person who's in charge of the distributing the funds, and that's all it needs to be, needs to be set. That's my opinion. And you can from there, you can do it the way that you feel is most comfortable to you. I don't have a problem telling a little white lie when it protects people's lives, and livelihoods. So it doesn't matter to me if I say those benefactors, you know, billionaire benefactors, who are part of the program is I have no problems without a law. Because the fact of it doesn't matter to them, and has no meaning for them anyway. So you can just tell whatever you feel I can be consistent in what you do. Work out your spiel, whatever you're going to say. And then stick with him. Next question.

I would be a donator and maybe a substantial donator to the PBS programs. But I would stay away from buying it. And then using that as my platform to give out my personal stuff that I want to give out. Why do I feel like my information is just because I have a right to check my information, my way of looking at things is better than somebody else's. We have to be careful that we don't become arrogant and present ourselves as the nobles just because we have money. We need to remain humble and let things take its natural course. We can assist in our with our money, but let's not use it for manipulating and our own personal agenda, except the agenda of being a humanitarian. Next question.

Ron Giles 14:16

Email me and I'll give you a link on eBay where you can buy some now you're, then you're going to be in business, the sellers out of California. So it may take five or 10 days to get to or fiber for two weeks to get to. But I think we got plenty of time to do that. So but you don't sit around wait because I'm publishing this not publishing, I'm telling you a lot of people and although they have plenty to sell, sometimes they can get down to where they need to reorder and you might not get any for a while. So if it's there, take advantage of it. I have another place

that's got \$17 for 10 100, Tinos, they're, they're blue in color rather than the gold till there's places on there. But they can dry up real fast if everybody starts going there and buying them. Because the opposition about the competition is \$250, or something like that for a 100 kinome when you buy the original bonds on paper, and everybody thinks that that's important, and that the alliance won't take the gold in the silver ones. But, you know, knowledge is power. And you know, that when we know that they will take it, then we don't spend the money on that larger don't know, are doing. So we let people don't like this, that they can get it. And there's no reason to want to be a benefactor and not have Zim there's just no reason for it. And less, you have exhausted every opportunity. And if you have them, there might be some other people that will help you be a part of their program. Let's see. Next question.

It's my understanding that Zim is for humanitarian projects, only. My question is, if I have dinar, or Dong, are these also only for humanitarian projects?

R

Ron Giles 16:29

Okay, now, where did you get the idea that they're only for humanitarian projects? Okay, now, I'm distinguishing the difference between a humanitarian and humanitarian projects. And the reason I say that, and I've answered a little bit about it earlier today, or have done before, the alliance is not funding your projects. The Alliance is funding humanitarians who will do projects. So when I say I have this project, and I'm going to get funds for that, they say, Oh, well, we're going to fund you. And what you do with the money is your stewardship responsibility. You may think that clothing, the homeless and finding them homes off is your total humanitarian activity, because that's the project that you can drive around your neighborhood and see needs to take place, go back and drive around there in a year or so. And see if there's a lot of homeless people, is every one of those homeless people has a chance to become a Zim beneficiary. And all they need to do is to establish their account in the quantum financial system. And they're getting somewhere between \$1,000 a week and \$7,000 a week, depending on how many trustees set up for themselves. Come back here later and talk to him about finding a place these people, if you give them the money, they will have their they will use the money for their own purposes, we can give them opportunities. But you cannot force them to accept things that you want, and the philosophies that you have. Because you think that's important, because you've got money now. And so everybody's looking up to you to know don't go there, don't go there at all. remain humble and be in a position to assist people not coerce them into something that you have, and you think that they need. And so here, here it is come and get it sort of thing. A lot of arrogance in our humanitarian thought processes are left over from the Cabal, the heart is there, but the mind has to change projects wherever you want. Out. You say you have the dinar and Dong that's good. Who told you how to use those trades humanitarian projects? Or why would you assume that? Again, you're getting money to do humanitarian work, because you are a humanitarian is coming into your hands. Does that preclude you from buying a house that you'd like to live in, in a neighborhood that you'd like to live in? No, it does not preclude you. That means you still can do that. Because whose money is it? It's your money. Can you spend your own money? Yes, you can spend your money. Can you spend it on other people? Yes, you can. And you spend it on yourself? Yes, you can. Can you spend it on your family? Yes, you can. It's yours. Get that in your mind and then know that the alliance knows who will use the money for the right thing. And they are the only ones that will

be getting the money and if they're not humanitarian, they won't be getting anything from the redemption of funds. If you don't have Zim you'll go into a bank with your dog dinar or whatever opportunity do you have to get your reevaluate, revalued currency on your own. But there's no responsibility that you have for dinar and Dong to do humanitarian projects, although they wanted to force you to do it, but you can't. It's a transaction. It's a legal transaction, and they can't force you to do something with it. Give you a different type of rate, if you whatever but nobody should be requiring you to do humanitarian work with with the money that you receive on the revaluation of currencies. Zim is a different thing. Next question.

I don't know. Your typical bank dinar the currency from a from Iraq? So I don't know if they accept it? And I'm not sure how that question is what that question is asking. But if you have dinar and Dong and deposited to your bank, when the time comes, or wherever you're going to redeem it, or exchange it. When there you go, Bobby, a lot of information now, some will be garbage, and some will be really good. Check for the persons who were saying the alliances has authorized the US for the Alliance has done that. Because if the DOD authorizes something or any of the other calling calls, Khan calls icon. They're going to say stuff, but if it's not from the Alliance don't believe it. If they don't claim it from the Alliance, don't believe it. If they claim it, then you may have to question it. But I don't know too many, if any other than myself that claim that they have information that comes from the Alliance. But I would require that you have if I was out there in the world and just trying to get find a place to for my humanitarian work. Next question.

Ron Giles 22:34

Well, it's a it's a good question. And I sense that you're coming from fear that that can take place, oh, I have complete faith to the alliance, that they'll set them to put in place things that we can use so that that doesn't happen. Love won, society is one of those. It's not the only perhaps, I don't know of any others like ours. But to look at our program, we put money into the hands of people, the CAC gets it into the communities. The the real estate listing service, just people helps people to get into homes, the ESS economic stabilization, you use that program and it stabilizes all prices, and there's never inflation, there will never be from us anyway, because we will administer our programs in a way that will be effective in in never creating hyperinflation or even inflation. And you look at the way it's set up, and you see that for yourself. Don't come to fear. Don't be projecting things from the past into the future, because

it's not going to be that way. You won't even have the same characters around that would do that stuff. So be sure that you don't be coming from the past and judging the future. By that because things are changing. Cabal, you're going to have inflation, the ball, you're going to have all kinds of property prices and explosions and stuff like that, but not with us, because we're not going to put up with it. And our programs are designed so it won't. So, next question.

The position of Zim benefactor is a very responsible one and he must have a necessary know how of the financial markets and knowledge of the economic consequences of his actions. How can this be ensured? The desire to do good for people is not enough to avoid unintended damages and disasters?

R Ron Giles 24:49

Well, again, that's the same type of question that I've been addressing. There been this last question. Yes, it's in benefactor is going to be in a position where they have to Really learn. If it were not for the fact that the alliance has an agent that we will that will be our counselor, then I think that that would be irresponsible to give people that kind of money without any experience in humanitarian work. And then try and go out and do on the job training. To become a humanitarian, without any central or a consistent source of information for you to ask questions to your call in line for questions, is your counselor. If you're not working with your counselor, then you may be going out of bounds. So there are things in place that will ensure that we, we don't do things like that. And yet, there, perhaps are those who would try and do things that are silly, or make mistakes. Don't be afraid of making mistakes. You've got money coming in next month or next quarter. If you lose some money, who cares? You put it into society and has been run around and the money's out there. So you're you're never failing and your responsibility, but you got to be, yes, be responsible, do things wisely. Get the counsel and advice and help. And then you will learn a decision making process. Through that, that will make it so you don't have to ask questions every time you want to make a move. You'll learn how to think it through. Next question.

What happens to your mother account? If you were accidentally to die? does it disappear? Because no one has your details? Or could it be passed to your nominated family? For example?

R Ron Giles 26:58

Why don't you ask that, that question to your counselor. And see what he asked. There, see what he says. Thank you keys didn't let you just go through life. And all of a sudden you die and you haven't made preparations for people to take over for you. Are you going to be that eerie? irresponsible? Would you do that with your life now? This is another way of question that has an answer within each person and in the set of circumstances that are present for them to make that decision. So hopefully, that's helpful. Next question.

How do we go about buying farms or large tracts of land? I want to get my sister back into a farm and I want to at least help Cherokee Nation get back on some fertile land?

Ron Giles 28:00

Well, it's good idea. How do you buy land, you go to the people who own it and negotiate the salary. If you can't do that, then find somebody that can real estate people do it all the time. If there's one, there's 2030 different national organizations sell ranches and that sort of thing. Farms, you just get into the industry and find out. So if you have the desire, you go search it out. But I'm not going to tell you, I don't know how I'm going to learn because that's the sort of thing that I want to do. I want to get farmers who lost their money or their farms to the to the Cabal organizations that were foreclosing on farms. I want to get those firearms back into the hands of the people who really own them and love the land. That's where they belong to I'm going to do it. And I'm not personally going to do I'm going to be sure it's being done through CAC many Assistance Center Directors. Next question

How do we go about buying a car for us and one for our family? Do we wait until the Alliance buys up over produced cars? You said we should show an abundant life so it seems we should drive a really nice car.

Ron Giles 29:33

I got to watch what they say because people interpret it 27 different ways. I'm just saying that it's that the money is yours. Go out and buy the car that you want. You don't have to show that you are abandon. Let people just see your abundant mentality. When we get into it and we can have cars it any cars that over five years old? Let's give them a really good trade in value. We can control that, can't we? We got the money. Let's get the older cars off the road. They're polluters. They're unsafe. And so if there's new cars being made, then we can recycle the old stuff. And but then we need to remember that there's new technology that's coming. We might be using anti gravity machines, just that a car, who knows? We don't know, how soon would that take place? We're going to go lickety split with this new technology coming in, you will have view your head will be spinning if you try and keep up with it. So pick your your particular interest and get all the information you can implement the projects that you want to do and the new technologies and, and have a lot of fun with it. That's because they are the ones in charge. Even people who own their own small businesses give themselves this title of CEO. It makes them feel good raising their frequencies. Do you agree? Since titles are free, perhaps and benefactors who will be in charge of their own humanitarian funds will feel more in charge with just a simple title reflecting their responsibilities? What do you think?

I think it's a good idea. Use titles that help you to begin a respect quotient. But you can give yourself titles. You could be the CEO, jerk. Those are the kinds of things that can happen with titles. But I think it's a good idea to use a title that would help you to be and your people is more so than you help your people to feel that they're, they have a real good job and a real responsibility to perform. And they'll move into the idea that this is my job, and I'm going to do it well. And we're in the business of helping people with money. Is there a greater business to do that? I don't know. We can change everything. So yes, I think it's a good idea. Let's just be sure that we don't go to the CEO mentality. Well, I'm, I'm in charge of all this. And you guys do what I tell you to do. That doesn't work. That management style goes away with Tarot deck tiles and dinosaurs of the past Cabal, ways of doing things. Next question.

When you say copyrights, I'm not sure what that means, mean, or doc or documents, I don't know that that needs to be a problem. If they're going to be that way and want to do it, and they can, and they'll probably want to go someplace out. When I say someplace out, it's a it's a it's a vibrational thing. Well, if you're referring, they use your user ID. And then they sign up with that as a referral agent. Other than that, even if you're the Zim benefactor, you probably won't be using your ID number very often, I don't think, but then you're going to relegate directors and people of that nature, to have access to the RSS platform so that they can perform their labors. That's where the the work of of humanitarian activities are in the local communities. So your directors will be the ones that have the responsibility to be able to go into the RSS platform under your user ID

numbered that gives them authority to make changes within the RSS program, that's all going to be part and parcel to what this whole program is about. It'll be set up that way. So that there is a chain of authority for anything that goes on that changes, makes changes within the RSS program, beneficiary program is not going to be touched. But there's a whole lot of stuff that you can do with the employment portion of the RSS platform. And that's where you'll really have some fun. I think I've covered that. Next question.

Do I understand this correctly, the Benefactor would have to sign all employment contracts, even if the project covers more than half of countries in the world? Is it possible to delegate responsibility for employment contracts to let's say, regional or national directors? I'm not talking about delegating, decision making and what kind of position or responsibilities but on employing a suitable person on a local level, or just thinking a recruitment agent who has a good sense could take responsibility delegated for assigning employment contracts. At the beginning, there will be plenty of new contracts in time the number of contracts will decrease.

If there are contracts, they are the form or the way that we will engage people in our work. employment contracts, doing this doing a being coming, a director contract, all of those things will have somebody that you can delegate to, to perform that that function. If you try and, and as in benefactor, trying to be the one that has to sign 250,000 different contracts on a monthly or two monthly or annual basis, you won't have a chance to do anything else, you've got to delegate responsibility and have accountability for the decisions that they make. And that's the way you set up your business, you'll have a counselor to help you to do that. And it's not that hard to do. It looks bigger than it is. But you break it all down. And there are certain elements, this is the way it works. Jones Oh Is the director and he's in charge of that community over there and he gets to establish the owner. Employment, let's see what was in business owner employment contracts. So there it is, it's it's all there. And the structure then how you want to do it is your own personal thing. But don't be labor this. You've got to have faith and trust in other people, that they if they fail you it's not a problem can be a problem for them. If they get fired or something, but you're not, they're not going to go out there and cause major problems that you can't resolve. or live with. So, again, you got a counselor counselor with do some best resource I can help I can find or who would want to find. Next question.
