The Alliance will take those because you bought them to get money for your, for your humanitarian activities, the alliance will honor that. They said they

would and they will follow through. So don't overly concern yourself. Serial number has nothing to do with it. Nor does a date and all that sort of thing. So you buy him then the facsimile then that's good, gold, silver, whatever, are the real ones, they'll all be redeemed. Next question. For the

Since benefactors have to start the cascade distribution process by at least sharing their account with their managing directors, everyone should protect their pin accordingly.

Well, a pin should never be given to anybody, for sure. So the Zim master, when you st Zim master account, we're looking at this master ID account, yes. Versus the pin, the account can be given the account number, as in the master ID can be used forever, whatever purposes you want, you will be identified as a sim benefactor with that, and only Zim benefactors will have a series of numbers that are for just gym benefactors. And with that, then you start delegating to people in your like in the CAC director giving him the permission to go in and, and change things in the RSS program under your authority, then that will be a chain of certain numbers that reflect back to the master user ID number. So but the pin number is the thing that you just never give out. Obviously, for security purposes for anybody. So I think that covers. Next question.

I hear Ron talking about the five main components of the program or RSS, CAC, NRELS, CSS and ICCH. I've heard him mention in passing that we will need common law lawyers to develop employment contracts. In my experience. I've hired technical folks engineers, but never the infrastructure folks like real estate brokers, human resources, purchasing agents, accountants, in addition to the lawyers, will we be learning on the fly with the help of our angels to discern the right people to support the staffing efforts? I would think these people will be essential to get our RSS and CAC started up quickly.

Is it going to be set in stone Well, as far as we're concerned, it would be but the way you use it is up to the individual, and benefactor and the director. So we're going to do what we can to support. But it's always your responsibility to fine tune it and get it working for you in the way that you would like. Next question.

No, there's not going to be a problem with that. We will make it available so that they have the ability to go it doesn't matter where, where they are, but the directors need to have the flexibility, because people are going to move around. And, and so there may be an opportunity for an employment contract by a director that's under a different Zim benefactor. So there has to be crossover, there has to be the ability to change things. Now, keep in mind, that the beneficiary program is is gonna say it's set in stone is 10 cents a minute, and you get six trust, and they're at 10 cents a minute, that won't change, neither will a belt bonus programs change. But when you get into a contract, it's a different section of the RSS platform. And that's where you have control. So if somebody already has a beneficiary account that will be in a place where the director can go in and create an employment contract for that person. Setting it up the way they want to. The appointment is only for the benefactor to the region is confused as you haven't seen it in play. As a beneficiary, a beneficiary will not be involved until the RSS platform is up and running. The Zim benefactor, when they get their money and love won society is able to get the platform up and running, then by contract, you will become a Zim benefactor. There's nothing in there that has anything to do with a beneficiary. So get the concept of a beneficiary out of your mind, because you're not going to be a beneficiary, you're going to be the Benefactor beneficiary receives the money. benefactor gives money benevolently. So I hope that that's clear. Go to the glossary on the websites, the first menu item on the first menu and take a look at and see what the definitions of benefactor and a beneficiary are. But too many people are confusing. Are they going to be a beneficiary or they're going to be in? Or do I go to the, you're not going to be a beneficiary. Unless you find somebody to refer you into their program into their chain of beneficiaries. You're not in the business to be a beneficiary. You're in the business to be a benefactor, and beneficiary won't go into a redemption appointment. They won't even know about it. They don't have Zim they're not part of it. Justify, open up to yourself that you are the benefactor and you will be setting up your RSS program. You're not going to be a beneficiary under the terms that we're using as a beneficiary account, so in the RSS

program, so please, just separate those two ideas in your mind. beneficiary will not be going to redemption center period. They don't know anything about it. Just an individual it's only For the humanitarians who want to be beneficiary benefactors. Next question.

Okay, look at the card, what is the card for? You're promoting the RSS program, I had nine friends that were going to be part of our RSS program or benefactors and go through redemption appointments. The card is for promotion. It has to have on there things that are credible, making that card in the program credible. So I shared it on there nine billionaires. Well, when you do the math, how many people even nine billionaires can keep up with the demand of the money, its own ends, and there's going to be some people say, Well, I better get in before the benefit, before these billionaires lose all our money. You know, there's how do you present that? This is my way of presenting it. If you want a different way than do it, there's nothing sacred about nine billionaires. Period. It's just a promotional card to create credibility amongst people who are extremely skeptical about anything that has to do with getting money in this way. cards is a promotion that people one person can use with another person who is a beneficiary and they want to refer their family member or whatever, to this to get a beneficiary account in the RSS program. Now, this shouldn't be that hard, shouldn't be that difficult to understand. So if you really have some questions about it, think about what are you trying to do? What is Ron trying to accomplish with this example of a card? And if you don't like the example of the card, then do unto yourself, I just like to see you put things in there like this is the person who referred you without that referral you can't get in. Without that referral identification number. You cannot get an account in the RSS program this year for beneficiaries not benefactors. Next question.

There's a number of different ways that you can you can set up trusts for them for specific things. In the past, the stress have been the 10 cents per minute, just similar to what the Alliance or excuse me the beneficiary program is about. But when we get into this and change things around a little bit, so that the Benefactor can do benefactor accounts. And then you can put in there any amount of money you want, for whatever reason you want. Those are ways that you can work with your your government officials. But I would do things on grants with them. They want to build a rec center, recreation center, or sports field or something of this nature. Have them tell them that you'd like to give them a grant to do that they need to do the the homework and figure out what's going on and, and, you know, give them some money to get the architectural stuff done and that sort of thing, get it all approved, and then let them manage the contractors, or manage the contract and set it up so that the money is going to the right sir. But you don't just give them a grant of a billion dollars or a million dollars or whatever, and then expect them to do something right with it. Be sure that they've got a budget or the amount of money that they need. And then the terms of the contract and the building and so forth, all has to be in place. And they're really good at that. That's what they've done for a long time. So be sure that you work with them in that way as grants or as trust that they can do for you might do a grant to for a police department to get bulletproof. windshields and stuff in there and windows in their cars would not be a great thing. But if it benefits, a grant is for specific purpose for a certain amount of time. But there's other things that you want to help them to do overtime. So it might be a maintenance contract for the maintenance pool or something of this nature. There's things that you can do to assist them. And really, they're going to need our assistance, because they're going to have to downsize everything that they have done. And because they cannot sustain it on the sales tax is going to get. So they're going we're going to step up and be the go to people for the things that they need to have done. So that's the way that I'm working with my anticipation of working with people. they said that they would do that. So I'm planning on that taken care of, they will give you a referral letter from them to me to level on society to become a gym benefactor. And I believe that that's the way it's gonna work. So, next question.

If you set it up that way, yes. But here's, here's what, as I'm analyzing this, if, as in benefactor forgets to do that, and put money in their account, then we go to the bond account, that you're setting up, how the first payment, you're going to get on the structured payout. Your first payment, you'll be walking out the door with that, it'll be in your bank account in your quantum excuse me into your quantum financial system account. Now, are you going to go out and spend 1.25 quintillion in your first quarter? I doubt it. So most of that money will be going into your bond account. Now your bond account, what is it, it's an assessor and assurance assurance bond or performance bond that says I will do this part of that bond will be associated with your master account. Because that bond is bonding the performance of the master account as a master as a benefactor in the quantum financials or in the RSS program. So the chain is the Benefactor sets up their master account that's associated with the RSS platform. So when they, the benefactors beneficiaries asked for their money, then it comes out of that master account, if there's insufficient in that master account, then the computer will draw from the bond account to cover the insufficient funds that are there. And then they guess it's by email or whatever, maybe there'll be his own go off in their bedroom or something, I don't know. Or some way to identify the fact that they need to put money in there. And then they go ahead and do that. But I as love won society, I have to be sure that it is it is taken care of. Because when somebody a beneficiary needs their money, then that money has to be available. And that's going to be part of the quality of the Benefactor contract that they signed with Loveland society, or with the RSS platform that they will perform in this sort of way. So that there's, if there's a problem with a master account, it can be drawn down from the bond account. This is something that flew new, it's a new idea that this is going to be the way it's going to be as far as a contract is concerned, because there has to be a solution to the liability problem. And this is the only way that I can figure out to do that. So no insufficient funds, even right off the bat 1.25 quintillions are going to take a while to get rid of if you have to be first take care of responsibilities totally. Which is not going to happen.
