Well, the LW s create a separate training or learning materials for the CAC directors for RSS CAC, and how to operate the RSS platform when it comes to managing and enrolling beneficiaries.

R Ron Giles 00:33

Yeah, we'll probably do a lot of the continued training on that. Once the money comes down, everything is going to be intense, and we'll do things that need to be taken care of fairly quickly. So we anticipate doing videos and things to help out with those trainings as we get into them. Next question.

T Tracee 00:54

Well, the CAC directors have the same access to the LWS learning materials for benefactors. I'm just concerned that the CAC directors have access to our benefit factors, actual materials, such as blogs, chats, videos, etc, they might figure out that we are the benefactors who have the money. What do you think about that?

R Ron Giles 01:15

Well, that's a concern. You know, it's designed for benefactors, if you feel like there's

something that you'd like to include for the director for your training. We'd love to to be responsible, but but you're the responsible party for your training, your people will try and assist as much as we possibly can and do things appropriately. But what you actually train your directors to do, is to be an extension of you. And so you need to set some parameters are around which you want them to work. And, you know, it'll be similar from one director to another in one CAC to another CAC even even same CAC from manufacturer. So one to another, there's, there could be a lot of the similarities. And, and, you know, I'm not sure exactly how we'll do that policies and procedures or ways that we would feel are appropriate. But we want don't want to still overstep our boundaries and try and tell you what to do. And we don't want you to want us to do that, because it is your responsibility. And those are the decisions were just kind of prompting your ideas and thoughts. So that you can get up to speed in a fairly quick way, your main person for that kind of training, and that kind of stuff would be your your counselor, your angel, I hesitate to call it that, because could be an Ascended Master. It could be anybody as and resurrected being. But somebody from the other side of the veil, that will be your counselor, and you'll be able to talk with them and get up to speed on the things that you need to know about. Don't take advantage of them. Next question.

In Europe, hardly. Nobody has a credit card. Mostly we use debit card, debit bank cards and use this service called ideal to do internet payments. Will this be accepted to pay for the RSS assuming for the beneficiaries?

The accounts will be in the quantum financial system. So I'm assuming that there will be some opportunities there. There may be a transition where there may be a hiccup or two but generally speaking, debit cards or Visa cards as well as credit cards. So we'll work it out. I mean, that's a that's a major thing that will solve a problem. And it's a problem, but we'll solve the problem very quickly with some of the things that we have available. It's part of the mission can be part of the mission. We're not going to dictate to you. It all depends on how you want to go about your business. When you say who are people who are in business for themselves. I think that that's appropriate. This ECS is not really designed for people in business for themselves as more of the Community Assistance Centers. So that would be the and that would be with your directors, and so forth. When you get into it, you'll you'll understand what I'm saying, as far as differences are concerned, and implementing the CAC program, you'll be able to identify the differences between the two, when it's time to do that, and study it out now, if you want, but it's good thing to know how you're going to approach them. But the CAC program is designed specifically for people who are in business for themselves. Next question.

When talking to business owners, we can offer to pay them double or triple their best years income from the past five years, would this be a yearly payout to the owner? Is it my understanding, correct that this would be in addition to the initial RSS download, and the ECS download to the owner.

R

Ron Giles 06:07

The owner would sign up as a beneficiary. And, and that's in addition to anything else that you were to do for him or her. And then you would talk about doubling their income. You know, if you, it sounds like you've been doing some independent thinking as in double, or tripling their best years, we haven't said best years before, but I usually use an average of the last five years if that's that's not, that's not the important thing. Important thing is you want them to stay in business. There's no reason for us to skip on giving skimp on us giving them what they feel that they need to stay in business. Now we're going to take care of their employment, their their labor costs, to employment contracts that we do with their people. So you double their present income, subtract out from that their employee wages and benefits. And they're going to be really happy with what we come in and do for them. And the people who are working for them, they should receive a substantial increase in their wages as well. Keep in mind that the the business owner is the one that's in charge of those people. And his wishes, as far as their wages are concerned, should be honored and and invited for his input. Some employees might, he might have been there longer would have more than another one. And those are the things that the boss would do. And the employees themselves might talk back and forth. If they do that's not appropriate, in my opinion. But if they do, then that's their problem. But you just give them the it's we're not going to interfere with the bosses, with a business owners employees. Let's put it that way. We're accommodating what he would like to do with him. And in invite him to be very liberal in what he pays for his employees because they're the basis of his business, and will keep him running. So that's important thing to keep in mind. In a training video, it stated that you as a beneficiary signing another two people receive \$100 plus one cent added to this download vary to people who signs is this correct? Or does he only receive the ones that download?

Every receives all of it, you have the bonus the thank you bonus which is \$50 for each person that you register, and every on the second one that you register, you get another \$50 plus a one penny increase in your download. So you've got it right. Cool. Next question.

Africa, Russia, China, middle and South America have almost no LWSs members, how is the wealth going to be distributed there? Who is going to do and NRELS or CAC in those countries?

Wondering where you get all of your information from? We have a number of people in Russia, a number of people in Africa, Middle and South America, not too many. So you're right in some respects, but we anticipate that there'll be an overflow going through those countries very quickly, because there's no reason why somebody in South America needs to wait for a CAC program that can all that can already be, they can already have the RSS program and the beneficiary programs going as, as people want to invite their friends and relatives in other countries to participate, you're taking it upon yourself a major concept in your mind to think that, who's going to do that, you'll leave that up to God, those people will be taken care of, we just do what we can do in the first step is right in front of you. So when you're, when your money comes, your first step is to take care of people right in front of you, take care of your community, take care of your city, take care of your county, state, whatever it is your country, and then move on. If you only consider that part of your responsibility in your local area, then you're not thinking globally, which is okay. There's no problem with that. But there are many, many 1000s, who will be doing things in other countries as just a course of action. So don't worry about them, they'll be taken care of next question.

And allow it just simply allow it to be true that you are in line to do that. Let it happen. And don't try and force it. If you try and force something, there's resistance. Why? Why do I say that? Because you're forcing something instead of letting it flow. There's no, there's no resistance to the flow of the Spirit in your life, unless you're putting it there. Well, it doesn't take a lot of patience. I understand where you're coming from. But I would I would advise you to not go into the judgment of other people and determine whether they are unworthy to play their video games or not. How do you identify them and say, well, they're not entitled to it. They will Get it. If they register, there's no conditions. What they do with it, is the conditions upon which their money will bring them joy and happiness. And if they sit around and just play games, that's their choice. It is a free agency, I have absolutely no judgment of somebody who wants to use our money for drugs. Why do I feel that way? Because I know that they're God's child, and the spirit will help them to write their ship. And then the money is still

coming to them. And they'll say, you know, I can use this money to get the help that I need. I don't like living life this way. I'm not adding to society, I'm not doing anything. It's gonna weigh heavily upon their minds. Because we're coming into a new way of life. There will be different emphasis. It's not how much money you have, it's what you use your money for. One of my humanitarian projects would involve helping families that are devastated by medical bills due to a loved one's illness, my goal would be to pay off these medical bills. My question is with NESARA implementation, will medical bills be included in forgiveness of debt?

R

Ron Giles 28:31

It is not a loan. So it won't be forgiven. It's a debt that you have in done to another individual, not an institution. So no, the the your bills like that will not be from my understanding will not be forgiven, because just not alone. That was created with fiat currency. It's a personal debt that you have to another individual. So you're going to have to pay it. It's appropriate to do that. But keep in mind that yes, there can be some fairly high medical bills. However, there's certain if you get in the RSS program, as \$1,000, we could do six videos, six trust, that's another \$6,000 a week. Well, that's seven, multiply that by four weeks, it's 28,000 a week. If there's a husband or a wife involved as well then that's another 20 pounds \$56,000 a month. Now, there's a lot of bills that can be paid with \$56,000 a month. So don't overthink this. Give the people a chance to have save their own face a their own ability to pay their own bills. We're giving them the money to do so. Why would we go in and pay it off when they can do it themselves and then they then they still have their integrity? They haven't had to go to somebody else doing something for them that they could do themselves had they had the ability to make that kind of money. So be wise, if it's if it's appropriate to pay the doctors off or something like that they're trying to collect on him and take him to court and all that sort of stuff. step in and help whenever you can. But be sure that you're not taking away their opportunity to pay off their own tests that they have incurred. Medical bills sometimes come under a different set of circumstances because you, it's something that you had to do to stay

alive. It's not a choice that you made, that was a poor choice. Unless you're smoking all your life, and you have lung cancer and that sort of stuff. I'm in even in that case, the idea is that you give them the help they need, and that's what we're doing. And let them make the decision of using that money to pay off their debts. And when they're finished, they'll feel really happy. And they'll feel like they've done something right, with the use of the money that they received. And it's a gift and they use it for the right thing. And it's a gift that keeps on giving. So next week, next week, next month, next day, you're going to get another \$144,244 for trust and swell with everything. So let's not overthink this and cause some of the problems for ourselves and don't project that onto the people. Give them what they need. This is God's way of getting the money into the hands of the people so that they can do what they feel is appropriate. And a blessing that would be will be next question.

Ron Giles 32:08

I think we should do away with inhumane factory farming, yes. But there's nothing about I say ESS farmer having to become organic farming, we encourage them to do that. Because we give them the incentive that we will produce all of the organic food that they can produce. If they use fish, farm, farm fish farms and that sort of thing. And let's not be dictating to them what what they can and cannot do, let's just say this is the desired way to do things. And setting the example. And if you've got the money to help them to make those choices, that their bottom line can be that they're making more money, then that's an incentive to, to go a different way than GMOs and all of that sort of garbage. You know, for me, I'm not going to pay for GMO crops, period, exclamation point won't won't participate in it. I'd like them to go to get proper seeds and get rid of the organics or the GMOs, for sure. But let's allow them to have a certain amount. I say something and now all of a sudden, they're required to practice organic farming. I've never said that. I'm encouraging them. And I want them to do that. And perhaps some of the things I said make it sound like that supposed to be the case. And perhaps that's a better way of going but I hope it's we're not dictating to farmers, what they have to do and are required to do in order to participate with us. However, in some circumstances, so for farmers involved in GMO farming, because that's the way he was making a living before. Let's say let's try a different way of making a living, that will produce the kinds of foods that people can eat and not get sick. Your bodies do not recognize GMOs as food. And that's why we have so many problems with overweight, because our bodies are not picking up on the because the food we eat is not giving us the nutrition that we're looking for. So we have to eat more and more and more. Some people say that, you know, just a couple of apples is sufficient for lunch or something like that. And if you're going to work real hard, then take three apples. I've heard that said before. But I think that there's probably a lot of truth in that. We're eating far more food than we need. But we're eating far more food because we don't have the nutrition so their body needs. So let's be wise in what we do. But let's not be dictating to the point that we're causing problems for families and farmers. We're there to help them, and encourage them to produce the food that has the nutritional value in it, repairing the soil, doing things like that.

Oftentimes, there's no money and repairing the soil. They can feed it all kinds of garbage. And and you know, the tomatoes tastes like plastic. We want tomatoes to taste like tomatoes, what is have you ever had a beautiful tomato, that tasted like a tomato, probably the only if your do your own farming, and do your own backyard sort of thing. We're trying to do this in a way that is beneficial for society and for everybody. And let's let's not pretend that we can make changes like that overnight. Let's let things take its course. But the farmer has an incentive to do things in our way of thinking that and let that be their decision. And let us manipulate to the point. I say manipulate to the point that we emphasize the things that we would like to emphasize. And I'm in my mind, I'm trying to think there's a balance here somewhere. I'm not sure where it is. But there's a balance that the farmer can come along. Because there's an incentive to do so rather than a requirement. It's a subtle change and subtle difference. But I would err on the side of letting them make the right choices on their own. We give them the opportunity. Money is the thing that talks. If it costs money, then they're not going to repair the soil because they're barely making it. But if you give them more money, and an incentive through the use of grants to to recondition and repair their soil, they'll do it. Because they want the same things we want. humanitarians are there to help everyone. And it it says part of the this is a question as part of the last answer that I gave the last question. Let's do what we can. But let's not be jerks about it. Allow people to be who they are, and then give them incentives to change to a different way. And they will because we're talking about money, money yells at them that they want money bad enough, they'll make the changes. It's not like we're requiring this, we're just saying these are the things that we would like and let's give some incentive for doing it. They'll come along, we're in a position to change the way the economic system of this earth is run. We're changing everything. And if you see the programs, you'll see what I'm saying about we're changing everything, especially the ESS program, and the International commodity clearing houses, it's going to change the way humanity works and works with each other. Because we there's there's not going to be any inflation because we control the price. The money that we get, and we don't have to have a return on it, or won't get a return on it. We can give these things away. Inflation. Don't talk to me about inflation. Because if the price of things is reduced every year by 10%, isn't that a good thing? There are arbitration boards already effectively in place. We work with those kinds of people anyway, when they go to judging things. We just give them punitive things that they can add to the pile. Let's say somebody signs a seven year contract, and they don't, after a year, they don't want to go through with it. Well, there's got to be some teeth in making them stay. Wouldn't you agree? When I say T? Otherwise, if it doesn't mean anything to them, they'll just walk away? Well, if they walk away, because there's no, because oh, I don't want to go to work today. And the boss calls him upset, Hey, are you coming into work? There's no I don't feel like working today. Those are the kind of people that receive the punitive actions that we're talking about. And the arbitration boards are the ones that that administer that, and they can go into the beneficiary program. Now, the basic beneficiary program, I think, is in viable, you don't change that. But you have the trust and things of this nature that you can get into, you don't want to take them out completely, financially insecure, or putting them on the dole or something. But give them it's almost like a threatening thing. If you if you don't feel like going to work today, and you've signed a contract that you will, you better get your butt out of the out of the bed and go to work. Or there's consequences. And these consequences that we can do here, put teeth in that contract. And it's essential to have it there now how its administered, is according to circumstances. What if they have COVID-19, they can go to work, we're not going to punish them for their work, if they're coming down, or they had a heart attack, and they can't go to work, we're not going to be causing problems for people. It's people causing problems for themselves. And there's consequences for those things. And that's why you have an arbitration board that has some ability to put teeth into it. If the arbitration board's there, there, that whole system has already been set up in certain areas. And if it hasn't been then you'll gather some people together that would be with legal minds or something of this nature, IP, some of the attorneys that have been steeped in common law. We readjusted in their attitudes towards the law. That's what I say readjust, their attitudes are no longer the king the crop and serving the elite anymore. That's shaping us. Dollar scans, there's good people around who will find them. And you will find them as an arbitrary love won society will not get involved in everything. We will be love won industries is the one that will administer the ESS program. And there will be things in there that will address these kinds of problems. Let's just see how that all works out because that's a big, that's a big mountain to climb. But we'll climb it. We'll do it. Oh, next question.

I thought in the past of just creating these trusts that pay 10 cents per minute, but I'm thinking more in terms of having the benefactors in benefactor account, and he can set up how much they feel that they need to have. And then that's that's their CAC budget for what they want to do and keep them within the budget, but don't be so inflexible that they can't buy a new computer if they need or something of this nature.
