Thank you for the question. And I can see that you do have some major concerns that would like to take care of, first of all, you're not making a decision. Now to do anything, the only thing decision you're making is to move ahead with the training, once you understand everything, and have a chance to get your funds and so forth, and you'll be able to make a decision. But this is not the time for that you're just going into the training and trying to understand what we're about so that if you want to move forward with your funds when they come, then you can do so. But this is not the time to make a decision that is binding. That's later. Next question, Tracee.

When the ISS platform is up and running, and we have our CAC office setup, do you think we should put a web address for CAC on the cards we give away for signing up for the RSS? Or do you think that would confuse people? Do you think it would be a good idea? Should our CAC have a website? And should we give that web address out on our RSS cards?

Ron Giles 01:27

My opinion about web addresses or websites for each of the CAC that you set up? You know, you might be setting up hundreds of CAC in different locations? So are you planning on doing a web address or website for each one of those? I'm not sure that that's why they don't need to go on the website to access information on in a personal website basis, a CAC basis. So I would not go there. If I were you. You're certainly welcome to do so if you feel that that would enhance your projects. But the CAC program doesn't need its own website. At least at this point in time, I don't see the need for it. If there's a problem, you're on the phone, and you have you can talk in person, it's just down the street, not not across the country or the other side of the world. So I think keeping it local is probably the best way to look at it. And I don't see the need for a web address. I'm willing to change if there's some reasons to do so. But I don't see it. Yeah. Well, is I see it as when a beneficiary registers and other beneficiary? Should they also tell them about the six trust? The answer to me is yes. Do that. Now, when you bring in the other programs, I'm not sure how you include that in a beneficiary doesn't know that much about these programs. So my question and and you, you pick your benefactor instead of beneficiary, and that's, but I look at it one way or the other, if it's a beneficiary sign somebody, tell you people, friends, family, whatever it is that you're signing, registering, tell him about and see the six trust as a benefactor, I would do the same thing as well. But the benefactor is going to be doing the NRELS and the CAC programs. Yeah, tell them any chance again, don't leave it up to the CAC or the NRELS program. You're signing people up as beneficiaries, and that's the program that needs to have all the information and telling you about six dress is a good idea. We welcome that. No. The court of law has no business and what we're doing you're not registering with a court. They have no jurisdiction over us. That's our will be the law of the land and NESARA law does not overstep personal boundaries. No.

Next question, without sounding too 3D, we won't be harassed by a tax collector of our gold back digital currency?

R Ron Giles 05:21

That's true. They won't even know about it. Tax Collector has no way to know see, the tax is usually from a bank. They share all of your banking information with the tax collecting agencies for income tax purposes. But there's nobody that's going to be sharing your personal injury information in the quantum financial system, which is where you will be holding your gold back currencies but we won't be harassed by them. No. Next question.

I assess can work. Not all governments with small salaries will do but only receive if they work 10 cents or 25 cents, and Sasa elders childcare inability 14 million on government money plus salary, this looks like a translated one. Money plus salary equals purchasing power equals stimulate economy. Can the workers with a salary sign the RSS?

R Ron Giles 06:21

Yes. Other than with all of the setup, I'm not sure what that all means. But a worker can have both the beneficiary cans as well as employment contracts. I'm assuming that's what the question is, and the answer is yes.

Okay, is the main bond account where total amount goes in under the Zim holders name, where 10% goes in every 90 days and operational account? What not used, they top off? The 10 year performance bond has nothing to do with the main bond account because the P B will be made out to LWS. Do I understand this right? performance bond? Oh, I guess that's performance bond.

R Ron Giles 07:15

I'm not fully sure of what you're going to hear as far as is the main bond account where a total amount goes in under Zim. So your your bond account is not the holding is a holding account. The Alliance will not be putting your money in the bond account. abunda account is a separate account that you that you establish in the quantum financial system. And all I'm saying is at the end of the quarter, when you get a new bunch of money, what's left in the account you put over and transfer over into the bond account. That's the one that you use for your two as a performance bond for all of the activities that you do. In addition to all of that the bond account will be attached to your master ID or master account in the RSS program as a benefactor. In

other words, you as a benefactor will have a master account that will be feeding money to the people who draw from that from the activities that you go out and do in your CAC programs and, and other employment opportunities. If for some reason, you neglect to put money into that account a sufficient amount into the master account for RSS purposes, then the bond account will be attached as a bond for that account. Meaning if there's not sufficient amount of money in there, the computer will go in and to your bond account, and transfer money into your master account could take care of all of the responsibilities. It's just a backup. Now the concept of bond is it's a performance bond. And you're performing doing things with your master account. The bond account will be attached to that so that there is a channel for the computer to draw from that bond account. When you have insufficient amounts in your master account. It's just a temporary thing. But we don't want you to just plan on that you've got to control your money. And by controlling the money means that you are responsible to pay those people and just be sure that there's sufficient amount of money in that master account to do so. There's a certain amount of automation that can take place, and that is something that we all have available and you can sign up for that but after a period of time, we have a track record that we can use to project into the future The growth that might happen. And so those are the things that we'll take care of once we're there, but the structure is that the bond account that we're asking you to set up or requiring you to set up is the one that will be used to, to as a backup for your master account. And that's in embedded in the, into your account in the revenue sharing solutions platform. Oh, it is.

So let me see if I can put this into other words. So it's not made out to LWSs. But it's more like an overdraft account on your checking account. So for instance, you know how like, a lot of banks have like \$1,000 for overdraft protection, just in case you write more checks than and forget to put money in to cover it. So covers you temporarily and then you just pay it back. Is that kind of what it's like.

Nicely put. Yes, that is. Oh, yeah. So Good thinking 99.

I had been listening to long enough. Okay. All right. Let's see where we are. Okay, well, meat factories be included in employment contracts and ESS. ICCH programs? Or will they be phased out?

R Ron Giles 11:22

What is your presumption here? Are you saying that everybody's going to become vegan?

Actually, I think their presumption is based on what you've said before that factory farming, also

Actually, I think their presumption is based on what you've said before that factory farming, aka meat factories, will go away?

Ron Giles 11:43

Well, there's always going to be a place to process beef for consumption. I'm not saying that that's, that's going to do away go away. We've got a whole program that we'd like to introduce as much as we can, using baby bowl neat, you know, somebody was quite offended when I said that as in promoting things from, from my perspective. But we need to understand that we're dealing with a whole population of the world. There are those who won't be this and won't need that, but we're not going to dictate to them. Baby bowl me mean simply means instead of that calf being able to bowl or not male or female or not. They they go to the slaughterhouses or yards, and they get fattened up and injected with all of these growth hormones and things of this nature. We're not going to allow that. But we are going to have the beef stay on the ranch for another year. And there'll be fed through the winter months, hay and other things. So it's going to be an increase in the use of hay. But the natural way that that bulls put on me is what we're interested in. And that's why I call them baby bull meats. So they're, they're going to be around for two years. And they will have their own natural growth hormones, that will produce a very tender and very delicious meat. And because it doesn't have growth hormones and all of the other garbage in it, it will be very nutritious, or people that want to eat meat. That's the program. So those people will be given those people associated with that will be given employment contracts. Where I'd like to do away with stockyards. I think that that's a travesty. I think that's a killing ground and I don't like and there's a there's a good way and a bad way to process me. We're going to be sure that it's being done the right way, which is a loving way which is Native American way. Give, give thanks for for the life of the animal that's been taken so that you can eat an array of other things. Next question.

If I understand well as a benefactor, I will give money to beneficiaries which I will find on my way with good humanitarian projects. And as a benefactor, I can have personal projects since it is asked to present a short bullet point presentation of personal projects. Is that right?

Ron Giles 14:49

No. Your personal projects have nothing to do with your beneficiaries. You won't know who your beneficiaries are. Your beneficiaries will grow From referral to referral, and they can be all over the world, you won't know who they are, there's no reason to know who they are us, as a benefactor will be doing your projects has nothing to do with the beneficiaries. The RSS program is what you're using to do your work. But you have no control over the benefits you won't ever. I don't see a need to know. I'm not saying that you. Suppose we could figure that out. But I don't see the need for any benefactor to know who the beneficiaries are. Because you could have 50 60 million of them and why would you want to know who they are, you're not involved in their lives. And the money that you give to them to the beneficiary program has no conditions upon it, which means that they have to do projects. So separate those two out. You

are the benefactor, your projects are the things that you are going to find yourself. That's what you prepare for your presentation at your appointment. Have nothing to do with beneficiaries. So separate those in your mind. Next question.

You mentioned there about 10,000 potential benefactors? Is it for the entire countries of the world? Is that number enough? Or do we need to get more involved?

R

Ron Giles 16:37

There's very little involvement or control or prompting for something. We're working with people who are sensitive to spirit. I'd say humanitarians do, they're prompted in their hearts to do certain things. The number of people who will become Zim benefactors, they're the point of the spear, they're the ones who will be getting the funds. And you'll be finding other humanitarians to implement those funds use the analogy of the spear, the force of the spear, it has a it has the the point on it, which penetrates into the darkness in this particular case. But everything behind that point is the thing that gives the enter the point the energy to penetrate that the shaft and all that are the people who will assist in your projects. They're the ones who will be doing the work, you will be employing them. They will be sharing with you the opportunities to give benefit to the world to the financial services that we that we offer to them. So the number of beneficiaries are not in my control. If somebody wants to go through the process and become a benefactor, then we welcome it as many as want to be there right now we have 10,000 over 10,000 people who are in our training, how many of them are going to continue on and get their training and they get the and if they are humanitarians and get their funds, then they will be benefactors. We're not certainly not going to limit the numbers that we have. But we we present the program and God gets the people in the right place to do it. That's the way that I see it happening. We don't have to worry about the numbers. I don't have to worry about the numbers. We just do our part. God will do his and everything will be will be fine. Next question.

Absolutely. However, keep in mind that the alliance will contact you. If you're in New Zealand, they'll contact you and Zealand in the South Island near Christchurch. Where you live. You will be contacted by the Alliance. They will arrange for you to have your redemption appointment. Some some were close to you. I don't know how that is is going to break out. I don't know. I don't know what it's going to look like. I just know that they will contact you and some way that is the best way possible for you. Keep in mind, we have this idea that we have to jump through hoops for the Alliance to take care of it. And I'm saying hell no. We are the ones that they're looking forward to do the work they're going To contact us, we set our hearts in place so that

we can qualify for what's going to take place. And then they come to us. Does that make sense? They come to us, because they know that we're the ones that they are looking for, to do the work of humanitarian activities, to bring mankind out of the, the debt slavery systems and into the golden age of mankind. Let's just be sure that we understand what is taking place if you give a Zim note to per all New Zealand, who's going to show up at the appointment for that it's you. It's yours. It's your Zim bond. Now, in your mind, you've decided, well, I'm going to this is all the money that I get for this is going to be for the entirety of New Zealand. You need to get your feet on the ground. You need to understand the reality of what you're doing. Why would you give bonds away you are the one that has the responsibility for them. You go to the appointment and get the redemption funds. What you do with the funds, then is your projects. Those are your projects. They're not funding projects. They're funding you as you humanitarian. What you do with the funds will reflect the projects that you want to accomplish. Love won society is a structure that is used to enhance your ability to perform your humanitarian Labor's you you have the idea that you're going to do these centers all over New Zealand. And many other people are doing the same concept and the same idea. And how many other people in other countries are going to come to Zim to New Zealand and do things there as well. You need to understand that you are the humanitarians in charge of those him go in and get your funds and then you do what you feel you can do. And that's why one per one entity called love won industries, needs to coordinate everything that's being done so that we can be as a group and done in an orderly fashion. So that it's, it accomplishes what it was supposed to do instead of everybody going which way in every which way and in which way the CAC program will be fine. If you want to have some liaisons with some of the work you want to do for love won industries, that's okay. They're good people, they can help out. So it's, again, you are the one that's in charge. Now, when I say service oriented businesses, owners, and you're saying less than 20 employees, I think from I said maybe less than 24. I don't know where the demo

occasion line is, I don't know where you say, Well, you've got 21. So you don't qualify for us? Oh, the point is, it has more to do with the ownership of the business rather than the number of employees. A private person can be an owner of a very large business. Does that come under the LWS and ESS program? Or should it come under the CAC program you'll be able to get in there and when you do the work, and you'll be able to accomplish the things that you feel comfortable doing. But all of the answers are not available yet. This is all brand new. Never been there before. Or setting out on a new adventure. There's going to be problems. We solve those problems when we get to them. Sometimes we try and shoot them down before we get to them. But the reality is that we can't do anything until they're there.
