Absolutely incorrect. No, that's there's no financial return. Money has been a source for the money, the people that made the money. And therein lies the whole demise of their financial system. They make money on money, they make money making money. That system is going away. So don't even confuse it. There's no return on anything that is part of the quantum financial system. In fact, we are not allowed to make a profit and neither are they. Money you leave in an account will never be used for making money in the quantum financial system, period, exclamation point. So these are the kinds of questions that cuz they're glaringly right in your face, if you will get in and start learning what's going on. And how did it happen. Some people asked me other day, an email, you start with reading from the menu items. Now, she couldn't figure out where the menu items, there's a black list of words, or I call them that they are menus on the top of the homepage, you'll go up there and click on it. And then then the drop down menu will come and show you all of the different articles and things that we have written. I suggest that you read through all of those first, you're getting into the videos for the guestion and answers and the other videos that we have. And that's good. But if you do that and not read, you're not going to get the information, you got to go from both sources. That would be my suggestion, if you're really and truly interested in finding out what this is about. Start reading, listening to the videos, I'd pay attention to the overall overview of the of our five programs, I'd suggest that you look into and understand the structured payout system. There is so much in there. It's going to take you a long time to do it. So it's not a slam dunk two points. And away, you go off down to the rest of the court. Now you got to focus on this and make it your if not your primary job. If you've got one, you're going to be a humanitarian. And that is your job. And you've got to show up to the point where you can say I'm ready to do this. And then you take your zoom in and I asked you asked for a particular rate because you prepared yourself for them. So again, these three questions just sound like it was somebody And I'm not trying to, to diminish their questions or demean their questions, because they're good

questions. But I'm telling you that those are the kinds of questions that show that you have not gotten into the program. So start reading first, then do the videos, answer the questions, the questions and answers and become familiar with it. And the questions are there just to find out what we think is important. How will combined currency system and QFS? I guess how will the currency and the QFS be combined maybe?

Well, it's it's a difficult question. And I can see that was done through a translator. I'm just going to take a stab at what you want to know, each currency that's represented by a particular country or group of countries. Some in saying that the Middle Eastern countries, we're going to use the dinar, all of them, if that's the case, and that's the case. But all of the currencies in the world will be on par value with one another. Right now, it's not the truth is right now, some countries are higher rate than other countries. So instead of getting a one to one exchange, you get, there's a factor involved that one country's worth more than another, the quantum financial system will not do that. All currencies have to be the same value. So that's why we're going through a Global Currency Reset GCR. Now, there are many people who don't know what the GCR really stands for. And they think it's part of the revaluation of currencies. To some extent it is but the Global Currency Reset has to happen before the quantum financial system is up and running. So those who are having trouble with language barriers and listening to those, go to YouTube, take the we send these links out, go to the links. Click on that and then you have a chance to change the subtitles and into the language that you want. So that's why we did it. So there's no problems with, with people, at least we're on the same translations. Let's put it that way. And hopefully, there's good as you can get. Next question.

I as the Benefactor buys a building to use as a Community Assistance Center, I guess the seller would like to know who he sells it to, not only who was signing on behalf of the owner, I tried to put myself in the other person's place, I would have wanted to know, to be able to make up a story about all this wealth, it would be great to know your thoughts about this. Anyway, I do not worry, as I know, my angel will be able to help me with this. I just wanted to be a little prepared with my story, train on it. Guess maybe a trust is the answer.

That last statement is, is true. There are people who buy stuff and each item that they buy, put it in a trust, like a car, something that this nature, any large purchases of property so that the trust is the name and then the trustee. Trustee is not the owner of the trustees, just the one who does. Who manages the Trust for the beneficiary. So there's in that is your anonymity that you're looking for. So it's each of the zero or the CAC areas that you set up can be a trust. I'm just gonna name them Glendale CAC and have that on the door, but then below the smaller words, understand the answer Community Assistance Centers. That's who do you work for I work for the Community Assistance Centers? Well, who the who owns that? I don't know. That they're the ones who provide the funds for us. So that I'm under an NDA, I won't know that. I have no need to know. And there is no need for them to know where the funds come from. Except that the money is clean, clear and non terroristic. And that there's somebody that puts up the stuff about that. Talk to your angel and see what kind of documentation you can provide for them to placate or so they don't have such a big hiccup about it. Because we're not under any taxable authority with this program, and with our money. So you're not going to have IRS type people looking into this and trying to figure out who's making the profit on it, because obviously, you can see we're giving money later, it's no profit, idiot, IRS people. Are they anyway, I shouldn't have said that. It's inappropriate. My real feelings came out. So we're not having to deal with those kinds of people anymore. They're gone, they will be gone. All they're doing is snooping around trying to find more money, who made the money so they can tax you? All of that's going away? So we don't have to we don't overly concern ourselves with have at all. So how do you do it? I think that I think that trusts are a good way. But you always say I'm under an you can say it this way and put all your people under an NDA, if that's what you feel you need to do. So they can don't have to lie. an NDA doesn't have to be in writing written, it can be just a, an idea. I'm sure that Simon and Charlie don't have a written NDA or just say don't talk about it. So they don't. If they did, then they get cut off. It's my thinking. I don't know that they physically have signed an NDA. Maybe they have they haven't said that. So an NDA can just be verbal. So put your people under an NDA. Somebody ask them where's my income from? I don't know, I work. This is this. I work for these people. And this is what I do. And we're distributing their funds and whoever has those funds. I don't know. Would you tell everybody if you had the fence? No, you wouldn't do it. So don't expect them to do it either this stuff like that. So I, it's an important question. And I don't want to diminish it. But you're going to come up with some really clever ways of putting things out to the public where they can't find out where the money comes from. It's already in place, those kinds of things. That's why they have the Cabal created the corporations and all that sort of stuff. So I call them legal fictions. Anyway, we're going to have trusts or whatever other vehicle survives into the Nisar and just

Please clarify generation bonuses, who is first, second and third generation that is registered under a beneficiary's ID, are these people in the same family registered under one beneficiary's ID, I would assume these details will be built into the platform for everyone.

Ron Giles 23:05

Okay, first of all, the beneficiary program is a referral program. And let's say Tracee, referred me and I signed up as a beneficiary. That would make me her first generation. If I save up somebody else, which I plan to do, because there's bonuses there, then I get to, then I'm her first generation, I get to have my first generation of people that I sign up, which would then be her second generation. And then to go down one step further. And that's the third generation. The reason we did three generations deep is because you as an individual might go to a pastor of a congregation, and the pastor, and you want them to sign up? Well, it means could mean that the pastor signs up to be on the first generation. And then the pastor might have a group of people that are in charge of the church, they may be the second generation. And then whoever signs up from the congregation is the third generation. So if you as the individual that was introducing this to the, to the church, to the congregation, you would get paid in the file. Generations, one cent per every 10 people to join. So it makes it worthwhile for you to do that without the generational bonuses. You wouldn't make that you wouldn't make any money there'd be no incentive to do that sort of thing. And so we built into that a promotion for the

way that we want to open up for and and what isn't that a great thing for a church to have? income that's coming in, they don't have to pass the hat. They don't have to worry about all of the budgets and everything because they know how much money is coming in every year. And if they need new roofing on the chapel or something like that, or on their place of worship, then they, they can do that. They'll have plenty of money. And if they want to do humanitarian work, there it is. Right there in the community. It's a great thing. So that's why the generational bonuses were made. I hope that helps. When it says, seeing family, registered under one beneficiary, ID, yeah. If if Tracee would sign up her family, and she would be the number one person and then those she signed up would be her first generation. I hope that helps. A little bit like network marketing, but obviously there you're in it for profit, we're not. It makes us difference. Next question. Go ahead. What were you saying, Tracee?

Oh, I was going to say it doesn't just have to be a family, it could be friends, you know, or anybody in your community.

Ron Giles 26:21

It's not going to create a cohesive group. Unless you say this is my person, this is my second, this is my third bigger third generation you probably never know about. Because it's a referral system. And it's so far away from you, two or three generations, that this is going to go like wildfire, wildfire, and you're seeing one or being in one. And it's frightening, because it goes so fast, when whipped along faster than you can run. But the point is, is that it will go so far, so fast that you will, there's no way to control it. It'll you thought you started in America, or in particular city, in a state in a county and so forth. You thought you got there. And then all of a sudden, you find if you were to find out, your referral system has gone into other states into other countries and is all over the world now. And that Zim benefactor is the one that's financing all of that. And that's the way it's set up. So you have no idea where it's going to go. And it can go really fast in all kinds of different directions. Next question.

If a person is a beneficiary, which they have to be before getting an employment contract, why would they sign an employment contract when they can make endless money signing up beneficiaries?

Ron Giles 27:54

What you're asking is, why can't the person have a job? In their own mind signing up beneficiaries? Well, it's not going to be a contractual who's going to give them a contract to do that. Maybe the gym benefactor would do that. I don't know. However, it leaves it open for that. So I am, okay, here's a statement, I'm having problems with which they have to be before getting an employment contract. Now, that means that they already have to have one before they can get an employment contract. Well, the person who's introducing the boss at their work, he'll, he can introduce you or refer you to the RSS program, and you get your RSS

program up and running from there, your, your your ID number, and then that's so when you say you have to come before that the employment Yeah, it comes concurrent. i You can't have a contract. Because there's nothing there. There's no place to put it unless you have a beneficiary account. So to some degree, that is true. But it almost sounds like you have to be just sitting around waiting for somebody come and give you a contract. And you sign up a beneficiary before as a beneficiary before that. We want them to be pretty much the same time if possible, because if they if they learn how they can make \$28,000 a month with six trusts and the beneficiary account, they could they may not want to do work. As in working for somebody else, they probably start their own business because they can have they have the money to do it or something that they're interested in doing. And we certainly encourage that. Everybody gets a chance to be who they want to be in this program. So you can either work for somebody else serve, start your own business, we would like you to be productive in society and carry your weight, bring to society, your uniqueness, the things that you'd like to do. And then that can be your job. And as somebody making a job out of going to different organizations and doing the generational bonuses, I think that's a great thing. There's so many different ways that this can be worked. So we'll find, I'm sure there will have some that I've never thought about. Next question.
