So I can see that you're brand new, or you have quickly gone over things that are very important and have not absorbed them. So the reason for it is because zim has the ability to get a lot of money. If you don't have a lot of money, you cannot do the RSS program, or any of the other programs. That's the reason. Now, that's all in the documentation. So you need to go and start reading and there's a lot of questions you're gonna ask. But they're all in the in the documentation. So if you don't like a lot of hours of q&a, then get in there and get your stuff your answers to your questions for yourself. I would appreciate that very much. So let's go to the next question.

Okay, next question. If a beneficiary signs up on the RSS under one benefactor and gets a job contract, under another benefactor, how will the beneficiary get his further downloads will be under the four second benefactor or both?

It'll be under both.

So basically, both you get the RSS from the one, you signed up for that, and you get the contract money under the one you signed? Okay, so next question. Do you not know, this has been addressed yet, but I was wondering if Ron has done a printout of the suggested RSS business card, I have done it on cardstock. You know, let me add to that, I do believe I remember seeing pictures in the forum of different people's business cards. And perhaps I can make an announcement about that. Thank you. Okay. Under the ESS program, and in the beneficiary count adjustment for employment contracts, you discuss a 25 cent start and also an ECS share 37 cents? Can you explain the difference?

R Ron Giles 03:38

I'm not really sure what your question is. But here's my answer to it. I have said in there that the minimum is 25 cents per share, or per contract download that's added to your beneficiary download account. It's a different accounting area in your personal office. So it's all in there and you're getting paid for those things, and the computer will pull from the right benefactors master account. You don't have to worry about that. This is just an accounting picture anyway.

And and we've got it all taken care of. If you do 25 cents for an employment contract share, you're not giving enough money. And here's my reasoning. They've gotten a they've got the beneficiary account. If they get the six trust, that gives them the 70 cents per minute download, as well. There it is. It's \$20,000 a month \$7,000 A week. To compete with that you're going to have to get your employment contracts up to at least 70 cents. per minute, or nobody's going to want to do it. So you're just adding, you're doubling their income by by increasing the employment contract up to at least 70 cents, all of my directors are going to be 70 cents, and some of them are really good, and I'll put them up higher. And then they get their additional money from the beneficiaries that they sign up as well as a quarterly raise. One cent per per quarter, we are getting into a lot of money. That's why we have been told to go from the 100 T note up to the 100 quit until you don't. And this is one of the things in the SKR program that is just so simple to do. A lot of people think you're going to get you're going to trade those 100 T notes in for the 100 quintillion, that is not what goes on. You ask for them, you asked for the higher rates on the Jot form, which is the request form for the SK er, you keep your 100 Zim and you send or take them into the appointment with you to get them redeemed, you don't give up anything. This is all in addition to what you have. The SKR program is for every Zim benefactor in training that we have. And the person who is on the training, and is signed up for the emails will get the the Jot form, it will come in the email. And I'm not sure how often it will come but I'm thinking very often. So that you'll have plenty of opportunity to get into whatever because you're entitled to 180 million. You're You're welcome 280 and five for each SKR 5 million for SKR. it's gonna take you a while to get your 190 We're starting out slow. And it'll eventually get to where there may be 10. And maybe after that they will go up higher, we'll see. We have to keep our stethoscope on this to be sure that we're getting as many out as we possibly can. But we won't don't want to send them all out to the people now. And and people who are coming in, have a problem with him. But we're looking for 30,000. Zim benefactors, and all of my fingers are force 30 1000s In benefactors. So if we have 30 1000s in benefactors, then each one of them can have 180. And we're not going to have any problems. So just a side note to that was get your employment contracts up. As far as money is concerned, we have the money, there's no reason for us to say, Well, what kind of work is this guy going to be doing? And the lead to that the law? And well, they're in the the normal is, is about 25 cents per minute, which is \$2,500 a week, \$10,000 a month, 120,000 for a year? It doesn't matter. We've got so much money, why would we want to keep it extra as in the in the Zim bond account? And why are we doing that instead of putting the money out into that that part of our what you're doing is going to fill up really fast. That's not the problem. The problem is getting that money out being used in the economy. And then if you'll read my Zim, or my fkr explanation, we've got to pull out that those we got to activate the money in the as in the quantum financial system that are represented this the digital gold certificate, they do nothing until there is a transaction that turns them into money into an account. If we don't do the transaction, the money is not activated into somebody's account. It just sits there. I don't want to ever hear somebody telling me well, I don't want to be greedy. If you're concerned about that you're coming from your mind, instead of your heart, you're missing the boat. You think you're got some pride or something and not being greedy. That's all ego. bypass all of that garbage thinking and go to your heart and let your heart tell you what to do. Because you're not serving anybody very well, by having that greedy concept in your mind, that's making decisions for you. Turn it over to your heart for your decisions. The Cabal, wants people to be really, really smart, and have no connection to God. And that's why very smart people are often recruited by the Cabal, because they want an example of those who have the ability to think. And they got four people involved that Kevin that extra two cents that go and get into employment contract for 25 cents, and that's how it adds up to 37 cents. And that's the that was the explained explanation. But I don't realize me I can't figure out why people can't see an explanation and have it be true for them. There, it's I don't know how to do it any better. Well, don't worry about it. I'm not trying. I'm not trying to pick on you. You're doing the best I can. I'm just trying to give you a boost to get you over that hump of limiting thought processes. So let's go on to the next question.

If you go to the menus at the top of the page, sometimes people don't see them there because it's dark colored with a light colored printing or light white printing. That's where the menus are. The first menu talks about stuff like this. Now I'm saying this a little bit. Why don't you read? Why don't you read these things and answer your own questions. The Redemption appointment is not made by anybody on this earth. You will be contacted by the Alliance. They know who the humanity arrange czar. And there are only so many manatorian humanitarians that have contracted with God and made their their agreements with God to come forth on this earth and receive the money received

It's an excellent question. And there's a degree of confusion there because the refinance will go through the financial service centers. And they don't need a broker there. But see, if you don't have the financial service centers active, then you'd have to go to a bank, and they charge you all kinds of money for a refinance. So the financial service centers will take over that part of the hit NRELS program, you won't have to have a broker, you won't even go talk to a broker for that. The brokers are the ones who are selling buying the houses for the program, and then reselling that through the NRELS program. And and that's that's basically separate. But I've said it before, the NRELS is one of the most difficult for us to provide, because there's so many changes in different countries. So let's just recognize the fact that that's when we try to tie things down, we're shooting, we're shooting at a ghost on this one, because it's going to happen. And what happens when it happens is what happens isn't that interesting statement. We can plan all we want but what's going to have to work out to solve problems with the program. And in solving the problems with the program, then we'll solve the problems and people getting homes. And that's what it's all about. So there will be changes. And the NRELS is one of the ones that will make the biggest changes, I believe because there's so many different countries and ways to convey title. And if you're part of the Cabal countries, then you they own you. They own the land, they own the ground, they own everything. And that's why there's so much of a problem that has to be resolved. And the the laws of the land are going to be changing to the point where we accommodate the reality that we finally get to own our own property instead of just them owning that and we pay for it and then they charge us rent to kick us out and if we don't pay the rent. You're no, and that's okay. Because this is a good question. And one that needs to be answered properly and without feeling that you asked a dumb question, because it's a good question. The referral program. In order for me to determine whether an individual is has the finances and his event that humanitarian, I have to determine that myself. And I have to be sure that that's accurate before I make a contract with that person. Well, the Alliance said, Alliance, I'm not into judging people's humanitarian disposition. That's your job. That's, that's, you're the one that judges and so it has to come from you. So you're are vetting the people before as they go into their appointment. You're vetting them as humanitarian. That is legal. Now, the referral then comes from the alliance, the representative of the Alliance, which will be your new counselor. They're the ones who will refer you to a love won society as ones who have qualified to become a Zim benefactor in NESARA And the love won says hi these programs. And that means that you have the money, you got the money because you're a humanitarian. You were vetted out to see humanitarian. And the alliance is saying, we refer these people to you to become Zim benefactors. If they want to become Zim benefactors. Without that referral letter, you will not



be offered a contract to become a Zim benefactor. That's how important that is. The referral come from the Alliance, and is given to a love won society, as a person who they have vetted and done everything and they do have the money to be able to do it. That's all I asked them to do. And they did it, they agreed to do it. So I hope that helps out.

Yes, certainly, personally, I recommend you set up a CAC. And you're where you live. And it's easier for you to find the people and you're locally so that they can, so you can go and check up on them and get things started to the point where you feel merrier as as in benefactor, you get familiar with the CAC program, because you're there administering it. And then you put people in place for you and then move on to a new area that you want to do a new CAC program, and that can be in the same city, different location in the same city. And you can coordinate it there. And, and then you can go to a town that's close by or whatever community center is, is a geographical area. And I don't know what they are. But you can you can create those as you move through things and get directors for certain locations in the city, column ad committee Assistance Center. It's it's, it's a movement thing, it's a start here and then get

really good at it. And as you're getting really good at it, you start moving out, getting new people in and giving those who have shown their worth more responsibility. So you can get one director who's in charge of four or five directors. And then you have that director being working for somebody in the more like a county, or it all depends on how big there are. The locations are quite interesting and quite different can be quite different. There were all the inner cities, the rural, and and then suburban areas. If you're going to get familiar with it, it's hard to understand it all now, but you'll get familiar then you'll do a really good job. That's why you're chosen. Let's go to the next question.

That's why people get an office someplace else because when they come home, they can leave the office and go home. So you're gonna have people coming and going, Are you going to Delaware out your carpet. You're gonna have a lot of people coming through. Now then you're going to throw in a healing treatment and retreat center. I'd like to think that that thing through a little bit better because there's some, I see some red flags there, I would not do that that way. Personally, I would set up a CAC, Community Assistance Center and have a very large office with space for people to, for you to put on seminars and things of that nature. You can have computers there that they can hook up. And and write contracts for businesses, and also for people who want to join us as a beneficiary. CAC is going to be a large place. Now, how to start out, you've got all the money, there's no reason to be poor, boring it by going from your home and doing something different. And moving up that way. You've got the money to buy the best place in the city for Community Assistance Center, do it. We're changing our thought processes, we're changing from lack mentality, and planning on poor boy in it and setting things up in a way that it just doesn't work. When you have the money, you'll do it properly. And you won't be some scabby organizations. You have fine furniture you have the the best of what is available. And why not because you've got the money to do it. And I don't want to hear anybody talk about greed. Okay. This is your your a public high for our program, that CAC center. So I wouldn't set it up in my home unless I have a huge home and then why would you want people walking through your house? Let's go to the next question, please.
