Hello humanitarians. This is Ron, and I'm here with Tracee. We have a lot of questions concerning the request form for the SKR program. So we thought we'd spend a little time on that today and help get some clarification on what needs to take place. Tracee is going to do thing to read it and I'm going to comment. So go ahead and begin Tracee.

Okay, so first off, I just want to say that we have changed things to make it easier for you and to address some concerns that were brought up. But this is what it is right now. And you only need to fill it out one time. This is not a daily request, like we had said before, or Ron had said not me, but it is just a one and done. Okay, so if you don't have up to the desired amount, because you were confused, you can fill it up until you actually have it. But please don't do these daily. Okay, so the form says this SKR request form is restricted to those humanitarians that have registered with loved one society to receive training and information to become managing directors aka Zim benefactors. In the loved ones Society programs due to the alliance vetting program, LWS cannot issue a guarantee that these SKR will be redeemed. This is an alliance program that LWS has been given authority to implement for our potential managing directors and Zim benefactors who are in training. Okay.

**R** Ron Giles 01:34

It's for the Zim benefactors who are in training with the level and Society Program. It's not open for anybody outside of us. So it's not open to the public at all. Go ahead.

**T** Tracee 01:50

Okay. So all we're asking for his name, first and last email and Country, we took out the address and everything, we don't need all that information. And then it says, I hereby request

the bloesem bonds as the safekeeping receipt from the storehouse of love won society as authorized by the Earth Alliance, I understand that I can include these as care bonds for redemption out my appointment, the Alliance wants us to have the greatest number of funds possible. Therefore, you can request a maximum of 180 million in your combined SKR And in total of 2100 quintillion, these are the limits, please use a zero for the denominations not requested. Okay? So total total is 2100 quintillion. So if you haven't made a request yet, you can just fill this in with 20 and up to 180 Millillion, you do not need to have this much just go into your heart and find out what it is that you need to fill this out with. So please just leave this as just digits. Okay, so either 20 or somewhere around there or 180. Somewhere around there. Don't add any zeros, please,

let me just make a comment on that. They want us to use quintillions. In psychologically in our minds, that's the least that you should have. So if you have 100 trillion, trillion notes, and that is the basis of your asking for funds, they would like you not to discard them, and you're not trading them in for something else. You're just adding to it, okay? And in means that you keep them and you redeem them at the appointment, but they do would like they would like you to have the 100 quintillions. Now, one of those, in comparison to the 100 T note is six more zeros. So you go from a trillion to a quadrillion and then there's a quintillion. Yeah, how many of those do you want, you can have up to 20. If you have one that's a lot better than just the one 100 T note. So we're upgrading our request forms or request for to have the higher rates. Now, why is the Alliance wanting this to do this? Well, let's go to the next one. And I'll explain. And you've already said you're we're just in the process of saying how many Mulligan's you want you know what a milliliter means? And how many zeros are there are out there? Well, we put it down there so that you would have an understanding. There's 3,000,003 zeros In a 1 million bond, now, we're not just making this up. These bonds have been issued by the Reserve Bank of Zimbabwe many, many years ago, so that they're available for us now to use. Now, let's go back. Zimbabwe has absolutely nothing to do with these bonds, it's a distinct defaulted use of these things, because they no longer have their own Zimbabwe dollars. They don't have it, they're trying to redo it. And if they do, has nothing to do with these bonds, Malayan is a huge bond. Well, it's huge, but then there's others that are bigger. But we've decided to use the multimillion because I'm gonna say it this way. And you may not agree with it, it only has 3 million zeros to it. But huge in anybody's mind. That has not lived with these high numbers for a long time. There are higher bonds. And I have been given a lot of these higher bonds. Now I took a lot of time to do a post, a document then explains all that this is about you cannot disregard that document. If you don't read it, you will continue to be confused. You will make mistakes. And then we'd like to show you how to resolve those mistakes without coming and that I've got over 100 emails in my account now. And I've had up to 300 I have a life. But I don't anymore, because I'm always doing the emails back and forth. Because people don't understand at every time and I'm just getting furious about this. People do not read those things that I have given you. And then you make mistakes. And you come back to me with an email and complain about it and say, Well, I did this and I did that. It's in the documentation. If you don't read that, I'm not going to answer any more questions. If you have a question, we have the Jot forms that will be out there. You write your question on that. And then that will be we will do those the answers to those questions in the killer q&a that we do almost, least once a week, but we've used to do them every day. But the point that I'm trying to say is, you're not little kids anymore. Love won society is a structure that you can use as a humanitarian. You're in training to become a humanitarian through level one society's programs. I do not have any responsibility to do this at all. I've done all that I can. Now we're up to 15,000 people and I'm

getting all kinds of emails, asking silly questions. I'm saying silly when they're already being answered in all of the q&a, and they have already been answered in the documentation. If you want to complain about something that I'm doing wrong, you go ahead and complain. But I'm telling you that I have no responsibility for you to come and do something that I have created for love won society to do our own humanitarian work. I'm sharing it with everybody else. And now I get people with their real strong attitude. Well, I haven't you haven't taught us how to use. I've given you everything you want, or everything you need. I'm going to retain a life of my own. There we're looking for another 15,000 people to get up to where we're supposed to be. Well, I'm ranting and raving here because I want you to know that this program, the skr program, is all outlined in those documents. If you don't read them and you complain to me about I'm going to I'm going to write you back and even if I read it, I'm gonna say Do back an email and chew you out for not understanding and not realizing that you have to read everything in order to get it right. That don't complain to me if you don't get it right, read over. If you've done something you feel it, you will Oh, I didn't get this. Well, you go ahead and read those things again. Because in that is all of the definitions are everything you need to know. I've had 4400 emails in the last two or three days since we put this out. We've made some mistakes. we've corrected those mistakes. And if you don't read things, you're not going to keep up with us. You'll be left behind and you'll be wondering why isn't somebody could notify me and telling me what's going on? Okay. The my Lillian's three excuse me, 3 million zeros 3,000,003 zeros or using that one. So that because we have the we have the bonds that would support the numbers of millennials that we're using. The Alliance has said yes, you can divide the larger bonds a Yoda trillion does that have settled audience all of those we can, we can divide up and make my Lillian's out of them. Then we send the SK ours to you. And the alliance has said that they will redeem them. Just as if I had sent you the bonds. Long with this program has come the idea that the alliance would like us to donate the extra amount that we have to the alliance, you take your zero you take how many millions Can you have, you can have 180 multiply that out by the the Zim rate that you're going to use for your redemption. That's what we want you to do. That's the redemption rate that you got in your heart. And you're gonna go in there and you're gonna say I have these medallions that I would ask SKR. And I would like to use the same rate for to redeem these SKR. And they will do that. Yeah, imagine if you had 180 bonds of the size. They're not just simply for you to do your humanitarian work your projects, the Alliance's up this to the point where they can, we can have plenty to give to the alliance and a separate account, we'll go through our appointment. And in that appointment, we'll say I'd like to, to dedicated how see who is you're going to be there with in your appointment. And I don't believe a lot of people understand this. Or they don't believe it. When you go in for your appointment, the person who is going to be there with you is the one who will contact you and tell you when they'd like to meet with you and you make out the time and where you're going to meet. It's personal. It's a contact and you work out the date and the time that you want us. They will give you a place to go. Does anybody else know about that? Absolutely not. Every person is personal. It's for them alone. We have people in Africa that one of his benefactors they will be contacted it's not by carrier pigeon or something like that they will get a real contact from the Alliance probably from the guy that's or girl that's going to do the redemption appointment for you. That is your counselor. Okay. You're going to ask him for a rate and he's there's the bonds that I have and here's the status SKR. What is it an SKR It's a safekeeping receipt. It means that in our case in level one societies case I have the bonds in my own account right here. I'm staring at them right now. And we're dividing them up so that you can have millions. And you can have 180 of those. That means you talk to your opponent, you're at your counselor at your appointment. Here's what I have already. This is the right that I'm asking. In addition to that, I have 180 million that I would like to redeem along with my other stuff. But I would like to discuss with you what is necessary for me for to look out for this 100 years and the projects that I'd like to do. And anything that's going to be leftover, instead of

being put into another account of some sort, I'd like you to put it into an account specifically designed, it'll be my money, whose money is it? It's your money. But you're donating it to the alliance. Who you're donating it to the alliance. When will they come and get it? I have no idea. They may never come and get it. But what we have done by doing this, and I'd like everybody to really understand this concept, really understand this concept. In the quantum financial system, we're using digital gold certificates. For every increment of money, there is a gold piece of gold at kilo of gold with a serial number on it. The digital gold certificate refers back to that particular piece of gold. That kilo of gold that means that that digital gold certificate is backed by that that piece of gold that kilo of gold. Okay, those are sitting there. They have been sitting there for years, as they have been accumulating. The elders have have bought us all of this gold. And every time I ask well, is there enough gold to to redeem a yodalillion. Yes, there is. At the high rates that I want yes for is. What about the 100? You're looking? Is there enough gold to cover that? Yes, there is. What if I had 200 of those bonds that have 100 yodalillion apiece, no. Is there enough? Yes, there is. What about the guy down the street? Or over in Africa or over in Australia and selling them? Is there enough to cover all of that? And he says yes. And it's like, for us it's like counting the sands of the sea. But they can count every single one of them and then possibly be named. They understand what's at stake here. They understand what we're doing. Okay, so we go in there and we redeem our bonds. And then we come up with 180 your meal millillion well the millillion and we've had people say well, I don't I've got plenty for me I don't need all that stuff. So just I'm not going to do this. I you know, you hit your head on the with your hand, banging on the door, whatever you want to do. Don't you love God? Don't you love the Alliance? What do you not just simply get a free gift that they're asking you to get and to redeem and put the money into an account. So that as the alliance is trying to go into the galaxy that we live in, and another galaxy next door and another galaxy next door. I have said for years, the quantum financial system is going to be the financial system for at least our galaxy. I don't have an understanding of how many galaxies I have no idea. I have no idea about how large the universe is. The Alliance they're asking us to just take a free 100 80 million redeeming that the value that you give it, the rate that you give it, and then put it in an account so that can just stay there. If indeed them alliance can use it to expand the quantum financial system, and to the rest of God's creations where belongs. Don't tell me that there's no need for money in those other realms. They're using barter systems. Whoever told you that we're not going to have money. If somebody's been telling you that they don't know about the quantum financial system. They don't know what they're talking about. Every single time I ask about the use of money in the future, it is always part of the quantum financial system. So those people that say that sort of stuff, I say, Well, who do you talk to? What What organization are you with? Because it's not the Alliance, I'll tell you that for sure. Because the Alliance knows what we're doing. They know what they want us to be doing. It's on our shoulders. If you disregard this, you're basically saying to God, I don't want to help you. So help yourself you created at all, Jeremy is not mine. And those are the kinds of people that I look at. And I say, there's a good chance you will not be getting any funds, because you're only looking at yourself. I've got enough for my projects. God's asking you to extend yourself a little bit and let him have enough for his projects. Or what other thing you think God, yes. Creator, Prime Creator, divine consciousness, whatever you want to call it. You don't believe in that. That's your problem. You're here because of it. So let's understand what we're trying to do here. This is not just another project. It's the implementation of the golden age of Van kind. For every human being that God has created and is alive somewhere in his universes. It's for each one of those people. Show there's something that you're learning. If you don't believe in all of this, then you're going to be left behind. And your sacred little projects may not get funded by us meaning those who receive the funds. You don't have to sit and wait for somebody to come to you with their money and that they did properly and got properly and are humanitarians. And then you'll be working for them. Okay. This is I'm frustrated. I really am. I've not been this

frustrated since I got into love won society. I spent hours and hours creating documentation so that I think people will read and then I know that they haven't even opened it or even started looking at it. I have a lot of patience, but I'm losing it. Because people are not taking the responsibility to do things. I'm not here to make you a humanitarian. I'm here to provide you a vehicle to use your humanitarian funds. But somehow it's my responsibility to train you to do everything for you. To bow kowtow to your every demand. It's time that you picked up the ball and and run with it yourself. There are no mothers here, taking care of you Okay 180 Millions, each one with 3 million zeros. You take those data and you redeem them, because they're part of your SKR program and they will they aligned says they will redeem them. Okay. That's, that's all there is to it is very clear and cut. I hope so now. And I've been on my high horse last four or five days, I've had trouble sleeping because I do everything I possibly can and people just won't take the responsibility to learn stuff for themselves. And then I ended up with three or 400 emails because people don't understand what we're trying to do. And then they hear it is you haven't read it yet. So I said, just read the documents. Will you please? If you have a question, use the Jot form. And we'll come back to the q&a, and we'll answer it for everybody. But why should I have to answer for every single person on an individual basis? I'm not going to do that. I'm going to do that anymore. Okay. Well, got Tracee. That was millillion box. Let's go fine. There.

Okay, so then we have you sign, I declare that I've registered with LW s, and I'm receiving training emails from them, I understand that any fraudulent activity renders all SKR our agreements, null and void sign. And then you have to do a CAPTCHA to verify and then you submit. And then this document goes into a database slash spreadsheet. And then the spreadsheet will be edited because some of you guys make mistakes. And we edit the spreadsheet and then we upload it. Now, we just found out that if you submitted two of them before receiving a certificate, it will only send you one. And that is nothing we can do. So at the end of the day, or at the beginning of the next day is even better look at your certificates, make sure you've given yourself 24 hours, if you don't have what you feel you need, you may submit again, this is just something we can't control. It has to do with a software problem. So I received an email somebody, some people didn't get the do million because we said we'd still honor it. Well, once I took it off the Jot form, it was off the spreadsheet, so it never went into a bond, we have no way of knowing who requested them. But I don't think it's a big deal. Because I think that you're going to have plenty of what you need by making sure that you have up to 20 and up to 180 of the remaining currencies, the Quintilian and millillion okay. So that is the form you should receive the emails, check your junk, you will receive a receipt from jot form that shows your submission. But then twice a day. The spreadsheet, like I said, is uploaded into our email server. And then we send out the quote unquote, like certificates via email. So it is quite a process on this end. Oh, that's KR, sorry, we send the s KR via email. But please give it 24 hours at least and we are approaching a weekend. So you will not receive emails for the SKR? Well, US Friday or Saturday, they will resume again on Sunday because my helper doesn't work on Friday and Saturday. So we'll resume again on Sunday. So with that said, we'll start the q&a sound good?

Yeah. What happens if if there's a mistake on the request form? How does how does our assistant helper take care of that? Is there something that she does?

She goes through the spreadsheet manually. Now we have no way to verify if it's a name or email, you no problem. The only thing we switch around or or add up is if they have too many requests, like somebody requested a billion of one thing well clearly we're not going to give them a billion So, what we are doing is like if they ask for, or if they add, if they ask for too much, or if they write words, then we edit that. So that's kind of how that goes.

Yeah, don't make it don't make her have to be doing things in a different sort of way. Use numbers, most of them are, like 100 80 million. Yeah, most people are. And those who are hurt or not, are the ones that are causing the problems that are so frustrating for us right now. And that's because they haven't read the document. So 95%. You know, if I have offended any of those that are doing it, I apologize. I really do. And I'm so grateful that you get it. This is the biggest thing that this world has ever known. And some people aren't taking it as if it's, no, I can do it tomorrow. I can do it next week. I probably won't do that, because I got enough of them. And I'm gonna get those are the kinds of people that I am having problems with. So let's, let's go ahead. Oh, there was one other question I had. Sometimes the email system is, is not very good in other countries. But I had a lady who says she's familiar with a person over airs, a friend of hers is over in Africa, wanting to be as him benefactor. And he's having trouble with his email system to be able to get the requests. And he's not really sure if what's going to how he's going to get the, the, the STRS themselves. And so he, she asked me, if she could fill it out for him. I said, Well, we're tracking it by emails. So if you put his name and his email, it doesn't matter who is sending that it's received. And we can send it to the right place. As in the email, the SKRs, we can send the fkr by the email to that email that is listed on the on the request form. And the person who's doing all that work for them is it's okay. That there's that the email is not part of our program, that they won't get the fkr Is that appropriate? President I'm just saying that tell we could talk about this later. But I feel that it's an appropriate sort of thing, and it solves a problem.

It is mentioned that we must be vetted with referral letter when signing the contract with all of us where and from whom do I gain an acceptable referral letter as proof of humanitarian mission and sufficient funds? I answered this just the other day. And sorry, my computer's been really messed up. But on the love won Society website in the middle tab, scroll to the bottom, it's there, just print it up and bring it with you for signature. I would do two copies. Yeah. Is that good? Correct? Is it is it required that all SKR funds be donated? If I have 100 T and desire more from my own projects? Can some of the SKR funds be used as CAC distribution funds over the next 100 years?

R Ron Giles 40:54

Yes, and this is why when you go into your appointment, you've got your counselor right there. And I'm telling everybody now, if you're getting the 100 million, and you already have some of your own, ask your ask your counselor. What are your options here? What can I do? And it might be that he'll give you some, if he asked for his opinion, you might give it to him, he might give it to you. But they're not going to volunteer anything unless you ask them. But in that current course of correspondence, between the two of you discuss the options that you have with the extra 100 million. Most people don't have the need for that kind of money for their humanitarian work for 100 years. And I don't know if I've said this before, I have said it before. But I want to make sure that there's something else here that you understand the importance of of getting the right amount for yourself is is necessary. The structured payout is the way that you will get your allotment or your payment on an annual basis, we'll go back to the 100 T note, then we've come up with the fact that you get 1.25 quintillion, and that's five quintillion per per year. Well, the 500 quintillion per year there's going to pay for that is taken into the quantum financial system, under the auspices of the structured payout plan, and it will be administered there. But there's 500 quintillion that goes into that appointment. That is money that cannot be used for any other way. So you sit down with your your counselor and you say, they'll you'll figure out the best amount of a lot more than you'll ever need. And then because the most of that is not going to go in, well, the what you need, we'll go through the the structured payout program, but the rest of it will just be put in the account. Now, let me be very clear, this is your money. The Alliance will not come up and just take it from you. The Alliance

may come to you and ask if it is would you like to use this money for some of the projects that we're on? They're not going to come and say this is you donate to this to us. So it's no, it's your money? Still, it's in your account with your name on it. And the Alliance does not just come in and take it? No. Will they just come in and take it? No, that's not what it's for, because it's still your money. So they will ask you if you want to participate in projects. And then that's your decision. And that's why the funds are still in your name. Be sure you understand that. Next question.

I do not want to make rash decisions on the spot. You often say speak to your counselor who is my counselor, can I hold discussions with him before the redemption appointment?

No. Who is my I don't know. I have no idea. They know who they are. And they know who you are. You'll be introduced at the appointment. So yeah, don't make rash decisions. If that's what you're prone to then don't do that. But if you're prone to planning things out, then plan things out do everything as much as You can do. But if there's still some decisions that you need some help with, that's why the counselors there at your appointment. That's when you set the sail for the thing, the place that you want to go. They'll all just work out perfectly for you. You have that there for your, that counselors there for your use for your source resource of information, use it wisely and use it often. How often do you want to use how often you aren't? Well, I'd like to at least have an opportunity to every day to talk to you. Okay, we can work that out what time of day you want it? Or do you just want me to show up when you say hey, come here. That's a little rude. But it could be that way. Could be that way. You set it up the way you want it to be. Next question.
