So if you really want to know everything, go to each country and find out what their laws are. I'm not going to do that. Until I start setting up the NRELS in those countries. And it's going to be difficult for us all to do that. from one country to the next. That's why we have Zim benefactors in countries. As we have so many different countries right now, I don't remember how they how many we have Jim benefactors in training to be Zim benefactor in that country? I don't know. Those are the kinds of things we can't, there's no way to know. Next question.
